#### Hon. Speaker, Sir,

Mr. Speaker Sir, The Nairobi City County Wards Development Fund Bill, 2014 was published on 14<sup>th</sup> November 2013 by the government printers for debate and enactment by the Nairobi County Assembly, thereafter the bill elapsed pursuant to Standing Order 134 131 and it was republished in the same form by Government Printer on 27<sup>TH</sup> January 2014 as Nairobi City County Wards Development Fund Bill, 2014(Bills no 3 of 2014) before its re-publication

The Ward Development Fund Bill, 2014, underwent the First Reading on Wednesday, 27<sup>th</sup> November, 2013 and was committed to the Committee on Transport and Public Works, as provided for under Standing order 121(1).

Pursuant to Article 118(b) and Standing Order 121(3) which require public participation and involvement in the legislative and other business of the County Assembly and its Committees, a notification was placed in the Nation Newspaper on November, 2013, informing the public that the Committee was considering amendments to the Nairobi City County Wards Development Fund Bill, 2013, and inviting them to submit their memorandum either in hard copy to the County Interim Clerk or by Email <a href="mailto:nbiclerk@gmail.com">nbiclerk@gmail.com</a> to be received on or before Thursday, 5<sup>th</sup> December,2013 at 5.00p.m.

#### Hon. Speaker, Sir,

It is important to note that, there was no responses from the members public, either through memoranda's or the email address forwarded to the public for the same, however, the Transport and Public Works committee received a memorandum from the Minister in- charge of Transport and Public Work, Nairobi City County, P.O.Box 30075-00100 attached please find the memorandum of the same.

#### Hon. Speaker, Sir,

The Committee held a total of seven meetings, to deliberate on the NCCWD BILL, Attached are minutes of the meetings held in regard to the NCCWDF.

During its consideration of the Bill with stakeholders from the Executive, The Executive Member for Finance Hon. Gregory Mwakinongo, informed the committee that the funds set aside for development of the Wards was still available and the department will implement the projects once the bill is passed, the County Engineer Eng. Christine Ogut stressed the need to spend the ear marked fund within the remaining months on priority projects.

Report of the Sectoral Committee on Transport and Public Works on the Consideration of the Ward Development Fund Bill, 2013

The Engineer advised the Committee that if County did not implement projects targeted for the financial year, then they risk being challenged on county funds absorption capacity and the electorate will question the County Government's performance. It was agreed that members ensure proper utilization of the allocated funds for the Bill.

The Committee resolved that a meeting be held on 3<sup>rd</sup> February 2014 during which it will receive the Executive's report on the establishment of the Ward Development Fund disbursement structures and the disbursement program.

### Hon. Speaker Sir,

The Transport Committee proposed that by 30<sup>th</sup> January 2014 the Committee for the Ward Development Fund, in the 85 wards should be in place. The Committee observed that there was need to decentralize the County Treasury, and called upon the Budget and Appropriation committee to act with speed in ensuring this is done so as to fast truck development in the County.

### Hon. Speaker Sir,

It is prudent to inform the Assembly that the County Executive Committee Member for Transport and Public Works, Mr. Evans Ondieki, informed the house that the Executive was in support of the Bill and was anticipating its passing into law so as to have the structures to spur development within the City County of Nairobi.

He submitted a write-up on amendments to the Bill. Among the amendments were:

- (a) That there should be an equalization fund under clause 14(i)
- (b) That the proposed 5% under clause 4(2a) be increased to 10%

The Committee subsequently agreed on the following as the way forward regarding the Bill and proposed amendments;

- (a) It was agreed that some of the structures required in the Bill would be put in place by the executive by end of January 2014 and Members would proceed with the Bill till it is enacted into law to support the structures that will be set up.
- (b) Projects to be implemented are to be identified for the Bills of Quantities documents to be ready by the time the structures are in place.
- (c) The requested priority projects should be submitted to the Engineer within the next 7 days since the meeting.
- (d) The members were asked to note that the Ward Development fund was not to carter for the submitted priority projects but for a different set of projects that would be identified by the set up structures.

### Mr. Speaker,

The need for devolved grassroots development at the Ward level to compliment development initiatives from both the National and County Governments is paramount to entrenching service delivery. The object of this Bill is therefore to provide for the establishment, administration and use of the Ward Development Fund and for connected purposes.

## Hon. Speaker, Sir,

In examining the Bill, the Committee noted that some proposed amendments, such as amendments to Clause 2 and 4, are timely as they seek to bolster the fund's resource base and ensure it takes off.

The lack of previous audited accounts for the Nairobi City County Government necessitated amendments to Clause 4. The Committee was of the opinion that the requirement that the fund be drawn from not less than five percent of the "most recent audited accounts of revenue" would stagnate its establishment. It was therefore proposed that Clause 4 be amended so the fund can be set up from the readily available "ordinary revenue collected in the previous year."

It was further noted that it is important to ensure amendments are in tune with the spirit of the Fund, which is designed to support Ward-level, grass-root development projects. It was aimed to achieve equitable distribution of development resources across Wards and to control imbalances in development brought about by partisan politics.

To that end, the Committee proposed that the Fund take into cognizance the rights of children, persons with disability, youth, minorities, marginalized and older members of the society as provided for under Article 53, 54, 55, 56, and 57 of the constitution of Kenya (2010). This necessitated proposed amendments to Clause 28, to expand the net on groups legible for support from the fund.

During its deliberations, the Committee also took note of transition issues arising out of the management of the fund through successive terms of the Assembly. It was agreed that Clause 8 be amended, such that the Ward Management Committee serves for a period of three years, as opposed to the four originally proposed. This will allow incoming management teams to benefit from the knowledge and hindsight of the outgoing team in the one year of transition, and to create continuity in the management of the fund and projects.

Other crucial amendments noted by the Committee included deletion of Clause 26, to forestall any potential conflict amongst Wards in terms of allocation. Clause 26 had proposed formulae for disbursement of the fund whose criteria the Committee felt would give rise to conflict amongst Wards. The Committee was of the opinion that all Wards be given equal allocation regardless of their population or other criteria as had been outlined in Clause 26.

Additionally, Members were in agreement that since priorities may differ from Ward to Ward, an amendment be brought to Clause 28 (f) to remove the ceiling on purchase of Motor Vehicles. It was agreed that "purchasing" be left out from sub-clause (f), and be considered a Capital Budget to allow Members purchase Cars for development initiatives that call for such.

Amendments to Clause 49 were meant to ensure the Fund does not stagnate due to a lack of quorum. The Committee agreed that the Fund's Management Committee should be able to meet for the first time even before its membership from amongst the Public is elected or it is fully constituted.

#### Mr. Speaker, Sir,

The Committee is thankful to the Office of the Speaker and the Clerk of the Nairobi City County Assembly for the logistical and technical support accorded to it during its Sittings in consideration of the Bill.





Members were informed by the executive that the fund set aside for development of the Wards was still available and there was need to spend it within the remaining months on earmarked priority projects.

Hon. Ondieki minister for finance informed members that an extra Ksh 2billion which was expected from the National Government for earmarked road projects in the County.

The county Engineer Hon. Christine Ogut, reported that if the County did not implement projects targeted for the financial year then it risk being challenged on their funds absorption capacity and the electorates will question the County Government's performance.

The minister in charge of Finance informed the committee that his position was not that of the Executive, and the executive had not received the bill, however the Minister in charge of TRANSPORT AND PUBLIC WORKS, confirmed to the committee that indeed the Interim clerk of the assembly had forwarded the bill to the executive, and the executive was waiting for the assembly to work to the bill.

Hon Kennedy Ongondi challenged the minister in charge of finance Hon. Gregory Mwakinogo to state his presence in the committee if he was not representing the executive.

The Chairperson Hon. Dianah Kapeen, on works also question if the minister would implement the bill if he was present on his own capacity. The minister stated that he would implement the bill but requested for 14 days to present the input of the executive.

The Executive member on Finance, Hon. Greogory Mwakinogo assured the committee that the funds allocated to the WDF, was available he however noted that the money can only be realized, as per the remaining part of the finical year.

Hon, Gregory Mwakinogo committed to appear before the committee on 3rd February 2014 to present the Executive's report on the establishment of Ward Development Fund disbursement structures and the disbursement program, Members requested that by 30th January 2014 the Committee for the Ward Development Fund should be in place.

Members decried the bureaucracy in the procurement sector and agreed to work towards changing the way things are done in the department. Hon. Chege Mwaura asked the minister incharge of finance, why finance matters are centralized in one department and questioned if that does not promote corruption and also encourage slow activities in the departments. The Minister said lack of personnel had led to the centralization of the activities at the treasury department, and agreed that was need to decentralize the treasury activities to fast truck activities and management of the departments.

Hon Chege observed that there is need to devolve money. He said that the Finance Department needs to let the 10 A.I.E (Authority to Incur Expenditure) holders of departments to be in charge of their finances to allow for faster procurement processes and processing of payments.

Hon. Kenethh Irungu, Pumwani ward asked the minister in charge of finance to explain the state of the vote set aside for the WDF, and if the funds were available, the minister confirmed that the funds were available.

Hon, Chege mwaura reminded the minister the assembly will not accept a reduction to the vote set aside for the WDF.

1. Hon. Micheal Waweru, Kariobagi, South questioned the performance of the electrical department, since most of the city was in darkness and if the department was well financed due to it pivitol role in the county development. Eng. Christine Ogut observed that there was need for more funds to be allocated for street lighting as there was a deficit of Ksh3O3 million, she noted that most of the recurrent funds regarding the lighting was due to vandalism, she acknowledge that the department was under performing and is putting in structures for better performance.

The Engineer requested the Hon. MCA'S educate members of the public on the importance of lighting and the dangers of vandalism. Members undertook to educate their constituents on the importance of street lights in a bid to curb vandalism.

2. Hon. The traffic marshals' project is expected to be launched with a view of decongesting the city, the member quarried the viability of the project and the minister offer to table more information.

4. The executive Member. Hon. Evans Ondieki informed the committee, of county to plans to have a parastatal established within the county for the for purpose managing issues relating to transport sector, he noted that he will present a proposal to the sectorial committee on roads regarding the same.

Hon. Samuel Irungu reminded the Executive member that matters of the transport committee were sensitive hence the need for inclusion and public participation.

# MIN. 141/NCCA/TPWC/88/JANUARY/2014 - FURTHER DELIBERATIONS ON THE AMENDMENTS TO THE WARD DEVELOPMENT FUND 2013

The chairperson welcomed members to the meeting. She did inform the members that the days agenda was to further deliberate on amendments to the Ward Development Fund Bill 2013. Members agreed that clause 4 which read ordinary revenue should include the definition of the word ordinary revenue which should include National and county government. Hon Ken Ngondi was in agreement that there was need to capture the real definition of revenue to avoid a situation where the word would end up tying them and to some extent bringing up some ambiguities. He therefore concurred with honorable members that the amendments were in order and should be submitted,

Hon Chege Mwaura also concurred on the usage of the word ordinary revenue. The issue of composition of the ward fund management committee was also deliberated; Members were in agreement that having county assembly members in the ward fund committee would amount to usurping the doctrine of separation of power. The Interim clerk Jacob Ngwele advised members that as a county with basically two arms that is the legislature and judiciary having members sitting in the management committee would be detrimental to the spirit of checks and balances. The clerk further advised the committee that since the vote of the fund will not lie with the assembly it would mean that the County assembly plays an advisory role, regarding clerk's advice members were in agreement that the amendment on inclusion of members of county assembly be dropped.

Hon Chege while commenting on financial provisions in clause 18(1) reiterated the need to maintain a lean staff that would basically be drawing allowances on 18(1) members agreed that it remains the same as matters to do with benefits and salaries of public servants remains solely on SRC. On submissions of ward projects proposals members agreed that clause 20(2) shall remain a penalty clause on clause 26(b) the clerk advised honorable members that it was rather contentious because B actually means the equalization fund meaning you have to retain some money.

On Part v types of projects, members had amended clause 28(b) (g)to read 3% of the total allocation be used for emergency but it was found that a provision to cater for emergencies had been accommodated

Part VI on the ward development fund committee was also discussed by honorable members and various amendments proposed on Clause 17(2) the clerk promised the members that he would confirm with the drafter to get better interpretation of the clause. Ondiekis amendments were also discussed by the committee ondiekis amendment on 48 was foregone thus it was inadmissible but his amendment on 28(1) was admissible in which ondieki proposed for inclusion of persons with disability to the ward development fund committee.

On PART VIII ON Miscellaneous provisions Hon Hashim Kamau the minority whip had some proposed amendments particularly in clause 49(1) to read that the initial capital of the fund shall be the sum of one hundred and twenty seven million five hundred thousand on clause 4(20) that reads notwithstanding subsection (1), if this act comes into operation midway financial year then the leader of majority shall within fourteen days of its publication, introduce in the assembly the amount proposed to be put in the fund and the amount proposed shall; be allowed through supplementary estimates



### MIN1/TPWC/JAN/2014 - INTRODUCTORY REMARKS BY THE HON, CHAIRPERSON

The Chairperson welcomed members of the transport and public works committee to the session. She informed members that this was the last chance they had to make any amendments to the ward Development Fund Bill 2013, so it was upon them to come up with conclusive amendments to the ward development fund bill 2013 before its tabling on 28th of January 2013.

### MIN2/TPWC/JAN/2014- REMARKS BY HONOURABLE MEMBERS

Honorable members also had some remarks concerning the ward Development Fund Bill 2013; Hon Irungu noted that it was very important that each member acquaints himself/ herself with the bill for the purpose of defending the bill when it is tabled before the house. He reiterated the importance of the session and urged members to make a point of accurately defending the bill when it is finally tabled. Hon Martin Gichuhi in his remarks also told the committee that it was fundamental for the committee to ensure that loopholes in the bill are sealed to avoid unnecessary court battles.

# MIN3/TPWC/JAN/2014 – COMMITTEES FURTHER DELIBERATIONS ON THE PROPOSED AMENDMENTS

Member's started deliberating on the bill by looking at clause by clause, but of more importance to them were the rather contentious clauses, Clause 26 emanated a lot of discussions with some members proposing that wards should receive money depending with the population but majority of members objected this particular clause arguing that it will bring acrimony among members, Members argued that this would forestall any potential conflict among wards in terms of allocation of funds. The committee was therefore of the opinion that all wards should be given equal allocation regardless of their population or any other criteria as had been outlined in clause 26 members were in consensus that priorities of wards may differ from ward to ward they agreed that an amendment be brought in clause in clause 28(f) to remove the ceiling on purchase of motor vehicles it was agreed that purchasing be left out from sub-clause (f) and be considered a capital budget to allow members purchase cars for development initiatives that call for such. Members also proposed for amendments in clause 31 that clause 31 be amended in (c) in sub-clause (2) by inserting the words social welfare programs immediately after the expression "subsection (i) an". In (d) in sub-clause (2) by deleting the words "twenty five" and inserting the word "fifteen immediately after the expression "more than." Honorable members argued that it would widen the net on the kinds of welfare programs the fund can be applied to and in sub-clause 2 to remove ambiguity on the percentage ceiling for the funds meant for welfare programs.

Honorable members also agreed that clause 44 be amended in sub-clause (2) by deleting the expression "the Ward Development" substituting therefor the expression "The county development".

Clause 49 was also proposed for amendments in (c) by deleting the word "five" appearing immediately after the expression 'imprisonment for a term of not less than and substituting therefor the word "two"

In (d) by deleting the word "five hundred thousand "appearing immediately after the expression "fine of not less than" and substituting therefor the word "two hundred"

thousand". This was basically to reduce the severity of the penalty for persons, who misappropriate any funds or assets from the fund, or assists or causes any person to misappropriate or apply the funds in any other manner not specified in the act.

Clause 49 (d) in sub-clause (2) was also proposed for amendments by deleting the word "one month" appearing immediately after the word "shall within" and substituting therefor the word "fourteen days". On this particular clause members argued that it would reduce the period which the Leader of the Majority ought to bring supplementary estimates to the assembly for setting up the fund should the Act come into force halfway through a financial year



## THE NAIROBI CITY COUNTY WARDS DEVELOPMENT FUND BILL, 2013

### PROPOSED AMMENDMENTS AND ADDITIONS

Section 4 of the Act is amended to read

I. Section 4(a) An amount not less than 10% of all the revenue collected by the Nairobi City County in every financial year

Section 4(c) Any monies donated by well wishers, development partners and/or gifts in form of materials and equipment donated to support ward development in Nairobi City County.

4(6) once the amount is transferred it shall be held in a special interest earning account until used for the intended purposes

Section 34(1) (f) is created to include Persons with Disabilities and older members of Society in accordance with Article 54 & 57 respectively.

Section 48 is amended by creation of;

Section 46(6) there is created the Nairobi City County Wards Development Tribunal.

Section 6(a) the Tribunal shall have jurisdiction to hear and determine any disputes and/or disagreements arising from the County Management Committee and all other connected purposes.

Section 6(b) composition of the Tribunal shall comprise;

- (a) A Chairperson with over 15 years wide experience on economic and financial issues;
- (b) A member who must have a legal background of not less than 10 years;
- (c) A member who shall be having expertise in accounting and auditing of not less than 10 years;
- (d) The Tribunal shall have a Secretary who shall be a member of the CPS Kenya;
- (e) The Governor shall appoint Tribunal members from a list of applications submitted after advertisement off the posts.

Section 49(i) is amended by including a new sub-section 1(a) The subsequent funds and disbursements shall be captured and reflected in the budget estimates notwithstanding any contrary provisions by other laws.

Section 2 is amended by adding Ward Equalization Fund this is a special Fund created Section 33(2) which shall support Wards that have been marginalized and lack piped water, proper infrastructure, schools, hospitals and other basic necessities of life in accord with Article 43 of the Constitution and also experience flash flooding and storm water drainage during the rainy season.

Section 33(2) is amended by creating sub-section 2 which provides there is created a special Nairobi Ward Equalization Fund.

Section 33 (2)(a) The Ward shall receive 5% of all the collected revenue to address unique challenges in some wards which lack basic infrastructure.

Section 33 (2)(b) criteria to access funds from the Ward Equalization Fund;

- The Ward lacks basic infrastructure like schools and hospitals;
- (ii) Lack of murram or tarmacked roads in the Ward;
- (iii) Lack of piped water in the Ward;
- (iv) Lack of security and street lights in the Ward;
- (v) This Fund shall be administered by a special Committee created by the Ward representatives in liaison with the county Secretary and the office of the Governor.

Section 2 is further amended by adding the following terms;

Unspent Funds- means monies in the County Management Committee Fund Account at the end of the each financial year;

Unutilized Funds-means monies in the Ward Fund Account at the end of each financial year.

Section 34(1)(d) one representative of local non-governmental organizations or religious organizations who shall be nominated by the elected Member of the County Assembly.

Section 34(2) shall be amended to- The seven persons referred to in subsection(1)(b),(c),(d), (e) and (f) shall be nominated through the following procedure-

- (a) Within forty-five days of being sworn in, each Member of the County Assembly for a particular War shall convene open public meetings of registered voters in each of the elective wards in the Ward to nominate individuals who will fill the slots created in (1) (b) (c) and (e)
- (b) Applications shall be invited for individuals who wish to fill the slots created under (1)(f). The individual should meet the following qualifications;
  - (i) A Certified Public Secretary
  - (ii) Should have worked as an administrator for not less than 5 years

Section 33(2)(d) should be amended to read upon conclusion of nomination, the officer of the Ward Development Fund Committee shall forward the names of the members of the Ward Development Fund Committee to the Officer Administering the Fund for the onward transmission to the member of the County Executive Committee for Gazettement;

Section 28(1) (c) be alive to the rights of Children, Persons with Disability, Youth, minorities & marginalized and older members of society as provided under Articles 53,54,55,56 and 57 respectively of the Constitution.
