## 1.0 BACKGROUND INFORMATION

The Sectoral Committee on Children, Early Childhood Education and Vocational Training is established under Standing Order 203, and its mandate amongst others, as outlined under Standing Order 203 (6) is to:-

- a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned departments;*
- b) study the programme and policy objectives of departments and the effectiveness of the implementation;*
- c) study and review all county legislation referred to it;*
- d) study, assess and analyse the relative success of the departments as measured by the results obtained as compared with its stated objectives;*
- e) investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly;*
- f) vet and report on all appointments where the Constitution or any law requires the County Assembly to approve, except those under Standing Order 196 (Committee on Appointments); and*
- g) make reports and recommendations to the County Assembly as often as possible, including recommendation of proposed legislation.*

The Committee exercise oversight role on the work and administration of the Education, Children, Youth Affairs, Gender Affairs, Culture, Social Services Sector.

In accordance with the third Schedule of the Standing Orders, the Committee is mandated to consider all matters relating to: - “pre-primary education, village polytechnics, Home craft centres and childcare facilities; children welfare”

## **1.1 INTRODUCTION**

On 20<sup>th</sup> February, 2018, the Committee on Children, Early Childhood Education and Vocational Training conducted a site inspection visit to Juja Road Primary School, Dr. Aggrey Primary School, Muslim Primary School and Cerebral Palsy Unit & Pangani Primary School in Pangani Ward and St Elizabeth Primary School & Star of Hope Primary School in Viwandani Ward.

The site inspection visit to Juja Road Primary School & Dr. Aggrey Primary School, Muslim Primary School and Cerebral Palsy Unit in Pangani Primary School in Pangani Ward and St Elizabeth Primary School & Star of Hope Primary School in Viwandani Ward was in response to a concern by the Committee regarding lack of compliance with County Government Education requirements on advertisements on the perimeter walls of school facilities and Sub-letting of school playgrounds to private stakeholders for construction of private sportsgrounds.

The Committee observed that the perimeter walls of school facilities in Pangani Ward carried advertisements and that some schools had sub-let school playgrounds to private stakeholders for construction of private sportsgrounds.

The Committee was accompanied by the Senior Education Officer, County Department of Children, Early Childhood Education and Vocational Training.

The Committee also met the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services together with the Head teachers of Dr. Aggrey Primary School, Muslim Primary School & Celebral Palsy Unit and Pumwani Primary School in Pangani Ward regarding the compliance with County Government Education requirements on advertisements on the perimeter walls of school facilities and Sub-letting of school playgrounds to alleged private stakeholders for construction of private sportsgrounds.







## 2.0 COMMITTEE FINDINGS

### 2.1 JUJA ROAD PRIMARY SCHOOL

During the visit to Juja Road Primary School, where they observed the Early Childhood Education Development Centers (ECDCs) as follows:

- i. The school duty house that was to be occupied by the School's Head teacher had been let to the Nairobi County Executive Committee Member for Health who had in turn sub-let to private residents;
- ii. Incomplete Perimeter Wall at the Early Childhood Education Development Centers (ECDCs);
- iii. The roofs at the Early Childhood Education Development Centers (ECDCs) WAS made of Asbestos;
- iv. The toilet roofs and floor were worn out;
- v. Worn out ceiling boards in the classes;
- vi. Lack of water tanks at the toilet area and the playground;
- vii. Poor drainage at the Early Childhood Education Development Centers (ECDCs); and
- viii. Lack of enough desks, teachers, chairs for pupils at the Early Childhood Education Development Centers (ECDCs).

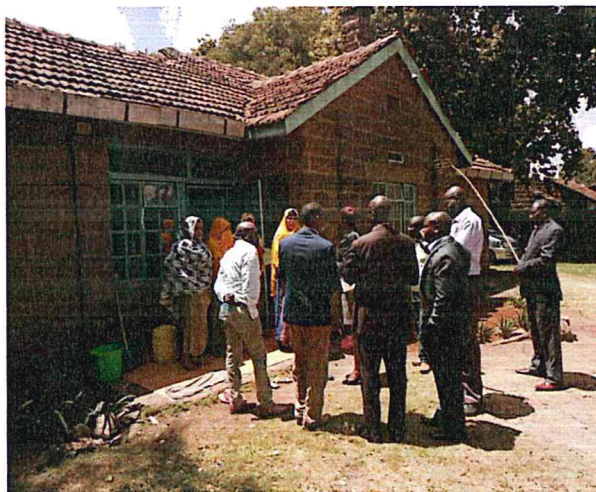


Figure 3: Head teacher's duty house at Juja road Primary

## 2.2 DR. AGGREY PRIMARY SCHOOL

The Committee made the second stop at Dr. Aggrey Primary School, Pangani Ward where they observed that:

- i) The school's perimeter wall had been advertised on by Safaricom Limited; and
- ii) It was alleged that initially the school had been allowed by Nairobi County Government to build a mini playground with the understanding that it was to be for the exclusive use of the school. Once it was discovered that the private stakeholders were sub-letting for Ksh. 3000 per hour per head, no further authority was granted.

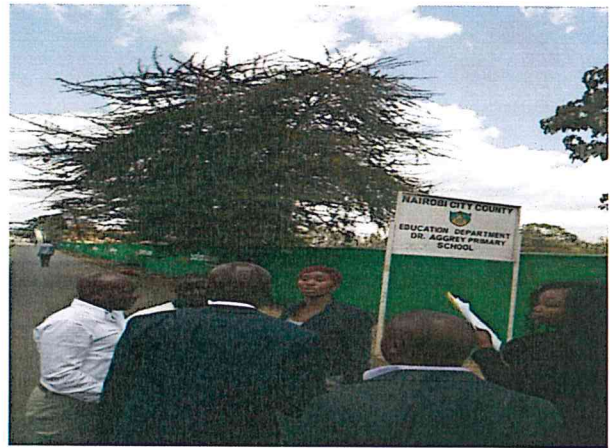


Figure 2: painted perimeter wall at Dr. Aggrey Primary

## 2.3 MUSLIM PRIMARY SCHOOL AND CEREBRAL PALSY UNIT

The Committee made the third stop at Muslim Primary School and Cerebral Palsy Unit where they observed that:

- i) The school had a total of 393 pupils;
- ii) The school Early Childhood Education Development Centers (ECDCs) was not included in the county schools feeding programme;
- iii) The school's head teacher had allowed Safaricom Limited to advertise on the school's perimeter wall because Safaricom Limited had sponsored a great project in Cerebral Palsy special unit at the school;

#### 2.4 PUMWANI PRIMARY SCHOOL

The Committee made the fourth stop at Pumwani Primary School where they observed that:

- i) The school's management had allowed private stakeholders to construct a private sports grounds at the school's playground hence were sub-letting for Ksh. 4000 per hour per head to the Muslim Community living in Eastleigh; and
- ii) The school's perimeter wall had been advertised on by Safaricom Limited.

## 2.5 ST. ELIZABETH PRIMARY SCHOOL, LUNGA LUNGA

The Committee made the fifth stop at St. Elizabeth Primary School, Lunga Lunga in Viwandani Ward where they observed the Early Childhood Education Development Centers (ECDCs) as follows:

- i) The school had a total of 200 pupils;
- ii) The school Early Childhood Education Development Centers (ECDCs) was included in the county schools feeding programme; and
- iii) Poor drainage at the school i.e Leakage of raw sewer at the premises;
- iv) Incomplete Perimeter wall at the school compound;
- v) Insufficient water tanks at the toilet area and the playground; and
- vi) Insufficient toilets hence posing a health risk to the pupils at the ECDE Centers.

## 2.6 STAR OF HOPE PRIMARY SCHOOL, LUNGA LUNGA

The Committee made the sixth stop at Star of Hope Primary school, Lunga Lunga in Viwandani Ward where they observed as follows:

- i. The roofs at the primary and (ECDCs) were in a deplorable state;
- ii. The toilet roofs and floors were worn out;
- iii. Worn out Ceiling Boards in classrooms and offices;
- iv. Leaking Drainage in the school;
- v. Improper lighting system at the system unit;
- vi. Lack of water tanks at the toilet area and the playground; and
- vii. Lack of enough desks, teachers, chairs for pupils at the Early Childhood Education Development Centers (ECDCs).



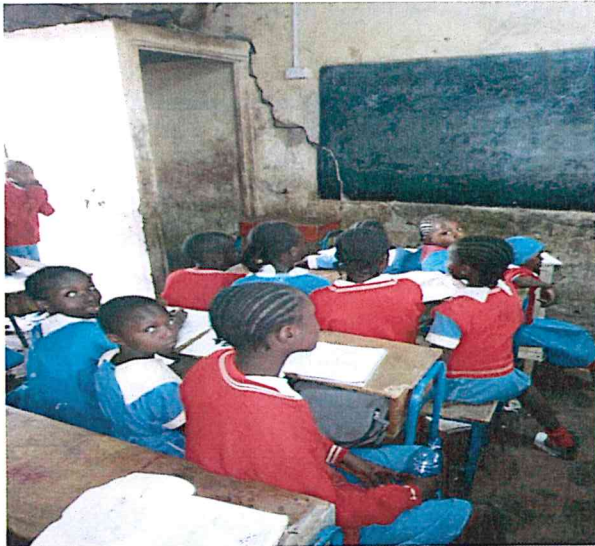


Figure 1: star of Hope Primary cracked walls

### 3.0 MEETING WITH THE CHIEF OFFICER FOR EDUCATION, YOUTH AFFAIRS, SPORTS, CULTURE, CHILDREN & SOCIAL SERVICES AND HEADTEACHERS OF THE RESPECTIVE SCHOOLS

The Committee met the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services together with the Head teacher of Dr. Aggrey Primary School, Muslim Primary School & Celebral Palsy Unit and Pumwani Primary School in Pangani Ward on Wednesday 6<sup>th</sup> June, 2018 regarding the compliance with County Government Education requirements on advertisements on the perimeter walls of school facilities and Sub-letting of school playgrounds to alleged private stakeholders for construction of private sportsgrounds.

#### 3.1 DR. AGGREY PRIMARY SCHOOL

On whether there was a Public Private Partnership (PPP) Agreement in regard to the said advertisements on the perimeter walls of the said school facilities by Safaricom Limited, the head teacher responded that Safaricom Foundation had not made any agreement with the said



school but had painted the school perimeter wall to make it clean and in extension of the perimeter wall at Muslim Primary School and Cerebral Palsy Unit.

On the Sub-letting of the said schools' playgrounds to alleged private stakeholders for construction of private sportsgrounds the head teacher responded that the school had entered into an agreement with Jambo Football Academy in 2015 who constructed a sportsground at the school's playground and the agreement ended in December, 2017.

That currently the sportsgrounds was being used by the pupils of the said school. He further stated that the school had benefitted from Jambo Football Academy such that they had bought 500 desks and chairs for pupils at the said school.

On Measures the County Government had put in place to address compliance with Education requirements on the said issues, the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services responded that:

- a) The County Department on Outdoor and advertisement would move with speed to remove all the advertisements from the school's perimeter wall; and
- b) The County Department on Planning and Housing should move with speed to remove the private sports grounds sub letted to private stakeholders.

### **3.2 MUSLIM PRIMARY SCHOOL AND CEREBRAL PALSY UNIT**

On whether there was a Public Private Partnership (PPP) Agreement in regard to the said advertisements on the perimeter walls of the said school facilities by Safaricom Limited, the head teacher responded as follows:

That Safaricom Foundation had made a grant agreement with the Board of Management of the said school on 31<sup>st</sup> January, 2017. That the grant amounted to a sum of Ksh. 920, 000 paid in July, 2017 for renovation and fully equipping of a cerebral palsy special unit classroom to assist children living with cerebral palsy and give them therapy sessions. The head teacher submitted the copy of the PPP Agreement to the Committee.

The head teacher further stated that Safaricom Foundation had assisted the pupil who led the school last year by paying for her school fees in secondary school.

### **3.3 PUMWANI PRIMARY SCHOOL**

The head teacher Pumwani Primary school stated that she had been deployed at the school in February, 2018 and had found the perimeter wall painted by Safaricom Limited and the school's playground sublet.

On whether there was a Public Private Partnership (PPP) Agreement in regard to the said advertisements on the perimeter walls of the said school facilities by Safaricom Foundation, the head teacher responded as follows:

That Safaricom Foundation had not made any agreement with the said school but had promised the said school head teacher to renovate it before end of 2018.

On the Sub-letting of the said schools' playgrounds to alleged private stakeholders for construction of private sportsgrounds, the head teacher responded that an agreement was made between the Board of Management of Pumwani Primary School with Khalid Ahmed Mouhamed as the sponsor to construct a temporary pitch at the school's playground which detailed as follows:

- i) The sponsor was willing to pay an annual fee of Kshs 60,000 before commencing on the construction of the Futsal pitch;
- ii) The sponsor would offset the outstanding electricity bill and would continue paying the subsequent bills; He would employ security personnel to enhance the services of the one employed by the secondary wing;
- iii) He would buy the head teacher a laptop and install a printer in the office;
- iv) He would clear the bushes where armed thugs were using as their hideout;
- v) He would erect a high mast to light up the tuition and administrative blocks;
- vi) Upon completion of the structure it would be free for use by the school's children during day time since they would be using it after school hours;
- vii) The school children would be using it on the seven aside game; and
- viii) After it has become operational, Mr. Khalid and the Board of Management members would sit and agree on what would be paid monthly and the modalities.

The head teacher further stated that so far the pupils at the school were not benefitting from the private sportsgrounds.

On Measures the County Government has put in place to address compliance with Education requirements on the said issues, the Chief Officer stated that their Department would liaise with the County Department on Planning and Housing should move with speed to remove the private sports grounds that had been sub-let to private stakeholders.

#### 4.0 MEETING WITH THE CHIEF OFFICER FOR EDUCATION, YOUTH AFFAIRS, SPORTS, CULTURE, CHILDREN & SOCIAL SERVICES AND THE HEAD OF CORPORATE RESPONSIBILITY, SAFARICOM FOUNDATION AND THE DIRECTOR, DEPARTMENT ON OUTDOOR, ADVERTISING, SIGNAGE CONTROL & REGULATION

The Committee met the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services together with the Director, Department on Outdoor, advertising, Signage Control & Regulation and the Head of Corporate Responsibility, Safaricom Foundation on Tuesday, 26<sup>th</sup> June, 2018.

The Committee managed to meet all the parties other than the Head of Corporate Responsibility, Safaricom Foundation who failed to attend the meeting of the Committee regarding the compliance with County Government Education requirements on advertisements on the perimeter walls of the said school facilities. Mr. Antonio Odhiambo, Development Control Officer for the Department on Outdoor, Advertising, Signage Control & Regulation represented the Director, Department on Outdoor, advertising, Signage Control & Regulation.



#### 4.0 MEETING WITH THE CHIEF OFFICER FOR EDUCATION, YOUTH AFFAIRS, SPORTS, CULTURE, CHILDREN & SOCIAL SERVICES AND THE HEAD OF CORPORATE RESPONSIBILITY, SAFARICOM FOUNDATION AND THE DIRECTOR, DEPARTMENT ON OUTDOOR, ADVERTISING, SIGNAGE CONTROL & REGULATION

The Committee met the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services together with the Director, Department on Outdoor, advertising, Signage Control & Regulation and the Head of Corporate Responsibility, Safaricom Foundation on Tuesday, 26<sup>th</sup> June, 2018.

The Committee managed to meet all the parties other than the Head of Corporate Responsibility, Safaricom Foundation who failed to attend the meeting of the Committee regarding the compliance with County Government Education requirements on advertisements on the perimeter walls of the said school facilities. Mr. Antonio Odhiambo, Development Control Officer for the Department on Outdoor, Advertising, Signage Control & Regulation represented the Director, Department on Outdoor, advertising, Signage Control & Regulation.

Mr. Odhiambo stated that the Department on Lands, Planning and Housing gives authority for Companies to advertise on Public Premises. He also stated that the procedure for advertisement in the County was as follows:

- i. The respective Company identifies sites they are to claim for branding through the County Chief Valuer;
- ii. The County Chief Valuer seeks approval from the relevant Sector regarding the intended branding i.e In this case the Department on Education, Youth Affairs, Sports, Culture, Children and Social Services;
- iii. The respective Company makes payments to the relevant Department with a list of all the details of sites they are to brand with regard to the rates in the Finance Act, 2017. That Safaricom Foundation made their payments to the said Department.

That all the payments made by the respective Company were received by the Department on Outdoor, advertising, Signage Control & Regulation without sharing with the recipient of the premises to be branded.

The Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services stated that the Department on Education, Youth Affairs, Sports, Culture, Children and Social Services were not informed of the branding of the perimeter walls of the said school facilities by Safaricom Foundation.

That going forward, the Department on Education, Youth Affairs, Sports, Culture, Children and Social Services should be informed of any advertisements on all school walls or anywhere within the proximity of schools as this will assist in vetting purposes of protecting the young minds.



## 5.0 COMMITTEE RECOMMENDATIONS

In view of the findings, the Committee recommends that this Assembly adopts this report of the Sectoral Committee on Children, Early Childhood Education and Vocational Training on its site inspection visit to Juja Road Primary School, Dr. Aggrey Primary School, Muslim Primary School and Cerebral Palsy Unit & Pangani Primary School in Pangani Ward and St Elizabeth Primary School & Star of Hope Primary School in Viwandani Ward as follows:

- i) The County Attorney to establish regulations on Public Private Partnership (PPP) Agreements to guide all sectors in the County. For instance policy structure on how advertisements are to be regulated in school's facilities hence Safaricom Foundation sought approval from the County Department on Outdoor, advertising, signage control and regulation who failed to consult and be approved by the Department on Education, Youth Affairs, Sports, Culture, Children and Social Services
- ii) There is need for regularization on the need formula of benefit sharing between schools with the respective Sector in the County. For instance when payments are made to the respective County Department by a respective Company regarding branding on school facilities, there should be a policy put in place to guide on distribution of the revenue to benefit both the school and the County Executive;
- iii) That the Department on Education, Youth Affairs, Sports, Culture, Children and Social Services should be informed of any advertisements on all school walls or anywhere within the proximity of schools as this will assist in vetting purposes of protecting the young minds;
- iv) The County Department on Planning and Housing should give a seven(7) day notice to the respective private stakeholders to remove the said private sportsgrounds at Pumwani and Dr. Aggrey Primary Schools failure to which the said Department should move with speed to remove the private sports grounds sublet to private stakeholders as the pupils of both schools were not benefitting from the said facilities;
- v) The County Department on Outdoor, advertising, signage control and regulation to give a seven(7) day notice to Safaricom Foundation to remove their advertisements made on the perimeter walls of the said school facilities by painting the walls in monochrome paint, failure to which the said Department should move with speed to remove the said advertisements as Safaricom Foundation did not seek approval from the Department on Education, Youth Affairs, Sports, Culture, Children and Social Services before advertising on the perimeter walls of the said school facilities as required;
- vi) The school Early Childhood Education Development Centers (ECDs) at Muslim Primary School and Cerebral Palsy Unit should be included in the county schools feeding programme;
- vii) That the Early Childhood Education Development Centers (ECDEs) at Juja Road Primary school and Star of Hope Primary School are in a dilapidated state hence the County Government should move with speed to rehabilitate the said ECDEs;

- viii) The County Government should ensure that all school duty houses meant for teachers are occupied by teachers and not private residents. The duty house at Juja Road Primary School meant for the school's head teacher should be occupied by the head teacher and the County Department of Education, Youth Affairs, Sports, Culture, Children and Social Services to table all schools that have staff quarters before the Committee, list of occupants together with their designations and place of work;
- ix) That the County Department on Security, Compliance and Disaster Management to demolish all inappropriate billboards encroaching on road reserves and within the proximity of all school compounds in the County;
- x) The County Department on Security, Compliance and Disaster Management to demolish all illegal structures constructed within the proximity of all County schools including the church constructed at Star of Hope Primary School as the Church Owners did not seek approval from the County Government to construct their premises at the said school;
- xi) The County Department on Water and Sanitation to construct proper sewerage system and sufficient toilets at St. Elizabeth Primary School in order to improve the sewerage system at the school premises; and
- xii) The County Department on Planning and Housing to move with speed to complete the perimeter wall at St. Elizabeth Primary School as lack of fence was posing a security risk to both the Pupils at the said School's ECDE Center and the Primary school.



The Committee met with the chief officer (representing the County Executive Committee Member for Education, Youth Affairs, Sports, Culture, Children and Social Services and other officers from the said sector on Wednesday, 6<sup>th</sup> June, 2018.

**Sector Achievements**

The Ag. Chief officer Ms. Ruth Owuor and the officers from the said sector presented their views regarding the Estimates as follows:

In this Fiscal year 2017/2018, the sector in cognizance with its mandates played crucial key roles towards service delivery as highlighted here below;

- In The approval by the County Executive Committee in December, 2017 on Free-Preprimary Education, on a capitation of Kshs 3,300 per child per year provided the sector an opportunity in ensuring access to education, high enrollment and retention. A total of Kshs 52.9 Million was approved by the Controller of budget and disbursement done to 205 schools.
- The Education sector facilitated the processing of Bursaries. A total of Kshs 3.5 Million is available to each Ward. A further 1000 students in secondary schools are set to benefit from full scholarship.
- The Bursaries Regulation was approved by the Assembly.
- The sector partnered with Good neighbors in construction of Dandora VTC at a cost of Kshs 184Million. The school was opened February 2018.
- Partnered with Book Bunk organization to undertake renovation of Macmillan library including Kaloleni and Eastlands branches at a cost of 117 Million

That due to the high population of the youth job creation is a priority of the county and in this regard the County is investing towards equipping the vocational training centers by equipping the Youth with necessary skills to enable acquire formal and self-employment. In this regard, the sector has allocated Kshs 70 million towards the construction and rehabilitation of Vocational Training Centres.

That the sector intends to accelerate the investment towards the expansion of Early Childhood Development Education. That the County has allocated Kshs 100 million towards the construction of 17 new ECDE centers and rehabilitation of 10 No. existing ECD Centers and provision of didactic materials for ECD Centres. In addition, Ksh. 80 million has been provided for implementation of free ECD Programme. That the Department is also rolling out recruitment of 521 no ECDE teachers to bridge the gap of teacher pupil ratio.



Towards improving the transition and retention rates in education, the eEducation Department has set aside a total of Kshs 270.156 million towards the award of bursaries to the needy and bright students from Nairobi County. The budget is half the total requirement.

Due to the high population of the youth job creation is a priority of the county and in this regard the County is investing towards equipping the vocational training centers by equipping the Youth with necessary skills to enable acquire formal and self-employment. In this regard, the sector has allocated Kshs 70 million towards the construction and rehabilitation of Vocational Training Centres.

AGGREY PRIMARY SCHOOL, MUSLIM PRIMARY SCHOOL & CELEBRAL PALSY UNIT AND PUMWANI PRIMARY SCHOOL REGARDING THE COMPLIANCE WITH COUNTY GOVERNMENT EDUCATION REQUIREMENTS ON ADVERTISEMENTS ON THE PERIMETER WALLS OF SCHOOL FACILITIES AND SUB-LETTING OF SCHOOL PLAYGROUNDS TO ALLEGED PRIVATE STAKEHOLDERS FOR CONSTRUCTION OF PRIVATE SPORTSGROUNDS.**

The Committee met the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services together with the Head teacher of Dr. Aggrey Primary School, Muslim Primary School & Celebral Palsy Unit and Pumwani Primary School in Pangani Ward on Wednesday 6<sup>th</sup> June, 2018 regarding the compliance with County Government Education requirements on advertisements on the perimeter walls of school facilities and Sub-letting of school playgrounds to alleged private stakeholders for construction of private sportsgrounds.



### **3.1 DR. AGGREY PRIMARY SCHOOL**

On whether there was a Public Private Partnership (PPP) Agreement in regard to the said advertisements on the perimeter walls of the said school facilities by Safaricom Limited, the head teacher responded that Safaricom Foundation had not made any agreement with the said school but had painted the school perimeter wall to make it clean and in extension of the perimeter wall at Muslim Primary School and Cerebral Palsy Unit.

On the Sub-letting of the said schools' playgrounds to alleged private stakeholders for construction of private sportsgrounds the head teacher responded that the school had entered into an agreement with Jambo Football Academy in 2015 who constructed a sportsground at the school's playground and the agreement ended in December, 2017.

That currently the sportsgrounds was being used by the pupils of the said school. He further stated that the school had benefitted from Jambo Football Academy such that they had bought 500 desks and chairs for pupils at the said school.

On Measures the County Government had put in place to address compliance with Education requirements on the said issues, the Chief Officer for Education, Youth Affairs, Sports, Culture, Children and Social Services responded that:

- a) The County Department on Outdoor and advertisement would move with speed to remove all the advertisements from the school's perimeter wall; and
- b) The County Department on Planning and Housing should move with speed to remove the private sports grounds sub letted to private stakeholders.

### **3.2 MUSLIM PRIMARY SCHOOL AND CEREBRAL PALSY UNIT**

On whether there was a Public Private Partnership (PPP) Agreement in regard to the said advertisements on the perimeter walls of the said school facilities by Safaricom Limited, the head teacher responded as follows:

That Safaricom Foundation had made a grant agreement with the Board of Management of the said school on 31<sup>st</sup> January, 2017. That the grant amounted to a sum of Ksh. 920, 000 paid in July, 2017 for renovation and fully equipping of a cerebral palsy special unit classroom to assist children living with cerebral palsy and give them therapy sessions. The head teacher submitted the copy of the PPP Agreement to the Committee.

The head teacher further stated that Safaricom Foundation had assisted the pupil who led the school last year by paying for her school fees in secondary school.

### **3.3 PUMWANI PRIMARY SCHOOL**

The head teacher Pumwani Primary school stated that she had been deployed at the school in February, 2018 and had found the perimeter wall painted by Safaricom Limited and the school's playground sublet.

On whether there was a Public Private Partnership (PPP) Agreement in regard to the said advertisements on the perimeter walls of the said school facilities by Safaricom Foundation, the head teacher responded as follows:

That Safaricom Foundation had not made any agreement with the said school but had promised the said school head teacher to renovate it before end of 2018.

On the Sub-letting of the said schools' playgrounds to alleged private stakeholders for construction of private sportsgrounds, the head teacher responded that an agreement was made between the Board of Management of Pumwani Primary School with Khalid Ahmed Mouhamed as the sponsor to construct a temporary pitch at the school's playground which detailed as follows:

- i) The sponsor was willing to pay an annual fee of Kshs 60,000 before commencing on the construction of the Futsal pitch;
- ii) The sponsor would offset the outstanding electricity bill and would continue paying the subsequent bills; He would employ security personnel to enhance the services of the one employed by the secondary wing;
- iii) He would buy the head teacher a laptop and install a printer in the office;
- iv) He would clear the bushes where armed thugs were using as their hideout;
- v) He would erect a high mast to light up the tuition and administrative blocks;
- vi) Upon completion of the structure it would be free for use by the school's children during day time since they would be using it after school hours;
- vii) The school children would be using it on the seven aside game; and
- viii) After it has become operational, Mr. Khalid and the Board of Management members would sit and agree on what would be paid monthly and the modalities.


The head teacher further stated that so far the pupils at the school were not benefitting from the private sportsgrounds.

On Measures the County Government has put in place to address compliance with Education requirements on the said issues, the Chief Officer stated that their Department would liaise with the County Department on Planning and Housing should move with speed to remove the private sports grounds that had been sub-let to private stakeholders.

**MIN. 31/FEB/2018- SITE INSPECTION VISIT TO JUJA ROAD PRIMARY SCHOOL & PANGANI PRIMARY SCHOOL IN PANGANI WARD AND ST ELIZABETH PRIMARY SCHOOL & STAR OF HOPE PRIMARY SCHOOL IN VIWANDANI WARD.**

**Juja Road Primary School**

The Committee made the first visit to Juja Road Primary School where they observed the Early Childhood Education Development Centers (ECDCs) as follows:

- i. The school apartment that was to be occupied by the School's Head teacher had been let to the Nairobi County Executive Committee Member for Health who had in turn sub letted to private residents;
- ii. Incomplete Perimeter Wall at the Early Childhood Education Development Centers (ECDCs);
- iii. The roofs at the Early Childhood Education Development Centers (ECDCs) WAS made of Asbestos;
- iv. The toilet roofs and floor were worn out;
- v. Worn out ceiling boards in the classes;
- vi. Lack of water tanks at the toilet area and the playground;
- vii. Poor drainage at the Early Childhood Education Development Centers (ECDCs); and
- viii. Lack of enough desks, teachers, chairs for pupils at the Early Childhood Education Development Centers (ECDCs).

The Committee recommended that the County should move with speed to:

1. Paint all the Early Childhood Education Development Centers (ECDCs);
2. Fixing of tiles on ECD floors and toilets at the Early Childhood Education Development Centers (ECDCs);
3. Completion of the perimeter wall about 300 meters around the Early Childhood Education Development Centers (ECDCs) area;
4. Purchase of additional 300 new desks and Chairs at the Early Childhood Education Development Centers (ECDCs);
5. Recruit an addition of teachers at the Early Childhood Education Development Centers (ECDCs);
6. Removal of Asbestos with immediate effect as they pose a health risk to humans;
7. Installation of a water tank close to the toilets and at the playground;
8. The apartment meant for the school's headteacher should be occupied by the head teacher; and
9. Replacement of the worn out ceiling Boards in the classes.



### **Dr. Aggrey Primary School**

The Committee made the second visit to Dr. Aggrey Primary School, Pangani Ward where they observed that:

- i) The school's perimeter wall had been advertised on by Safaricom Limited; and
- ii) That initially the school had been allowed by Nairobi County Government to build a mini playground with the understanding that it was to be for the exclusive use of the school. Once it was discovered that the private stakeholders were sub-letting for Ksh. 3000 per hour per head, no further authority was granted.

The Committee recommended that:

- i) The County Department on Outdoor and advertisement should move with speed to remove all the advertisements from the school's perimeter wall; and
- ii) The County Department of Planning and Housing should move with speed to remove the private sports grounds sub letted to private stakeholders.

### **Muslim Primary School and Cerebral Palsy Unit**

The Committee made the third visit to Muslim Primary School and Cerebral Palsy Unit where they observed that:

- i) The school had a total of 393 pupils;
- ii) The school Early Childhood Education Development Centers (ECDCs) was not included in the county schools feeding programme;
- iii) The school's head teacher had allowed Safaricom Limited to advertise on the school's perimeter wall because Safaricom Limited had sponsored a great project in Cerebral Palsy special unit at the school;

The Committee recommended that:

- iii) The County Department on Outdoor and advertisement should move with speed to remove all the advertisements from the school's perimeter wall;
- iv) The school Early Childhood Education Development Centers (ECDCs) should be included in the county schools feeding programme; and
- v) The County Department on Planning and Housing should move with speed to remove the private sports grounds sub letted to private stakeholders.

### **Pumwani Primary School**

The Committee made the third visit to Pumwani Primary School where they observed that:

- i) The school's management had allowed private stakeholders to construct a private sports grounds at the school's playground hence were sub-letting for Ksh. 4000 per hour per head to the muslim Community living in Eastleigh;and
- ii) The school's perimeter wall had been advertised on by Safaricom Limited; and

The Committee recommended that:

- i) The County Department on Outdoor and advertisement should move with speed to remove all the advertisements from the school's perimeter wall; and
- ii) The County Department on Planning and Housing should move with speed to remove the private sports grounds sub letted to private stakeholders.

#### **St. Elizabeth Primary School, Lunga Lunga in Viwandani Ward**

The Committee made the fifth visit to St. Elizabeth Primary School, Lunga Lunga in Viwandani Ward where they observed the Early Childhood Education Development Centers (ECDs) as follows:

- i) The school had a total of 200 pupils;
- ii) The school Early Childhood Education Development Centers (ECDs) was included in the county schools feeding programme; and
- iii) Poor drainage at the school i.e Leakage of raw sewer at the premises;
- iv) Incomplete Perimeter; and
- v) Insufficient water tanks at the toilet area and the playground.

The Committee recommended that the County should move with speed to:

- i) Complete of the perimeter wall about 200 meters around the school;
- ii) Installation of water tanks close to the toilets and at the playground;

#### **Star of Hope Primary school, Lunga Lunga in Viwandani Ward**

The Committee made the sixth visit to Star of Hope Primary school, Lunga Lunga in Viwandani Ward where they observed as follows:

- i. The roofs at the Early Childhood Education Development Centers (ECDs) was in a deplorable state;
- ii. The toilet roofs and floor were worn out;
- iii. Worn out ceiling boards in the classes;
- iv. Lack of water tanks at the toilet area and the playground;
- v. Poor drainage at the Early Childhood Education Development Centers (ECDs); and
- vi. Lack of enough desks, teachers, chairs for pupils at the Early Childhood Education Development Centers (ECDs).

The Committee recommended that the County should move with speed to:

- i) Paint all the premises at the school;
- ii) Fixing of tiles on ECD floors and toilets at the Early Childhood Education Development Centers (ECDs);




- iii) Completion of the perimeter wall about 300 meters around the Early Childhood Education Development Centers (ECDCs) area;
- iv) Purchase of additional 300 new desks and Chairs at the Early Childhood Education Development Centers (ECDCs);
- v) Recruit an addition of teachers at the Early Childhood Education Development Centers (ECDCs);
- vi) Removal of Asbestos with immediate effect as they pose a health risk to humans;
- vii) Installation of a water tank close to the toilets and at the playground;
- viii) The apartment meant for the school's headteacher should be occupied by the head teacher; and
- ix) Replacement of the worn out ceiling Boards in the classes.
