1.0 PREFACE

Mr. Speaker Sir, on behalf of the Members of the Sectoral Committee on Health Services, it is my pleasure and priviledge to present to the Assembly, the Committee's Eighteenth Report on inspection site visit to Special Treatment Clinic (Casino) on 14th April 2015.

2.0 BACKGROUND

Special Treatment Clinic is situated in Starehe district, off River Road behind Kampala Coaches Limited offices.

It is a level 1 facility as per KEPH levels offering ART, PMTCT, PEP and laboratory services.

The Health Services Committee resolved to visit the Special Treatment Clinic (Casino) to inquire into the true state of affairs at the facility following a complaint by a Member of the Committee that a parking lot belonging to the facility had been grabbed by a private developer. The visit was thus conducted on 14th April 2015.

2.1 Committee Mandate

Mr. Speaker Sir, the Committee on Health Services is one of the Sectoral Committees established under Standing Order No. 191 (5) which provides that, the functions of a Sectoral Committee shall be to:-

- Investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned departments;
- Study the programme and policy objectives of departments and the effectiveness of the implementation;
- Study and review all county legislation referred to it;
- Study, assess and analyze the relative success of the departments as measured by the results obtained as compared with their stated objectives;
- Investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly;
- To vet and report on all appointments where the constitution or any law requires the County Assembly to approve, except those under Standing Order 185 (Committee on Appointments); and
- Make reports and recommendations to the County Assembly as often as possible, including recommendations of proposed legislation.
- Mandate: All matters related to county health services, including, in particular County health facilities and pharmacies, ambulance services, promotion of primary health care, licensing and control of undertakings that sell food to the

public, veterinary services (excluding regulation of the profession), cemeteries, funeral parlours and crematoria.

3.0 INSPECTION OF SPECIAL TREATMENT CLINIC (CASINO)

The Committee visited Special Treatment Clinic (Casino) on 14th April 2015 at 11.00 am and was accompanied by a team from the County Health Services department.

The Committee was received by the Health Centre Management team as well as staff from the County Health Sector .The delegation proceeded into a room where a meeting was held and several issues were discussed and noted.

After deliberations in the meeting the Committee was taken on a tour of the facility.

The observations and challenges noted by the Committee are highlighted in this report.

4.0 SUBMISSIONS BY THE FACILITY MANAGEMENT

- Facility In charge-(Annah Mwangi -Nurse)
- a. Services offered
 - -She informed the delegation that the facility amongst others offers;
 - i. Free outpatient services;
 - ii. Skin specialist services;
 - iii. HIV prevention and care services;
 - iv. Laboratory services; and
 - v. Food handling certificate services but this function has since been transferred of the function by the County government and handed over to KEMRI.

b. Challenges faced

- i. The health centre is understaffed. It has;-
 - No Doctors:
 - 4 clinical officers:
 - 9 nurses:
 - 2 lab technicians;
 - 1 HTC (HIV testing and Counselling)counsellor;
 - 1 assistant in clinic; and
 - Few support staff who are about to retire. Most were absorbed into the parking department by the County.

- ii. The supply of medicine is not consistently forthcoming as they have gone for two quarters without supplies, however three weeks ago they received their last supply from KEMSA.
- iii. The security provided is inadequate.
- iv. The underground parking lot at the back of the facility was grabbed in 2013 September by a private developer but has since been repossessed by the County. It is proposed that it should be converted into a VCT centre.
- v. A Health Sector Services Fund (HSSF) quarterly component of Ksh 112,000 (from DANIDA) is always remitted to the County but the monies never reach the facility to aid its daily operations. HSSF composes of;
 - DANIDA-Ksh 112,000
 - Maternity reimbursement
 - Revenue allocation criteria based on workload (RACC)
- vi. Staff do not get appraisals. They have stagnated in one job group for periods longer than is required by the employment regulations (i.e 10 years for some).3 years is the maximum recommended period before an employee is elevated.
- vii. There is lack of motivation amongst staff as salaries of devolved staff from Ministry of Health and those of the County carrying out the same duties have major disparities. They need to be harmonized.
- viii. The devolved staff from the Ministry do not have medical covers whilst County staff are covered by AAR insurance, although the AAR offers them access to only Guru Nanak hospital, Nairobi west hospital and Nairobi Women's hospital.
 - ix. The monies issued for acquiring lab reagents is quite low i.e Ksh 30,000-40,000 quarterly. This amount is usually exhausted within a week in some instances. KEMSA should include supply of lab reagents in its list.

5.0 RECOMMENDATIONS

Mr. Speaker following the visit, the Committee urges this Assembly to resolve as follows:

- Supply of drugs including laboratory supplies to the facility be resolved immediately and future supplies to all other County Health facilities be processed and delivered on time:
- The County to procure laboratory reagents from KEMSA to have the laboratory remain constantly stocked or increase the amounts allocated for this function from Ksh 40,000 upwards;
- 3) The County Health sector to deploy additional staff to curb the shortage of staff so as to improve on health service delivery to the citizens of Nairobi County as hereby proposed;
 - a) Clinical officers;
 - b) Laboratory technicians;
 - c) Support staff;
 - d) Registration clerks;
 - e) Nurses;
 - f) HTC Counsellors; and
 - g) Nutritionists and psychological counsellors for the Sub County.
- 4) The County to repossess the grabbed underground parking lot and consider converting it into the proposed VCT centre;
- 5) The water shortage issue be addressed by the County by identifying the source at which the water piping has been tapped and rectify it as well as bring to book the culprits;
- 6) The entire facility be refurbished to give it a new look and enough security be provided;
- 7) The solid waste management challenge be addressed by constructing an incinerator within Starehe Sub County;
- 8) The County to ensure that the HSSF quarterly component of Ksh 112,000 from DANIDA is remitted on time from now henceforth to the centre;
- 9) The County Health Sector to start appraising employees who have served in the sector for long in one job group, harmonize salaries of the staff who were absorbed from the Ministry during transition with those from the defunct City Council and ensure all of them are enrolled in a favourable medical cover scheme;
- 10) All obsolete items be audited for disposal to allow the building to be used in other day to day operations of the facility; and
- 11) The Sub County Health Management team be provided with;-

- viii. There is no incinerator. A proposal is that one should be established at Ngara to serve Starehe Sub County.
