1.0 PREFACE

Mr. Speaker Sir, on behalf of the Members of the Sectoral Committee on Health Services, it is my pleasure and duty to present to the Assembly, the Committee's Nineteenth Report on inspection site visit to Mowlem Health Centre on 14th April 2015.

2.0 BACKGROUND

Mowlem Health Centre is situated 19km from Nairobi CBD off Kangundo Road in Embakasi West Sub County.

The Health Services Committee resolved to visit the Mowlem Health Centre to inquire into the true state of affairs at the facility following a concern by a Member of the Assembly that the facility was not equipped an was in dire need of infrastructural development. The visit was thus conducted on 14th April 2015.

2.1 Committee Mandate

Mr. Speaker Sir, the Committee on Health Services is one of the Sectoral Committees established under Standing Order No. 191 (5) which provides that, the functions of a Sectoral Committee shall be to:-

- Investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned departments;
- Study the programme and policy objectives of departments and the effectiveness of the implementation;
- Study and review all county legislation referred to it;
- Study, assess and analyze the relative success of the departments as measured by the results obtained as compared with their stated objectives;
- Investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly;
- To vet and report on all appointments where the Constitution or any law requires the County Assembly to approve, except those under Standing Order 185 (Committee on Appointments); and
- Make reports and recommendations to the County Assembly as often as possible, including recommendations of proposed legislation.
- Mandate: All matters related to county health services, including, in particular
 County health facilities and pharmacies, ambulance services, promotion of
 primary health care, licensing and control of undertakings that sell food to the
 public, veterinary services (excluding regulation of the profession), cemeteries,
 funeral parlours and crematoria.

3.0 INSPECTION OF MOWLEM HEALTH CENTRE

The Committee visited Mowlem Health Centre on the afternoon of 14th April 2015 and was accompanied by a team from the County Health Services department.

The Committee was received by the by the facility's management team as well as staff from the County health sector and the area Ward Representative .The delegation proceeded to an outdoor meeting where several issues were discussed and noted.

After deliberations in the meeting the Committee was taken on a tour of the facility which is made up of iron sheet structures.

The observations and challenges noted by the Committee are highlighted in this report.

4.0 COMMITTEE OBSERVATIONS

The Committee observed several issues as noted below.

- In the meeting observations were drawn to the attention of the Committee by the following participants;-

1. Facility In charge

Brief of the facility

- i. The facility started as an initiative of the Community and was handed over to the County Government to run;
- The land where it sits initially belonged to Kenya power & Lighting Company who later donated it to the Community. It now officially belongs to the County;
- iii. The infrastructure comprises of an iron sheet structure that is further subdivided using iron sheets into three rooms that are used to offer services to patients. There is also a store made of iron sheets and a toilet block made of concrete within the compound;
- iv. The facility has only two staff (two nurses) who reported to work on the previous day i.e 14th April, 2015;
- v. Inside the facility, it has;

 - o Table;
 - o Sink:
 - Vaccine carrier;
 - A small domestic fridge;

- vi. The next nearest facility to Mowlem is the Kariobangi South Health Centre.



ii. There is an urgent need to construct a strong and permanent structure financed by the County Government as the one in place is limited in space and quite insecure for housing equipment and supplies.


5.0 RECOMMENDATIONS

Mr. Speaker following the visit, the Committee urges this Assembly to resolve as follows;


- Supply of drugs, laboratory supplies and working equipment listed above be provided to Mowlem Health facility as a priority to kick-start efficient and sufficient provision of medical services to the residents of Mowlem;
- The County Government to allocate funds for construction of permanent structures that will improve provision of services and enhance security to the facility's equipment; and
- 3) The County Health sector to deploy additional staff to curb the shortage of staff so as to improve on health service delivery.
- 4) The County Health Sector to urgently conduct an audit of all County Health facilities, including the physical location, staffing levels of all cadres and adequacy of physical infrastructure.




HSC Members listen to the Chair of Mowlem ward on history of the facility. (Note the iron sheet structure on far left)




