## **COMMUNICATION FROM THE CHAIR**

**Hon. Speaker:** Once again good afternoon Hon. Members I have the following communication to make.

# CAPACITY ASSESSMENT AND RATIONALIZATION OF THE PUBLIC SERVICE BIOMETRIC DATA CAPTURE FOR MEMBERS OF THE COUNTY ASSEMBLY.

Hon. Members as you are aware the National Government recently launched the capacity assessment and rationalization of the Public Service through the Biometric data capture verification in all Counties in order to capture details of state officers and public servants in their respective work stations, all public servants and state officers are required to present themselves at identification centers to ensure their data is captured through the Biometric registration exercise.

Failure to participate in this exercise would occasion the loss of earnings for persons whose detail will not have been captured, Hon. Members you are therefore requested to kindly present yourself for the said head count on Thursday 30th October 2014 at the former Mara restaurant next to the Assembly charter Hall, the exercise will commence at 8:00 am and terminate at 5:00 Pm. Hon. Members bring with you your original National identification Card, pay slips for the month of September and October, Birth Certificates, Original Education Certificate.-- Order Hon. Thuo. Duly filled Biometric data capture form, you are advised accordingly.

Pursuant to section 5 2 (D) of the Ward development Act 2014 the County public Service Board has recruited and nominated the following 4 persons to the management fund Committee, The names are;

Hon. Speaker: Hon. Adow:

**Hon. Osman Adow:** thank you Mr. Speaker, pursuant to standing Order 180 section 6 I beg to lay the following Paper on the Table of the Assembly today Wednesday 29<sup>th</sup> October, 2014. Report of the Budget and Appropriation Committee Workshop, on the County Integrated Development Plan 2013/2017. Thank you.

Hon. Speaker: Thank you very much Hon. Adow

Hon. Speaker: Yes please Hon. James Chege

Hon. James Chege: Thank you Mr. Speaker I rise on point of Order number 49 B, am only requesting that if we would adjourn the House to discuss the serious matter of a Motion that was brought here sometime last week and it also generated a lot of heat and has also been a matter of concern within the House business Committee and I was just proposing that it would be important for Members to be able to ventilate in an adjournment Motion so that we can discuss deeper on the way forward with regards to the Loan that has been requested for, standing Order number 49 2 (B). Thank you very much Mr. Speaker.

Hon. Speaker: Hon. Chege, I am guided that the following motion may be moved without notice, motion by way of amendment to a question already proposed from the Chair, motion for adjournment of the County Assembly or of a debate of a Motion and that Motion has not been tabled in the House. It awaits the House Business Committee. And I would suggest that the House Business Committee meets tomorrow at 10 o'clock to finalize the meeting, the date of the question that you have just asked. But you see, it is not tabled as a motion. That is the problem we have now. But tomorrow, at 10 o'clock, failure to a meeting of the House Business Committee, then you can raise it tomorrow at 2.30 p.m.

Hon. Chege, again, adjournment on definite matters of urgent County importance. You didn't give us a notice for adjournment in time. So I think, let us just be fair. I thank you. Hon. Thuo.

**Hon. Stephen Thuo:** Thank you Hon. Speaker. I salute you this afternoon. This is a House of tradition, rules and Standing Orders. You also have a lot from other jurisdictions like Parliament and other Common Wealth Parliaments. There is another item called precedence and I am very keen in noting the various precedence that we have made as a house. We have debated such a motion before, not once not twice. So, I would want to know the position of precedence as far as this particular Motion is concerned as part of our traditions and rules of this House.

**Hon. Speaker:** Hon. Thuo, my problem is that the Motion has not been brought to the House. That is the problem that I have. I have no problem with precedent. Hon. Hassan.

Hon. Abdi Hassan (Leader of Minority): Mr. Speaker Sir, I still insist on precedence because even the other day, on Thursday, what happened in this House was out of order and the Chair allowed it to go

on. If my memory serves me well, on Wednesday, you ordered that the Motion which seeks to approve the loan for this County be subjected to the Budget Committee and be brought to this House yesterday, Tuesday.

The same Motion was on Thursday sneaked as a Supplementary Order Paper which the Chair allowed to go on and I didn't see the Clerk give an advice on the same because what was done was illegal. The Motion did pass through the House Business Committee. You ruled that that Motion should be placed on Order Paper on Tuesday. The same ruling should stand and I didn't hear you overrule the earlier ruling which you made on Wednesday. Mr. Speaker Sir, any citizen can now move to court based on your ruling and that could put this county in a litigation spree. Mr. Speaker Sir, that is a very urgent matter. It is a concern to Nairobians because this House represents the will of Nairobians as article 1 of the Constitution entails. Mr. Speaker Sir, kindly with your guidance, allow this adjournment Motion to take place.

**Hon. Speaker**: Hon. Hassan, I agree with what you are saying but again the same Motion that you have tabled is before the House Business Committee and therefore, I will wait for the dispensation of that by the House Business Committee.

Hon. Abdi Hassan: Mr. Speaker Sir, as things are going on, I don't think this House can continue on a very unprocedural and unconstitutional way if you are going to do things the way we are doing. Mr. Speaker, as you are aware, because you are the Chairman of the House Business Committee, the House Business Committee yesterday adjourned. We didn't agree on any business of the day because the Clerk did not give proper advice. I brought a Motion, not as an MCA of Matopeni Spring Valley, I brought a Motion as Minority Leader, as a Party sponsored Motion.

Mr. Speaker Sir, under your chairmanship on the House Business Committee, the Motion was not put on Order Paper as our Standing Order entails. With your permission, can I read Standing Order number 44(5)? "Unless the County Assembly resolves otherwise, a Motion sponsored by a Party shall have precedence over all other Motions." Mr. Speaker Sir, if we disregard the Constitution of Kenya, if we disregard an Act of Parliament which has been enacted by the National Assembly, and if we disregard our own Standing Order, where does this Assembly head? This is a new Assembly and we should not set ourselves into a hole. We will set a very bad precedence and will go into history. If you can lend me your ear, Mr. Speaker.

Hon. Speaker: Order Hon. Thuo. Continue Hon. Minority Leader.

**Hon. Abdi Hassan:** Mr. Speaker Sir, we don't want to go into the history book as an Assembly which went the Kisia way. As we are speaking, the 5 billion loan which was taken by the defunct Council and by then I was a Member of that Council, and if you go through the minutes, I was not among the people who approved the 5 billion loan. Up to now, we are still paying the interest rates of the 5 billion loan.

You were one of the members of that Council and I want to give you the credit since you refused to engage yourself in those matters. But it is strange enough, Mr. Speaker Sir, while you chair the session, you allowed the same thing you refused 4 years ago to happen this time around.

Mr. Speaker Sir, I don't want my grandchildren to be paying the County of Nairobi loan which was put to them by this Assembly. As you are aware, this County has not finished paying the 3.8 interest rate which was imposed on us by the Equity Bank. We have not even started paying the loan. That is a very serious matter. Now, we are borrowing another 4 whooping billion. That is a very serious matter. Mr. Speaker Sir, as we are speaking, the Finance Act which we legislated on 2013/2014, we doubled, everything in this County. But as you are speaking, no revenue is increasing. We are asking ourselves: where are these revues going? Where is it ending? Is it ending in people's pockets? Because as we are speaking, by the time we were in the Council, the parking was 140 shillings. As we are speaking, the parking is 300 shillings. Where is this money going to?

Hon Speaker: OK correct, the other point is Hon. Leader of Minority. Hold on, I will give you to talk, today is a cool day, what we need to do is Hon Leader of Majority to take his papers for the Chief Whip to (interruptions) hold on, hold. We are talking about the Party sponsored Motion.

Leader of Minority: Mr. Speaker Sir the Standing Order says a Member but the motion was brought by me, the Minority Leader

Hon Speaker: Thank you for your cooperation, order! Now we will go this way, this is the way we will go. A Motion sponsored by a Party shall have precedent over all other motions on such day as the County Assembly Business Committee in consultation with the Speaker may determine. Hon Members but where a Party has sponsored a two or more Motions, the Motions shall be considered on such Order as a sponsoring Party may determine. We will go on 44, 45(a) Motions sponsored by a Party shall with precedence over all other Motions on such day as the County Assembly Business Committee with consultations with the Speaker may determine, therefore it comes to my earlier sentiment that tomorrow ten O'clock the House Business Committee meet in my office then in consultations with the Speaker I will for sure have on the Order Paper as the first item and that is the way we should go.

Leader of Minority: Mr. Speaker Sir can I take it now the good Chair has ruled that the Motion is a Party sponsored Motion and it will take precedence over any other Motion tomorrow, can I take it that way?

Hon Speaker: After our meeting with the House Business Committee tomorrow in my office at ten O'clock it shall be done

**Leader of Minority**: Mr. Speaker Sir I think the issue will be handled with all fairness...

Hon Speaker: Order, Hon Leader of Minority, order I think that is the fairest I can go, honestly it is (interruptions), Hon Members of the House Business Committee I do not think I can swallow my word, ten O'clock in my office and deliberation is Party sponsored Motion, period.

**Leader of Minority**: All the clarity we need Mr. Speaker is we have an understanding that for a Party to sponsor a Motion we don't not need the House Business Committee to tell us that this is a Party sponsored Motion. What we need is that the Party brings the Motion that is supported by the Party and if we meet tomorrow, we need to know and agree that motion A is a Party sponsored Motion Mr. Speaker.

**Hon Speaker**: We have agreed it is a Party sponsored Motion

(Applause)

The letter signed by A. Hassan is signed as Leader of Minority Party in the County Assembly of Nairobi, that has no problem with anybody but what I would say is we meet tomorrow and consult then are done. I thank you very much. Next Order.

**Hon. Leader of Minority**: Mr. Speaker Sir, before I register my thanks to you, I think you are bringing two paths. The way I am reading the Standing Order, it is very clear that the House Business Committee does not have mandate, has no authority to determine which Motion is a Party sponsored Motion and which one is not. We are on this floor say "I want the Hansard to capture me very clearly" as the party leader of Jubilee in this Assembly, I am stating here very clearly that, that Motion is a Party sponsored Motion. Let it go to the record Mr. Speaker Sir.

**Hon. Speaker:** Very well Hon. I Hassan. That one, we have agreed as a House that, that is a Party sponsored Motion and this is not new, but we have decided or we will go as per 44 (5) (a) and we are done and will be home. Next Order!

#### **STATEMENTS**

**Hon. Speaker:** We are on Statements now unless you are on a Statement. On what, my brother?

Hon. Member for Kahawa West Ward, (Mr. Chege Ngaruiya): Thank you Mr. Speaker. I rise on a Point of Order number 31 meaning that, Mr. Speaker since you have stated very clearly that this particular Motion takes precedence, I also believe that it can apply because it is an important issue which is very urgent to this House and also to the Nairobians. I think it should be tabled now and we debate it.

**Hon. Speaker:** No! No! Let us not go to that way please. We have finalized and you are out of Order please.

(Laughter)

**Hon. Minority Leader**: Mr. Speaker Sir, I have a Statement in my capacity as the Minority Leader. Today is a very sad day because as you look on my right side, you do not the Majority side in this House. They have boycotted the House to attend to a private matter. That is a very serious matter and I am asking the former Prime Minister...

Hon. Speaker: Order Hon. Isaac Hassan! Order my brother!

(Loud consultations)

Hon. Speaker: Order! Very well

**Hon. Minority Leader**: I have withdrawn that Mr. Speaker Sir.

Hon. Speaker: Thank you.

Hon. Minority Leader: Mr. Speaker Sir, we want the Hon. Members from Cord side and our senior citizen to respect this House. They have been voted and nominated to come and represent Nairobians in this House Mr. Speaker Sir. They have abandoned the Nairobians when they are needed most. As we are speaking now, two to three months to come, Nairobians will feel the burden of what we had done last week and all of that is because my brothers who are the majority are not in this House.

The business of the House must be taken seriously and as the Speaker of this Assembly, you must enforce rules of this House. If today any Member of Cord gets a signature showing that on this day they were in Assembly, we are going to take some people to court because these people have boycotted the House. As we are speaking, they are having lunch with their very senior good citizen of this Country, discussing private matters, which do not benefit Nairobians at all and I think maybe they are planning to come cause turmoil in this House and we know they are good at that.

Hon. Speaker: Very well. Order Hon. I Hassan!

**Hon. Minority Leader:** Mr. Speaker Sir, give me time to finish what I am saying, I think I have some more minutes. With your discretion and your permission, Nairobians are crying as we are speaking, since they are not getting any service delivery from this County.

As we are speaking, the high court of Kenya has jailed the Secretary of this County. Reason, they went to court, took commitment, told the court that they will pay certain amount of money to lawyers and they did not fulfilled their part of bargain. I am not dwelling on the matters of court Mr. Speaker Sir, but it shows that, this County is completely grounded to its knees. If a high ranking officer can be arrested because of twenty million, where is this County heading? I think we are doomed.

A few years ago, when you could go around Nairobi at night, the whole of Nairobi was bright, as we are speaking today, Nairobi is in total darkness like this House.

Mr. Speaker Sir, Nairobi should be a role model to the other 47 Counties, in terms of Assembly matters and in terms of executing matters but I think we are now can be ranked 47<sup>th</sup> out of 47 Counties in terms of legislation, because the leadership of the Assembly have failed since we are doing nothing.

I cannot sit with you and wait for 2017 to shown the door. Mr. Speaker Sir I am still young, since I am only 31 years of age and I am not ready to go home because I have a boy who is five years old and a girl who is two and half years old and I love them very much. The way things are going in this House it means that I will be given my retirement by 2017 by my electorates. I refuse to go home and from now on, we will put the leadership of this Assembly, and the executive on spot until the Nairobians get service delivery.

Mr. Speaker, it is a shame, a County like Machakos, our neighbor here, are thriving while a big County like Nairobi which collects more than thirty million per day, cannot even pay salaries to its staffs. When you reach a standard of asking for loan so that you can pay staffs salary, then we are doomed, then this County has no business being there.

We can even ask the National Government to dissolve this County so that we can go back to the electorate and tell them, we have failed you. It is because of the Majority side of this House that has failed Nairobians and not us. Let me give a good example, in National Assembly, the Committee which is being chaired by the Majority side which is Jubilee side are very active. Mr. Speaker Sir, if my memory serves well, the transaction between the safaricom and the National Security was stopped by the Committee of the National Security so that it can be scrutinized and be given a clean Bill. What are we doing in this County? We are sleeping. We are doing nothing.

The Chairperson of the Sectorial Committee has failed Nairobians in this Assembly, and it is high time they know that they have totally failed. As much as I don't like to dwell on the Majority side, I think the sycophancy and the dictatorial tendency of the Majority side has made this Assembly to go to its knees. We need this House to be democratic. As you were aware, the Jubilee side, there are times that I support a Bill and my members here oppose it and also their leader has a reason for supporting it. This is democracy at its best.

Mr. Speaker Sir, we want you to reign on the Chairpersons of these Committees so that they have to work or they ship out. A few weeks to come if this House does not change, we are going to go the Kibwana way. We are going to tell Nairobians to take signatures; so that they can take all of us home, we go back to them and ask for signatures because we are not going to stay like this for the next five years. Mr. Speaker Sir, I think I have another five minutes if you may allow me.

Hon. Speaker: Your time is up. Order Hon. Thuo!

Hon. Leader of Minority: Mr. Speaker Sir, as we are talking now more than ten hawkers have lapsed---

Hon. Speaker: Order!

**Hon. Leader of Minority:** Mr. Speaker Sir, Kenyans are crying because of lack of opportunity to get jobs. When a young man decides to hawk, why do you have to stab such a young man.

Hon. Leader of Minority: To stab to death. Mr. Speaker I don't know if it is profiling, I am not sure about that, I can't say fully about that but those who have died come from one community.... The information we are having, the Officer in charge of this County's Security, is that they are targeting hawkers from specific communities. That is a very serious matter which should be urgently addressed by this County. If they don't stop, we are going to paralyze the operations of Nairobi because as the Jubilee fraternity of this County, we are going to tell our people, come out there we are being killed, we are tired, come out of the streets and we can even tell people even not to pay rates until this County government comes to its senses. With these few remarks, I beg to sit down.

Hon. Speaker: Order Members! Thank you very much Hon. Abdi Hassan. There is only one thing that you forgot; the leadership of this House does not pass that which has been passed by this Assembly. You can only condemn us because may be you don't like us and I can tell for sure that he leadership of this Assembly, we do not implement the tools that we have given to the County government in form of Bills. Therefore, the County Assembly has no problem amongst themselves all I can say is only hatred. You pass Bills here--- Somebody here is deep asleep.

Hon. Members, I am just correcting the Leader of the Minority that the Speaker, the Leader of Majority and the Leader of Minority, we do not follow up, it is the work of the Implementation Committee and the Chairpersons to follow up. I think we have given tools of trade to the County government in form of Bills. It is therefore unfair to condemn the leadership of the Assembly unless you don't like somebody's face. Next order please.

Request for statements? I can't understand why you are not orderly on the other days. Hon. Members, Hon. Pius Mbono.

Hon. Member for Zimmerman Ward (Mr. Pius Mbono): Thank you Mr. Speaker. Pursuant to Standing Order 41 (2) (c) I wish to request for a Statement from the Chairperson for the Sectoral Committee on Transport and Public Works regarding the lighting of high masts in Zimmerman Ward. Hon Speaker, the residents of Zimmerman have been in darkness for the last five months due to the failures...but nothing tangible has been done. Mr. Speaker, what is disturbing me most is that---

**Hon. Speaker**: Order, is the Hon. Member well? Are you well Hon.--- That was a very strong sound that came from you. You are a good citizen.

**Hon. Pius Mbono:** Mr. Speaker, do I continue? What is disturbing me most is that there is a lot of mugging and thuggery in Zimmerman and the electricians cannot even replace the worn out bulbs because

the report that we are getting is that he bulbs are out of stock, for the last five months the bulb are out of stock. We are also understand that the tendering—

Hon. Speaker: Order! Hon. Pius I think you want this Statement

Let me go on Mr. Speaker. In the Statement the Chairperson should inquire into and report on:-

- 1. Whether the high masts will be repaired and when;
- 2. The measures being undertaken by the County government to ensure that all the high masts in the County are repaired.

Thank you, Mr. Speaker.

Hon. Speaker: Chairperson for Transport and Public Works

**Hon. Member for Kasarani Ward** (Mr. Martin Waweru): We I will give the response on Wednesday 13<sup>th</sup> October 2014.

Hon. Speaker: Very well and you are very smart. Next order, Hon. Mugo.

Hon. Member for Eastleigh Airbase Ward (Mr. Martin Mugo Kanyi): Thank you Mr. Speaker---.

**Hon. Speaker**: You are not properly dressed.

Hon. Martin Mugo Kanyi: Mr. Speaker you can see that I am very popular. I will like...pursuant to Standing Order 41 (2) (c) committee for a Statement regarding chicken meat in Nairobi County

- 1. The existence
- 2. Names of germs that have been identified
- 3. Measures being employed by the County...against eating contaminated meat.

Mr. Speaker the Committee wrote to the County Executive Committee Member for Health and the Chief Officer Health Services. Further, the Agriculture Chief Officer delivered a written response to the Committee on letter dated 23<sup>rd</sup> October 2014. In this regard, I wish to report to the Assembly that the Health Service requests to be given 30 days to come up with a comprehensive report as they need to collect samples for testing for the 17 Sub-Counties. However, they have currently instituted the following actions:

- 1. Immediate action The Sub-County Public Officer has been inducted to undertake inspection of butcheries, chicken slaughter house in Kariokor. They should give a report of the findings on 30<sup>th</sup> October 2014.
- 2. Immediate action 100 samples to be collected from chicken vending outlets and the slaughter house in Kariokor for testing at the National Public Health laboratories.

I therefore urge this Assembly to wait for comprehensive report from the County Health Services Department within 30 days. I beg to lay the Statement. Thank you.

Hon. Speaker: Thank you very much. Hon. Mugo

Hon. Member for Airbase (Mr. Martin Mugo): Thank you.

Hon. Speaker: Hon. Kamweru.

Nominated Hon. Member (Mr. Rachel Kamweru): Mr. Speaker, I had been here in the House before.

**Hon. Speaker:** Order! Hon. Adow needs to interrogate his statements.

Hon. Member for Eastleigh North (Mr. Osman Adow Ibrahim): Thank you Mr. Speaker. I can now see action is being taken but I would like to point out the fact that Majority Leader has been saying people are really sleeping on their job. I don't understand how the people from Health Department so long to take samples and test for contamination of chicken meat and waited until a Statement was came from this House.

Once the Kenya Medical Research Institute (KEMRI) came up with the report, they should have taken that action immediately and even probably close down all the chicken outlets until such a time they find out that it was okay for the residents of Nairobi to consume such meat. Therefore we must put the officers on notice so that it should not take them statements from this House to do their work. They should do their work day in day out without being pushed. They said it will take 30 days to do their sampling and bring out a report.

**Hon. Member for Dandora Area II** (Mr. Stephen Kambi ): Thank you Mr. Speaker Sir for this opportunity, I am very much humbled.

Hon. Speaker: Order!

(Loud consultations)

Hon. Speaker: Next Order. Hon. Kamweru!

Hon. Rachel Kamweru: Thank you Mr. Speaker. Three weeks ago, I stood here on a personal Statement No. 80 on ICT formation and on gender inequalities in the House. If you go to online statement tracker, personal Statement No. 80 is never tracked. At times, to get a response to know what is happening becomes difficult. What actions the Clerk's office is going to take so that personal Statements are tracked? At least one would like to track what they have been asking. I am very concerned, whether it is 41 or whatever they track, personal Statements are not tracked. If they cannot be put online, let them

show that this personal Statement was asked and I see as an oversight for the people capturing. This has to be redone.

I am also concerned that the Select Committee has not sat to review the ICT which is the backbone of this County; it does not take education or justice to check what ICT is doing. Money is collected, as we are communication, through ICT. What have we done? Are we sleeping on our job or there is no oversight of the ICT? I am concerned because I am really interested on this. We wouldn't be borrowing money if we had a better tracking system of the ICT. We should be having media policies in this House. Maybe in the leadership, somebody somewhere knows if the ICT Committee is formed, things are going to be unleashed. We need an answer and I am very clear about this tracking. We need to be told how personal Statement No. 80 will be tracked online. Thank you, Mr. Speaker.

# THE NAIROBI CITY COUNTY SOLID WASTE MANAGEMENT BILL, 2014 (ASSEMBLY BILL NO. 11 OF 2014)

An Act of County Assembly of Nairobi City to make provisions for the management of solid waste in the County and co-related matters.

(First reading)

Hon. Speaker: Order Hon. G. Maina. Yes Hon. Karen.

**Nominated Hon. Member** (Hon. Karen Wanjiku): Thank you, Mr. Speaker Sir, I have a concern about the Order Paper. According to Standing Order No. 35(2), the Order Paper shall be published in the County Assembly website and shall be made available to Members at least 12 hours before the County Assembly meets.

**Hon. Karen Wanjiku:** Mr. Speaker Sir, I have not finished. It was not in the website and it did not pass through the House Business Committee, so it is illegal.

**Hon. Speaker:** Order Hon. Karen. This was ongoing and therefore why it delayed before you were notified is because of delay on the House Business Committee. There are several Motions that are online but we have not yet done the ICT. So through the ICT we will be able to follow them. This Bill goes to the Committee of Environment and Natural Resources.

Hon. Member for California Ward (Mr. Athaman Kamau): Mr. Speaker Sir---

Hon. Speaker: Order! What do you want to inform the Hon. Member?

Hon. Athaman Kamau: I want to inform the Member that...

Hon. Speaker: Which Member?

Hon. Athaman Kamau: The Minority Leader.

Hon. Speaker: Call him by his official names.

**Hon. Athaman Kamau:** The leader of Jubilee coalition in this Assembly, Hon. Hassan Guyo, that indeed he withdrew his Motion. This is another Motion brought by somebody else, it is not the same Motion that he withdrew. If I can remember, he withdrew his Motion last week.

**Hon. Speaker:** There is a difference between his Motion and this one.

Hon. Leader of Minority (Mr. Abdi Ibrahim Hassan): Mr. Speaker sir---

**Hon. Speaker:** Order! He gave clear reasons as to why.

**Hon. Leader of Minority:** Mr. Speaker Sir the Member is misinforming the House. It is the same Bill and I wish to withdraw it under Standing Order 133 (1).

**Hon. Speaker:** The Motion is about solid waste.

**Hon. Leader of Minority:** Mr. Speaker Sir, I want to inform you on Standing Order No. 35(2). The Order of the paper shall be published in the County Assembly website and shall be available to the Member at least 12 hours before the County Assembly meets. But supplementary Order Paper shall be made available at least one hour before the County Assembly meets and that one did not happen on Thursday.

**Hon. Speaker:** It happened. Order! Hon. Members, the Assembly is adjourned until 2.30 p.m. tomorrow.
