REQUEST FOR A STATEMENT REGARDING THE POOR STATE OF STREET LIGHTING IN UMOJA I WARD

Hon. Member for Lucky Summer Ward (Mr. Kennedy Oduru): Thank you, Mr. Speaker sir. I have a Response for Hon. George Njoroge Maina, who rose on the floor of the House on 1st of July, 2015, pursuant to Standing Order No. 41 (2c) and requested the Chairperson of the Sectoral Committee on Transport and Public Works for a Statement regarding the poor state of street lighting in Umoja I Ward. He further requested the Chairperson to inquire into and report on:

i) What became of the of the solar powered lights which were installed by the defunct Nairobi City Council;

Hon. Speaker: Order, Hon. Members! Please consult in low tones, Hon. Mark and Wahinya Parklands.

Hon. Kennedy Oduru:

- ii) Measures that the Nairobi City County Executive have put in place to address the complaints made by residents of Umoja I Ward; and
- iii) Measures put in place to curb vandalizing of street lights and action taken against the offenders.

Mr. Speaker sir, the Committee wrote to the County Chief Officer responsible for Roads, Transport and Public Works with a copy to the County Executive Committee Member responsible for Roads, Transport and Public Works on 8th July, 2014 requesting to be furnished with a written Response to the Statement requested by Hon George Maina. The County Chief Officer responsible for Transport and Public Works responded through a letter Ref. PWT/2611/CO/JMG. In this regard I wish to report to the Assembly as follows:

1. What became of the solar powered lights that were installed by the defunct City Council of Nairobi

Hon. Speaker: Order, Hon. Members please!

Hon. Kennedy Oduru:

- The Committee was informed that the solar powered lights along the Parliament Road and Harambee Avenue were installed and financed by the Ministry of Energy
- That the Light output reduced with time and the system failed to function throughout the night

 That they reverted back to the convectional system powered by grid Kenya Power supply but solar panels and the batteries were disconnected and were still on site.

2. Measures the Nairobi City County Executive has put in place to address the complaints made by the residents of Umoja 1 ward

The Committee was informed as follows;

- 1. That in the last three months, the County has maintained lights at blocks B,F,J and P precincts and lane Nyagusu, Moi Drive and around Rockfield.
- 2. That the County will install eight ten metre masts at strategic locations within the next two months as a strategy to improve the street lighting in Umoja 1 ward

3. Measures put in place to curb vandalism of street lights and action taken to its offenders.

The Chief Officer stated that the County has started employing new designs to enable new installation methods such as the following; use of aluminum cables in place of copper, use of concrete holes with overhead system and installation of control gears on top of holes.

The officer further informed that culprits found vandalizing public street lighting are taken to the City court and fined based on the item vandalized. She added that the costing---

Hon. Speaker: Order Hon. Members!

Hon. Kennedy Oduru: She added that the costing is done by the engineer from the electrical section. Thank you Mr. Speaker sir, I beg to lay this response.

Hon. Speaker: Hon. G. Maina

Hon. Member for Umoja 1 Ward (Mr. George Maina): Mr. Speaker, thank you very much. I am not satisfied with these answers because they cannot even prove that they are doing the maintenance yet on paper they write that they have done them. However, I will consult with the Chair for Transport because the Executive is not giving satisfactory answers.

Hon. Speaker: Hon. G. Maina, which areas are you not satisfied with?

Hon. George Maina: The Committee was informed that in the last three months the County has maintained lights at blocks D, F, J and P and that is a white lie.

Hon. Speaker: Order! Please use proper language.

Hon. George Maina: I withdraw.

Hon. Speaker: Which area are you not satisfied with?

Hon. George Maina: I am not satisfied because they are saying that the County has maintained lights and if you go to these blocks that they are saying, Mr. Speaker there is a lot of darkness and so I wonder. The Chief Officer for Transport is misleading this Committee. You rather take action, Mr. Speaker.

Hon. Speaker: You know your statement has three components; what became of the solar power, measures the Nairobi County has put in place to address the complaints made by residents and measures put in place to curb vandalism. You have three components so which one are you not satisfied with?

Hon. George Maina: I am not satisfied with the measures that Nairobi City County has put in place to address the complaints made by the residents of Umoja I Ward. On that one, I am not satisfied, Mr. Speaker.

Hon. Speaker: Hon. Chairperson, the Member is not satisfied with the measures the Nairobi City County Executive has put in place to address the complaints made by the residents. I therefore direct that you go back and bring to the Assembly the measures. We now want you to deal with the measures, only the measures. Is that okay, Hon. Member?

Hon. George Maina: Yes.

Hon. Speaker: Can you give us an undertaking on that?

Hon. Jairus Atenya: Thank you, Mr. Speaker sir. In this regard I request if you can allow the Committee to go for site visits so that we can observe for ourselves what is happening on the ground.

Hon. Speaker: How much time do you need?

Hon. Jairus Atenya: Two weeks at least.

Hon. Speaker: Hon. Chairperson, you do not need a site visit. What you need is for them to tell you what measures they are taking in regards to all the complaints from the residents of Umoja. Next Order.

Hon. Jairus Atenya: Mr. Speaker, I also have a Statement for Paul Kados.

Hon. Speaker: Hon. Paul Kados is not in so let us continue.
