Temporary Deputy Speaker (Hon. Samuel Nyang'wara): Hon. Members we don't have a quorum I direct the Serjeant-At-Arms to ring the bell for the next 10 minutes.

Temporary Deputy Speaker: Still we don't have a Quorum, I want to be guided enough because Hon. Kwamboka has requested me I add you 5 minutes. Hon. Member for Githurai Ward (Mr. Jackson Ngare): Mr. Speaker sir, I would like to strengthen you decision, we don't have a sitting as you made the ruling because I can see some Members at the Public gallery wearing T-Shirts so Mr. Speaker sir, stand with you decision and lets---
