### REQUEST FOR STATEMENT REGARDING A STATE OFFICER HOLDING A CIVIL SERVANT OFFICE IN THE COUNTY

Hon. Speaker: Hon. Elkana Mauti!

Hon. Member for Kwa Reuben Ward (Mr. Elkana Mauti): Thank you Mr. Speaker, pursuant to Standing Order 41 2 (c) I wish to request for statements from the Chairperson of Sectoral Committee of

Justice and Legal Affairs, Chairperson of Sectoral Affairs of Labour and Welfare regarding a State officer holding a Civil Servant Office in the County.

Hon. Mr. Speaker, the County Executive Member for Finance and Economic Planning has also been holding a position of the County Secretary since the Office was left vacant resulting to a major conflict of Interest. Hon. Speaker. In the statement the Chairperson should inquire into and report on:

- 1. The criteria used to appoint the CEC Member as the County Secretary and the resolution of the CEC Member's meeting on the appointment or on the Public service Board.
- 2. The illegality of the CEC Member Holding the position of the County Secretary
- 3. Whether the CEC Member authorized any payment of any kind as the County Secretary.
- 4. Whether there are revenue collectors who have been arrested since he came into the office. We would like to know whether he is among the people in the deal or he is the person who is influencing such workers to do corruption.

**Hon. Speaker:** Order Hon. Mauti! I think now you have gone out of your statement. Let's deal with what we had asked and then when it comes you will give us the details. I thank you. The Hon. Chairperson for Sectoral Committee on Justice and Legal Affairs.

**Hon. Moses Ogeto**: Thank you Mr. Speaker sir I request you to give me two weeks to respond to this.

**Hon. Speaker:** Very well Hon. Chairperson. Hon. Members Hon. Mauti's question statement will also go to the Committee on Labor. Work together on that one concurrently. What is the matter Hon.?

**Hon. Member for Zimmerman Ward (**Mr. Pius Mbono): Thank you Mr. Speaker, I made a request for a statement from the Committee of Health in the month of March regarding the state of community health workers and it has never been responded to.

**Hon. Speaker:** Very well Hon. thank you. This is to the Chairpersons of Committees. You remember last week you were all to answer questions this coming Thursday. I hope you are all prepared to bring in statements and answers on Thursday including that one of the *Mheshimiwa* who just stood on the floor. Let's have all that. We don't have to have a backlog. Hon. Chairpersons please take note that you should have these answers as you indicated on Thursday. There is a Member who is in the House Hon. Obonyo. Is he in the House?

Hon. Member for Gatina Ward (Mr. Mike Obonyo): Yes Mr. Speaker I am in the House and I also wanted to know if the response to my statement will be given.

**Hon. Speaker:** Now, Hon. Members--- Order Hon. Obonyo! Order Hon. Chege! Hon. Members I want to--- in fact I forgot to do a communication because Members are complaining about their statements not forthcoming. I want to tell you Hon. Members that the Speaker does not go for the answers from the CECs or the Executive. This is in regard to Hon. Obonyo's statement which he indicated from an office that

the Speaker has said that statement cannot come on the floor. I approved that statement for Hon. Obonyo and I expect that Jambo Pay statement to be here by Thursday 2:30 p.m. whoever is dealing with it please leave it and leave these shenanigans. The Speaker is not involved in bringing statements. Whoever is involved in bringing those statements please bring them. Don't involve the name of the Speaker or the leadership of the Assembly. I thank you.

**Hon. Moses Ogeto:** Mr. Speaker, I want to answer on behalf of the Chairperson of Justice and Legal Affairs Committee. The statement which was asked by Hon. Obonyo was before the Public Accounts Committee but on the legal documentation of the same, we'll table it on Wednesday next week.

**Hon. Speaker:** Very well, Wednesday next week, thank you. Yes Hon. Leader of Majority what are you saying?

**Hon. Leader of Majority** (Mr. Elias Otieno): Mr. Speaker, I just heard that you--- how does this Jambo Pay affect the leadership of the Assembly?

**Hon. Speaker:** I want to tell you that I got a call from some Members of the County Assembly indicating that I and the Deputy Governor have conspired not to have an answer brought on the floor of the Assembly.

**Hon.** Leader of Majority: Which means that one is an individual not the leadership of the Assembly Mr. Speaker.

**Hon. Speaker:** I am the Speaker of the Assembly.

**Hon. Leader of Majority:** But not the entire leadership. Maybe it might be an individual perception but all in all there must be an interest somewhere because if somebody is asking for these things for about a year and he doesn't get the answer then there must be something fishy somewhere.

Hon. Speaker: Correct.

**Hon. Leader of Majority:** I think this time PAC is going to give us the report. I know Ogeto is the beneficiary that is the reason why he wants to---

Hon. Speaker: Order Hon!

Hon. Leader of Majority: Okay Mr. Speaker, I rest my case.

**Hon. Moses Ogeto:** Mr. Speaker sir, I respect the Leader of Majority so much. I have categorically said that this issue is before the Public Accounts Committee. The question about the legal and the contract signed I said I am going to table it on Wednesday next week.

Hon. Speaker: Very Well.

Hon. Moses Ogeto: When the Leader of Majority is misleading this House by saying that we have-

Hon. Speaker: Order! Order! Proceed, we want the answers on the floor, all the Jambo guestions. Hashim Kamau asked nothing has come. That one--- Hon. Chege what can I do for you?

Hon. Member for Kahawa West Ward (Mr. Patrick Ngaruiya Chege): Thank you Mr. Speaker. When I look at the statements--- I had requested a statement not this year, last year in February 2014 from the Chairperson Planning, Lands and Housing. Two weeks has now been three years. This statement is very emotive Mr. Speaker. It is blocking so many things that are taking place at Kahawa West Market. Could the Chairman have some interests? Are the persons concerned in that particular department probably the owners of those stalls that they construct?

I also requested for a statement of a public utility land that had been grabbed in Mihang'o. The Chairperson always said two weeks. Now it has been many years and we are still expecting. He is always here and never serious. The other time I requested that he be reprimanded. We need another Chairman if things continue to be the same. This is the Chairman that we have trusted with the Committee of Planning. Yes, sitting next to you and you are the appointing authority. You are supposed to dismiss him immediately. We cannot continue---

Hon. Speaker: Very well Hon. please. I think so that we go to other business, I want to make the following ruling. First of all, if you look at your Order Paper, there are several statements due for response. I don't know how many are ready for response. How many statements you have that are ready for response. I want to make a ruling on this. Order! Hon. Members, statement requested by Hon. Manoah Mboku is it ready? The Chairman of the Committee on Planning is it ready?

Hon. Member for Imara Daima Ward (Mr. Jairo Atenya): Mr. Speaker sir, this statement was referred to the committee for PAC. We no longer deal with it.

Hon. Speaker: Public Accounts Committee! Two, a statement requested by Hon. Moses Ogeto from the Chairperson of Sectoral Committee on planning and Housing, regarding the grabbing of public land in Kiliman Ward, Hon. Chair.

Hon. Jairo Atenya: Mr. Speaker Sir, regarding the second statement this is a matter that's in court we cannot discuss about it. Matters in Court we cannot discuss.

(Loud consultation)

Hon. Speaker: Order Hon. Members! Chairman Planning we want the statement on the floor of Nairobi County Assembly, regardless the matter where it is.

Hon. Jairo Atenya: Next week.

Hon. Speaker: Tuesday 2:30 pm.

Hon. Jairo Atenya: Thank you.

Hon. Speaker: Statement requested by Hon. Michael Ogada, Legal and Justice Affairs and Planning Committee regarding the demolition of structures by the County Executive on Land registration. Planning and Legal!

Hon. Leader Majority: I think let me just rescue the Chairman of Planning. There's sometimes we might slaughter this man here or roast him as a potato and yet he is not getting the feedback from the Executive. Mr. Speaker this Planning department we should not just joke with it, we are always asking the Chairman to give us answers on the floor of this House and he's giving us two weeks and after two weeks he's increasing the period. So may be Mr. Speaker just call him in your office and ask him what's wrong? Because I don't think he's up to the task as for today.

Hon. Speaker: Very well Hon. Chair. Statement by Hon. Herman Azangu from the Chairman of Sectoral Committee on Labor and Social Services, regarding the payment of accumulated days for officers working in Security Section, is it ready?

Hon. Member for Dandora Area I Ward (Mr. Peter Wanyoike): Thank you Mr. Speaker, we are not ready with this statement because we found that the statement was so broad because there were more than 500 people retiring this year. So the Committee decided to work on it as a whole, and response will be given next week but one.

Hon. Speaker: Next week but one?

Hon. Peter Wanyoike: Yes, because we have scheduled to sit with the Executive by next week Mr. Speaker.

**Hon. Speaker:** Hon. Pius Mbono from the Chairperson of Health a statement regarding the safety equipment by the County community health workers, is it ready? Hon. Jairo Atenya: Mr. Speaker this Statement was withdrawn by the owner who asked the Statement.

Hon. Speaker: Statement requested by Hon. Kennedy Ngondi from the Chairperson of Sectoral Committee of Public Accounts (PAC) and Budget and Appropriation regarding the memorandum of understanding (MOU) between Nairobi City County and Foton Company.

# THE NAIROBI CITY COUNTY DISATER AND EMERGENCY MANAGEMENT BILL 2015, ASSEMBLY BILL 4 OF 2015

Hon. Speaker: Hashim, Order! All the Members are here.

(Hon. Speaker exits, Hon. Akuk Murice takes over as Chair)

(Several Members walk out)

**Hon. Chairman**: Members, you are requested to come back. Searjent-At-Arms, could you please lock the door and have Members inside. Searjent-At- Arms, please!

Hon. Members, we are now in Committee of the Whole Assembly and we will start with Bill from Clause 3.

#### Clause 3

(Question that Clause 3 be part of the Bill proposed)

Hon. Ronald Milare: Hon. Members, I beg to propose that Clause 3 be amended as appearing in the Order Paper and the reason for this is to specify the applicability of the council that is applicable to the Nairobi City County; and two to review the composition of the council by including the County Executive Committee

(Question that Clause 3 as amended be part of the Bill, put and agreed to)

#### Clause 4

(Question that Clause 4 be part of the Bill proposed)

**Hon. Ronald Milare:** Hon. Members, I beg to propose that Clause 3 be amended as appearing on the Order Paper and the reason for this is to specify the applicability of the council that is applicable to the Nairobi County and two, to review the position of the council including the County Executive Committee.

**Hon. Chairman:** Hon. Members, I put the question that Clause 3 be part of the Bill.

(Question put and agreed to)

#### Clause 4

**Hon. Chairman:** Hon. Members, I propose that Clause 4 be part of the Bill.

Hon. Robert Milare: Hon. Members, I propose that Clause 4 be amended as appearing on the Order Paper and the reason for this is to enable the establishment of the directorate before conferring functions and two, to expand the roles of the Directorate.

Hon. Chairman: Hon. Members, I propose that Clause 4 as amended be part of the Bill. Hon. Karen.

Hon. Karen Wanjiku (Nominated Member): I support the amendments of Clause 3---

**Hon. Temporary Chairperson:** Hon. Member, Clause 4.

**Hon. Karen Wanjiku:** Clause 4 because it gives us the mandate of the directorate. Thank you.

**Hon. Temporary Chairperson:** Hon. Members, I now put the question that Clause 4 as amended be part of the Bill.

(Question put and agreed to)

#### Clause 5

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 5 be part of the Bill.

**Hon. Ronald Milare:** Hon. Members, I wish to propose that Clause 5 be amended as appearing on the Order Paper and the reason being is that this is purely editorial. Thank you.

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 5 as amended be part of the Bill.

(Question put and agreed to)

#### Clause 6

**Hon. Temporary Chairperson:** Hon. Members, I propose that Clause 6 be part of the Bill.

Hon. Ronald Milare: Hon. Members, I wish to propose that Clause 6 be amended as appearing on the Order Paper. One is purely editorial, two to enable sharing of disaster and emergency response plans, and 3 is to identify areas that are a potential at risk for disasters at timely response.

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 6 as amended be part of the Bill.

Hon. Member for Sarang'ombe Ward (Mr. Pius Otieno): Mr. Speaker, thank you I support that amendment because it will only necessitate for a better response, better coordination that will be backed up by early warning systems. Thank you.

Hon. Temporary Chairperson: So do you support?

Hon. Pius Otieno: I support.

**Hon. Temporary Chairperson:** Thank you. Hon. Members, I put the question that Clause 6 as amended be part of the Bill.

(Question put and agreed to)

#### Clause 7

Hon. Temporary Chairperson: Hon. Chairman, I propose that Clause 7 be part of the Bill.

**Hon. Ronald Milare:** Hon. Members, I wish to propose that Clause 7 be amended as appearing on the Order Paper and the reason being this will provide mechanisms for responding to disaster and emergencies particularly procurement of goods and services required by those affected.

**Hon. Temporary Chairperson:** Hon. Members, I propose that Clause 7 as amended be part of the Bill. Hon. Karen.

**Hon. Karen Wanjiku:** I support because this Clause shows the role of the County and especially in training officers and employees and also ensuring that we have resources for disaster mitigation.

**Hon. Temporary Chairperson:** Hon. Member for Kayole South.

**Hon. Member for Kayole South Ward** (Ms. Elizabeth Manyala): I support but however if I refer to 7(a), something is disturbing my conscience because where upon occurrence of a disaster, are we still in the council or the County?

Hon. Member for Viwandani Ward (Mr. Samuel Nyangwara): Point of Order, Mr. Speaker.

Hon. Elizabeth Manyala: ---because I am looking---

Hon. Karen Wanjiku: Point of Information, Mr. Speaker.

**Hon. Temporary Chairperson:** Hon. Member will you accept a Point of Information? Hon. Nyangwara proceed.

**Hon. Samuel Nyang'wara:** Mr. Chairman, we have already dispensed Clause 7 and have taken a vote on the same and you made the ruling. I don't see the reason as to why we should go back because Hon. Manyala is saying that she has an issue with it.

Hon. Karen Wanjiku: Point of Information.

**Hon. Temporary Chairperson:** That was Clause 6. Let's hear Hon. Karen. Just hold on Hon. Manyala

**Hon. Karen Wanjiku:** Mr. Speaker sir, I want to inform her. If she has read the Bill, there is somewhere we have established a council. This is not the City Council; it is the council that we have established for this fund. It is the council for the disaster management. Thank you.

Hon. Pius Otieno: Thank you, Mr. Speaker. I would wish to jog the memory of Hon. Manyala. If you look at part 1 of this Bill, it is unfortunate that we are going through this process while other Members don't have it. It is also an indictment to the same House and the pigeon halls are there. The council has been defined as the disaster and emergency management council established by section 4. It does not refer to the semantics of the old Nairobi City Council. Council means an institution that would be in-charge of the day-to-day management of this disaster thing.

**Hon. Temporary Chairperson:** Thank you for the information, Hon. Member. Hon. Manyala, I am made to understand that the amendment you are talking about is to come later. Right now, we are just talking of the addition. So, we will proceed.

(Question proposed)

**Hon. Ronald Milare:** Hon. Members, I wish to propose that Clause 7 be amended as appearing on the Order Paper. And the reason for this is to provide for mechanisms of responding to disasters and emergencies.

(Question put and agreed to)

#### Clause 8

**Hon. Temporary Chairperson:** Hon. Members, I propose that Clause 8 be part of the Bill. Hon. Chairman?

**Hon. Ronald Milare:** Hon. Members, I wish to propose that Clause 8 be amended as appearing on the Order Paper.

(Question proposed)

(Question put and agreed to)

#### Clause 9

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 9 be part of the Bill.

**Hon. Ronald Milare:** Hon. Members, I propose that Clause 9 be amended as appearing in the Order Paper. The reason for this is to give estimates. Estimates should be tabled together with those of the relevant sectors since the directorate established is not an independent body.

(Question proposed)

(Question put and agreed to)

#### Clause 10

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 10 be part of the Bill.

**Hon. Ronald Milare:** Hon. Members, I propose that Clause 10 be amended as appearing on the Order Paper. This is purely editorial.

(Question proposed)

(Question put and agreed to)

#### Clause 11

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 11 be part of the Bill.

**Hon. Ronald Milare:** Hon. Members, I propose that Clause 11 be amended as appearing on the Order Paper. The reason for this is that this is quite an obvious matter. So, the inclusion is superfluous.

(Question proposed)

**Hon. Karen Wanjiku:** Mr. Speaker sir, I support that it be deleted. It should not be included in the Bill. Thank you.

(Question put and agreed to)

**Hon. Temporary Chairperson:** Hon. Members, just to inform you that the Bill is in the Order Paper and the amendments that we are proposing today, you can refer to your Order Paper. Though the Bill was in your pigeon holes sometimes back. Any member who doesn't have can be provided with one right now. Let's proceed.

Hon. Temporary Chairperson: Hon. Members, I propose that Clause 12 to 14 be part of the Bill.
