## First County Assembly – Fourth Session

Wednesday 10th August, 2016

#### **PRAYERS**

**Hon. Deputy Speaker:** I direct the Serjeant-At-Arms under Standing Order number 31(2) to ring the bell for ten minutes due to lack of quorum in the House, thank you.

**Hon. Deputy Speaker:** Order Members! Hon. Members we now have quorum in the House. We may proceed.

Hon. Wilson Ocholla: ... The report of the Sectoral Committee on Labour and Social Welfare of the Nairobi County Public Service Board report on promotion of national values and principles on the governance in Public Service for the year 2014 was laid on the floor of the Assembly Tuesday 5th July, 2016.

Mr. Speaker sir, the Committee held a retreat with the County Public Service Board from 10th to 13<sup>th</sup> March, 2016 in Mombasa for purposes of being taken through the Public Service Board on promotion of National Values and Principle of Governance for public Service Board for the year 2014.

Hon. Speaker sir, in interview of the above, the committee recommended as follows;

- 1. That the Assembly facilitate the County Public Service Board by ensuring that the Board receives adequate funding to enable them automate their service and undertake intensive training and capacity building on National Values and Principles of the Governance amongst County staffs
- 2. The County Public Service Board to activate and participate in all County Executive Human Resource activities including hearing of casuals and interns to promote transparency and accountability
- 3. The County Public Service Board should give high priority to women and marginalized groups during recruitment in order to promote National Values and Principles.
- 4. The County Public Service Board to urgently embark on promotion and fair computation by championing for the harmonization of salaries for staff seconded from the National Government and County staff

Mr. Speaker sir, I urge this Assembly to adopt the report of the Sectoral Committee on Labour & Social Welfare or the Nairobi County Public Service report on promotion of National Values and Principles of governance in the Public Service for the year 2014.
