Hon. Imwatok: Point of Order.

Hon. Deputy Speaker: Hon. Imwatok.

Hon. Member for Makongeni Ward (Mr. Peter Imwatok): Mr. Speaker as a victim of circumstances in this Assembly, kindly authorize the Majority Leader to have respect of the Assembly, please Mr. Speaker

Hon. Deputy Speaker: Order! It did not catch my eye in any way Hon. Imwatok, but thank you for the observation. I know Majority Leader is student of this House.

Hon. Leader of Majority: Thank you Majority Leader. Okay, Hon. Kagiri, you may proceed.

Hon. Nominated Member (Ms. Carolyne Munga): Mr. Speaker, I beg to give Notice of the following Motion: That aware that the United Nations Convention on Rights of the Child is the most complete statement on children rights ever produced and is most widely ratified international human rights treaty in history, which Kenya is party to, noting that the convention has 54 articles that covers all aspects of a child life and set out the civil, political, economic and social and cultural rights that all children everywhere are entitled to and also explains how adults and governments must work together to ensure all children enjoy their rights; deeply concerned that ensuring children rights in Kenya is still a challenge 26 years after ratification...

Hon. Deputy Speaker: Order Hon. Members. Please give Hon. Member time to give out the Notice of Motion.

Hon. Carolyne Munga: Thank you Mr. Speaker. Deeply concerned that child rights in Kenya is still a challenge 26 years after ratification of treaty and efforts by state to enforce these rights has not been sufficient as evidenced by rampant cases of abuse and neglect. The children's Act 2001 states that it is the duty of local authority and in this case the County government to safeguard and promote the right and welfare of children within its jurisdiction. Recognizing that the County government do not supplement effort to address child rights by national government and implementation of the UNCRC Charter will remain a mirage; considering the huge mandate that the Nairobi City County has in respect to children, this

Assembly urges the Nairobi City County Executive Committee and the Nairobi City County Public Service Board to move with speed and establish a full-fledged children's department to work hand in hand with national government agencies in ensuring the protection of child rights and related concerns in Nairobi City County. STATEMENTS

Hon. Deputy Speaker: Hon. Warutere

Hon. Member for Roysambu Ward (Mr. Peter Warutere): Thank you Hon. Speaker. Pursuant to Standing Order 42(2) (c) I wish to request for a statement from chairperson of Sectoral Committee on Justice and Legal Affairs regarding the total pending claims for legal fees estimated at Ksh. 5 billion in Nairobi City County.

Hon. Speaker a report submitted to the task force by Legal Department on calculation of legal fees revealed that there is no official policy governing determination of legal fees hence giving room to unethical conduct in determination of fees therefore to the detriment of this County.

Hon. Speaker specifically the County executive has engaged services of one Prof. Tom Ojienda as Legal Counsel on number of high profile cases despite us having a Legal Service Department. Hon. Speaker in the statement the chairperson should inquire and not limited to the following:

- 1) How and why the County appointed Prof. Tom Ojienda as external Counsel despite us having a Legal Services Department
- 2) How the specific cases he has handled or he is handling are allocated to him and why
- 3) How many cases involving the County he has handled or he is handling since 2013 and the cost benefit to this great County
- 4) Amount of money he has been paid since 2013 to date and any pending amount due
- 5) Measures taken by the County Executive to deal with rogue lawyers and County officials who connive to misappropriate public funds within our County.

We are in 2016 we have to play our oversight role and the journey has just began. Thank you.

Hon. Deputy Speaker: Chairperson for Justice and Legal Affairs, this is indeed a very grave matter as you are aware it was raised by the Law Society of Kenya (LSK) that there are several lawyers who are milking City Hall dry of its resources. So you need to take it very seriously.

Member for Parklands Ward (Mr. Jaffer Kassam): Thank you, Mr. Speaker. We will require a week and we should be ready with the response next week on Wednesday. Thank you.

Hon. Deputy Speaker: Thank you Chairman for the effectiveness. Hon. Imwatok.

Hon. Member for Makongeni Ward (Mr. Peter Imwatok: Mr. Speaker, with all due respect to the House procedures and rules, may I get directive from you whether the Chairman for legal Affairs is properly dressed as per the Standing Orders of the Assembly Mr. Speaker?

Hon. Deputy Speaker: Order Hon. Members! Under the procedures of the House Hon. Members on the dress code, it is indicated that Members should be in the official attire and the Hon. Member is properly dressed.

(Applause)

Hon. Deputy Speaker: We may proceed.

MOTION

Hon. Deputy Speaker: Hon. Majority Leader

Hon. Leader of Majority (Mr. Elias Otieno): Mr. Speaker today I think you are lenient to some Members here because if I am not wrong---

Hon. Deputy Speaker: Is that Motion No. 8 Hon. Majority Leader?

(Laughter)

Hon. Leader of Majority: Mr. Speaker, pursuant to Standing Order No. 25 (i), this Assembly approves the calendar of the Assembly regular sessions for 4th Session of the Assembly as contained in the Schedule attached to the Order Paper. Mr. Speaker, I call the seconder, Ngaruiya, to come and second the---

Hon. Deputy Speaker: Order, Hon. Member! Can you address the Member properly?

Hon. Leader of Majority: Hon. Ngaruiya, come and second the Motion because maybe *nimechanganyikiwa*.

Hon. Member for Kahawa West Ward (Mr. Ngaruiya Chege): Thank you, Mr. Speaker and thank you, Majority Leader. I rise to second this Procedural Motion that this particular calendar remains the way it has been brought in the Order Paper. Thank you, Mr. Speaker.

Hon. Deputy Speaker: Thank you.

(Question is proposed)

Hon. Deputy Speaker: Hon. Member for Eastleigh

Hon. Member for Eastleigh South Ward (Mr. Nelson Masiga): *Shukrani Bwana Spika. Mimi kwanza napinga Mswada huu kwa sababu nikiangalia Sessions za mwaka huu, hiki ni kipindi cha lala salama na tuna Mijadala mingi ya kufanya. Ukitupatia twende recess mwezi wa tano long recess na kuna recess ingine mwezi wa nne, mwezi wa saba kuna short recess, mwezi wa tisa kuna long recess, December pia kuna long recess. Hon. Deputy Speaker: Thank you. Hon. Imwatok.

Hon. Peter Imwatok: Mr. Speaker, thank you for giving me a chance to be able to put through what I think is important on this Motion. I fully support it, Mr. Speaker. When we went for recess in November, I said something which is very important to me and the people of Makongeni, that a year to election is time that we dedicate a lot of time to where we came from. I believe this calendar is the best option for us to go back at every opportune hour to join our people and to explain to them what we have been able to do and what we have not been able to do and why. Mr. Speaker, as Hon. Warutere has just said after reading the Statement, unfortunately he just walked out because the Statement is "corded". It is time also that the Speaker's Panel---

(Interjection)

Hon. Deputy Speaker: Declined. You may proceed.

Hon. Peter Imwatok: Thank you my wise Speaker for giving me a chance to---

Hon. Deputy Speaker: Do you want to be informed?

Hon. Peter Imwatok: No.

Hon. Deputy Speaker: Please take your seat, Hon. Karen.

Hon. Peter Imwatok: Mr. Speaker, as I was saying, it is time 2016 that really if we squandered 2013, 2014 and 2015, at least Hon. Members let us show Nairobians 2016 is never the same both in the House and outside. Just as some of us, to date as much as we are speaking on this platform, we don't know maybe a Subaru is outside there waiting for us because of our stand on some issues in this County, Mr. Speaker, but we are not afraid of that. What we are saying is an oversight, a legislative and also representative which is a very key role as to why we were elected that we must represent our people here and also back down there where we were elected. So, Mr. Speaker, I support this Motion fully.

Hon. Deputy Speaker: Thank you. Hon. Diana Kapeen.

Hon. Member for South 'C' Ward (Ms. Diana Kapeen): Thank you, Hon. Speaker. I rise to support the Motion of the calendar as it is and I want to echo the sentiments of my colleague, Hon. Imwatok. This is the final lap although it will not make a difference whether we go the Wards or not. What you did before will determine whatever you will do now. However, Mr. Speaker sir, even if you look at the quorum and we are just from recess, you will notice that you have rang the bell for quite some time, meaning that people do not want to come and sit in the Assembly to pass Bills and Motions that are not implemented but they would rather have these recess sessions to go and work with their electorates, Mr. Speaker sir.

We will also have some changes that were done in the Cabinet, we want to make use of very many changes that were done especially on the Environment Committee, we want to go and clean Nairobi because it is very dirty, and we want to do lighting. Therefore, I rise to support the Motion Mr. Speaker sir, thank you.

Hon. Deputy Speaker: Hon. Karen.

Hon. Karen Wanjiku (Nominated Member): Thank you, Mr. Speaker sir. I want to support this Motion because we really need those recesses. Most of us are tired of being nominated and we want to go in the grass root and get those votes so that when we stand here, we will not be called Ward less Mr. Speaker sir.

What I want to say is that we should be serious by using the time that we have here, coming in this House to deliberate important issues. This year, we should change by not wasting time and we should be having quorum because the year "*ni mwaka wa lala salama*". We have no time to waste because it seems in this Session, we are not going to that new *Bunge*. Therefore, we want to be there come 2017. Thank you, Mr. Speaker and I support.

Hon. Deputy Speaker: Thank you, Hon. Kagiri.

Hon. Member for Pipeline Ward (Mr. Samuel Kagiri): Mr. Speaker, I rise to support this Motion, but before I support, I can see there is a problem in the timetable because you see in the Fourth Session,

first part, it is written that we are supposed to start from Tuesday, 9th February to Thursday, 28th April, 2016, but the long recess here down starts from Friday 6th May, and not 28th Thursday. Another mistake is in the third part of Fourth Session, it is indicated that the Assembly starts from 29th September to Thursday, 1st December, 2016 and then you come to the long recess on Friday 1st December. So, I think there is contradicting information in this timetable here.

Hon. Deputy Speaker: Okay! May be the Clerk will take up the errors and amend them accordingly. Hon. Majority Leader!

Hon. Leader of Majority: Thank you, Hon. Speaker. I think there are some errors which have been already identified by Hon. Kagiri. So, I think they must be amended and then the Clerk should take into consideration those errors.

Mr. Speaker, I thank all Members who have supported this Motion and the ones who are opposing it because I know there are some people who I know, they don't want to go back to their Wards. That is the reason why when you see anybody who doesn't want to go back to the Ward, they have already sensed their fate.

Therefore, Mr. Speaker, let them just give some room for those who are going to be elected again, to go back to the people and campaign and also work for their electorates. I want to be here in the next five years. For the ones who don't want to go back to the Ward, please give us room for us to go back to the Ward as you continue coming to City Hall. Thank you, Mr. Speaker.

Hon. Karen Wanjiku: Point of Order.

Hon. Deputy Speaker: On What, Karen?

Hon. Karen Wanjiku: Mr. Speaker, I think we should not put the question today before we do the amendments because we cannot put a question on something that is not in the Order Paper. Thank you, Mr. Speaker sir.

Hon. Deputy Speaker: In fact I have been alerted by the Clerk that there is no error at all. That is the position of the office of the Clerk, so we may proceed.

(Question put and agreed to)

PROCEDURAL MOTION

LIMITATION OF DEBATE ON A MOTION

Hon. Leader of Majority: THAT, notwithstanding the provisions of Standing Order 94(4), this Assembly orders that, each speech in a debate on any Motion, including a Special Motion be limited in the following manner: A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of

the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

Mr. Speaker, with those few remarks I must call Hon. Ngaruiya because today he is on the hot seat to come and second the Motion.

Hon. Ngaruiya Chege: Thank you, Mr. Speaker. I stand here to second the Motion. If some amendments can be done, if the Majority and Minority Leader cannot exhaust the minutes that they have been given, they are free to donate to other Hon. Members in this House so that they can contribute to this particular Motion. I second, Mr. Speaker, thank you.

(Question proposed)

Hon. Deputy Speaker: Hon. Members, before I put the question, Hon. Majority Leader do you have any comment to make?

Hon. Leader of Majority: *(Inaudible)*

Hon. Deputy Speaker: Yes, but no Member is up on their feet.

Hon. Leader of Majority: I can see these people are already tired and the Assembly was only opened yesterday. Maybe they are demoralized by someone somewhere who I don't know. You are not tired?

Hon. Member: We agree.

Hon. Leader of Majority: Okay the Members have already agreed so Mr. Speaker, let me just thank Members for not taking too much time on debating this Motion. Let us just pass it then we go to another Motion.

Hon. Deputy Speaker: Thank you Majority Leader.

(Question put and agreed to)

MOTION

Limitation of Debate on Bills sponsored by Parties or Committees

Hon. Leader of Majority: THAT, notwithstanding the provisions of Standing Order 94(4), this Assembly orders that, each speech in a debate on a Bill sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty-five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a

maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that order

Mr. Speaker, I think Hon. Ngaruiya is on his feet to come and second the Motion.

Hon. Chege Ngaruiya: Thank you Mr. Speaker for the opportunity again to come and second this procedural Motion on limitation of debate on individual Members. Mr. Speaker I concur and I believe all the Members concur, thank you.

(Question proposed)

Hon. Deputy Speaker: Hon. Karen.

Hon. Karen Wanjiku (Nominated Member): Mr. Speaker sir, I want to support this procedural Motion. I also want to make a comment that we give so much time to the Majority and Minority Leaders and yet some times we don't see them here talking. Most of us Members who like contributing here are denied minutes. They should be more active, thank you.

Hon. Deputy Speaker: Order! That is at least a grave allegation Hon. Karen. Please you cannot justify. If you have anything to pick with the office of the Leader of Majority and Minority Party then you should bring at least a substantive Motion to discuss their offices not on the time allocated as per the Standing Orders, thank you.

(Question put and agreed to)

MOTION

Hon. Majority Leader: Limitation of debate on individual Member's Bill; THAT notwithstanding the provision of Standing Order No. 94 (4), this Assembly orders that each speech in a debate on Bills not sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows; a maximum of 3 hours and 30 minutes, with not more than 30 minutes for the mover in moving and 10 minutes in replying and a maximum of 30 minutes for the Chairperson of the relevant Committee and a maximum of 10 minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party who shall be limited to a maximum of 15 minutes each and that priority in speaking be accorded to the Leader of the Majority Party and the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee in that order.

Without taking too much time, I ask Hon. Ngaruiya to come and second the Procedural Motion.

Hon. Ngaruiya Chege: Thank you, Speaker. I stand here to second the Procedural Motion and I believe by the time the Majority Leader comes to the end of his Motions, he will have lost some calories. Thank you, Mr. Speaker.

(Laughter)

Hon. Deputy Speaker: Thank you.

(Question proposed)

Hon. Deputy Speaker: Hon Diana. The Majority Leader.

Hon. Majority Leader: Thank you, Mr. Speaker. I can see we are going very fast. I wish to thank Members for accepting the Motion even without debating it because it is common sense for everybody to understand what is contained in this paper. So, Mr. Speaker, I thank them.

(Question put and agreed to)

MOTION

Hon. Majority Leader: Few are remaining now. Limitation of debate on Report of a Committee; THAT notwithstanding the provision of Standing Order No. 94 (4), this Assembly orders that each speech in a debate on a Report of a Committee, a Sessional Paper or any other Report submitted to the Assembly be limited as follows; a maximum of 60 minutes for the mover in moving and 30 minutes in replying and a maximum of 10 minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party who shall be limited to a maximum of 15 minutes each and that priority in speaking be accorded to the Leader of the Majority Party and the Leader of the Minority Party in that order.

I call upon Hon. Ngaruiya to come and second the Motion because he has not done anything for this Assembly since we started.

Hon. Ngaruiya Chege: Thank you, Mr. Speaker. I rise to second this Motion on limitation of debate on Report of a Committee. I would also request that this continues we give the Majority Leader more task so that at least he can lose more weight. Thank you, Mr. Speaker.

(Laughter)

Hon. Majority Leader: Okay, Hon. Ngaruiya, you are very much concerned with the weight of Hon. Majority Leader. You may have at least a special session outside so that you can help and give advice to him.

(Question proposed)

Hon. Majority Leader: Thank you Mr. Speaker. I think we are about to finish. Let me thank Members for their support of the Motion. So, without much ado, let just sit down for another Motion.

(Question put and agreed to)

MOTION

Limitation Debate on Adjournment

Hon. Majority Leader: This is the last one. Limitation debate on adjournment. That notwithstanding the provision of Standing Order no. 94 (4), this Assembly orders that the debate on any Motion for the adjournment of the Assembly to a day other than the next normal sitting day in accordance with the calendar of the Assembly, be limited to a maximum of 3 hours with no more than 5 minutes for each Member speaking except the Leader of the Majority Party and the Leader of Minority Party who shall be limited to a maximum of 10 minutes each and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party in that order provided that when the period of recess proposed by any such Motion does not exceed 10 days. The debate shall be limited to a maximum of 30 minutes and shall be strictly confined to the question of the adjournment.

Mr. Speaker, I think this is the last one which Hon. Ngaruiya is going to second before we go for our normal exercise.

Hon. Ngaruiya Chege: Thank you Speaker. I rise to second this Motion of adjournment. It is a big relief for the Majority Leader that he is not going to stand because he is already sweating. And Mr. Speaker, some of these minutes as I said earlier...

Hon. Deputy Speaker: Order Mr. Ngaruiya! Are you trying to insinuate that the Majority Leader is not in good health?

Hon. Ngaruiya Chege: I am saying he is sweating and I said by the end of reading all these Motions, he will have lost some---

Hon. Deputy Speaker: Order Ngaruiya!

Hon. Elizabeth Manyala: Mr. Speaker, can the Hon. Member withdraw because it is a song? I don't know if that is what he is singing in his lips. Every time he stands to speak, he is talking about the weight of the Hon. Majority Leader. I think we are here for business and we are serious people.

Hon. Ngaruiya Chege: Thank you Mr. Speaker. Hon. Manyala must say something and I think the Majority Leader missed a point. I didn't say the weight of the Hon. Member, I said the Hon. Member is healthy and he is sweating. You know when you are sweating, it means you are healthy. So, when you come here and start saying that---

Hon. Deputy Speaker: You may proceed Hon. Ngaruiya.

Hon. Ngaruiya Chege: So, what I was saying is that, let's forget about Hon. Manyala because we know her. What I am saying is that some of these---

(Hon. Manyala stands on a Point of Order)

Hon. Deputy Speaker: Order Hon. Manyala. Please sit down. We don't want to prolong this. Please, just get seated. Hon. Ngaruiya, are you seconding the Motion?

Hon. Ngaruiya Chege: Yes I am seconding the Motion.

(Question proposed)

Hon. Deputy Speaker: There seems to be agreement on this. Hon. Members, I will allow the Majority Leader to reply.

Hon. Majority Leader: Thank you Mr. Speaker. I don't think there is anybody complaining---

Hon. Majority Leader: That is the reason why I am replying. Mr. Speaker, as I reply, nobody is complaining about my weight except one and he is my opposite. The other part is not complaining. So, I don't know why Mr. Ngaruiya is complaining about my sweating because the way you look like, Mr. Ngaruiya---

Hon. Deputy Speaker: Order Hon. Majority Leader!

Hon. Majority Leader: Okay Mr. Speaker. Thank you Members for accepting the proposals and we just take very little time to pass all the motions. As Hon. Warutere said before, this is a year of actions. I don't think we are going to bring these statements here just for walking around. Mr. Speaker, let us be serious this time. Thank you.
