COMMUNICATION FROM THE CHAIR

Good afternoon Hon. Members. I have the following communication to make. Hon. Members, permit me to welcome you to this state-of-the-art debating Chamber. Hon. Members, the new Chamber has been designed to conform to modern legislature design and architecture. It is also fitted with an ultra-modern state-of-the-art digital multimedia conference system. Similar systems are placed in the United Nations, African Union Headquarters, Parliament of Kenya to name but a few. As you are aware, Hon. Members, before now, the Assembly carried out its sittings at Charter Hall where voting was manual and debate was undertaken without much technological controls in place. Hon. Members, to access the microphone and catch the Speaker's attention, you will be required to insert your card in the slot provided on the side of your microphone stand. Hon. Members, there are two ways through which you will be able to contribute to debate and make interjections. Firstly, to address the Speaker or contribute to debate, you will be required to press the MIC button and wait for the Speaker to give you the floor by assenting to that request and switching on your microphone. Only request approved by the Speaker will have their microphone turned on and have the opportunity to address.

Secondly, Point of Order or Information will be raised by pressing the intervention key, marked as INT on your device. Again, the Speaker assents to your request for an intervention. He will switch on the microphone. Hon. Members, know that the Speaker will not entertain debates outside of the conference system as highlighted above.

Hon. Members, the Chair retains the ultimate discretion to allow or disallow a request for intervention or debate. Once a request is approved, such Member will be required to stand up in order to address the Chair. Should the Chair find the contribution or interjection to be out of order, such Member will be asked to resume their seat upon which the Speaker will have the discretion to switch off the microphone.

Hon. Members, the Chair wishes to request all of you to make time to appreciate the use of the resources availed in the Chamber. Indeed, a lot has changed on the way we conduct our business and Plenary in Charter Hall and as such we must orient ourselves to the new system. As you were indeed digital. It is so guided, thank you.

THE USE OF FUNDS COLLECTED FROM LIQUOR LICENSES IN THE COUNTY

I have a second statement Mr. Speaker. Pursuant to Standing Order no. 41 (2)(c), I wish to request for a statement from the Chairperson of the Sectoral Committee on Culture and Community Services regarding the use of funds collected from liquor licenses in the County.

Hon. Speaker, the Nairobi City Alcoholic Drinks Control and Licensing Act 2014, section 43(1) established a fund known as the Nairobi County Alcoholic Drinks Fund which is to be used for meeting expenditure relating to research, documentation and disseminating of information on alcoholic drinks in the County, promoting, cessation and rehabilitating programs in the County, financing the operations of the Sub-County committees and voluntary programs and for carrying out functions of the Nairobi City County Drinks and Licensing Board.

Hon. Speaker, in the statement, the Chairperson should inquire into and report on;

- 1. Status of the money that has been collected from the liquor licenses to date
- 2. Status of the money spent by Liquor Licensing Board from the Ksh. 300 million collected as licensing fee and the criteria used in expending the same, and
- Action taken by the County Executive to ensure that the 85 Wards in the County benefit from the collected money from liquor licenses as per the Alcoholic Drink Control and Licensing Act 2014.

Speaker, there has been an ongoing concern from the residents of Nairobi that the leadership of the County Government has failed in its key mandate given the dismal implementation of key projects and development goals since the year 2013. Most of the projects captured in the financial year 2015/2016 are pending including some from as far as year 2014/2015 resulting in services not being offered and failing County infrastructure. There has been hue and cry as contractors have gone unpaid for services for long. With implementation of Ward Development Fund having been intentionally sabotaged occasioning a total breakage of development centered projects across the City's 85 Wards just to mention but a few.

Hon. Speaker, the Chairperson should inquire into and report on the following:

- 1. Reasons as to why the leadership of Nairobi County is not acting on the contractors' pending dues for services offered to the County resulting to the pending projects.
- 2. Measures being taken by the County Executive to ensure that the residents of Nairobi get the required amenities as stated or captured in the budget.
- 3. The status of projects undertaken by the County Executive for the financial year ---

Hon. Speaker: Why are you on your feet?
