I beg that you stay in the House and attend to plenary as usual for that particular request to get approval. Do not blame the Chair on that. Thank you. Clerk, proceed!

## MOTIONS

PUBLIC FINANCE MANAGEMENT (NAIROBI CITY COUNTY BURSARY AND SCHOLARSHIP FUND) REGULATION, 2017

Hon. Temporary Deputy Speaker: Hon. Pius K'Otieno?

**Hon. Member for Sarang'ombe Ward** (Mr. Pius Otieno): Thank you, Mr. Speaker. I beg to move THAT the Assembly adopts the report of the Select Committee on delegated County Legislation and Public

Finance Management (Nairobi City County Bursary and Scholarship Fund), regulation 2017, laid on the table of the Assembly on Wednesday 31<sup>st</sup> May, 2017.

Mr. Speaker, the Public Finance Management Nairobi City County Bursary and Scholarship Fund Regulation, 2016 were laid down on the floor of the Assembly on Tuesday 18th October, 2016. Indeed you can imagine how long it has taken for us to move this Motion.

Pursuant to section 116 of the Public Finance Management Act, the regulations were thereafter being committed to the Select Committee on Delegated County Legislation for scrutiny and a report was laid to this Assembly. The Committee identified and resolved to meet the County Executive Committee Member in charge of Finance and Economic Planning, CEC for Education, The County Attorney and the County Assembly Legal Council before making appropriate recommendations.

Mr. Speaker, Section 16 of the PFM Act 2012 provides for the officer administering the fund to administer the County Bursary Fund for the County Government in accordance to the framework and criteria approved by the County Assembly. All these processes were done a long time ago.

Hon. Members, the objective and purpose of the PFM Act Nairobi City County Bursary and Scholarship regulation 2017 is to operationalize specific provision of Section 116 of the Public Finance Management Act and to provide for a bursary scheme for provision of financial assistance to intelligent students. The Committee included scholarship which will be issued by the County Executive and not the individual office of the Governor. Thereof, the Governors Bursary Oversight Committee will not form part of the committees issuing bursaries/scholarships.

The committee also included scholarship management committee to cater for the overall responsibility of the entire bursary and scholarship award for needy and bright children from vulnerable groups.

Mr. Speaker, I beg to move and ask that Hon. Petronilla to second.

Hon. Temporary Deputy Speaker: Okay. Hon. Petronilla to second.

**Hon. Nominated Member** (Ms. Petronilla Achieng): Thank you, Mr. Speaker sir. I want to second this particular Motion. I ask the members not to leave the House the same way the Chair for Legal has left after the passing of his Bill. I ask that Members be patient. This is because all the bursaries we were receiving were not within the law and we are enacting the specific law that is going to help on that.

(Question proposed)

Hon. Temporary Deputy Speaker: Are you making any request Hon. Member?

Hon. Member: (INAUDIBLE)

Hon. Temporary Deputy Speaker: Okay.

**Hon. Member for Makongeni Ward** (Mr. Peter Imwatok): Thank you very much, Mr. Speaker for allowing me to borrow a card to speak. My president of the poor and his Committee has done well by bringing this report to the House. This Assembly has been working on the issue of bursaries on favoritism. It is high time Nairobian's know that there is a committee working towards putting everything in a legal perspective. If you go to the bursary offices at the Old Annex, MCAs have been turned into office messengers. They carry files around looking for the signatories. This is because that has not been anchored under the law.

Now that both the Jubilee and NASA manifestos are saying that there will be free secondary education, it is important to have it in the event that an independent candidate wins. I beg to support the Committee on this. It is a very noble cause and I believe that with time Nairobian's and our successors will see this as something substantial.

Hon. Temporary Deputy Speaker: Thank you. I now call the mover to reply

**Hon. Pius Otieno:** Thank you, Speaker and Hon. Members. I want to say one thing, which is that the next Assembly has a big task in ensuring that they plan and prioritize. Most of the time, the Budget Committee has been doing this on our behalf as if they are magnanimous. It will be upon the Members to allocate the right amount of money that goes towards the bursaries, as much as I know that I will not be there. I want that Assembly to be alive to the fact that if they will not do it then they will be shooting themselves in the foot.

There is no Executive anywhere in the world that will allocate you enough resources. It is upon the members. Be it in London where Teresa May beat Kobbin the other time or in France where Macron is the new President or in America. It is upon the Members to allocate sufficient funds to themselves. With that I thank you.

DOG CONTROL AND WELFARE REGULATIONS, 2017

Hon. Temporary Deputy Speaker: Hon. Chair, Delegated Legislation.

**Hon. Pius Otieno:** Thank you once again, Mr. Speaker. I beg to move THAT this Assembly adopts the report of the Select Committee on Delegated County Legislation on the Nairobi City County Dog Control and Welfare Regulations, 2017 with the recommendations of the Assembly for consideration and adoption and laid on the table of the Assembly on Wednesday 31<sup>st</sup> May, 2017.

Mr. Speaker, the Nairobi City County Dog Control and Welfare Regulation 2017 were laid on the floor of the Assembly on Tuesday 14<sup>th</sup> February 2017 pursuant to Section 3 of Nairobi City County Dog Control and Welfare Act 2015. The regulations were therefore committed to the Select Committee on

Delegation of County Legislation for scrutiny and report to the Assembly. The Committee met all the stakeholders from members of Livestock and Fisheries, Forestry and Natural Resources, Legal Council, Sectorial Committee on Agriculture, Environment and Natural Resources who gave their views on the said regulations other than the County Attorney General before making appropriate recommendations.

Mr. Speaker, Section 37 of Nairobi City County Dog Control Welfare Act, 2015 provides for the County Executive Committee Member for Agriculture, Livestock and Fisheries, Forestry and Natural Resources to make rules for the carrying out of the provisions of the Act.

The objects and purpose of Nairobi City County Dog Control and Welfare Regulation, 2017, is to implement the Nairobi City County Dog Control and Welfare Act, 2015 and prescribe matters that the Act delegates to the County Executive Member. Mr. Speaker, for quite some time, this County has been operating without a framework that regulates issues of rearing, disposal and providing veterinary services to these dogs. People have been selling their dogs without any proper legislation that has been anchored in law.

This is the first step that this Assembly will be taking to ensure that there is a legal framework that would either protect the buyers or the sellers and even the people living in Nairobi from any illegal practice because there are also marauding dogs. You will think it is a pet only to realize that it is a dog that has never been vaccinated against rabies. These are some of the things that this Committee in collaboration with this House seeks to address.

With those many remarks, I beg to call upon Hon. Petronillah once again to second.

Hon. Temporary Deputy Speaker: Hon. Petronilla.

**Hon. Petronilla Achieng:** Thank you, Mr. Speaker sir. I wish to second the Motion. I am grateful to the Committee because now we are going to be safe so that we can eat meat in Kilimani and not eat dogs in Chinese restaurants. I second the Motion.

## (Question proposed)

Hon. Temporary Deputy Speaker: Hon. Members, allow me to call the mover of the Motion to reply.

**Hon. Pius Otieno:** Thank you, Hon. Members for your time and the cooperation. I look forward to meeting you in future endeavors.

**Hon. Temporary Deputy Speaker:** Hon. Members, before we move to the next Order, allow me to ease the tension. Hon. Peter Isuha looks as if he is under pressure and has made a request to the Chair concerning a direction that he was given when he was going out for a short call. Indeed, I was informed that he came back for the business of the House. He is still in the House. I want to direct that the Office of the

Clerk to expunge the wording of him missing the sitting of today from the records. I think he is now comfortable. You are welcome Hon. Isuha.

#### THE USE OF SASUMUA DAM

#### Hon. Temporary Deputy Speaker: The Hon. Chair, Water and Sanitation? Can you proceed?

**Hon. Hashim Kamau** (Minority Whip): Thank you. Mr. Speaker. I beg to move the following Motion: THAT this Assembly adopts the report of the Sectoral Committee on Water and Sanitation on the use of Sasumua Dam, laid on the Table of the Assembly on Wednesday 31<sup>st</sup> May, 2017.

Mr. Speaker, the drafters of the Constitution were aware that certain recourses, for instance water, will be shared among neighboring counties and as such they provided for mechanisms on how county governments could go to relate with the National Government and other county governments in performance of their functions, management of resources and resolutions of disputes that may arise.

Indeed, Mr. Speaker, Article 189 (2) provides that the Government, at each level, and different Governments at county level shall cooperate in the performance of functions and exercise of powers and for that purpose may set up joint committees and joint authorities. These provisions are strengthened by the provisions of the Intergovernmental Relations Act of 2012. It is against this backdrop that the Committee agreed to the proposal that the Nyandarua County Assembly Intergovernmental Resources Relations and Co-ordination Committee that discussions be held between the two counties, the two committees and other stakeholders in the spirit of Article 189 (2) of the Constitution and the Intergovernmental Relation Act of 2012.

In order to come up with amicable resolution to the unending complains raised by local residents from Nyandarua on the need to have significant degree of control over the Sasumua Dam and other water resources present in the area, the said dam is only operated by Nairobi City Water and Sewerage Company on behalf of Athi Water Service Board which is a national body.

Several meetings have been held on varied dates both in the Assembly precincts and in Naivasha in a bid to find a lasting solution. From this deliberation, it was generally agreed that the use and management of the water resources should be in line with existing national legislations and the Water Bill, 2014, the Mining Bill, 2014 and Natural Resources Bill, 2016 are finally enacted into law and operationalized. This will significantly address the issue of management and sharing of natural resources in Kenya.

However, in the meantime, efforts should be geared towards ensuring that water supply in the City is not disrupted while the host community also feel appreciated for their efforts in conservation of the rivers that supply water to the dam.

Mr. Speaker, this report put to the fore issues surrounding the sharing of natural resources in Kenya which must be addressed through national legislations. It contains the Committee's deliberation with



the Nayndarua County Assembly, Intergovernmental Relations and Coordination Committee and resolution and recommendations amicably agreed upon.

Mr. Speaker, I now call upon Hon. Kenneth Thugi to second the Motion.

Hon. Temporary Deputy Speaker: Hon. Thugi.

**Hon. Member for Njiru Ward** (Mr. Kenneth Thugi): Thank you, Mr. Speaker. I second the Motion as moved by our able Minority Whip, Hon. Hashim Kamau. He moved the Motion on behalf of the Chair. As the Committee on Water and Sanitation, we are a family and whenever a Member requests to represent a committee in any duty, we normally delegate. I second the Motion.

## (Question proposed)

Hon. Temporary Deputy Speaker: I now call the mover to reply.

**Hon. Hashim Kamau**: Thank you, Mr. Speaker. I am grateful to the Members of the Nairobi City County Assembly Committee on Water and Sanitation and the Nyandarua County Assembly Intergovernmental Relations and Coordination Committee for their commitment during the discussions that finally bore fruits. The Committee also acknowledges the efforts of the Chief Valuer, City County Executive Committee Members, Nairobi City Water and Sewerage Company Ltd, Nyandarua County Water Department and the secretariats for both committees for their support at all times. I reply.

# FINANCIAL STATEMENT OF THE NAIROBI CITY WATER AND SEWERAGE COMPANY LTD FOR THE YEAR ENDED 30<sup>TH</sup> JUNE 2015

Hon. Member for Makongeni Ward (Mr. Peter Imwatok): Mr. Speaker, I am privileged to be acting Chair of Public Investment Committee.

Mr. Speaker, I beg to move the following motion; THAT the Assembly adopts the report of the Public Investment Committee on the report of the Auditor General on the Financial Statement of the Nairobi City Water and Sewerage Company Ltd for the year ended 30<sup>th</sup> June 2015, laid on the Table of the Assembly on Thursday 6<sup>th</sup> June, 2017.

Mr. Speaker sir, this 4<sup>th</sup> audit report from the Auditor General on Financial Operation of Nairobi Water and Sewerages Company for the year ended 30<sup>th</sup> June 2015 that has been critically scrutinized and analyzed by the Nairobi City County Assembly Public Investment Committee. The main objective of the Committee is to ensure that Nairobi Water and Sewerage Company runs in a physically and sound manner that delivers proper services to the residents of Nairobi City County.

The Public Investment Committee scrutinized the Auditor General's reports interrogating the managing director and various departmental heads on audit queries raised by the Auditor General and come up with recommendations which include;

- 1) The company should provide for taxations since not doing so exposes the company to risk of penalties and this could ground the company.
- 2) All documents relating to property owned by Nairobi City Water and Sewerage Company should be under its custody.
- Nairobi City Water and Sewerage Company should write to the National Lands Commission seeking repossession of the land that has been grabbed by private developers like Kitusuru and many others.
- 4) The company should strengthen its debt collection mechanism to maximize its revenue.
- 5) The management should ensure that the company is registered as a public corporation.
- 6) The Accounting Officer should report back in writing within 60 days of the recommendation passed by the County Assembly as per the Public Audit Act, 2015.
- 7) The company should be re-incorporated as a public entity through legislation by the County Assembly to avoid tax liabilities and tax evasion among others as in the report.
- Mr. Speaker, I now wish to call upon Hon. Kimondo to second this report.

Hon. Temporary Deputy Speaker: Okay, Hon. Kimondo.

(Hon. Janet Kimondo Seconds by standing)

**Hon. Peter Imwatok**: Mr. Speaker, let me thank the Members of this County Assembly for being very good to us as the Committee of PIC.
