Hon. Herman Azangu: Hon. Speaker, pursuant to Standing Order 45 (2) (c), I wish to request for a Statement from the Chairperson of the Sectoral committee on Transport and Public Works regarding the state of roads in the County specifically, the missing link road between Enterprise Road and Rioko Rd in Land mawe Ward.

Hon. Speaker, it should be noted that Land mawe Ward lies in industrial jurisdiction where manufacturing and processing plants generate massive revenue for the county government yet it has been neglected in terms of public infrastructure development by the same government. Mr. Speaker, in the statement the chairperson should enquire into and report on;

- 1. Whether the county has plans for construction of the said missing link brought in the annual development plan even as the budget cycle gains momentum.
- 2. Whether the county executive has included roads in Land mawe Ward for rehabilitation in their annual work plan for the current or the next fiscal year and whether the residents of Land mawe will see efforts to improve the road infrastructure that will ease mobility.

#### REQUEST FOR STATEMENT REGARDING INVITATION FOR TENDER BIDS

Pursuant to Standing Order number 45(2)(c) I wish to request for a statement from the Chairperson of the Select Committee on Finance, Budget and Appropriation Committee regarding invitation for tender, tender bids NCC/REWT/T/339 of the financial year 2018/2019 and NCCEDU/10/209 of the financial year 2018/2019, NCCDU/T/337 of the financial year 2018/2019, NCCEDU/ICT/RFP/091 of the financial year 2018/2019 published by the County Government in the local dallies and its website on the 5<sup>th</sup> of February, 2019. Hon. Speaker, the County Government has published the said adverts calling for;

- 1. Bids for tenders on construction of a box culvert in different in Wards;
- 2. Construction of completion of ECD block in Gatina Primary School; and
- 3. Supply, delivery and distribution of milk for ECD children in Nairobi City County schools and supply installation configuration, customization, testing, commissioning and maintenance of an integrated city revenue management system respectively.

Hon. Speaker in the said publication, the bidders are asked to submit their bidding documents by February 15<sup>th</sup> 2019. In the statement the Chairperson should inquire into and report on;

> a. Whether the County Executive adhered to the provision of the Public procurement and disposal Act 2016 which requires that the bids be submitted at least within two weeks given the magnitude of the tenders

# REQUEST FOR STATEMENT REGARDING DISPLACEMENT OF TRADERS ALONG KANGUNDO ROAD IN RUAI WARD

**Hon. Waithera Chege:** I am still requesting for a statement Hon. Speaker. Pursuant to Standing Order 42 (c) I wish to request for a statement from the Chairperson of the sectoral committee on Trade, Tourism and Cooperatives and Planning, Lands and Housing regarding displacement of traders along Kangundo road in Ruai Ward.

Hon. Speaker, I wish to bring to your attention that the structures that the said traders use to trade their merchandise were demolished and currently lack space to operate. Hon. Speaker, it should further be noted that the public land LR. No. 118/1609 in Ruai is not currently in use and the traders may use the same in the short-term.

Hon. Speaker, in the statement the Chairpersons should inquire into and report on;

- 1. Whether the said traders can be given authority by the County Government to carry out their trading activities on the said unutilized piece of land?
- 2. Whether there are any plans by the County Government to construct markets in Ruai to accommodate the traders in the long-term?

Hon. Deputy Speaker: Chair Planning?

**Hon. Anthony Kiragu:** Thank you Hon. Speaker. I want to bring to your attention that Hon. Chege Waithera is a member of our committee and I would have preferred that she brings the statement directly to

the committee. Secondly, I think that she is misdirecting this committee to the Planning committee because trader matters should be directed to the Trade Committee.

Hon. Deputy Speaker: I wanted you to finish with your part that I ask for the other part, period.

**Hon. Anthony Kiragu:** I have not heard any question in her statement that should go to the Planning committee. She asked whether we have plans to relocate, honestly that is not a Planning issue. To relocate traders or give land temporarily is a Trade issue unless I did not hear correctly, but I wish she ask the two questions again and I believe you can be able to decipher that from where you're sitting.

**Hon. Deputy Speaker:** Hon Chair of Planning we have an issue of land and if you want Hon. Waithera to read again she can do the same for you to understand. But we have an issue of land and that is squarely in your sector.

**Hon. Anthony Kiragu:** The issue is not ownership of that particular piece of land. It is about giving it to traders temporarily for use.

Hon. Deputy Speaker: Chair, just say one or two days.

Hon. Anthony Kiragu: I will be able to give respond in two days.

(Loud consultations)

Mr. Speaker please protect me from people who are heckling when I am on the floor!

Hon. Deputy Speaker: Proceed.

**Hon. Anthony Kiragu:** Thank you. I will be able to give a response in seven days and I will redirect the question to the relevant office if need so that I come up with a proper response.

Hon. Jeremiah Themendu: Hon. Speaker, thank you. I think we shall reply to Hon. Chege in two weeks' time.

**Hon. Waither Chege**: Before I declare that I am comfortable, I need to remind my colleague, Hon. Kiragu that the challenges that Nairobi is having today is because of lack of planning. So, the question is properly before the committee.

# REQUEST FOR STATEMENT REGARDING ALLEGED OPERATION OF ILLEGAL CLINICS IN THE COUNTY

**Hon. Francis Ngesa**: Thank you very much Mr. Speaker. I need to ask for a statement. Pursuant to Standing Order 45 (2) (c), I wish to request for a statement from the Chairperson of the Sectoral Committee on Health Services regarding the alleged operation of illegal clinics in the county, specifically the recent case of the late Human Rights Activist, Caroline Mwatha, who alleged passed on while undergoing an abortion in a clinic in Dandora. Hon. Speaker, the said case has exposed how quacks are continually exposing the lives of Kenyans in Nairobi to danger by operating illegal health facilities without requisite qualification and providing low quality health services. Hon. Speaker it is therefore worrying how such clinics continue to operate without the attention of the authorities while noting that article 26 (4) of the constitution permits procurement of safe abortion under special circumstances, especially when the life an expectant mother is at risk, in the opinion of a qualified medical practitioner.

- 3. What measures the county executive has put in place to ensure that all health facilities operating in the county are licensed and registered.
