#### **STATEMENTS**

### RISK POSED TO RESIDENTS BY GROUNDED VEHICLES PARKED ON PEDESTRIANS' FOOTPATH IN MANY PARTS OF NAIROBI COUNTY

**Hon. Speaker:** Hon. Peter Wanjoike the Chairperson Transport is he around, he has a Statement for Peter Wanyoike regarding the request to residents. Proceed.

**Hon. Joyce Kamau**: Hon. Speaker, on 30<sup>th</sup> July 2019, Hon. Peter Wanyoike rose on the floor of the Assembly pursuant to Standing Order 45 (2) (c), and requested the Chairperson of the Sectoral Committee on Transport and Public Works regarding, the risk posed to residents by grounded vehicles parked on pedestrians' footpath in many parts of Nairobi County especially, in Kwa Mbao area along Komarock road in Dandora 1 Ward.

In the statement, the member requested that the chairperson should inquire into and report on -

- 1. Whether the County Executive has instated any measures to have vehicles towed away from the Pedestrian footpaths;
- 2. Safety measures put in place by the County Executive for its residents;
- 3. Whether there is a policy in place on encroachment on pedestrian footpaths; and
- 4. Measures the County Executive is taking in protecting public spaces.

Hon. Speaker, the committee wrote to the County Executive Committee Member responsible for Public Works and Transport inviting him to a meeting of the Committee that was held on Wednesday, 7<sup>th</sup> August 2019 at the County Assembly pursuant to Standing Order 45 (2) (d).

The purpose of the meeting was to enable the CEC Member to furnish the Committee with the response to the statement requested by the Member. The Committee further wrote to Hon. Peter Wanyoike inviting him to attend the said meeting of the Committee. With this regards Hon. Speaker, I wish to report to the Assembly as follows:

The Sector acknowledged and reported vehicles parked on pedestrian walkways, footpaths and road reserves to be a common phenomenon thought out the County particularly County residential estates. In view of the foregoing observation, the Committee was informed that the County was working on a strategy, which will culminate, into the issuance of a three weeks' notice to all owners of such vehicles to remove them on footpaths.

Failure to remove them will lead to the County undertaking a removal exercise by towing them to various yards of the County and at the owners cost. In the event, the owner fails to claim and pay for the towed vehicles the County, will subsequently auction the vehicles as scribe metals without further communication to owners and money forfeited to the County.

Hon. Speaker, Hon. Wanyoike was satisfied with the response, a copy of the detailed response has been given to him, who requested for it, and a further copy is hereby attached to this report. Hon. Speaker, I beg to lay this statement.

RISK POSED TO RESIDENTS BY LACK OF GUARD RAILS ALONG THE KOMAROCK BRIDGE IN DANDORA 1 WARD

I also have another statement for Hon. Wanyoike in the statement the Member requested that the Chairperson should inquire into and report on:

- 1. Steps the County Executive has taken to replace the guard rails on Komarock bridge; and
- 2. Measures the County Executive is taking for maintenance of Public bridges.

Hon. Speaker, the Committee wrote to the Executive committee Member responsible for Public Works and roads inviting him into a meeting that was held on Wednesday 7<sup>th</sup> August 2019 at the County Assembly pursuant to Standing Order 35 (2) (d). The purpose of the meeting was to enable the CEC Member to furnish the Committee with the response to the statement requested by the Member.

Hon. Speaker, the Committee wrote to Hon. Wanyoike inviting him to a meeting of the Committee. In this regard, Hon. Speaker, I wish to report to the Assembly as follows:

The Sector acknowledged that the absence of guard rails along Komarock Bridge is likely to compromise the safety of both the pedestrian and the motorist who are users of the facility.

The Committee was informed that the sector was making necessary arrangements to construct concrete guard rails to enhance the safety of the users of the bridge.

However, the sector noted that the said road was constructed and maintained by Kenyan Urban Road Authority, (KURA) which the sector would liaise with in order to have the guard rail installation expedited.

Hon. Speaker, Hon. Wanyoike attended a meeting of a joint sitting and was satisfied with the response. A copy of a detailed response has been given to Hon. Wanyoike who requested for the statement and a further copy is hereby attached to this report. Hon. Speaker, I beg to lay this statement. Thank you.

#### THE DEPLORABLE STATE OF ROADS IN THE COUNTY

Hon. Speaker, there is another statement for Hon. Mwangi Njihia who rose on the floor of the Assembly Pursuant to standing order 45 (2) (c) and requested the Chairperson should inquire into and report on:

- 1. Measures the County Executive has put in place to rehabilitate the Jamuhuri Court Road and Langiri road in Woodley Ward;
- 2. Steps that the County Executive is taking to ensure that the contractor is on-site and begin the construction works.

Hon. Speaker the Committee wrote to the County Executive Committee Member responsible for Public Works Roads and Transport inviting him to a meeting of the committee that was held on 7<sup>th</sup> August 2019 at the County Assembly Pursuant to standing order 45 (2) (d). The purpose of the meeting was to enable the CEC Member to furnish the committee with the response to the statement requested by the Member.

Hon. Speaker the committee further wrote to Hon. Mwangi Njihia inviting him to attend the said meeting of the Committee.

Hon. Speaker, I wish to report to the Assembly as follows:

The sector acknowledged the poor state of the roads in the county attributed this to heavy rains and inadequate budgetary allocation.

However, the sector reported that it is undertaking the following measures to address the issues:

- 1. Routine maintenance of roads through the road maintenance fuel levy, which will be in 100km;
- 2. Partnership with National Government in the Nairobi Eastlands Regeneration Programme which will be 66km; and
- 3. Implementation of a Capital Project Funded through the County Budget, which will be 117.55km.

Hon. Speaker, Hon. Mwangi Njihia attended the meeting and was satisfied with the response. A copy of the detailed response has been given to Hon. Mwangi Njihia who requested for the statement and a further copy is hereby attached to the report. Hon. Speaker, I beg to lay this statement. Thank you.

**Hon. Peter Wanyoike**: Thank you Madam Speaker, the affected area that is Kwa Mbao along the Komarock road, which was affected by, the grounded vehicles. I would like to report to this House that I thank the Committee, so much as the vehicles were removed and now the pedestrians are moving freely without any danger. Hon. Madam Speaker, I am satisfied with that statement. Thank you.

Hon. Madam Speaker, on the second statement, the rails of the bridge along Komarock Road, were vandalized and when we met with the committee, together with the sector, they promised that they would come up with concrete rails to safeguard the danger.

Now that they have promised to put the concrete rails, I urge the committee to follow up with sector so that the concrete rails can be put. Thank you Madam Speaker, I am satisfied with the statement

**Hon. Speaker**: You are satisfied but you want them to assure you that they will put the concrete rails. You had two statements. Hon. Joyce, had you combined the two statements?

Hon. Joyce Kamau: Yes.

Hon. Speaker: So we are done with that. There was a response for Hon. Njihia also do you have it?

Hon. Joyce Kamau: Madam Speaker I have read the response for Hon. Njhia also.

**Hon. Abraham Njihia**: Thank you Madam Speaker. It is true that I attended the meeting of the Public Works Committee concerning Rang'iri Road and Jamhuri Amani Court. We agreed with Chief Officer and the CECM that they are going to move to the site but they gave me routine maintenance through the Roads Fuel Levy partnership with the national government and the Nairobi Eastland Generation.

Hon. Speaker, as you can see this was in August and we agreed that they are moving to the site, I can confirm to you up to now I have not seen anything. However, today I met the Clerk of the Public Works and we agreed that he records them by next week Wednesday. Thank you, Hon. Speaker.

**Hon. Speaker**: Hon. Esther, you have something. You have to stand up because I have no idea what you are saying when you are doing this. There is no Standing Order that does this.

Hon. Esther Nyangweso: Thank you Madam Speaker. I have not pressed the mike.

Hon. Speaker: Hon. Kabiro, I know you want to---

Hon. Mbugua Kabiro: Thank you very much Madam Speaker for according me---

**Hon. Speaker**: Approach the Chair so that I understand what you want to do. On the other hand, are you ready?

Hon. Mbugua Kabiro: With your guidance, I can approach.

Hon. Speaker: If you are ready, you can proceed but you have to use the standing orders.

Hon. Mbugua Kabiro: I am ready Madam Speaker.

Hon. Speaker: Proceed.

**Hon. Mbugua Kabiro**: Madam Speaker I would like to rise on Standing Order No. 34, I am so sure that the Clerks on this bench are able to advise you well.

Hon. Speaker: Approach the Chair, so that can get you can get this copy and proceed in a procedural manner.

**Hon. Mbugua Kabiro**: Thank you Madam Speaker. I wish to stand on Standing Order No. 34 because of what has happened today in this great city of Nairobi specific leaders have held a meeting and spoke about this county in a bad light. I would like this House to adjourn its business so that Members can rise and support that we talk about an issue that affects this county; one that is been raised in the streets. Things that would allow Nairobians to understand what is bedeviling Nairobi and how we can seek it. Madam Speaker I would like the House to stand in support for us to discuss a motion that I am giving.

### (Point of Order)

Hon. Speaker: Yes, Hon. Imwatok.

**Hon. Peter Imwatok**: As much as I respect my learned friend, Hon. Kabiro, Standing Order No 34 speaks about a motion of great importance to the county. Standing Order No. 34 (2) stipulates that this motion should be brought before the attention of the Speaker two hours before and in moving the motion, the member should be blatant as it should be. What is this matter of importance? Not just telling the Hon. House that, what has happened today? Today many women in Pumwani Hospital gave birth; today some people succumbed to death at Mbagathi hospital, in Kenyatta Hospital some were taken in after accidents. What is this that the Hon. Member is telling us happened today?

Madam Speaker, some of us are in mosques and churches supplicating our prayers to God to give us peace in this House. What is it that has happened? Has this motion come to the attention of the Speaker two hours before? Because as the opposition side we will want to debate this when the assembly adjourns. But saying what has happened today honestly, today I was having a girlfriend, is that an episode to discuss in this House Madam Speaker?

Hon. Speaker: Hon. Kabiro, can you substantiate properly what happened.

**Hon. Mbugua Kabiro**: Thank you Madam Speaker I was confused by the fact that you asked me to approach the Chair yet I was very well prepared. I respect my Whip, but I would like to rise on Standing Order No 34 (1), on an issue that there are leaders within the confines of Nairobi who have held a press conference. This is an issue that I had notified you before; regarding the fact that Nairobi is heading in the wrong direction. This is what I would like us to guide and discuss so that we can get direction and say that Nairobi is riding in the right direction.

Members of Parliament and Senators within Nairobi have held a press conference and they have insinuated or rather said that Nairobi City County should be dissolved for not leading in the right direction. Moreover, we as the Hon. Members charged with the responsibility to steer and oversight Nairobi, it is our duty to make sure that they know that it is heading in the right direction.

Madam Speaker, I hope the Hon. Whip has understood my point and I request the House to rise in support of this motion. I hope you now understand.

Hon. Speaker: I think he has explained. I do not know what else we need to understand from this.

**Hon. Speaker:** What I heard is that the County is to be dissolved. Do you agree with that Hon. Minority Whip?

Hon. Speaker: Order! Press conferences do not solve the problems of Nairobi. Let us come up with solutions. Yes, Hon. Kados

Hon. Paul Kados: Madam Speaker, I listened to--- (Inaudible)

Hon. Speaker: Just a minute

Hon. Paul Kados: Madam Speaker, I listened to the press conference but did not hear anything to do with dissolving Nairobi County. If the member heard that, I do not understand because personally, I did not
