Hon Clarence Munga: Thank you Madam Speaker. I beg to give Notice of the following Motion: THAT aware the Article 29 of the Constitution of Kenya 2010 grants every citizen a right to freedom and security. Further aware that paragraph 8 of Part Two pf the Fourth Schedule of the Constitution provides for County planning and development including housing as a function of the County Government. Noting that

recent months have witnessed a marked increase in the number of insecurity incidences across the county and more so, in Nairobi City County. Concerned that majority of the buildings especially in formal settlements do not have closed circuit television cameras, whereas most of the criminal activities within the County go unnoticed. Acknowledging the importance of CCTVs in the modern world today where CCTV surveillance can deter potential criminals and video footages that can help law enforcement to investigate and later provide evidence for prosecution in a court of law. Further acknowledging that CCTV used in conjunction with audio, verbal and other types of sensors can alert officials to occurrences that are out of the ordinary. Noting that for the County to realize a 24-hour economy, security for the businesses and people and residents is indispensable. This Assembly urges the County Executive to formulate policy to;

- 1. Compel building owners to install close circuit television in all commercial and residential buildings to aid in reducing criminal activities across the County
- 2. Install close circuit televisions in all public areas and county facilities in the informal settlements across the County by the County Government.

Hon. Temporary Deputy Speaker: Hon. Nicholas Okumu.

REQUEST FOR STATEMENT REGARDING THE DEMOLITION OF STRUCTURES AROUND SOSSIAN AREA IN LOWER SAVANNAH WARD

Hon. Nicholas Okumu: Thank you Madam Speaker and welcome back. It has been long since I saw you on that seat. Pursuant to Standing Order 45 (2c), I wish to request for a statement from the Chairperson of the sectorial committee on Planning and Housing regarding the demolition of structures around Sossian area in Lower Savannah ward.

Hon. Speaker, it is alleged that the County Government has demolished residential structures of Sossian area which has adversely affected the residents and proprietor who for decades have been living and relying on the Davana hotel respectively.

Hon. Speaker, the residents of the said area have complained over the actions that were taken, as they ought to have taken a key role. They further registered their discontentment for not being issued with adequate prior notice as that led to them not having time to salvage their properties during the demolitions.

Hon. Speaker, in the statement the Chairperson should inquire into and report on;

- 1. Approvals for the demolition exercise in that area and the overall objective of the demolition exercise.
- 2. The reason for the demolitions without adequate prior notice being issued to the tenants and the proprietor?
- 3. Measures the County Executive and the NMS are taking to ensure residents are compensated for the loss of property during the demolitions.

Thank you Madam Speaker.

Hon. Temporary Deputy Speaker: Thank you. We also have Hon. Benson Mwangi. Is the Chair for Planning online? Deputy Leader, can you reply on behalf of the Chair, Planning? Kindly request

Hon. Peter Wanyoike: Thank you Madam Speaker. I wish to report back, two weeks after recess.

Hon. Temporary Deputy Speaker: Hon. Okumu are you okay with that?

Hon. Nicholas Okumu: Thank you Madam Speaker. This is a very sensitive issue given that members of the area are living in fear as their homes have been demolished and that is why I wish to request the committee to expedite the matter and give us a report in one weeks' time owing to the sensitivity of the matter. There is a court order in this effect but still people went ahead and demolished these homes.

Hon. Temporary Deputy Speaker: One week is going to be a bit difficult given our calendar. We are to start our recess this coming Thursday and we will be coming back on the 7th of September. Can they give you an answer personally as it cannot be brought to the House?

Hon. Nicholas Okumu: I wish to have the report sooner, even if it will not have been tabled so that I share with the residents. I still stand with the one-week request

Hon. Temporary Deputy Speaker: Will you be able to get an answer from the Executive within one week?

Hon. Peter Wanyoike: Madam Speaker, we have to write to the Executive and give them seven days to respond. The committee will only be able to report back after ten days.

Hon. Temporary Deputy Speaker: Is that okay with you Hon. Okumu?

Hon. Nicholas Okumu: Fair enough, Madam Speaker.

Hon. Temporary Deputy Speaker: Keep in mind that they are going to report to you and not to the House. The response will be brought to the House in September.

Is Hon. Benson in the House? Unfortunately, he is not in so we will defer that matter. Clerk.

ADOPTION OF REPORT ON CONSIDERATION OF THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE NAIROBI CITY COUNTY GOVERNMENT AND COOPERATIVE BANK OF KENYA LIMITED ON THE PAYROLL SUPPORT SERVICES

Hon. James Kiriba: Thank you, Madam Speaker. I beg to move the following Motion:

THAT, this Assembly adopts the 34th Report of the Select Committee on County Finance, Budget and Appropriations on the consideration of the memorandum of understanding (MOU) between the Nairobi City County Government and Cooperative Bank of Kenya Limited on the Payroll Support Services, laid on the Table of the Assembly on Tuesday, 3rd August, 2021.

I request Mheshimiwa Wanyoike, the Deputy Majority Leader, to second the Motion.

Hon. Peter Wanyoike: Thank you, Madam Speaker, I beg to second.

(Question proposed)

Hon. Temporary Deputy Speaker: Members! Hon. Immapet Kemunto.

Hon. Immapet Kemunto: Thank you, Hon. Chair. This is a concern to the department that was supposed to give us the report so that we are able to go through it before we debate.

Hon. Temporary Deputy Speaker: Hon. Immapet, do you still want to debate on it?

Hon. Immapet Kemunto: Thank you, Hon. Chair and Hon. Kiriba for bringing this Motion on board. I think it is a good report. Till now, the Executive staff have not been paid. I support it because we will not have hiccups in channeling of funds. Thank you.

Hon. Temporary Deputy Speaker: Thank you. Hon. Ariviza.

Hon. Mary Mwami: Thank you, Madam Speaker. I have not understood it well, but anything that can streamline our understanding between us and our main bank, the Cooperative Bank that has most of our funds--- I have been in Loans Committee, it gives loans to all Members and workers of County Assembly and most of the workers in the Executive get their salaries through the bank.

Also, the Cooperative Bank is our tenant in the City Annex. It is good to understand what is there between us and them. It should be a clear thing that if the salaries are delayed from the County or from the National Government, if there is good understanding between us and the bank, we can be able to be given salaries even before the money comes in.

In my quick preview of what it is, it is important to get this MOU so that we can be able to understand how we will engage with the Cooperative Bank at every other level, especially as far as salaries are concerned.

Lastly, when there is a good memorandum of understanding between a bank and a where people are getting their salaries, they can also get good salary advance or some small loans. So, those understandings are very important. They have been good partners, and we are not complaining but we want it to be streamlined. Thank you very much.

Hon. Temporary Deputy Speaker: Thank you. Hon. Wanyoike.

Hon. Peter Wanyoike: Madam Speaker, for the House to understand what the memorandum is all about, on 2nd August 2021, the Committee Executive Member responsible for Finance, submitted a request to the County Assembly, through the Office of the Clerk, seeking concurrence of the County Assembly to allow the Cooperative Bank of Kenya Limited offer payroll support services on need basis on the extra cost to the Nairobi County employee.

In the letter, the CEC for Finance had observed that the Nairobi City County Executive is unable to pay the salaries for July 2021 due to delay in uploading of the budget for the financial year 2021/2022.

Mr. Speaker, with this report, the Committee came up with following recommendations:

1. That the memorandum shall be varied, altered, or amended in any way without---

Hon. Temporary Deputy Speaker: Deputy Majority Leader, I think you should have asked for a point of Order because you had already seconded it. You should have debated at that point. For you to start that again, you need to raise a point of Order.

Hon. Peter Wanyoike: Madam Speaker, you are right. I had to read so that the House can understand what we are debating about.

Hon. Temporary Deputy Speaker: Okay. So, you need to ask for a point of Order so that you can proceed to elaborate on that.

(Point of Order)

Hon. Peter Wanyoike: Thank you, Madam Speaker. I rise on a point of Order so that I can inform the House about this memorandum. Sa I have said, on 2nd August 2021, the Committee Executive Member responsible for Finance, submitted a request to the County Assembly, through the Office of the Clerk, seeking concurrence of the County Assembly to allow the Cooperative Bank of Kenya Limited offer payroll support services on need basis on the extra cost to the Nairobi County employee.

In the letter, the CEC for Finance has observed that the Nairobi City County Executive is unable to pay the salaries for July 2021 due to delay in uploading of the budget for the financial year 2021/2022.

Mr. Speaker, the request is meant to operationalize the terms of engagement of the MOU, and thereby ensure timely payment of salaries to public and state officers serving within the rank of County Government. In line with the signed document, authority of the County Assembly is required before rolling out the memorandum.

Madam Speaker, the Committee went through the request and came up with the following recommendations:

- 1. That the memorandum shall be varied, altered, or amended in any way without the authority of the Nairobi City County Assembly;
- The implementation of the MOU shall not in any way result in extra financial burden to the County, and the County Executive Committee Member for Finance shall ensure timely honour of the obligation contained herein; and
- 3. The provision of the MOU shall, with necessary modification and with the approval of the Nairobi City County Assembly Service Board, apply on the County Assembly.

Thank you, Madam Speaker.

Hon. Temporary Deputy Speaker: Thank you, Deputy Majority Leader. I think those who are online are able to understand clearly. We had Hon. Themendu online, but unfortunately he is offline.

(Point of Order)

Hon. Temporary Deputy Speaker: Yes, Hon. Ariviza.

Hon. Mary Mwami: I have now understood, unfortunately the day it was read, I wasn't in. Now that we want to have the Cooperative Bank as the only domicile bank that processes our payrolls and so on---this is because we don't have salaries for July only. Is that MOU limited? If it is not limited, in my own thinking — maybe I need clarification — it may become quite inconvenient for people who have their salaries going through other banks.

Secondly, it is extremely dangerous for you to have your eggs in one bag. It is important for one to have in other places. We have history in this country where banks go down. If you have domiciled in one bank, it can be devastating for an organization. If it is for this month so that our staff are paid, it is okay. If it is long term, we may need to consider the fact that there are people have loans running in other banks. For

me, I have no problem because my salary comes through Cooperative Bank, but I think there are other people who may not. Thank you.

Hon. Temporary Deputy Speaker: Hon. Ariviza, this does not affect people holding different bank accounts, what they are asking for is money to allow them to pay the salaries. They are asking us to give them a go ahead to get a soft loan to pay salaries.

Hon. Mary Mwami: Madam Speaker, that is fine. Our people will be sorted out for this month. That was what I was saying, if it is for this month only, it will be good. Thank you.

(Point of information)

Hon. Immapet Kemunto: I have a point of information towards Hon. Ariviza's case. Whatever we are getting from the MOU is like salary advance. It is just a short term thing. Thank you for that clarity.

Hon. Temporary Deputy Speaker: Mover.

Hon. James Kariuki: Thank you, Madam Speaker. I want to appreciate the Hon Member who have contributed to the Motion, led by Deputy Majority Leader, Hon. Ariviza, my good Chairperson, and Member of Speaker's Panel, Hon. Immapet. I appreciate that we have a sense of giving short term solution so as our Members and staff will not suffer from the humiliation from the estate managers due to delayed rent payment.

Also, our children are going back to school and need fees. Therefore, this short-term arrangement is going to give us solution that would have otherwise become difficult. Thank you, I beg to move.
