STATEMENTS

REQUEST FOR STATEMENT REGARDING ALLEGED GRABBED LAND LR NO. 209/9295 Hon. Speaker: Is Hon. Ngengi around?

Hon. Daniel Ngengi: Thank you Hon. Speaker. Pursuant to Standing Order 45 (2), I wish to request for a statement from the Chairperson of the sectorial committee on Planning and Housing regarding the alleged grabbed land LR No. 209/9295 comprising 1.326 hectares that was conditionally granted by the defunct City Council in 1978 to Gemeni Property Limited for the construction of a clinic and a day nursery school and two resident houses for a teacher and the doctor in charge.

Hon. Speaker, in very unclear circumstances the alleged grabbed land has since been developed by entities masquerading as its real owners of Muthaiga Shopping centre. This has contravened the intentions of the special condition issued to have a clinic and a school constructed on the piece of land. Hon. Speaker, many concerns continue to be raised by associations, individuals and organizations, which have objected the construction of the shopping centre that has among other things encroached on a road reserve, giving rise to illegal development and noise pollution from newly open night club.

Hon. Speaker, in the statement, the Chairperson should inquire into and report on;

- 1. The history and ownership of land LR No. 209/9295 and relevant approvals of compliance?
- 2. Reason the land was not utilized for construction of a nursery school, clinic and two residences?
- 3. Why relevant enforcement team in the sector has failed to take action on the alleged illegality.
- 4. When the County Executive and the Nairobi Metropolitan services will undertake thorough investigations on the alleged grabbed land and specific timelines to have the same reverted back for use as intended.

Hon. Speaker, when you go to the site, you find lots of containers that have been placed there. The land has become more of a crisis for the area residents. The residents are seeking help from this House to contain this issue that they deem illegal and has affected the peaceful enjoyment of their property. I urge the Chairman of the committee and the NMS to expedite on this matter. Thank you

Hon. Speaker: Do we have the Chair of Planning or any Member?

Hon. Peter Imwatok: Hon. Speaker, as you are aware, today we will be closing the Assembly indefinitely until such a time that it will be conducive for us to take part in site visits. Hon. Member, allow us to monitor the COVID-19 situation first, so that once we come back, we will ensure that this happens. I will relay the same to Chair of the committee and request for two weeks to see if there is something we can do about it.

Hon. Speaker: Hon.Ngengi, are you content?

Hon. Daniel Ngengi: Hon. Speaker, the Members has stated that we should look into this after the COVID-19 crisis. We have no idea when it will end or rather when things will get back to control. I know that there is still hope for virtual meetings and if fourteen days will be sufficient. I am okay with that. This is a pending matter and I pray that after the fourteen days, the residents will get a response on this. Thank you Hon. Speaker.

Hon. Speaker: Thank you Hon. Member. As you aware, we are trying to limit physical contact as much as possible but I hope that the committee will look into it to stop cartels taking advantage and flouting all the regulations. Next order

PROCEDURAL MOTION

ALTERATION OF THE CALENDER FOR THE FIFTH SESSION

Hon. Speaker: Leader of Majority

Hon. Abdi Hassan: Thank you Mr. Speaker sir. Pursuant to the provisions of standing order 294, this Assembly resolves to alter its calendar for the 5th session 2021 as adopted on 9th February, 2021 so as to;

- 1. Suspend its sitting of Tuesday afternoon 6th April 2021
- 2. Suspend all its ordinary sittings from Thursday 8th April 2021 until further notice

The Clerk is a directed to make necessary arrangements to facilitate virtual meetings of the committee.

Mheshimiwa Spika, sababu yetu kuu ya kubadilisha kalenda ya Bunge ni kwa sababu ya jangu inayomulika inchi yetu ya kenya. Mimi ni mmoja ya waathiriwa wa ugonjwa huu wa COVID-19. Watu wengi wanafikiria kwamba ugonjwa huu haupo. Mimi pamoja na mke wangu na kijana wangu mkubwa tuliadhirika na tukaugua siku ishirini na nne nyumbani na ninashukuru mungu kuwa leo naweza hutubia hii bunge.

Hii ugojwa ni mbaya sana ambapo huwezi tamani adui yako apate. Kwa hivyo, ili kuweza kutunza waheshimiwa na afya yao na wafanyikazi wa hii Bunge ni vyema tubadilishe hii Kaleda mpaka wakati ambapo serikali itaona kuwa ugonjwa huu umerudi chini kiasi ambapo watu wengi hawawezi kuambukizwa. Waheshimiwa kadhaa hapa Bunge wako na hii ugonjwa. Kuna waheshimiwa wawili ambao wako mahali pabaya ambapo wanategemea oxygen kupumua. Hii si hali mzuri na kwa hayo, ningelipenda kuwaambia waheshimiwa kuwa hii ugonjwa si mchezo, iko na inabidi waweze kujikinga.

Mheshimiwa Spika, mimi niko hapa kwa sababu labda mimi ni kijana na sina ugonjwa ingine ndani yangu ndio sababu niko hapa. Ndani yetu kuna wale ambao wako na conditions ambaye inafanya hii ugonjwa iweze kukulemea Mheshimiwa Spika. Tuko na watu ambao wako na kisukari, wengine wako na blood pressure, sijui kwa kiswahili wanaitaje, na tuko na watu wako na magonjwa tofauti tofauti kwa hii Bunge. Pia na wafanyikazi wetu, tuko na wale wako na hizi conditions ambaye inaweza kufanya hali yako iwe mbaya unapopata hii ugonjwa.

Mheshimiwa Spika, nakumbuka mwaka jana wakati COVID-19 ilianza, aliyekuwa Spika wa hii bunge Madam Beatrice Elachi, aliweza kubadili calendar ya Bunge mpaka wakati serikali ilisema ugonjwa wa COVID-19 ulianza kurudi chini. Ningependa kuambia wale waheshimiwa ambao hawafurahishwi na hii maamuzi, waelewe hii maamuzi imetolewa kwa manufaa yao, ya wafanyikazi wa hii County na kwa manufaa ya wafanyikazi wa hii Bunge kwa sababu tukiendelea na hii hali, tukiendelea kuweza kukutana na hii ugonjwa unaendelea kujibadilisha kila uchao, na inakuwa na makali zaidi Mheshimiwa Spika, watu wengi wataweza kuathirika.

Na mimi najua, kati yetu kama waheshimiwa na wafanyikazi, tuko na wazazi wengine ambao ni wazee sana, na tunapenda kuwatembelea, lakini tusipoweza kujitunza tutawapelekea hii ugonjwa na tuwaweke katika hali hatari. Kwa sababu vile tunaongea na wewe Mheshimiwa Spika, mahali ninaishi majirani zangu kama watu kumi wameweza kulemewa na hii ugonjwa na wakaenda mbinguni, hii kitu si

mchezo Mheshimiwa Spika. Vile tunaongea na wewe Mheshimiwa Spika, saa saba na nusu naenda mazishi ingine iliyosababishwa na hii ugonjwa ya COVID-19. Ningeliomba Waheshimiwa waunge mkono hii mswada na tuweze kubadilisha kalenda ya hii Bunge mpaka siku ile tutaona hii ugonjwa imeweza kugandamizwa na serikali na ile mikakati imewekwa na Wizara ya Afya ya watu kukaa umbali, kuvaa barakoa na kuweza kujikinga na hii ugonjwa, ningeliomba kwa unyenyekevu, Waheshimiwa waunge mkono hii mswada, na ningeliomba Kiongozi wa Walio Wachache, Mheshimiwa Spika, aweze kuunga huu mswada mkono. Kwa hayo machache ningelipenda kumualika kuunga hii mswada mkono. Asante Mheshimiwa Spika.

Hon. Michael Ogada: Mr. Speaker Sir, I stand to second the Motion that has been brought about by the circumstances in which we live now. The Leader of the Majority Party has really explained what is going on and we have had a meeting with you severally to really look at the same. One thing we are all in concurrence is that nothing is as important as life. You don't need work if you are not healthy because you can't work. We simply come to work in order to provide for our families and maybe to take care of their health as a result of what we get and if we know our coming here could be one of the contributing factors that is going to affect our families, then the only honorable thing to do is to allow ourselves to take at least some few weeks or days to see how this thing goes around.

Because as I speak with you, I have lost at least three friends, two of them are my former lecturers who were my project supervisors, one comes from Eldoret, the other one comes from Siaya. They were sick for just like two to three days. I just lost another senior police office friend yesterday who became sick just the previous day and she is now gone. So we can really say this thing is real, this thing is serious. And just as the Majority Leader was talking about it, several Members here including staffs have really been affected.

The only honorable thing that we can do as a result of the request of the President, who is the Head of State, is that let us take a break and really study how things are going around. By the grace of God, if it will have subsided in the next few weeks, then we will be back. But if it will continue to be the way it is misbehaving, then it is only safe for people to be at least far apart, being far apart is to give you time so that you can be with your family. It is very difficult for me, particularly somebody like me, I have a father, he is 89 years old, and as a result of the pressure within this place, I am unable to go and see him because I am not sure whether that particular day I am safe, so you just have to talk to him on phone and you know somebody who lives in the village and is 90 years old, even him hearing you on phone is another issue, so it is just difficult, it is a very difficult life.

So Mr. Speaker, I am in total support of what is happening. Members did raise the issues that if we are going to go on recess because of this, they could continue with the virtual committee meetings. But as we were discussing with you, we realized that even the staffs themselves will have to do a lot of interactions so that at least they make things to move in committees, which also we realized is going to affect many staffs so I think it is only safe that we take a whole break, for let's say two, three weeks, as we study the situation, and if there is a special need Mr. Speaker, I know definitely you are going to call for a special sitting, so we will be able to conduct the affairs of the Assembly. Otherwise Mr. Speaker Sir, it is a serious concern to most of us and several Members as it has been said, are sick either at home, or some are in hospital, the only thing we can do is to pray for them and I know God is going to help them. Otherwise Mr. Speaker Sir, I beg to second.

Hon. Speaker: Thank you.

(Question proposed)

Hon. Speaker: Minority Whip? ICT please try to work on the gadgets.

Hon. Peter Imwatok: Hon. Speaker, allow me to say one or two things. First of all, is to congratulate your office for steadfast leadership that you have shown this County Assembly since inception or the beginning of this corona virus pandemic. Mr. Speaker I have two or three issues to raise. Number one Speaker, it's been said, as a Seventh Day Adventist, I don't participate so much on Christmas and Easter festivities, but indeed it is important as a County Assembly of Nairobi to applaud the President and his government for a good job done during Easter, by suspending all the travels in the five counties.

Hon. Speaker, as you were just sharing with me in your office, how you have lost some of your friends, the Majority Leader just informed me how our friend from South C, the best friend of NMS has passed on; the Minority Leader shared with me how he lost two of his lecturers who were supervising his project. Hon. Speaker, when you look at the politicians who want to take advantage of every situation to gain political mileage, the likes of Murkomen and the rest, castigating the President for closing these five counties, it is something that as the leaders of the capital city, we must come out and condemn and ask them to have utmost respect for the President. This is because some of us we know what COVID-19 is because we have experienced it.

Hon. Speaker, number two, we also implore upon the press in particular to be so much responsible in their reporting. Parliamentary practices dictate that every parliament observes and respect its calendar. That does not exempt us from the Presidential directive. When I woke up today morning, the reporting in particular, the Star Newspaper, reported the sitting of this Assembly in a very negative way, including casting aspersions against your persona. Hon. Speaker, we know corona is there, the newspaper has to be sold, but kindly we are asking the media, before you report anything pertinent as such, that the Speaker has defied, no, even National Parliament had to recall Assembly to make sure the Assembly is properly adjourned procedurally. Therefore, this is a message to our media, in particular the Star Newspaper, I was not pleased with the reporting on this city. We are responsible leaders, we know what ought to be done and there are parliamentary practices and precedents that Speaker you must adhere to at all times as the Honorable Speaker of this House. I therefore implore the Star Newspaper respondents if they are here that they owe this Assembly and the Speaker an apology for the writing they did today.

Number three, Hon. Speaker, we must now talk as leaders of this County. Some of us, we have gone through this COVID-19. A night before yesterday, a friend of mine called me past midnight, we walked across the entire city, there were no beds just to admit a patient of COVID-19. Unfortunately, the patient also had underlying conditions, we traversed this city until morning without getting medicine. There is particular prescription we were given, we bought one vial at Kshs 400,000, by yesterday at 9.30 a.m. in the morning. We had to buy four vials at Kshs 1.6 million.

Hon. Speaker, the situation of health is wanting, that one brings me to a point to congratulate the Director General NMS, for making some re-alignment on the directorates. Speaker, this is a capital city, we cannot depend on permanent hospitals which are there. There are no beds in Kenyatta, no beds in Nairobi Hospital, even for the rich, no beds in Karen for the affluent people, no beds in Aga Khan, in Mutuini, no beds

in Mama Lucy or Mbagathi. Hon. Speaker, we have fields in this county, we have Nyayo Stadium, Kasarani, we implore upon NMS and the County Government, it now not about NMS alone, the acting Governor should take responsibility and work in concurrence with NMS to provide temporary isolation centers with ventilators to our people.

Hon. Speaker, it does not add any value if you are going to build roads for Kshs 5 billion and there are no citizens to drive or walk on those roads. We need health to offer our people. Assume Speaker in my ward in Makongeni, a ten by ten house, a father is diagnosed with COVID-19 and he has six children in the same house, where is he going for isolation? Where is this old man going to go for isolation without affecting the family?

Hon. Speaker, NMS must wake up to the call because of the transferred function into the county Government. The County Government must also under the leadership of the acting Governor, wake up to the responsibility of citizens because we will not sit and keep quiet when things are not going in the right direction.

Therefore, Hon Speaker, I want to implore the Majority Leader and Minority Leader in this House because Minority Leader is a culprit like me. Therefore, I implore the two of you as the lead political leadership of this County currently as it stands, there are issues we can make a decision and make sure that the County Government and the NMS must implement Mr. Speaker.

If these trends continue this way Speaker, in the next two weeks or three we will not have anywhere to attend a patient of COVID-19. Therefore, Speaker last time we did a supplementary budget of one point something billion and we gave NMS strict instructions that this money was primarily to create an isolation Centre across Nairobi. We singled out Kasarani Centre or Nyayo Stadium, where we do proper isolation centers and ventilators, when we are caught up with this disease the Government can take responsibilities.

Therefore, Hon. Speaker whether we build roads or bulldozers of roads without health, a wise man said that health is wealth; if you are healthy, you can achieve anything. You can maneuver driving in a pothole road but if you are not healthy even an ambulance cannot come to collect you.

Therefore Hon. Speaker, I urge the Majority Leader - because we are going on a definite recess and your Minority Leader and you Hon. Speaker - let us give the leadership to the County in times of this epidemic. Thank you, Speaker.

Hon. Speaker: Thank you. ICT I am trying to get hold of Hon. Warutere who is on Zoom. There is a problem with ICT. Hon. Member Warutere we are having a challenge! In the meantime, ICT let us have Hon. Wanyoike as you trying to organize your systems so that Hon. Warutere can be able to contribute.

Hon. Peter Wanyoike: Thank you, Mr. Speaker I rise to support this Motion and let me first of all congratulate and thank the leadership of this House, for coming up with this idea. Mr. Speaker, it is worrying that as the Hon. Member and the Leader of this House have just said that he contracted this disease.

Mr. Speaker, I am aware that many Hon. Members out there who are ailing this disease. My message I want to send out there to our electorate is that they take caution because it is as if they seem as if they are denied chances to run their businesses and have their normal lives. Mr. Speaker, as we adjourn this House I think it is also our duty and mandate to go out there and inform our electorates that this disease is killing. I beg to support.

Hon. Speaker: Thank you. I understand now that ICT is ready to get *Mheshimiwa* Warutere. Proceed, Hon. Member.

Hon. Peter Warutere: Hon. Speaker, I do not know if I am audible but if indeed I am I just needed five minutes to stand in support of this very important Motion. I have been a victim. I happened to be a victim away in a country outside this country. I know how it feels four of us contracted COVID-19 and as we speak one of our colleagues has not turned negative and as in a foreign land without proper insurance, the medication I can tell you is very stigmatizing.

How I pray that all the MCAs take this thing very seriously. I want to confirm what my Majority Leader has said that this is not something you can even wish even your worst enemy at any given point. For seven days I have not eaten; I could not eat anything and I lost 7 kilograms within one week. I saw death next to me, I can tell you that this is something that you have to take extremely seriously. There are no beds, drugs; things are not functioning and you cannot eat. The only thing you can do is to stay in bed.

The next thing you hear is that someone has died, what has happened you feel probably now being the statistics you would be the next person. I pray that we should take this very seriously and know that COVID-19 is with us and it is the number one killer it is going to kill many people and the best we can do is to avoid been infected. I am lucky that at least I was able to come from India (*The Member spoke off-record*) ... the food is delivered in the door, you need oxygen, you cannot go out of that door to go and get that food or oxygen.

I tell you ladies and gentlemen when you have an opportunity and God has given you an opportunity please be precious as it is. I thank God that at least I am well and I have turned negative and I can enjoy with my family. I would like to tell you for free people need to take this very seriously this issue of COVID-19.

We have no business being in that Assembly; let us keep safe and once we are safe let us support the president. Thank you, Hon. Speaker and all those who are sick get well and hopefully we will rejoice again. Thank you very much, Hon. Speaker.

Hon. Speaker: Thank you. ICT also try and get hold of Hon. Nancy Muthamia but in the meantime can I have Hon. Themendu.

Hon. Jeremiah Themendu: Thank you, Hon. Speaker, I rise to support the Motion and give a few remarks. That the COVID-19 pandemic is here with us and our people are suffering and I thank the leadership of this Assembly because they have seen it is wise to continue with doing our business of legislation, oversight and also representing our people. You know very well that the Government departments cannot stop working because like now we need water, streetlight and many projects in our wards and we need to do oversight. Therefore, I would like to thank them for the same but I would like to add another issue here. Last year I remember we had proposed Kshs 1 million per ward because our people are suffering a lot and their business has collapsed.

The Coronavirus is here with us and we do not know how long it shall take but we need to look at our people who are unable to find themselves and find how we can try to use the disaster management fund and give them some food. I think this can help. I can urge NMS and the Governor to come together and find a way of giving them at least some food to sustain themselves.

Hon. Speaker, the pandemic is here with us and I know when we are there we shall teach our people that the disease is there and they should wear the mask, sanitize and keep their distance. Because the ignorance is there with our people we need to teach them how they can behave although even ourselves we are being attacked by the same disease. Therefore, as far we are praying to God to put aside this pandemic but we should find something that can sustain our people on the ground if it is possible Hon. Speaker and I think it is possible.

I think it is possible because as I had said earlier, last year I had proposed Kshs 1 million per ward in Nairobi County because as you know it has been affected more than any other county. I do not know what happened because we heard that money that was given by World Bank and NACADA to help the suffering Nairobians was used the other day by NMS and it was not used here in Nairobi.

I request for your indulgence that you make sure that Nairobians are being taken care of by either the NMS or the Governor of this County. With those few remarks, I beg to support Hon. Speaker. Thank you.

Hon. Speaker: ICT can we have Hon Muthami? The let us have Hon. Ngengi in the meantime as the ICT looks for the Hon. Member.

Hon. Daniel Muturi: Thank you Hon. Speaker. I rise to support this Motion that has been brought to this House by our very able Leader of Majority, Hon. Abdi Hassan Guyo. And seconded by our equally able Minority Leader Hon. Ogada.

Hon. Speaker, I will not dwell on a lot of things since my equal intelligent colleague Hon. Imwatok has pretty summarized what we need to do. However, a point of information is that; we are at war with a disease that is invisible, we are at war with an enemy that we cannot see, and we are at war with an enemy floating in the air who does not know age, creed, colour, race or any other standing. Hon. Speaker, if we were on a physical war with another country, a state of emergency would be declared. Thus, the President has declared a state of emergency against the COVID-19 pandemic.

Hon. Speaker, as I walk around, you hear people say there is no corona. It is very unfortunate because all those who have contributed before me have a story to tell. It is very sad that in my ward I have a lady and a gentleman who have buried both their parents within two weeks, every week a funeral. As Hon. Themendu has said, we need to find ways of helping our citizens because every morning I am finding myself being added to groups and phone calls even during the Easter holidays where all of the deaths are COVID-19-19 related. We have reached to a level of helplessness Hon. Speaker as we are not working, we do not have resources and even cannot isolate in a nine by nine.

I would like to articulate one thing, NMS need to figure out with health being a devolved function that was transferred, we need temporary structures in our stadiums or churches or schools. This had been proposed from a long time ago. We need to have these facilities with oxygen and the relevant medications to treat the symptoms because it is very sad. We used to hear numbers from CS Kagwe and those numbers have become names of the people we know; people we are related to.

Hon. Speaker to summarize to Nairobians, to Kenyans and to the world because this is not a disease that is confined in Nairobi or Kenya, it is a pandemic. I would like to quote the UK prime Minister, Boris [Johnson], he said, 'The biggest gift that you can give to your parents is not to visit them'. Not because you

do not love them. Every time I hear my mother's voice - I am still her son despite being in the assembly - she still refers my as my son.

There is an incidence that I witnessed Hon. Speaker, and I will not mention names here; where a certain gentleman was sick and he visited his father who was taken to hospital. In the next day or two and he [father] passed away which is a very sad case. Hon. Speaker, one of the things that I would like to beg my fellow Hon. Members and our electorates is to keep our parents as safe as possible and to keep our families as safe as possible. We can only do that through what the Hon. Majority Leader said that is, follow government protocol of sanitizing, wearing mask and keeping distance.

With those few remarks, I beg to support. Thank you.

Hon. Nancy Muthami: Hon. Speaker----

Hon. Speaker: Proceed Hon. Member, I can hear you.

Hon. Nancy Muthami: Thank you Hon. Speaker. I want to concur with the Majority Leader. I fully support this Motion because I have been a victim before. Until you get there is when you know how serious this disease is. I urge Hon. Members to go to the electorate (*The Member spoke off-record*).

I support the Majority Leader on this Motion. Thank you Hon. Speaker.

Hon. Speaker: I call the mover, the Majority Leader, to reply.

Hon. Abdi Hassan: Asante Bwana Spika ningelitaka kujibu. Nachukua hii fursa kuwashukuru Waheshimiwa wote kwa kuunga Mswada huu mkono. Inaonyesha kuwa Waheshimiwa wanajali wenzao na hata wafanyi kazi wa hii Bunge.

Ningetaka pia Mheshimiwa Spika kuwaambia Waheshimiwa wasitangamane na watu sana kwa kuwa hii sio wakati wa kutangamana, ni wakati mgumu na mbaya sana. Waheshimiwa wote waweze kuzingatia yale masharti yote yamewekwa na Wizara ya Afya. Kwa hayo machache, ningelitaka kujibu. Asante Mheshimiwa Spika.
