#### STATEMENT

RESPONSE TO A STATEMENT REGARDING RECRUITMENT OF COUNTY CONSTABLES

**Hon. Pater Wanyoike:** Hon. Speaker, on 9<sup>th</sup> February 2021, Hon. Redson Otieno, MCA, rose on the floor of the Assembly pursuant to Standing Order 45 (2) (c) and requested the Chairperson of the Sectoral Committee on Labour and Social Welfare for a Statement regarding the recruitment of County constables.

In the Statement, the Member requested that the Chairperson should inquire into and report on:

- 1. The criteria used by the County Public Service Board in the recruitment of County constables and the report of the outcome of the recruitment process; and
- 2. Steps that the County Executive is taking too ensure that all qualified persons called to collect their appointment letters are handed their letters.

Hon. Speaker, the Committee met the secretary of the County Service Board to deliberate on the Statement. Hon. Redson Otieno was also invited to the said meeting, pursuant to Standing Order 45 (2) (e). Hon. Speaker, in this regard, I wish to report to the Assembly as follows:

The criteria used by the County Public Service Board in the recruitment of County constables and the report of the outcome of the recruitment process

Madam Speaker, the Board commenced recruitment by advertising the provisions in the daily newspaper, that is Standard newspaper dated 4<sup>th</sup> March 2020 and the County Public Service Board website.

At the close of the application notice, the Board had received 20,688 applications for the position of the County constables and 12,437 applications for the position of the County firemen/women.

The Board commenced the exercise of shortlisting and it was successfully done on the consideration of the following criteria:

1. Gender, regional diversity, Academic qualification, age among others.

The names of shortlisted candidates were published on the County Public Service Board website and thereafter the date was set for an interview that was from 9<sup>th</sup> to 21<sup>st</sup> September 2020 and 5<sup>th</sup> November 2020 respectively.

During the interviews, the Board used the following criteria in selecting the best candidate.

- 1. Confirmation of the documents
- 2. Identification of candidates and physical fitness among others.

At the end of the exercise, the candidates were rated, through a scorecard rating total generated by the department technical team.

The Board selected 800 number of successful candidates for the position of the County Constable and 300 for the position of firemen and consequently issued appointment letters. All successful candidates were informed through the website, text message and our various notice board.

Likewise, the recruits were dispatched in their respective sector for training and the County secretary was advised to factor them in the payroll effective 12<sup>th</sup> November 2020.

Steps that the County Executive is taking to ensure that all the qualified persons called to collect their appointment letters are handed their letters.

Hon. Speaker, to make sure no unqualified person is employed the Board has written to Kenya National Examination Council and DCI to verify the documents presented to the Board during the recruitment.

Hon. Speaker a copy of the detailed response has been given to Hon. Redson Otieno MCA and further copies are hereby attached to the report. Thank you, Madam Speaker.

Speaker, I beg to give notice of the following Motion: aware that in the Nairobi County Persons with Disability Act 2015 passed by the Assembly on 22<sup>nd</sup> December 2015, assented into law on 12<sup>th</sup> January 2016 and subsequently gazetted vide the Nairobi City County Gazette Supplement No.24 Act No.9;

Further aware that Section 4 of the said Act establishes the Nairobi City County Board for Persons with Disabilities with its membership specified in Section 5 of the Act, which includes: -

- 1. Three persons nominated by the organizations representing persons with various categories of disability within the County;
- 2. Two members appointed from a panel of names submitted to the CECM by organization for people living with disability (PWD) subject to approval by the Assembly;
- 3. Chief Officer or Director representing the following departments;
  - a) Culture and Social Services
  - b) Education
  - c) Labour; and
- 4. Such other members as may be co-opted by the Board subject to approval by the County Assembly.

And appreciating that Section 5(2) of the Nairobi City County Persons with Disabilities Act, 2015 provides that the membership of the Board shall not exceed eleven persons, out of whom at least half of the members shall be persons with disabilities. Noting that the Nairobi City County Assembly, through the Sectoral Committee on Labour and Social Welfare, vetted and approved the nominees to the Nairobi City County Persons with Disabilities Board as it were, Being;

Further disturbed that the term of the first Persons with Disabilities Board ended prior to its realization. Acknowledging that the Annual Development Plan for the Financial Year 2021/2022 has addressed the same; this Assembly resolves that the Nairobi City County Public Service Board urgently re-appoints earlier approved and gazetted Members of the Nairobi City County Persons with Disabilities Board, vide Gazette Notice No. 9 of 2015 on 28th July 2017 as it were for an extra term.
