COMMUNICATION FROM THE CHAIR

CONVENING OF THE SPECIAL SITTING

Hon. Deputy Speaker: Hon. Members, pursuant to Standing Order 43 (2), I have the following communication to convey regarding today's special sitting:

Hon. Members, may I first of all take this opportunity to welcome you all to today's special sitting which has been convened at a time when the Assembly is on long recess. I sincerely thank you for honoring the invitation despite the short notice and cutting short your deserved break during this festive season.

Hon. Members, this special sitting is of great significance to the people of Nairobi City since it is likely to mark the end of the transition period following the general elections held in August, 2022. Without appearing to pre-empt debate, after today's sitting we expect the County Government to be now fully constituted. Therefore, Nairobians will expect nothing but uninterrupted service delivery from us.

Indeed, Hon. Members, on the request of the Leader of the Majority Party vide a Memo dated 22nd December, 2022, the Hon. Speaker, Kennedy O. Ng'ondi convened this Special Sitting vide Gazette Notice No. 15933 dated 23rd December, 2022 in order to consider the following business: -

- (i) Administration of Oath on the Member-Elect for Utawala Ward; and
- (ii) Consideration of the reports of various Sectoral Committees on the vetting of nominees for appointment as Chief Officers.

(Applause)

In this regard, Hon. Members, the Chair wishes to remind you of the provisions of Standing Order No. 32 (4) which provides that, and I quote;

"Whenever the County Assembly meets for a special sitting, the Speaker shall specify the business to be transacted on the day or days appointed and the business so specified shall be the only business before the County Assembly during the special sitting, following which the County Assembly shall stand adjourned until the day appointed in the County Assembly calendar".

Accordingly, Hon. Members, the Chair will not and I repeat will not entertain any other business apart from the gazetted business and once we conclude, the House shall stand adjourned in accordance with the calendar. I therefore take this earliest opportunity to wish all of you a happy Merry-Christmas, for those who believe, and a prosperous New Year 2023.

ADMINISTRATION OF OATH TO THE MEMBER - ELECT FOR UTAWALA WARD

Hon. Members, on the Order beforehand, as you are aware, the residents of Utawala Ward did not elect their Member of the County Assembly during the last general elections. This led to a by-election that was held in the said ward on 8th December, 2022.

Therefore, Hon. Members, before we proceed with this Order, I wish to remind the House that the Constitution of Kenya under Article 74 provides that, and I quote;

"Before assuming a State office, acting in a State office, or performing any functions of a State office, a person shall take and subscribe the oath or affirmation of office, in the manner and form prescribed by the Third Schedule or under an Act of Parliament."

As you are aware, the Office of a Member of County Assembly is among those defined as a State office under Article 260 of the Constitution. Consequently, Hon. Members, following the aforesaid by-election, the IEBC in a Gazette Notice No. 15569 dated 16th December, 2022 declared Hon. Patrick Karani as the duly elected Member for Utawala Ward.

One day while still in this Assembly, I want to see those constables down there working so hard knowing that one day they can be Chief Officers as opposed to the tradition of sourcing from the National Government. Madam Speaker, it is a good move and if this House is going to approve, I think I will be the proudest chairman to have sat through the vetting to ensure that we promote diversity.

As I reply, I wish to wish everyone a Merry Christmas, and since we are not going to see each other till January 2023, I wish you all the best, stay safe. Thank you.

Nominee, Geoffrey Omatoke Mosiria – Health Facilities, has over ten years' experience. Tom Michira Nyakaba has over 15 years' experience and Dr. Irene Njeri Muchoki has been an employee of this County under Health Commodities and has lot of experience.

Hon. Peter Imwatok: Madam Speaker and the entire House, allow me to say a few words on the last Motion. First, congratulations Madam Speaker, I have never sat in the Assembly while you are presiding.

Hon. Speaker, I want to go on record on HANSARD that this Assembly is not an open cheque, especially that the Majority Party has decided to work with the government of the day in order to deliver to the people of Nairobi. I have keenly listened from Motion No. 1 to Motion No.20; carefully and patiently waiting for the recommendations of the reports.

Hon. Speaker, I believe it is better for one not to appear before the committee than let Nairobi down as this gentleman has done. For those nominees that have been approved by this Assembly today, we want to tell them that it is not business as usual. It is not about being a chief officer; it is about delivering services to the people of Nairobi. More importantly, is to respect the Assembly. Hon. Speaker, I want also to intone that for those who have been rejected, others should learn from this; that history never lies. Some of them have been in this County and they think that they are bigger than the Governor and bigger even than the Queen of England.

You could call somebody and he feels that an MCA deserves Kshs. 10,000. Nobody was elected as a poor person in this chamber. No MCA in this chambers is equivalent to 2010 generation of MCAs. We are here to do our job in a proper, professional and in a legislative manner.

I want to congratulate the entire Azimio team; we have the number and we can transact any business in this county without UDA.

(Applause)

We want to tell Nairobians that they should not be afraid, service delivery has to be done. To the Governor, you have our back. As long as it is for the interest of Nairobians, we will support you fully. Our oversight role begins in earnest. We now have the CECs and the Chief Officers, accountability begins now. Any Chairperson that goes to the CEC's office and is treated like a rag, kindly let me know as the leader of this House.

They say garbage in, garbage out. With those few remarks I congratulate you, Madam Speaker once again and the entire House. Thank you.
