Hon. Temporary Speaker: Hon. Members, you may now be seated. Clerk please confirm whether we have quorum.

(The Clerk-at-the Table confirmed there was no quorum)

Hon. Jeremiah Themendu: Thank you Madam Speaker. I beg to give Notice of the following Motion:

THAT, aware that Chapter Four of the Constitution of Kenya 2010 provides for the Bill of Rights and freedom of any person in the country which include inherent dignity and the right to have that dignity respected and protected;

Right to clean and healthy environment, right to the highest attainable standards of health which includes right to healthcare services, right to accessible and adequate housing and to reasonable standards of sanitation, right to be free from hunger and to have adequate food of acceptable quality and right to clean and safe water in adequate quantities.

Further aware that Part II of the Fourth Schedule of the Constitution provides for the functions of county governments which includes county planning and development, county health services, water and sanitation services amongst others;

Concerned that the recent inhumane demolitions in parts of the county targeting buildings and other structures in riparian land have left several families in agony and frustrations; further concerned that the rights of the affected families have been infringed after being left in unhealthy environment with improper sanitation and lack of clean water;

Acknowledging that Regulation 6 (c) of the Environmental Management and Coordination Regulations 2009 provides that a person shall undertake or cultivate any development activity within full view of a river or stream to a minimum of six meters and a maximum of 30 meters on either side based on the highest recorded flood level;

Noting that the demolitions were undertaken haphazardly and inhumane manner without proper assessment of the areas, this assembly urges the county executive in conjunction with the relevant national government agencies to:

1. Conduct a survey to establish the exact measures to be considered as riparian land for the affected families to rebuild their structures in appropriate areas;

- 2. Compensate the affected families whose structures were erroneously demolished;
- 3. Relocate the affected families to alternative safer areas.

REOUEST FOR STATEMENT REGARDING PAYMENT OF WARD DEVELOPMENT FUND PROJECTS FOR THE PERIOD FROM 17TH SEPTEMBER 2017 TO DECEMBER 2022

Hon. Redson Onyango: Hon. Speaker, pursuant to Standing Order No.47 (2) (), I wish to request for a statement from the Chairperson of the Select Committee on Ward Development Fund regarding the payment of Ward Development Fund projects for the period from 17th September 2017 to December 2022.

Hon. Speaker, the County Assembly enacted the Ward Development Fund Act 2014 with the principal aim of undertaking development projects such as roads, lighting, water and drainage, schools, hospitals amongst other projects across the county.

Hon. Speaker, it is sad that there were irregularities in payment of the Ward Development Fund projects where some contractors who had submitted their projects completion certificates were not paid. It was noted that where such contractors were awarded other contractors by the county, they are not able to proceed to the site due to failed payments of previously completed projects.

Hon. Speaker, in the statement, the Chairperson should inquire into and report on:

- 1. List of Ward Development Fund projects that were paid for the period from September 2017 to December 2022;
- 2. Reasons for nonpayment of completed Ward Development Fund projects for the period from September 2017 to December 2022 yet the projects for the financial year 2022-2023 were paid; and
- 3. Measures the County Executive is taking to ensure payments of all completed Ward Development Fund projects before commencement of new ones

REQUEST FOR STATEMENT REGARDING MANAGEMENT OF CITY MORTUARY

Hon. Redson Onyango: Hon. Speaker, pursuant to Standing Order number 47 (2c), I wish to request for a statement from the chairperson of the sectoral committee on Health Services regarding the management of city mortuary.

Hon. Speaker, the county is mandated to manage the county health services including cemeteries, funeral parlors and crematories pursuant to the provision of Paragraph 2 of Part Two of the Fourth Schedule of the Constitution of Kenya 2010.

Hon. Speaker, it is alleged that the management of city mortuary is smeared with cases of corruption amongst its employees especially those employed as casual laborers.

Hon. Speaker, it is alleged that there are unknown bank accounts operated by the management of city mortuary which are not accounted for by the county executive.

Hon. Speaker, in the statement the chairperson should inquire into and report on;

- 1. Bank accounts and signatories operated by the city mortuary management
- 2. Number of bodies received and released at the city mortuary since January 2022 to date
- 3. Payments of the bodies released from the city mortuary since January 2022 to date
- 4. Forms of payment paid to city mortuary
- 5. Number of employees both permanent and pensionable and casual laborers since January 2022 to date
- 6. Payment made to the casual laborers since January 2022 to date
- 7. Proof of payment of casual laborers since 2022 to date.
