QUORUM

Hon. Speaker: Hon. Members, you may be seated.

The Chair has been informed that there is quorum in the Assembly, allowing us to proceed with the business of the day. Kindly Clerk, call out the Order.

PAPERS

Hon. Speaker: Hon. Members, under Order No. 5, I am made to understand the Clerk-atthe-Table is supposed to be in receipt of a Fiscal Strategy Paper to be laid. In the sequence of business, I direct that we proceed with other business and allow the Chair to proceed when ready.

STATEMENTS

REQUEST FOR STATEMENT REGARDING ILLEGAL CONSTRUCTIONS IN THE COUNTY

Hon. Speaker: Hon. Stazo Omung.ala, on behalf of the House Business Committee. Is he in?

Hon. Stazo Omung'ala: Hon. Speaker, pursuant to Standing Order No 47 (2) (c), I wish to request for a Statement from the Chairperson of the Sectoral Committee on Lands, Planning and Housing regarding illegal constructions in the County.

Hon. Speaker, Part II of the Second Schedule of the Constitution of Kenya provides that the urban planning functions shall be executed by the county government. Specifically, county governments are responsible for approval of development in Nairobi County. This is conducted by the Urban Planning Technical Committee. However, cases of buildings collapsing have been reported in recent years because developers either bypass the approval process or obtain the same irregularly and construct way above the stipulated floors level. Further, some developers construct buildings without public participation, in violation of Physical and Land Use Planning Act, 2019.

For instance, a developer is doing a construction on a piece of land designated as LR. No. 82/3716 and also 1960 in Upper Savannah Ward along Savannah Road in Donholm, allegedly without the relevant approvals from the County. In addition, there is no evidence that public participation was conducted prior to the commencement of the construction.

Hon. Speaker, in the Statement, the Chairperson should inquire into and report on: -

- 1. Whether the developer obtained relevant statutory approvals including development approvals from the County;
- 2. Whether the developer conducted public participation prior to obtaining the approvals, if any;
- 3. Whether the approvals, if any, are compliant to the zone floor level limit; and
- 4. Enforcement measures put in place to ensure developers adhere to development regulations and approved development plans.

Hon. Speaker: Chairman, Planning Committee, kindly give an undertaking.

Hon. Alvin Palapala: Thank you, Hon. Speaker. You recently made a communication, we are coming up with a schedule for site visits, and this will be part of it. If he can give us two weeks.

Hon. Speaker: Okay. Hon. Stazo, are you okay?

Hon. Stazo Omungala: Much obliged, Chair

Hon. Speaker: Thank you. Hon. Members, before we proceed with Order No.7, I just want to urge the House to take matters of this House seriously. As it appears in the Order Paper, you are just about to be requested to commit to your duty as a legislature and consider amendments on our Standing Orders. It is something that needs serious attention because the proposals came from the Procedure and Rules Committee, and it is before the Assembly for consideration. So, kindly be guided. Let us proceed. BUSINESS APPEARING BEFORE ASSEMBLY FOR WEEK BEGINNING 16TH APRIL 2025

Hon. Nicholas Okwacho: Thank you, Hon. Speaker.

Hon. Diana Mwangangi: Hon. Speaker, pursuant to Standing Order No. 47 (2) (a), on behalf of the Assembly Business Committee, I rise to give the following Statement regarding the Business appearing before the Assembly for the week beginning Wednesday 16th April 2025.

Hon. Speaker: Thank you, Hon. Nickson Juma. Hon. Members, as I had communicated earlier on deferring business under Order No.5 on Papers laid, I am notified by the Clerk-at-the-Table that the said Papers are ready for tabling. Hon. Wilfred Odalo: Hon. Speaker, I beg to give notice of the following Motion:

THAT, this Assembly adopts the report of the Select Committee on County Finance, Budget and Appropriations on the Nairobi City County Fiscal Strategy Paper and the Debt Management Strategy Paper for the financial year 2025/2026 and over the medium term, laid on the Table of this Assembly, today, Wednesday 16th April 2025.

Hon. Speaker: Thank you. Hon. Members, when you go through the Order Paper, we are supposed to be in Order No. 8, but I would like to remind you that Order No. 8 is on the Memorandum by the Governor of the Nairobi City County, under County Governments Act, Section 24 (5). Standing Order No.77 requires that we call for the division of the House.

I have been notified by the Clerk that we are less to form a required number of Members present in the House. Under the Standing Order, it requires that we must get at least 83 Members before we consider the Memorandum. At the same time, I am privy to the Memorandum by the Governor, and the feeling of the Committee of Education is that they have reservations and would want to overturn the Memorandum. For that reason, it is a requirement that we need to form a Whole House where we are more than 83 Members in number.

Hon. Members, I direct that the Order No. 8 be set aside as we proceed with other Orders until such a time the Chair will be convinced that the House has a number to transact Order Number 8. Hon. Members, you stand guided.

MOTION

ADOPTION OF REPORT ON CONSIDERATION OF PROPOSED AMENDMENTS TO THE NAIROBI CITY COUNTY ASSEMBLY STANDING ORDERS

Hon. Speaker: Do we have the Leader of the Majority? The Leader of the Minority? The Deputy Majority Leader, kindly – Sergeant-at-Arms, assist the Deputy Majority Leader. Just be seated, Hon. Member, they will guide you. We are in Motion No. 9. I am worried, do you have the Motion with you?

Hon. John Ndile: No.

Hon. Speaker: Hon. Members, kindly be settled. I am informed by the Office of the Clerk that the Committee on Procedure and Rules has a membership of 11, and the Hon. Deputy Majority Leader is not a member. So, he cannot transact on behalf of the Committee. In line of order, the Speaker is the Chair, the Vice is the Deputy Speaker, No. 3 the Leader of Majority, No. 4 the Leader of Minority, and then the Whips. For that reason, the Hon. Majority Whip is in the House, so let him act on behalf of the Committee. Kindly guide the Whip.

Hon. Moses Ogeto: Thank you for giving me this opportunity, Hon. Speaker. I thought when you are a deputy, you are supposed to take the responsibility of the boss. Now with your authority, I want to respect it because you are the head of this institution and the protector of the law. That notwithstanding, I move the following Motion;

THAT, this Assembly adopts the report of the Select Committee on Procedure and Rules on the consideration of the proposed amendments of the Standing Orders, laid on the Table of the Assembly on Tuesday 8th April 2025.

Hon, Speaker, as Members of the Rules and Procedure Committee, we sat in Nakuru and deliberated on issues which I believe the Hon. Members have seen on various amendments to the Standing Orders, including the one where the Members of County Executive Committee are supposed to appear and answer questions from Members directly before the plenary. We did amendments of Standing Orders Nos. 36 (a), 208, 108, and 109. We brought new Standing Orders Nos. 137(a), 206, 151(a) and 236A.

The Committee is requesting that if this Assembly approves these amendments, it will allow many Members to be able to interact with the CECs, and also reduce the duration which the Executive takes to reply Members' Statements, provisions of the law and statutes which will help this Hon. House to transact its business.

With those few remarks, I request my counterpart to second this Motion.

Hon. Mark Mugambi: I also wish to extend my gratitude to Members, yourself included, Hon. Speaker, for finding time to travel to Murang'a to accompany Minority Leader for the burial of his sister which happened yesterday. Hon. Moses Ogeto: Madam Chair, I beg to move:

THAT, the Standing Orders be amended by deleting the Standing Order 42 and substituting therefor with the following new Standing Order: -

Weekly programmes of the Business of the County Assembly

42. The Clerk shall prepare and publish on the County Assembly website a weekly programme showing the business of the County Assembly, a tentative list of County Executive Committee Members scheduled to reply to Questions and provide Reports to the County Assembly, and a schedule of sittings of the various Committees; and shall circulate such programmes to Members, Sectors, and the media not later than the Friday of the week preceding such business.

(Question, that the words to be inserted in place thereof be inserted, put and agreed to)

(Standing Order 42 as amended agreed to)

Standing Order No. 43

Hon. Moses Ogeto: Madam Chair, I beg to move:

THAT, the Standing Orders be amended by deleting the Standing Order 43 and substituting therefor with the following new Standing Order: -

Sequence of proceedings

43. (1) Each day after Prayers have been said and the County Assembly has been called to order, the Business of the County Assembly shall be proceeded with in the following sequence—

(a) Administration of Oath;

(b) Communication from the Chair;

(c) Messages;

(d) Petitions;

(e) Papers;

(f) Notices of Motion;

(g) Questions and Statements;

(h) Motions and Bills.

(2) Business shall be disposed of in the sequence in which it appears in the Order Paper or in such other sequence as the Speaker may, for the convenience of the County Assembly, direct.

(3) On Wednesday afternoon Questions and Reports by County Executive Committee Members shall have priority over all other business for a period not exceeding three hours.(4) The Speaker shall direct the Clerk to read the Orders of the Day without question put.

Standing Order No. 109

Hon. Moses Ogeto: Madam Chair, I beg to move:

THAT, the Standing Orders be amended by deleting the Standing Order 109 and substituting therefor with the following new Standing Order: -

Firearms and other Offensive Weapons

109. (1) A Member shall not bring a firearm or any offensive weapon into the Chamber or Committee Rooms and any such weapon must be deposited with the Sergeant-at-Arms for safe custody before entering the Chamber or Committee Rooms, and collected at the time of leaving the Chamber or Committee Rooms.

(2) Members with firearms must deposit it with the Sergeant-at-Arms for safe custody upon entry into the main County Assembly building.

(2) The Committee shall comprise the Speaker as chairperson, the Deputy Speaker, and not more than nine other Members. The Vice-Chairperson shall be elected among the nine Members of the Committee.

New Standing Order No. 36A

Hon. Moses Ogeto: Madam Chair, I would wish to move:

THAT, the Standing Orders be amended by inserting the following New Standing Order immediately after Standing Order 36:

36A Temporary suspension of a Sitting

(1) At any time during proceedings, a Member may, for reasons stated, claim to move "That, the Assembly do suspend its proceedings for ...(Minutes/hours) in order to...."

(2) The Speaker shall propose the Motion forthwith or if in the opinion of the Speaker that such Motion for suspension is frivolous, vexatious or an abuse of the proceedings of the County Assembly, decline to propose

(3) The debate on a Motion under this Standing Order shall be confined to the matter of the Motion.

(4) No Member speaking on a matter under this Standing Order shall speaker for more than five minutes, unless with the permission of the Speaker.

(5) A suspension under this Standing Order shall not exceed sixty minutes or such other time as the Speaker may direct.

(Question, that the New Standing Order 36 A be approved, proposed)

(Question, that the New Standing Order 36 A be approved, put and agreed to)

New Standing Order No. 47A

Notice of Question

THAT, the Standing Orders be amended by inserting the following New Standing Order immediately after Standing Order 47:

47A (1) A Member proposing to ask a Question in the County Assembly shall give notice to the Clerk.

(2) The Member shall deliver a signed copy of the proposed Question to the Clerk for submission to the Speaker for approval.

(3) Where the Speaker approves a Question and determines the County Executive Committee Member responsible for the matters to which it relates, the Clerk shall, at an appropriate time, publish the Question in the Order Paper.

(4) In scheduling a Question in the Order Paper, the Clerk shall consider the urgency of the Question as determined by the Speaker.

(5) The Leader of the Majority Party shall inform the County Assembly of the date, time and order in which County Executive Committee Members shall appear to reply to Questions and provide Reports to the County Assembly and Committees, subject to paragraph (7).

(6) A Member shall ask his or her Question on the day it is scheduled in the Order Paper.

(7) In determining the date and time when a County Executive Committee Member shall be required to answer a Question, the Leader of the Majority Party shall consider the urgency of the Question as determined by the Speaker.

(1) The Speaker may vary the order in which Questions shall be disposed of or defer a Question scheduled to be responded to.

(2) A County Executive Committee Member shall attend and answer any Question concerning matters for which the County Executive Committee Member is responsible.

(Question, that the New Standing Order 47 A be approved, proposed)

(Question, that the New Standing Order 47 A be approved, put and agreed to)

New Standing Order No. 47B

THAT, the Standing Orders be amended by inserting the following New Standing Order immediately after Standing Order 47A:

47 B (1) These rules apply to Questions raised in the County Assembly and replied to in the County Assembly or before a Committee.

- (2) Except as the Speaker may otherwise allow, a Member may not ask a Question which-
 - (a) is in effect a speech;

(b) is lengthy;

(c) is limited to giving information;

(d) is framed so as to suggest its own reply or to convey a particular point of view;

(e) includes extracts from newspapers or quotations from speeches;

(f) contains any argument, inference, opinion, imputation or ironical or offensive expression or epithet;

(g) seeks an expression of opinion;

(h) repeats in substance a matter already addressed by a Committee of the County Assembly or in the course of debate in the Assembly during the same Session;

(i) refers to more than one subject;

(j) includes the name of a person or a statement not strictly necessary to render the Question intelligible;

(k) contains an allegation which the Member is not prepared to substantiate;

(l) implies an allegation of a personal nature or which reflects upon the conduct of a person whose conduct can only be challenged through a Substantive Motion or upon the conduct of any other person otherwise than in that person's official or public capacity;

(m) relates to a matter which is sub-judice or which by any written law is secret pursuant to Standing Order 97 (Matters sub judice or secret);

(n) falls within the functions and powers of National Government as contemplated under Part I of the Fourth Schedule to the Constitution of Kenya 2010;

(o) seeks a reply that is readily available in ordinary works of reference or official publications; or

(p) refers to a matter under consideration by the County Assembly or a Committee.

(3) A Member shall take responsibility for accuracy of the facts upon which a Question is based.

(4) A Member may, with leave of the Speaker, ask a supplementary question to a Question raised in the County Assembly before it is referred to a County Executive Committee Member for reply.

(5) Where the Member scheduled to raise a Question in the County Executive is absent without the Speaker's permission, the Question shall be dropped and no further proceedings shall be allowed on the Question during the same Session.

(6) A Member scheduled to ask a Question in the County Assembly may—

(a) request the Speaker to defer a Question to another time or day;

(b) withdraw a Question where it has been overtaken by events; or

(c) at least two hours before a sitting, nominate another Member to ask the Question in his or her absence by notifying the Speaker in writing;

(7) The Speaker may defer a Question to a different time or day from its scheduled time and day.

(8) A Question may include a request for a Report from a County Executive Committee Member concerning matters under the control of the County Executive Committee Member.

New Standing Order No. 47C

THAT, the Standing Orders be amended by inserting the following New Standing Order immediately after Standing Order 47B:

Manner of disposing Questions

47C. (1) A County Executive Committee Member shall provide physical and electronic copies of the reply to a Question at least a day before appearing before the County Assembly.

(2) Subject to Standing Order 47A (Notice of Question), the County Assembly shall dispose of a Question in the sequence it appears in the Schedule of Questions or as the Speaker may direct.

(3) The Speaker may—

(a) permit the Member who raised a Question to ask a maximum of three supplementary Questions that relate to the original Question;

(b) permit a Member other than the Member who asked a Question to ask a further supplementary Question that relates to the original Question;
