Hon. Speaker: Thank you. The notices, as requested by the Hon. Chair for PAC, stand given. I would plead with the House that this falls squarely under your mandate, being the oversight. Hon. Members, the only way you can actively play a role while carrying out your responsibility as a Member of this Assembly, is to interrogate the reports and give a view as presented by the Committee. I hope the committee has done a good job, but that does not stop you or the House from interrogating the report further. For that reason, I direct the office of the Clerk to circulate the reports in good time, so that Members do not have any excuse as to why they are not in a position to debate on these reports. Thank you, Hon. members. Clerk!

STATEMENTS

Hon. Speaker: Under Statements, Hon. Matara had requested to give a small attribute in under two minutes, because he forwarded an official request to the office of the Speaker. He was not in a position within the timelines when Members were giving tribute. Hon. Matara, kindly proceed. Sergeant-at-Arms, kindly be of assistance to the Hon. Member.

Hon. Silas Matara: Thank you, Hon. Speaker, for this opportunity. I thought that since we didn't have quorum last week, that has passed, but I had made a formal request to give my condolences to the former Prime Minister. Before I give that, Hon. Speaker, at another sitting, I had requested that you consider instituting a procurement process for those of us whose cards were lost in this Assembly, so that we are able to have an opportunity to contribute meaningfully to this House.

In the shortness of time, Hon. Speaker, what I wanted to say is that, we lost a hero and patriot of Kenya, Africa and the global south region. Mine specifically went to the African culture or the Kenyan culture, where it is a problem that we get to normally appreciate our family members, our friends, and members of the society, when they have gone to be with the Lord.

Hon. Speaker, during last year's protests, some section of Kenyans were saying that our fallen hero had let them down. But what I wanted to tell them is that as an individual. In as much as he was a party leader and a leader of this country, he had a right to make his own decisions. It is quite unfortunate that when he stood to seek being elected into power, although there are questionable issues with regards to the results in the previous elections, the same individuals who used to cry foul that he made the wrong decision by joining the Broad-Based Government, only wanted to make other decisions. After things go bad, they seek his indulgence in terms of opposing whatever the social ills that the current or the previous regimes used to do to Kenyans. So, it is important as a society and as leaders, that we get to appreciate people on whatever they do when they are still with us.

Hon. Speaker, much has been said. Our fallen hero teaches us one thing as leaders. It is not about the positions that we get to hold in society, but it is about what you do for the people and the significance you have in their lives. Because looking at his life over the years, not only being as a party leader and as an opposition leader, he touched our lives. What happened or what is currently happening in Tanzania in the just concluded elections, the freedoms that we get to enjoy as a society today are due to his blood and sweat, together with the other fallen heroes like Kenneth Matiba, Timothy Njoya and the rest. So, it is important that as Kenyans, we really not focus on the shortcomings of individuals, but we get to let out the goodness that someone has been able to do for us as a society.

Therefore, the freedoms that we normally enjoy – especially this message goes to the Gen Z, who used to indicate that they are party-less, tribe-less and they are leader-less...

Hon. Speaker: Kindly conclude.

Hon. Silas Matara: Finally, Hon. Speaker, it is important that people know that he made the decisions that he made, because it is only the young who go to war. The aged do not go to war, but make decisions for the prosperity of the country. To that, I only say that for us who are left, let

us live according to the ideals that our fallen hero, the Rt Hon. Prime Minister showed us when he was with us. May he rest with the champions. Thank you.

Hon. Speaker: Thank you, Hon. Matara. Mheshimwa Redson.

REQUEST FOR STATEMENT REGARDING IMPLEMENTATION OF ROAD AND PUBLIC WORKS CAPITAL PROJECTS IN NGEI WARD

Hon. Redson Onyango: Thank you, Mr. Speaker. Pursuant to Standing Order 47(2) (c), I wish to request for a Statement from the Chairperson of the Sectoral Committees on Transport and Public Works regarding the implementation of road and Public Works capital projects in the County, more so, in Ngei Ward.

Hon. Speaker, Article 185 of the Constitution of Kenya, 2010 read together with the Public Finance Management Act, 2012 mandates the County Assembly to consider and pass policies and plans including budgets to finance County operations and development. In the financial year 2024/2025, the Assembly passed the Supplementary Budget Estimates where road projects were reinstated. Similarly, In the current Financial Year 2025/2026, the Assembly projects. passed the Budget Estimates containing allocations towards Ward Development Fund

Hon. Speaker, in its exercise of oversight mandate, the Assembly is required to be informed case there are challenges. of the implementation status of the aforementioned projects and make any interventions in

Hon. Speaker, in the statement, the Chairperson should inquire into and report on: -

- i. Whether the procurement process for capital projects contained in the FY 2024/2025 Supplementary Budget Estimates commenced;
- ii. If so, list of projects that have been advertised and the current status of their procurement;
- iii. Whether the procurement process for WDF projects contained FY 2025/2026 Budget Estimates has commenced, and if so, provide the current status of the projects for all the 85 Wards; and
- iv. Measures that the County Executive has put in place to ensure that projects that are contained in the various budget documents are implemented in time before the subsequent financial year in order to avert stalled projects and pending bills.

Hon. Speaker: The Chair for Transport Committee? The Vice-Chair? Any active Member who would want to commit on behalf of the Committee? Mheshimiwa Masitsa

Hon. Rosemary Masitsa: Thank you, Mr. Speaker. I am a member of Transport Committee. Because our Chair and Vice-Chair are not around, I request you give us two weeks to come with the report. Thank you.

Hon. Speaker: Thank you, and I hope you have considered the Calendar of the House at the same time. Hon. Masitsa, when is the Assembly going for long recess?

Hon. Rosemary Masitsa: On Thursday, next week.

Hon. Speaker: Long recess?

Hon. Rosemary Masitsa: Yes. After long recess, we will bring a report.

Hon. Speaker: Hon. Members, you need to update your Calendar properly. Time is running out. You know we are supposed to adjourn for the Games, that is next week. Then when we resume, we will only be in a position to have two sittings before we proceed for the long recess. Unless Members of this Assembly feel it is right to extend the Calendar by even three weeks; closing the assembly at the eve of Christmas.

Hon. Redson, Mhesimiwa Masitsa has requested two weeks upon the resumption of the sitting after the long recess.

Hon. Redson Onyango: No worries, well guided, Chair.

Hon. Speaker: Thank you. I can see you have got further Statements. Proceed.

REQUEST FOR STATEMENT REGARDING COMPLETION OF PROJECTS IN NGEI WARD

Hon. Redson Onyango: Hon. Speaker, pursuant to Standing Order 47(2) (c), I wish to request for a Statement from the Chairperson of the Sectoral Committees on Water and Sanitation regarding completion of projects in the County, specifically in Ngei Ward.

Hon. Speaker, Article 185 of the Constitution of Kenya, 2010 read together with the Public Finance Management Act, 2012 mandates the County Assembly to consider and pass policies and plans including budgets to finance County operations and development. In 2023, the Assembly passed a budget that was set aside for the construction of Ablution block and upgrading of sewer line at Huruma Sokoni in Ngei Ward.

Hon. Speaker, the ablution block has not yet been completed despite completion time having lapsed. On the other hand, the sewer line has not been completed because it is alleged that the County has constructed a road on the designated site.

Hon. Speaker, in the Statement, the Chairperson should inquire into and report on: -

- i. Reasons for the delay for completion of the ablution block and whether an extension of completion date has been processed by the County;
- ii. Whether the contractor constructing the ablution block has raised certificates and whether the County has made payments to that effect;
- iii. The fate of the sewer upgrading project given that the designated site has been taken over by an active road project:
- iv. Steps that the County is taking to complete stalled and ongoing projects in all Wards.

Hon. Speaker: Thank you. The Chairperson of Water Committee? The Vice Chair? Member of Water Committee? We have the senior ranking Member, Hon. Whip.

Hon. Moses Ogeto: Hon. Speaker, we request for two weeks.

Hon. Speaker: When?

Hon. Moses Ogeto: Hon. Speaker, Members will go to flex their muscles in Meru. So, before we go for the long recess.

Hon. Speaker: Hon. Leader kindly interrogate your Calendar properly whether we still have the privilege to be around for the two weeks you have just mentioned after the CASA games.

Hon. Moses Ogeto: Hon. Speaker, with the fact of the Assembly Calendar, let it be the first week after resumption, if God makes reach there. That is February next year.

Hon. Speaker: Thank you, Hon. Redson?

Hon. Redson Onyango: It is okay, Hon. Speaker. I have one last statement.

Hon. Speaker: Kindly proceed.

REQUEST FOR STATEMENT REGARDING RECRUITMENT OF ASSISTANT DIRECTOR FOR ECONOMIC PLANNING

Hon. Redson Onyango: Hon. Speaker, pursuant to Standing Order 47 (2) (c), I wish to request for a Statement from the Chairperson of the Sectoral Committees on Labour and Social Welfare regarding the recruitment of the Assistant Director for Economic Planning.

Hon. Speaker, Article 185 of the Constitution of Kenya, 2010 provides for the County Assembly's oversight mandate over the operations in the County Executive. In the exercise of this role, the Assembly directly or through its Committees is guided by the apportionment of functions under Part 2 of the Fourth Schedule of the Constitution, statutes, policies and other instruments.

Hon. Speaker, Section 59 (1) (b) of the County Governments Act, 2012 mandates the County Public Service Board to appoint persons to hold or act in offices of the county public service amongst other functions. The County Executive advertised and conducted interviews on 23rd April 2025 for the position of Assistant Director for Economic Planning. However, there are allegations that the person who was recruited and confirmed into the position was not among the candidates in the shortlist, going by the interview notice dated 8th April 2025. If so, Hon. Speaker, this is not only contrary to the law and Human Resource Practices but also negates the constitutional principle of fairness. Therefore, being a critical position in the County. This Assembly is entitled to be apprised on the entire recruitment process.

Hon. Speaker, in the Statement, the Chairperson should inquire into and report on: -

- i. The criteria used by the County Public Service Board in the recruitment process for the position of Assistant Director for Economic Planning;
- ii. The list of applicants for the said position; the names of persons that were shortlisted for the position; and persons who actually attended the interviews;
- iii. The qualifications and requirements for the position; and
- iv. The position held by Mr. Stephen Ochieng before recruitment into the position and whether he met the requirements for confirmation into the position

Hon. Speaker: The Chairperson for Labour Committee? Vice Chair, Labour Committee? **Hon. Mary Kariuki:** Hon. Speaker, on behalf of the Chairman Labour Committee, I give an undertaking that we shall respond in two weeks after the long recess.

Hon. Speaker: I hope that has been noted. Hon. Waithera Chege, are you ready to make your request? Kindly proceed.

REQUEST FOR STATEMENT REGARDING STATUS OF REIMBURSEMENTS OF SOCIAL HEALTH INSURANCE FUNDS TO COUNTY HOSPITALS BY SHA

Hon. Waithera Chege: Thank you, Mr. Speaker, for the purpose of this session I am using the Table Office card.

Speaker, pursuant to Standing Order 47 (2) (c), I wish to request for a Statement from the Chairperson of the Sectoral Committee on Health Services regarding the status of reimbursements of Social Health Insurance Funds to the County level IV and level V hospitals by the Social Health Authority.

Speaker, Article 41 (1) (a) of the Constitution of Kenya, 2010 provides for the rights of every person to the highest attainable standards of health care, which includes the right to health care services. Further, Article 41 (2) provides that a person shall not be denied emergency medical treatment.

Hon. Speaker, the Social Health Authority (SHA) reimburses health facilities for services provided to beneficiaries through a direct payment system to government, private and faith-based facilities. While SHA alleges to have made significant payouts, a notable backlog of claims remains and some hospitals have reported financial strain, leading them to shift to cash only payments.

Hon. Speaker, it is alleged that most, if not all, County health facilities, especially level IV and level V hospitals, are undergoing financial strain due to the delay in reimbursement of Social Health Insurance Funds by SHA. It is noted that a good number of claims are being rejected unilaterally by the SHA system and no clear feedback mechanism to engage SHA, either physically or online, on the steps to be taken to amend the rejected claims.

Hon. Speaker, in the Statement, the Chairperson should inquire into and report on;

- Status report on the reimbursement of funds to the County level IV and level V hospitals by SHA for the last one year, a breakdown of disbursement per Cunty health facility, vis-a-vis the claims lodged;
- Status report on the pending disbursement by SHA to all County facilities; ii.
- Reasons for delays in disbursement of social health insurance funds to the county iii. health facilities: and
- Measures the County Executive is taking to ensure timely disbursement of SHA iv. funds to the County health facilities.

Hon. Speaker: The Chairperson for Health Committee, kindly give an undertaking on what time or period of time you would require. I can see Hon. Madam Lily upstanding.

Hon. Lily Kidenda: Hon. Speaker, I would like to state that we appreciate the concerns that the Hon. Member has brought forth. This touches on our lives and the lives of those people we love. I would like to state that the investigation and the details of the inquiry may require a little longer than maybe agreed, but I would like to seek the indulgence of the Hon. Member that she gives us a period of three weeks after the long recess, for us to investigate this thoroughly and to be able to give satisfactory report to put us in a place where this kind of state in this County will not be repeated.

Hon. Speaker: Thank you. Hon. Waithera.

Hon. Waithera Chege: I agree with Hon. Kidenda, however, I want to request from your desk, since there are some people who are held in various hospitals because of nonpayment, that you give us an informal sitting outside the Assembly together with the Chair for Health, because some of these Members of Nairobi County are likely to still be within the hospitals even during Christmas time. When I look at the period that she has given, it might run all the way to February. So, we cannot wait for these Members of our society to be held in these hospitals until February comes. Thank you, Mr. Speaker, and I seek your indulgence.

Hon. Speaker: I think that is a noble request. For that reason, I just direct the Committee on Health Services to convene a meeting and bring understanding. But again, Hon. Members, as much as we are just about to proceed for recess, you must also acknowledge that there are committees which will be actively operational. So, like Health, you can't shut down the doors of the health facility and health services. Same applies even to the committee which can be running throughout the period of the recess. You will have to engage the Member as requested.

> REQUEST FOR STATEMENT REGARDING HANDLING AND MANAGEMENT OF DECEASED PERSONS AND UNCLAIMED BODIES IN HEALTH FACILITIES WITHIN NAIROBI CITY COUNTY

Hon. Joseph Ndungu: Hon. Speaker, pursuant to Standing Order 47 (2) (c), I wish to request for a Statement from the Chairpersons of the Sectoral Committee on Health Services regarding the handling and management of deceased persons and unclaimed bodies at Mama Lucy Kibaki Hospital and other level III and level IV health facilities within Nairobi City County.

Hon Speaker, taking into consideration that matters of law enforcement fall under the National Government, the County Government of Nairobi, through its Health Sector, bears responsibility for the management of County health facilities, including hospitals, hospital mortuaries, and the Fourth Schedule, Part 2 (a) of the Constitution of Kenya, 2010 assigns county health services a devolved function.

Hon. Speaker, there have been growing concerns and allegations that some county health facilities, including Mama Lucy Kibaki Hospital, are holding deceased persons under questionable circumstances. Families seeking to trace their missing relatives have reportedly been denied access to clear information regarding the presence or identity of bodies within these facilities.

Mr. Speaker, I give a case of one Charles Ndungu, a young man of 23 years who was arrested by police officers in Kayole Junction. On that material day, the young man called his sister and informed her that he had been arrested. The sister alleges that she heard over the phone someone saying forcefully to stop calling and that was the end of the call. That was obviously a police officer. From there henceforth, the family had been looking for their loved one for six weeks, until they were called at Mama Lucy Hospital, where they positively identified the body of their kin.

I would like to ask the Chairperson of the Sectoral Committee on Health to inquire into and report on:

- i. Comprehensive report on the total number of unclaimed bodies currently held at Mama Lucy Hospital and other level IV and V hospitals within Nairobi City County;
- ii. Whether there are policies, standard operation procedures (SOPs), and guidelines governing the handling, storage, and release of deceased persons and unclaimed bodies within the County health facilities;
- iii. Whether it is procedurally acceptable for deceased persons to remain within hospital wards or grounds instead of being transferred to designated mortuaries, as required under Section 32 of the Public Health Act, and;
- iv. Measures put in place by the County Executive to ensure transparency, accountability and humane treatment of deceased persons in all County health facilities.

Hon. Speaker: Thank you, Hon. Member. Hon. Kidenda.

Hon. Lily Kidenda: The concerns have been noted with great concern. On behalf of the Chair of the Committee, what is being asked is equally extensive, but I do appreciate that it is something that needs to be brought to book as quickly as possible. I would therefore like to request that we get two weeks after the recess. And as has been directed, we shall remain active even during the recess, and we can use the said period to follow up and to do the research. We appreciate the heavy concerns that has been brought to our Committee.

Hon. Speaker: Thank you. Hon. Ndung'u, is that in order?

(Hon. Joseph Ndung'u responded off the record)

Thank you. I am not able to notice Hon. Geoffrey Majiwa, who is listed as one of the Members with a request for Statement. So, under Order 7 (iv), the request stands deferred to a later date. Under (v) I am not able to see Hon. Sospeter Mumbi. Further, there is no delegated responsibility over the same. Under Order 7 (v), the same stands deferred.

Clerk, let us proceed to the next Order.

THAT, pursuant to the provisions of Standing Order No. 131, this Assembly resolves to reduce the publication period for the Nairobi City County Clean, Renewable and Sustainable Energy Bill, 2025 (Assembly Bill No. 4 of 2025) from 14 days to 7 days.

Hon. Speaker, the purpose of reduction of publication of this Bill is because the Hon. Member for Kayole Central, Hon. Themendu, want the bill to be passed so that it can start operating. For this reason, Hon. Speaker, I wish to call the Deputy Minority Leader to second this Motion. Thank you.

(Hon. Waithera Chege spoke off the record)

Hon. Speaker: Hon. Waithera, make me understand your action. Kindly switch on your microphone.

Hon. Waithera Chege: If I will have to use my words, Mr. Speaker, then I say, I second. But I was following the law.

Hon. Speaker: Okay. You know you are seated somewhere that is not clear.

(Question proposed)

Hon. Speaker: Hon. Members, plenary please. My screen is clear, an indication that there is no further engagement on Order No. 8. For that reason, I call upon the mover of the Motion to reply.

Hon. Moses Ogeto: Hon. Speaker, I beg to reply.

NAIROBI CITY COUNTY CLEAN, RENEWABLE AND SUSTAINABLE ENERGY BILL, 2025

(Order for First Reading read accordingly)

MOTION

RENAMING OF A COUNTY ROAD AFTER THE LATE SENIOR COUNSEL PHEROZE NOWROJEE

Hon. Waithera Chege: Thank you, Mr. Speaker. I beg to move the following Motion; AWARE THAT Article 186 (1) of the Constitution of Kenya, 2010 and Paragraph 5 of Part II of the Fourth Schedule to the Constitution provides for transport, including county roads, street lighting, public road transport, traffic and parking on a devolved county function;

FURTHER AWARE THAT the Country has since independence named and renamed roads and other public facilities in honor of heroes and heroines who have contributed immensely in the society as a way of honoring them;

APPRECIATING the late Pheroze Nowrojee, Senior Counsel, who was a distinguished and patriotic Kenyan lawyer, human rights defender, a poet, historian and patriot; who made indelible contributions to the Nation through his dedicated service and deep commitment to justice, human dignity, and the rule of law; his early legal training in Kenya, and later years in India, United Kingdom and the United States of America gave him a unique blend of local understanding and global perspective, that informed his work throughout his life. He was a kind of advocate who pursued justice over grandstanding and or profit, often offering his services pro-bono whenever the occasion so required, and who believed in the sanctity of the Constitution, even in the most turbulent political climates;

IN ACKNOWLEDGING some of the immense contributions by Senior Counsel Pheroze Nowrojee, in 1995, the Kenyan section of the International Commission of Jurists (ICJ Kenya) awarded him the Jurist of the Year, a recognition reserved for individuals who have demonstrated exceptional commitment to the protection and promotion of human rights, justice, and the rule of law; SC Pheroze Nowrojee, was also recognized by the International Bar Association in 1995, he received the Bernard Simons Human Rights prize for 2002- 2004, the Law Society Roll of Honor 2005, The Maasai People Safeguarding Rights Award 2007,the CB Madan Constitutional Prize 2014; He was a distinguished lecturer in the University of Dar salaam, University of Nairobi and Kenya school of law; he was a distinguished scholar and author of many books among them 'A vote for Kenya', The elections and the constitution 2013 and A Kenyan Journey 2014, among others:

RECOGNIZING that County established a County Policy on property addressing and street naming which provides for procedures that should be undertaken in relation to address management functions, such as address selection and naming of roads and streets within the County;

FURTHER APPRECIATING that by renaming of a prominent road in Nairobi would serve as a fitting tribute to his lasting legacy and ensure that his contributions are remembered and celebrated by future generations;

This ASSEMBLY THEREFORE URGES the County Executive to rename a County road after the late Senior Counsel Pheroze Nowrojee in recognition of not only his patriotism, excellent contribution to the rule of law, human rights and democracy and generally good governance in the Republic of Kenya but also the values he espoused; justice, integrity, humility, and above all, service to humanity.

Thank you, Mr. Speaker for allowing me to move this Motion. Allow me first to thank your office for allowing for a supplementary Order Paper today to allow this Motion to be on the floor of the House. I also want to thank the residents of Kilimani, led by Hon. Moses Ogeto, whom we have had consultative sessions on how to remember Senior Counsel Pheroze Nowrojee.

Mr. Speaker, the other day, I was going through the social media and I realized that if you want to hide money in Kenya, you should hide it in books because people rarely read books. If somebody had to ask a Nairobi resident who Senior Counsel Pheroze Nowrojee is, I doubt many would go wrong. He was not your standard counsel; within the court room, he was known as the Judges' student. Any court room he would attend; you would even hear a pin dropping because he was honored across the hallway of the court rooms within Kenya.

Mr. Speaker, Sir, when I was looking at the life of Pheroze Nowrojee and where he started, I doubt if many people know that he was born in Kenya. He has been one of the brightest legal minds that we have had in this country. One of the very many cases that he won, was the nullification of the presidential elections in 2017, which took this country back to elections. The other case that he won, was the lifting of the ban on the Nairobi Monthly Newspaper.

Mr. Speaker, Pheroze Nowrojee was not your usual lawyer, the lawyers in this country named him Lawyers' lawyer; because he was a lawyer of his own standard. Kenyans marked the death of Pheroze this year with a lot of sadness. I personally met the Senior Counsel. I was introduced to him by the now Governor of Siaya, Hon. James Orengo, when I first joined Social Democratic Party. He is not somebody that speaks loudly, he was a very simple man who spoke with a very soft voice but was heard all over.

Mr. Speaker, the roots of Pheroze family is deeply rooted in East Africa. The father was the first railway engine driver in Uganda. When I read the first book by Pheroze, I realized how he tells the story of the issue of becoming somebody who wants justice in this country. That is how his father finally left Uganda to come back to Kenya.

Mr. Speaker, Sir, Pheroze was not just a lawyer, he was a teacher, a mentor, a poet, a constitutional lawyer, and he has written so many books. He is the Author of Pio Gama Pinto, a book which is widely read in Kenya. He is also the Author of the 'Elections in Kenya'. I want to quote one of the most important books that he wrote – I am not saying that the rest are less important, is, Vote for Kenya, and how elections in Kenya are conducted. The other book is; Conserving the intangible that he wrote in 2015. The fourth one is, Elections and the Constitutionalism in Kenya, in the year 2013.

Pheroze was not just a writer, Mr. Speaker. I want to quote what he told lawyers when he appeared in one of the lawyers' gathering, he said; "The lawyer's duty is not just to argue the law, it is to argue justice even if that justice is inconvenient to the power". He wrote so may essays and speeches, and some of them are being studied today by legal scholars, not because of the insight, but because of the grace in which those essays and speeches are written in.

He mentored a very big population in law. For those people who have interacted with Pheroze, Mr. Speaker, they will tell you that he was the Jurist of the Year in 1995. For somebody in this country to be named the Jurist of the Year, you must have achieved several requirements among them, is to be a defender of human rights.

The International Commission of Jurists noted the immense contribution that Pheroze made in their offices, which included the building of the foundation for the ICJ headquarters in Nairobi.

The legacy that he left in ICJ, echoes even through the hallway of ICJ offices. For those who have had a chance to visit the ICJ offices, you will realize that the whole corridor is full of his photos because he not only fundraised for the construction of the ICJ headquarters in Kenya, but he also made sure that the students of law were a part of the benefits within the ICJ.

Mr. Speaker, we can speak about Pheroze for a very long time. You heard where he studied, both in Kenya, India, United Kingdom and the United States of America. I want to take very specific note of the fact that he taught in Nairobi School, the University of Dar es Salaam and the Kenya School of Law. His impact within these institutions is indelibly woven in the fabric of Kenya.

Mr. Speaker, when we are speaking about somebody and how to remember them, I would want to convince this Assembly that Senior Counsel Pheroze Nowrojee was not only a lawyer for the Orange Democratic Party, because I know there are some Members for the Orange Democratic Party who do not know that he has been their lawyer for a very long time. Pheroze also was a Member of some of the political parties that we have in Kenya. He served at the Social Democratic Party, and later moved to FORD Kenya where he became a National Executive Member, between the year 1992 and 1999. He also was the Vice Chair of the Ufungamano People's Commission on Constitution Reform in the years 2000 and 2001.

The BBC Africa awarded Pheroze Nowrojee for a competition price winner of 2001. He stood out as one of the people who really competed across the globe. Therefore, when I stand here and convince this Assembly that the reasons why we need to remember the work that has been done by senior Counsel Pheroze Nowrojee, I remember his voice and the work of pro bono that he gave to this country. For those people who were unable to pay court cases, he presented them for free.

Mr. Speaker, therefore, allow me to call my good friend, Hon Moses Ogeto, to second this Motion, noting the fact that one of the roads we are recommending to be renamed after Pheroze Nowrojee is the Turbo Road within Kilimani Ward. Thank you, Hon Speaker.

Hon Moses Ogeto: Thank you, Hon Speaker. As I stand here to second this Motion, Hon Waithera has spoken everything which I wanted to speak. This serious man lived in my ward. What I liked about him is that he was one of those lawyers who assisted during detention of prominent people during fight for multiparty, including the Late Hon Raila Amolo Odinga. He also participated in the case of 2017 where Chief Justice Emeritus of the Republic of Kenya, Maraga, nullified the election of 2017. Therefore, he defended those things which this Country needed. We need people like him because if it is left for few individuals, then this country may go back to one party state, which is very dangerous. With those few remarks, I second this Motion. Thank you

Hon Speaker: Thank you.

(Question proposed)

Hon Speaker: Hon Antony Kimemia?

Hon Antony Gathumbi: Shukrani za dhati, Mheshimiwa Spika kwa kunipa fursa hii kumzungumzia Hoja hii ambayo imeletwa na Mheshimiwa Waithera Chege, ambaye ni mdogo wa walio wachache katika Bunge hili. Hoja hii inamzungumzia Bwana Nowrojee, kwamba tumweke katika kumbukumbu ya nchi hii. Kuna wale wengi ambao wamekuja mbele yake na tumewapa hadhi hii ya kukumbukwa, kama vile Bwana Kibaki nas Bwana Gama Pinto, ambaye ameandika kitabu chake, na sioni kwa nini huyu mkereketwa akose pia kuwa katika kumbukumbu zetu. Hatumweki katika hizi kumbukumbu kwa sababu ya familia yake wala jamii yake, ni kwa sababu ya kizazi ambacho kinachokuja. Tunataka kizazi kinachokuja kijue kwamba kulikuwa na kiumbe ambaye alipigania haki na pia alipigania Katiba ambayo tunajivunia. Mtu yeyote ambaye anajivunia kuzungumza nchi hii yetu ya Kenya na anayefurahia hii kitaba ya Kenya, lazima amkumbuke huyu mwanasheria ambaye pia aliandika mashairi.

Bwana Nowrojee alipendwa sana katika *class* za wanasheria. Alifunza hapa Kenya na kule Dar es salaam. Kwa hivyo, naunga mkono Hoja hii kwamba tuwe tunakumbuka ambao walio tutangulia na ambao walitupa uhuru wa kuzungumza, ambao wametujali na wakapitia mengi.

Huyu anajulikana pia kwa kumsaidia baba yetu wa Taifa ambaye tulimpoteza juzi, Baba Raila Amolo Odinga. Mimi nikiulizwa, huyu ni mwanafunzi wa Raila Amolo Odinga na ni lazima apatiwe hadhi hii ya kukumbukwa. Sisi kama wanasheria wa Nairobi tumepata bahati kubwa sana kwamba tuna uwezo wa kusimama hapa na kuipa barabara jina la hawa watu mashuhuri. Nasema asante sana Bi Waithera Chege kwa kumkumbuka huyu mkereketwa ambaye ni kipenzi cha Wakenya. Asanteni sana.

Hon Speaker: Mweheshimiwa Akama.

Hon Jared Ondieki: Thank you very much, Hon Speaker for giving me this opportunity to say something and also to support this motion. First, I want to appreciate Hon Waithera Chege for coming up with this Motion. Sometimes when people die is when people claim that they knew this person, they have met this person, they have talked to this person, and so forth.

Hon. Speaker, I had the opportunity to interact with Pheroze Nowrojee. I want to salute his wife, Villoo Nowrojee for having stood beside this great man. I am saying that because during my youthful times, I used to be a very strong attendee of the Ufungamano House. I was also privileged to be part of the National Convention which was agitating for the new Constitution, that is after the Bomas Draft. Pheroze Nowrojee was there. He was part of the Firimbi Movement, and I was part of the Firimbi Movement in this town. Therefore, this is somebody I knew at a very young age of 21 years. I started a new political party in town called the United People's Congress, and when I was coming up with the constitution, I was introduced to Pheroze Nowrojee by the late Indimuli, who was the party leader of UNDA Party. When I took that constitution of United People's Congress to Pheroze Nowrojee, he went through it and made some amendments.

Hon. Speaker, Pheroze Nowrojee was a very soft spoken person. At times I used to refer to him as Mahatma Gandhi. When you looked at him, you thought that was Mahatma Gandhi of Kenya. One of the things he believed in is that, do your things quietly knowing that the divine is watching you and definitely you will be rewarded.

Hon. Speaker, he agitated for a road to be named after Gama Pinto road. He mobilized the Indians in town and all that, and that road came to pass. I did not know whether at one point there are people who would also stand for naming of a road in his honor.

Just as Hon Waithera Chege has said, this great man was one of the persons I also referred to as a walking Constitution, other than Hon James Orengo. So, in nutshell what we are saying is that, this great son, whom we also used to referred to him as a patriot, has done a lot for this Country. He stood by demonstrators in town. Whenever they were arrested, we knew that Pheroze Nowrojee will come to bail them out. Therefore, for his contribution and great things he has done for the Country, the little we can do for him in his honor is to ensure that we have a road named after him. I will be very happy if that comes to pass

Hon. Speaker, Pheroze Nowrojee was also a lawyer for one of the person we looked up to in this country, called George Anyona Moseti. Whenever Anyona found himself in trouble, Pheroze Nowrojee came to his aid. The Late Hon Anyona was one of my former Member of Parliament back at home. I strongly support this Motion. Thank you.

Hon Speaker: Mheshimiwa Fiunifiu.

Hon Kamau Fiunifiu: Thank you, Hon Speaker for an opportunity to contribute to this great Motion. Firstly, I acknowledge and commend the Hon Member for Nairobi South Ward for being thoughtful and sponsoring this Motion, and also Member for Kilimani Ward for seconding.

Hon. Speaker, I would ask, what is in a name? We are told that if you want to kill a dog, you give it a bad name and hang it. But if you want to make that dog thrive, you give it a good name. The man we are discussing here, as Hon Waithera has said earlier, not so many Kenyans maybe know Pheroze Nowrojee. He died at the age of 84 as a Senior Counsel who had very significant human right credentials and a decorated judicial officer, a defender of democracy and veritable man of letters.

Pheroze intellect was ferocious, Hon. Speaker. In the GenZ Movement that happened in the year 2024, he was in the forefront in the establishment of social justice center across Kenya, namely the Mathare Social Justice and Githurai Social Justice. Some of these centers have been the incubation of our young people into activism.

Hon. Speaker, before I sit down, I will go back to what is in a name. I remember back in 2015, I sponsored and championed for the renaming of Forest Road to Wangare Mathai Road. People were asking why give a departed person a road. I would say that when you go through Prof. Wangari Mathai, whatever goes through your head is a woman who was bold and fought for Kenya. So, when we are asking this Assembly to pass this Motion to recognize and acknowledge the role of senior counsel Pheroze Nowrojee did in this country as far as social justice is concerned, then it is to remind young people that if you do a good job you will be remembered. Pheroze Nowrojee goes into the hall of fame where Wangare Mathai has been, and the Late Raila Odinga.

Renaming of roads in this City is not a new thing. Moi Avenue back then was known as Government Road. Hon. Matiba has also been honored in this City. So, it is important to honor

senior counsel Pheroze Nowrojee with a road in this great County. Thank you, Hon. Speaker. I support.

Hon. Speaker: Hon. Members, let me give Madam Kidenda a chance to give her contribution

Hon. Lily Kidenda: Thank you very much, Hon. Speaker and HonMembers herein. Allow me to take this opportunity to thank in a very special way Hon. Waithera Chege for lifting this amazing man off the archives of this country. I want to say that his legacy indeed does move on.

My age gives me the authority to speak about senior counsel Pheroze Nowrojee in a very special way. I interacted with him not just at a personal level, but also remember the people in this country who owe their freedom to this man who has been spoken of in a very colourful way by a woman who took time to read, understand and bring out the salient facts that will support. So, Hon. Speaker, I support.

Hon. Nowrojee was a Kenyan patriot and a selfless learned friend who not only practiced law and supported the law community for money, but also did a lot of pro-bono support. There are cases of people I personally know that he took and executed successfully because of the love of what he stood for. He was an educator who taught across schools and universities. He was highly respected, and if you had an opportunity to speak to him, then you would know that he was methodical. His authored books are today being used in institutions not only here in Kenya but beyond.

I want to say that he will be highly remembered in this country and his legacy indeed lives on. I stand to support. Thank you, Hon. Speaker.

Hon. Speaker: Thank you. Mheshimiwa Mofire.

Hon. Jeremiah Themendu: Thank you, Hon. Speaker for giving me this chance to take part in recognizing the late Pheroze Nowrojee, senior counsel who protected and defended human rights and justice in this country. I support the renaming of a road to his name because, as I have learnt today, he wrote many books and one of them is, 'Voting in our country and how elections are conducted.

He wanted a better Kenya that recognizes everyone and every voice be heard. Hon. Speaker, I stand here before you asking the Executive to rename the road. Thank you, Hon. Speaker. I support

Hon. Speaker: Hon. Members, allow me to call the mover of the Motion to reply

Hon. Waithera Chege: Thank you, Hon. Speaker. I stand to thank all the Members who have contributed and waited patiently for us to summarize on this motion.
