NAIROBI CITY COUNTY SUPPLEMENTARY I APPROPRIATION BILL, 2025 (ASSEMBLY BILL NO. 1 OF 2025)

Hon. Wilfred Odalo: Thank you, Speaker. As the Chairman of the Board, kindly do something about our mics, as Nairobi City is the headquarters.

Hon. Speaker, Sir, I beg to move:

THAT, the Nairobi City County Supplementary I Appropriation Bill, 2025 be read a Second Time.

Mr. Speaker, in the Morning sitting, the County Assembly adopted the 24th Report of the Finance, Budget and Appropriations Committee on consideration of the Supplementary I Estimates for the Nairobi City County Government and the County Assembly for the financial year 2024/2025.

In the submitted Supplementary I Budget Estimates report, the County Assembly had granted the authority for the construction of selected roads that cover all the wards in the County, payment of various cadre of the pending bills including those to Wards.

Hon. Speaker, kindly protect me from my incoming Member of Parliament. Thank you. Others are payment of the statutory reduction, supply of Oxygen, tackling disasters and continuity of the school feeding programme, settling of medical insurance, and payment of WDF projects among others.

Hon. Speaker, Members of this Assembly should also know that next week, the government of the day will be paying the Ward Based Development Fund, so kindly liaise with the leaders for the same and the chair of WDF.

Hon. Speaker, I urge Members to support this Bill and give the County the leeway to utilize the fund for the stipulated priorities and the lines of the expenditures outlined herein for the financial year 2024/2025. Hon. Speaker, I beg to call Hon. Joyce to second.

Hon. Joyce Kamau: Thank you, Mr. Speaker, I second.

Hon. Speaker: Thank you, Hon. Chair.

(Question Proposed)

Hon. Speaker: Hon. Members, the screen is clear, which gives me the authority to call out the mover of the motion to reply.

Hon. Member you wanted to contribute? Kindly proceed, Hon. Majority Leader, please.

No, you can take your seat Hon.---

Hon. Peter Imwatok: Hon. Speaker, I do not know why the Chair of Budget Committee is reading our mood. He has changed from a doctor to a mood reader; I do not know when Hon. Odalo became a mood reader. You do not need to read our mood when we are in the assembly; you just need to make us understand what you are presenting before us.

Hon. Speaker, it is very important for us to put our mind into this particular Bill. I speak as the government and just as the Chair has said, I want to appreciate all the 23 chairpersons of the different sectors and their vice-chairs; I did not have the opportunity to do so. The Chairs must at all times work together with the Chief Officers. I am grateful in our last meeting with all the Chairs we agreed that in a few days to come we will have a collaborative meeting between the Chairs, vice-chairs and the Chief Officers so that we can have a harmonious way of working between the two arms of the government.

The Hon. Chairs who were present at the Windsor Hotel, I was there in person as the Chair of the Selection Committee, I appreciate you. If it was not for your collective responsibility across the county assembly and you did us proud by making sure that this document is brought before this House within a span of one week.

Hon. Speaker, secondly, I must applaud the staff led by Erick, the Clerk for the Budget Committee; that young man can really work. I remember yesterday I was called past midnight and the young man was still on his laptop making sure that this work is completed. We must appreciate the great advice from a lady by the name Asha Abdi and Mr. Kerich, he is one guy who cannot refuse pick your call, whether he hates you or not, that is an epitome of professionalism.

More importantly Hon. Members, I know we are on recess but we are here for the good of Nairobians. I implore the Executive to look into the magnanimity upon which this assembly is

History is being made and as a broad based government I expect Azimio la Umoja and the entire Kenya Kwanza Alliance to show that magnanimity and buy this book that expounds on the man who has brought us into the Kenya Kwanza coalition.

I also want to appreciate the Leader of Minority and the whip who is always on TikTok but very sober. The whip of the Kenya Kwanza alliance turns to TikTok when his side is quiet. Hon. Speaker I want to implore you to call the entire assembly at night and request that we turn up to show that Nairobi can work. I want to request all Hon. Members that this coming Sunday, let us join the Executive in making the city clean. We can as it is not a prerogative of the Executive alone.

(Applause)

Executive should bring down all the billboards that have been erected on our roads, we need our city and we are not going to be pleasing people while the city is going down to the dogs. I request the Leader of Minority to mobilize your Members; personally, I will lead my side on Sunday at 8 p.m. For those who know the beauty of the city join us next Sunday with the Governor to make sure that we clean the city.

With those few remarks, Hon. Speaker, I know you will lead us in that and we will have a clean city. Thank you Chair for Budget and the entire Budget Committee; you have done us proud for the last three years. God bless you, thank you.

Hon. Speaker: Hon. Minority Leader please.

Hon. Anthony Karanja: Hon. Speaker, the Majority leader has said everything I wanted to say, I do not know how he did that. I beg that we move forward.

Hon. Speaker: Allow me to call the mover of the motion to reply.

Hon. Wilfred Odalo: Hon. Speaker, before I reply, there is a concern by a Member on the Ward Development Fund where the amount is indicated Kshs. 90 million. I wish that the Member could refer to page 6, in that what he saw on the other side is recurrent and Ward Development Fund is at 2.155 and not 9. Thank you Hon. Speaker.

As I reply, let me take this opportunity to thank the secretariat one Wilfred Manyi, Erick, Alphonce and the team for the good job they have done. Two, the Budget committee is the best, I am also the longest serving chair in this House, and this has been the best team to lead. I have been the chairman of PAC and history repeats itself as one |Anthony Kiragu impeached me seven times but the Leader of Majority has today said that we should have no more impeachments. Members, we are happy and thankful for the support. I beg to reply.
