# ADMINISTRATION OF OATH TO MEMBER-ELECT FOR KARIOBANGI NORTH WARD

**Hon Speaker:** Hon Members, under Order No 1, being Administration of Oath, in the sequence of Business as it appears in the Paper today, we have Business to transact under that Order. But before then, I wish to make the following Communication.

Hon Emily, kindly take up your position.

Hon Members, following the demise of the then Member for Kariobangi North, the late Hon. Joel Munuve, MCA, I notified the Independent Electoral and Boundaries Commission (IEBC) of the ensuing vacancy for their further action.

In this regard, Hon. Members, the by-election for Member of County Assembly representing Kariobangi North Ward was held on 27th November, 2025. Subsequently, in a Gazette Notice No. 17611 dated 1st December, 2025 the IEBC declared Hon. Warui David Wanyoike as the duly elected member for the said Ward.

Hon. Members, the Constitution of Kenya, 2010 under Article 74 provides that:

"Before assuming a State office, acting in a State office, or performing any functions of a State office, a person shall take and subscribe the oath or affirmation of office, in the manner and form prescribed by the Third Schedule or under an Act of Parliament."

As you are aware, Hon. Members, the Office of a Member of County Assembly is among the State offices under Article 260 of our Constitution.

Hon. Members, the said Oath or Affirmation as highlighted above is indeed specifically detailed under the First Schedule to the County Governments Act, 2012.

I therefore now direct that the said Hon. Warui David Wanyoike be brought to the Chamber and be escorted to the podium for purposes of administration of oath and introduction.

(The Member Elect was escorted to the Chamber)

Before you proceed further, I expect one of the Hon Members of this Assembly to do the introduction.

Hon Joseph Ndung'u: Thank you, Hon Speaker, for this opportunity. It is my pleasure and privilege to introduce to the County Assembly of Nairobi City, the Member-Elect of the County Assembly of Nairobi for Kariobangi North Ward, of the Democracy for Citizens Party (DCP). Elected pursuant to Article 193 of the Constitution. Thank you, Hon Speaker.

**Hon Speaker:** Thank you. The Member may now proceed to the podium.

(The Oath of Office was administered to Hon. Warui David Wanyoike)

Hon. Speaker: Hon Members, under Order No.7, I will give honor to our newly elected Member of the County Assembly for Kariobangi North Ward to prepare after the Leader of Majority, to give his maiden speech.

Hon. Peter Iwatok: Hon. Speaker, allow me from the onset to appreciate your office for the good work you have done to this County Assembly so far. On behalf of the CASA Kenya team that I lead as the president, I must appreciate all the Hon Members and staff who were present in Meru, led by our Secretary General for County Assemblies Forum, Hon. Chege Maura, and the team who were there to make sure that we had a very eventful event.

As the Speaker said in his communication, we are second runners up nationwide. In football, we were the 'Harambee Stars.' The Nairobi City County Assembly took charge. And on matters of beauty contest, Hon Anthony Maragu is now the ambassador for CASA for 2025-2026. All other disciplines, including Choir, which was the most respected and the most decent team in Meru, came from our Assembly.

Hon. Speaker: Thank you, Leader of Majority. Hon Members, may be you may remember, under Order No 2 on my communication, I missed out on acknowledging, at the Public Gallery, Members of the great City of Nairobi. They cheerfully this afternoon came all the way from Kariobangi North to celebrate and to share the victory. I would want them to be upstanding and be welcomed by the House.

I wish them memorable moments. I do not know whether that is our women leader or... karibu sana, Mweheshimiwa. May be you can just wave. I hope it is not mistaken identity. Can it be confirmed to the Speaker whether... Okay, thank you for sharing similarity. Feel at most welcome, and we appreciate you and we appreciate your decision as the electorate. We have affirmed your wishes and now your Member is here solidly here to represent you. Thank you and feel utmost welcome

Hon Member for Kariobangi North Ward, you may proceed in front and give your maiden speech. Sergeant-at-Arms, kindly assist him.

**Hon. Speaker:** The Minority Whip had an issue.

Hon. Mark Mugambi: Thank you, Hon. Speaker. It is not an issue that I have, but first and foremost allow me to welcome Members of this Assembly back from the short recess, and also congratulate all the teams that brought trophies to this House. It is a great honour to be called champions of CASA in 2025. Noting my absentia as the most lethal midfielder or striker this Assembly has.

Also, allow me to welcome Hon. Wanyoike, who is a resident of Umoja. Despite being elected in Kariobangi North; he resides in my ward. Welcome *ndugu*. However, Hon. Speaker, just as I thank the people of Kariobangi North Ward, namwambia mimi ndio Ronaldo. I am sure you have heard my name being mentioned several times in your circles or at the table that you guys sit. Ronaldo ndiyo huyu. He is the Chief Whip for the UDA Party, the party of the President William Samoei Ruto, Daktari.

(Applause)

Just to remind you, Hon. Wanyoike, as the Speaker has informed you, do not be lied to. The party issues in some instances, you leave them outside that gate. Once you get here, we have rules and directives known as party positions. I have seen on my side that I have some tidings that need to be done here and there. I will make sure that I arrange our coalition in order to befit the new...

Hon. Speaker: Hon. Whip, I hope you are not trying to intimidate the new Member.

Hon. Mark Mugambi: No, Hon. Speaker. My statement needs a lot of wisdom to digest it. Therefore, it should not be translated or misquoted as a threat. I am just making a statement as a Chief Whip, as it is my role to defend my party and to make sure that things are going on well in this House. I should not be misquoted in one way or another.

Welcome, Mheshimiwa. Ulitupita katikati na kidogo tu. As the Broad-Based, tungejipanga, but ni mambo ya Mwenyezi Mungu.

Hon. Speaker: Hon. Member, you are out of order. You cannot mix...

Hon. Mark Mugambi: I withdraw, Hon. Speaker. It is all God's doing. That God decided that on this 2<sup>nd</sup> day of December 2025, you will be seated in this House, and no human being could have taken that.

(Applause)

Since the day you were born, God had already purposed this specific day and time. Also on the same wavelength, God purposed that the President of Kenya will be William Samoei Ruto. And the same God, I am sure, he has purposed that the same President shall serve until 2032.

(Laughter)

The same God that has brought you here, is the same God that has made sure that...

Hon. Speaker: Hon. Member, you are trying to mislead this Assembly. We do not have a term of 2032. We only have a five-year term, then another five-year term.

Hon. Mark Mugambi: Yes, we have another term that is ending. Hon. Speaker, I am just responding to the naysayers; the people that shout 'one term' and all those men of slogans. The same God that has given them a leader today is the same God that will grant William Samoei Ruto, Daktari, a second term.

(Applause)

Therefore, this House unanimously says, 'two terms.' Thank you.

Hon. Speaker: Thank you. Chairperson PAC, what is it?

Hon. Chege Mwaura: Thank you, Mr. Speaker. I just thought of also being in line with our leader here, the Whip, to congratulate the newest Member in Nairobi City County Assembly, and also welcome him. I just want to give him a piece of advice; that the Member he replaced, Mheshimiwa Munuve, was known to stand for what he believed. I hope you will go in that direction and stand with what you believe. This is a place where you openly have your own thinking and direct it.

Hon. Speaker, on the same wavelength, because I can see he has chosen to go to that side where the likes of Mheshimwa Karani are, I request that the committees that were given to the late Hon. Munuve, be given to him, so that he does not look like he would be lost anywhere. Otherwise, all these Members are good Members. We will be here to support you despite our different party affiliations. Also to inform the House that this is his fourth attempt. The new Member has tried to come to this House four times. So, it has been a long journey. I hope that it will mean something for the remaining of the term.

Finally, Mr. Speaker, when you look for up there, I recognized a member you served with in the defunct City Council. He is called Councilor Githua. I saw him somewhere when I was crossing on the other side. Hon. Speaker, one day all of us will not be in this House, we might sit

up there. So, it is good to recognize the people who have served the City. Mheshimwa Githua served in the days of the council.

**Hon. Speaker:** Where is Mheshimwa Githua?

Hon. Chege Mwaura: I saw him when I was across. Hon. Speaker, this member, once upon a time when I was new in politics, held my hand here and there. It is good to recognize somebody who has helped you do two steps. I do not think he would remember that, but I am a person who believes in fairness, somebody who has done good to you, it is good to recognize him. With that, Mr. Speaker, I have a different meeting, allow me to proceed. Thank you.

Hon. Speaker: Thank you. Mheshimwa Collins, under Order 7, last.

# REQUEST FOR STATEMENT REGARDING FAILURE TO COLLECT GARBAGE IN KAYOLE SOUTH WARD

Hon. Collins Ogenga: Hon. Speaker, pursuant to Standing Order 47 (2) (c), I wish to request for a Statement from the Chairperson of the Sectoral Committee on Environment and Natural Resources regarding the persistent failure to collect garbage in the County and specifically within Kayole South Ward.

Hon. Speaker, piles of uncollected garbage in Kayole II Social Hall, Nyando Road before Masimba Police Post (Kwa DO) and Ghorofa Saba, Butere Road next to Dominion flats, Riverine area, Kioi, Stage No. 20, and Sabasaba in Kayole South Ward, presents significant environmental and health concerns for my constituents, and requires urgent interventions.

Hon. Speaker, the accumulation of uncollected garbage is especially critical in the County. Non-collection of garbage has however led to the environment around these areas being filthy and stinking. This situation is unacceptable and poses a grave risk, as it could expose the community to diseases such as cholera, typhoid, and malaria.

Hon. Speaker, in the Statement, the Chairperson should inquire into and report on:

- The specific reasons why garbage has not been collected in the aforementioned areas of Kayole South Ward for the past;
- The schedule for garbage collection in Kayole South Ward, including the ii. designated service provider for each route, and the measures being taken to strictly adhere to this schedule;
- Whether the County Executive has sufficient functional equipment (e.g. trucks, iii. bins) and personnel to manage waste collection in Kayole South Ward;
- The immediate action plan to clear the existing backlog of uncollected garbage on iv. the above listed areas to mitigate the current health risks; and
- Measures the County Executive is taking to ensure consistent and timely garbage collection to prevent future health crises and environmental degradation in Kayole South ward.

Hon. Speaker: Do we have the Chair of Environment Committee in the House to give undertaking? The Vice Chair of Environment Committee? Any senior ranking Member of this House serving in the Environment Committee? Kindly proceed, Hon. Member for Korogocho Ward.

Hon. Joseph Ndung'u: Mr. Speaker, you are displacing me. I am from Kiamaiko Ward.

Hon. Speaker: Sorry, Kiamaiko Ward.

Hon. Joseph Ndung'u: Since we are going for the long recess and we only have a few days to adjourn, I ask the Member to allow us to respond to him two weeks after the long recess.

**Hon. Speaker:** I hope that is in order.

Hon. Collins Ogenga: Yes, Hon. Speaker.

Hon. Speaker: Thank you. Clerk, let us proceed.

#### **MOTION**

#### DEVELOPMENT OF LOCAL TOURISM POLICY

Hon. Perpetua Mponjiwa: Thank you, Hon. Speaker. Let me take this opportunity to congratulate the newly elected Member for Kariobangi North ward. When it is your time, we need to clap for you, so that when my time also comes when I will be winning the Kileleshwa Ward seat, you will clap for me.

(Applause)

I beg to move this Motion on development of local tourism policy.

AWARE THAT, Article 174 of the Constitution of Kenya, 2010 outlines the objects of devolution, including the promotion of social and economic development and to foster national unity by recognizing diversity; Article 185 (4) (a) further mandates the County Assembly to receive and approve plans and policies for the management and exploitation of the county's resources:

FURTHER AWARE THAT, Article 186 and the Fourth Schedule of the Constitution assign functions related to cultural activities, public entertainment, amenities, and local tourism to county governments;

RECOGNIZING THAT, the Nairobi City County, as the capital city and economic hub of Kenya and the East and Central African region, holds a unique potential for cultural, historical, conference, medical, urban, and eco-tourism;

NOTING THAT, the Kenya Vision 2030 recognizes tourism as a key economic pillar and emphasizes the development and diversification of tourism products, including promotion of cultural and urban tourism;

CONCERNED THAT, despite its strategic importance, cosmopolitan character, and rich historical, social, and cultural heritage, Nairobi City County has not yet developed or implemented a comprehensive local tourism policy to harness its full tourism potential and distinguish itself as a premier tourism destination;

DEEPLY CONCERNED THAT, the lack of an integrated framework and coordinated strategy has led to under-utilization of Nairobi's potential for local tourism, employment creation, youth engagement, and socio-economic empowerment;

NOW THEREFORE, this Assembly URGES the County Executive Committee Member responsible for Tourism and Culture to: -

- 1. Initiate and fast-track the development of a Comprehensive Nairobi City County Local Tourism Policy in line with the Constitution of Kenya, the County Governments Act, 2012, the Tourism Act, 2011, the Nairobi Integrated Urban Development Master Plan (NIUPLAN) – which has identified tourism and heritage as part of Nairobi's economic revitalization agenda, alongside other relevant policy frameworks:
- 2. Ensure that the policy provides for:
  - a) Mapping, preservation, and promotion of local heritage, cultural assets, and public amenities;
  - b) Strategic development and marketing of unique tourism products tailored to the Nairobi context:
  - c) Inclusive participation of local communities, youth, women, and creative sectors in tourism development;
  - d) Public-private partnerships (PPPs) and stakeholder collaboration in resource mobilization and service delivery; and
  - e) Integration with national tourism promotion initiatives under the Kenya Tourism Board, Magical Kenya and other entities;
- 3. Submit the draft policy to this Assembly within six months for consideration and adoption.

Hon. Speaker, this is backed by the constitutional functions of the County Government, strategic location and importance of Nairobi as a region hub, the need for coordinated and institutionalized tourism approach, economic growth and resource mobilization, youth employment and empowerment through the creative economy, preservation of cultural identity and urban heritage, enhancing investment and public-private partnerships, and alignment with Vision 2030 and Nairobi County development plans.

Hon. Speaker, I would like to call upon Hon. Catherine Okoth to second this Motion.

Hon. Catherine Okoth: Thank you, Mr. Speaker, I second the Motion.

(Question proposed)

Hon. Speaker: Hon. Emily Oduor.

Hon. Emily Oduor: Thank you, Hon. Speaker, I stand to support this important Motion. We are the only capital city in the world that has a national park. I guess because we do not have policies, that is why it is being run by the National Government all this time. I believe that if we have good policies, it should be handed over to Nairobi and the city will be able to get revenue

and attract more tourists not only to the national park but also to attract more visitors to Nairobi, and we get more revenue. This can also help to keep Nairobi clean because when you are expecting visitors, you are going to keep the city clean. With those few remarks, Hon. Speaker, I support the Motion.

Hon. Speaker: Hon. Emily, you have utilized your time well. Hon, Isalambo.

Hon. Emmy Isalambo: Thank you, Hon. Speaker, I support this timely Motion. Tourism will help boost revenue collection. Nairobi's population is growing, which means that we need more resources to run the city. If the park is left to Nairobi County to manage, most of our youth who have finished colleges will be employed in the sector. With those few remarks, Hon. Speaker, I support the motion. Thank you.

Hon. Rex Omolleh: Thank you, Mr. Speaker, for this opportunity. I stand here to support the Motion. Nairobi County is the capital city of Kenya, and every day we attract a lot of tourists. Just to mention a few tourist attractions that are within the city, I will start with Masai Market. This is one of the tourist attractions that is embodied with African crafts, jewelry and African fabrics which you don't get in any other African cities. If you look at the David Sheldrick Orphanage where we have baby elephants, it is within Nairobi County. This is something that would attract tourists. We also have the Giraffe Centre and the Karen Blixen Museum within Nairobi.

I urge this Assembly to pass this Motion so that we give Nairobi City what it deserves as a tourist destination. Thank you, Mr. Speaker.

Hon. Speaker: Hon. Members, my screen is clear. Right of reply from the mover of the Motion.

Hon. Perpetua Mponjiwa: Thank you, Mr. Speaker. I take this opportunity to appreciate the Members for supporting this Motion. I also take this opportunity to appreciate the County Assembly staff and you, Hon. Speaker, for always being steadfast and a leader to all of us. With those few remarks Hon. Speaker, I beg to reply. Thank you very much.
