Hon. Deputy Speaker: Majority Leader.

Hon. Peter Imwatok: Hon. Speaker, allow me move the following Motion:

THAT, pursuant to provision of Standing Order No. 31 (4), this Assembly resolves to alter the County Assembly Calendar and adjourn tomorrow, Thursday 9th April 2026 until Tuesday 21st April 2026 at 2:30 p.m.

Hon. Speaker, I am delighted that on a Wednesday the House is half full. Tomorrow, we will be having a historic moment by hosting the Head of State as he gives his Address as the first ever County Assembly in the history of the Republic of Kenya. Yesterday, the Secretary General of County Assemblies Forum alluded to the fact that there will be the Annual Legislative Conference in Mombasa and all the Hon Members are expected to travel on Sunday. It is prudent for us to alter the Calendar to allow Members to prepare for travel for the conference. This is in line with the interest of Members as far as tomorrow is concerned.

Hon. Speaker, I want to inform Members that the Speaker and the leadership are working round the clock and possibly within the day you will be given communications in regards to the travels and welfare. Some leaders had a meeting this morning from 9:00 a.m. till 12:30 p.m. in regards to the same. There are also further communications to come from the Speaker in regards to further committee travels.

Hon. Speaker, I implore on all of us to come early tomorrow because most of the roads will be blocked. There might be no parking. We will be securing parking at the Sunken Park. Strive to keep time, this is not about the position we hold as Hon Members but the security and integrity of this House. The Sergeant-at-Arms will give the routings of where to pass, and hotlines will be given for those who need assistance. I am also aware that a lot of communication is going out there, so let us concentrate on the core mandate that brings us here.

This is the first Assembly in the history of Kenya to host His Excellency the President and have him speak to us. I want us to implore to Kenyans to be patient, let us allow him to speak to us. In 2027, there will be elections and if you become a Member of the County Assembly, then talk for us. But for now, it is our privilege to host his Excellency the President of the Republic of Kenya. It is our right and the right of Nairobians to hear from the President as he addresses the County Assembly.

Hon. Members, I implore the Speaker that we will be leaving the House together with the Chair for Budget for the necessary guidelines.

This will be a precedent that all other counties will be using in the future. I am more than delighted about that. I noted that Hon. Catherine was concerned that my side did not applaud when I mentioned the term "two-term". It is good to offer clarity and step up by putting the record straight...

Hon. Deputy Speaker: Hon. Mark Mugambi, you are not supposed to address the Hon. Members.

Hon. Mark Mugambi: I am building up, Hon. Speaker. With all that said and done, I support 'two-term'.

It is good that you show clarity because on this side, most of us are normally branded or you are in quotes. You need to step up and put the records straight. Don't be like some of our...

Hon. Deputy Speaker: Hon. Mark Mugambi, I think you are not supposed to address some Members...

Hon. Mark Mugambi: I am building up.

Hon. Deputy Speaker: You are supposed to have....

Hon. Mark Mugambi: Okay. With all said and done, Hon. Speaker, I support 'two term.' Thank you.

Hon. Deputy Speaker: The Chairperson of the County Finance and Budget Committee?

Hon. Wilfred Odalo: Chair, I have been guided by the Majority Leader to be brief as I can. On that note, allow me to tell the concerned Members that Supplementary Budget is around the corner, and also to communicate for the concerned Members who have been asking about the loans, that is also around the corner, they will come.

Hon. Speaker, I will not go to my moving notes. The submitted CFSP had deducted WDF to around Kshs. 20 million per ward. The Committee saw the need and we reinstated the amount to the how it used to be.

(Applause)

Hon. Speaker, the money for recurrent for the Assembly was also deducted. Allow me to move the Motion now so that I go to what is in my mind.

THAT, this Assembly adopts the report of Select Committee on County Finance, Budget and Appropriations on the Nairobi City County Fiscal Strategy Paper and the Debt Management Strategy Paper for the financial year 2026-2027 and over the medium term, laid on the Table of the Assembly on Tuesday 7th April 2026.

Hon. Speaker, I am requesting for your protection from the Majority Leader, he is really worried of the time.

Hon. Deputy Speaker: Just go on, you are protected.

Hon. Wilfred Odalo: Thank you. What I was saying is; there were deductions which were there and also there was a deduction on the development vote for the Assembly side. We have also reinstated the Kshs.1 billion. I leave at that, though I had a long moving notes but I am seeing some signs that the state want to take charge of the Assembly.

Allow me to call my Deputy to second the Motion.

Hon. Emily Oduor: Thank you, Hon. Speaker. Since we do not have much time, I stand to second. Thank you.

Hon. Wilfred Odalo: Hon. Speaker, allow me to thank all the Members. As the practice goes, I would like to request the Members of the Budget Committee to stand so that they can be seen. They are the force behind the budget making of this term. At the far end is Hon. Mark Mugambi, he is a leader of this Assembly but reports where need calls. Hon. Waruguru is there, Hon. Whip, my Deputy, Hon. Jane, Hon. Collins, Hon. Masitsa, Hon. Catherine, the Minority Whip, the Majority Whip, and Hon. Perpetua. Thanks for the good job. These are the forces behind the success of this term's Budget Committee. Hon. Speaker, as you are aware, our budget resolutions have never been challenged since we started. Allow me to reply.

NAIROBI CITY COUNTY CLEAN, RENEWABLE AND SUSTAINABLE ENERGY BILL, 2025

Hon. Deputy Speaker: Hon Jeremiah Themendu?

Hon Jeremiah Themendu: Hon Speaker, I have the Bill.

Point of Order

Hon. Deputy Speaker: Hon Member, let me allow the Whip.

Hon. Mark Mugambi: Thank you, Hon. Speaker, I am raising on Standing Order No. 59. I beg your ear HonSpeaker. Yesterday, I raised in this Chamber a pertinent issue on my sitting position not being labelled among the other leadership positions. Still today, on the eve of the President's visit to this House, I am not sure if it is by design, I just read and perhaps thought they did it in a half and maybe they assigned our Deputy Majority Leader to have the name here. Hon Speaker, from where you sit, if you can read this name, I find it is an insult either from the Clerk or whoever is responsible to this. It reads 'Miolity Whip' I am not sure if they gave that work to our 'ndebt'. Maybe the person that had done this job before can be given back this contract of renaming it. Let me have it rectified by tomorrow's sitting.

(Applause)

Hon. Deputy Speaker: Thank you. Hon. Member. Because I am unable to read, can the Clerk confirm to us the reading on that seat. Yes, Majority Leader.

Hon. Peter Imwatok: Hon. Speaker, in line with that, sitting in this Committee for tomorrow with the Speaker, we need to hasten this particular Chamber to allow the the staffs to work on labeling of all the seats as required. I am aware there is cabling taking place in this

Chamber. By the time we walked in here the staffs and engineers were here working. Therefore, work is in progress. I want to assure the Whip and all the leaders that all the seats therein will be labeled. Unless we take until 5:00 p.m. here, we do not have enough time for these people to work on this Chamber. Allow us to adjourn. Any other procedural issues, we allow the Chamber to be free to be occupied by the staffs and the technical engineers who are working on it. Hon Speaker, I beg.

(Applause)

Hon. Deputy Speaker: That is noted. I know the relevant officers are going to take care of that.

Hon. Peter Imwatok: We just came in because we wanted to adjourn the Parliament appropriately. You can see cables are running all over, they are just waiting on the corridors to walk in. If I seek my brother elder brother, Hon. Themendu to do us service we adjourn the Assembly for tomorrow. You have a good Bill, if you allow us to debate in a later date when you are all active on it. For now, you can see fumes are coming all over. Allow us to adjourn.

Hon. Deputy Speaker: Hon Jeremiah Themendu, you have heard the sentiments of the Majority Leader. I had asked you to come forward but you did not, I do not know what happened, but I know the Majority Leader has taken care of that.

Hon Jeremiah Themendu: Allow me to...

Hon. Deputy Speaker: You are allowed.

Hon Jeremiah Themendu: Thank you Hon Speaker and also Majority Leader for the indulgence. I think what the Majority Leader has requested is in order. But my request is; we defer the Bill until when?

Hon. Deputy Speaker: Hon Members, as you know tomorrow we are having the Presidential Address, the President is coming to this Assembly and we have already adjourned 21st April, I will request it to be referred back to the House Business Committee sitting that will be on 24th April so that it can allocate it maybe within that week.

Hon. Peter Imwatok: We need your direction, Hon Speaker, as a matter of gesture he has shown us, direct that the next sitting of the Chamber, that will be the first agenda. As the Chair, you can direct without even the House Business Committee, it will be follow up.

Hon. Deputy Speaker: But, Majority Leader, you know when we come back, I think the House is going to discuss the Presidential Address for three days.

Hon. Peter Imwatok: So that the House Business Committee knows that the first agenda after the Presidential Address, is the issue of Hon. Themendu, under your direction.

Hon. Deputy Speaker: That is well taken care of, Majority Leader. After three days of discussing the Presidential Address, the House Business Committee will allocate it and give it the first priority.
