Subject: Promotion of Sports activities and talents in the County

THAT AWARE that Section 8 of the Nairobi City County Sports Management Act, 2017 provides that the Directorate in charge of sports in the County shall prepare the County Sports Plan, which shall include; measures to be taken in promotion of sporting activities in the County, measures to be taken for the integration of sports plan as stipulated in Section 8 (3) of the same Act; **FURTHER AWARE THAT** the Nairobi City County Sports Management (Amendment) Act 2018 establishes the Nairobi City County Sports Management Board, with the mandate of foreseeing the operations, promotion and management of Sports activities in the County; **CONCERNED THAT** the a number of talented youth in the County are not able to sustain a livelihood due limited sports opportunities; **APPRECIATING THAT** there

is need for the County Executive and the County Sports Management Board to develop and implement appropriate strategies, policies and Programmes to mitigate joblessness among the talented youth in the County; this **ASSEMBLY URGES** the County Executive to urgently develop and forward to the Assembly a Sports Plan for the County.
