*Subject: Reservation of seats for people with special needs in public service vehicles*

**THAT**, aware that under the Article 186 (1) of the Constitution 2010, and Fourth Schedule, the functions and powers of County Government, among others, covers County transport including county roads, street lighting, public road transport traffic and parking; further aware that recent years have witnessed a marked increase in the number of public service passenger vehicles plying various routes in the County; acknowledging that a well performing transportation system is both efficient and effective and is a pre-requisite to socio-economic growth and environmental sustainability; concerned that most public service passenger vehicles have not embraced the provisions of Article 54 (1) c which provides for the persons with special needs access to public transport; considering that the County Government enacted the Nairobi City County Persons with Disability Act, 2015 which provides for proprietors



of public service vehicles to adapt it to suit persons with disabilities in a manner prescribed by the Persons with Disability Board, this Assembly urges the County Executive to ensure all public service passenger vehicles operating within the County have designated seats with clear signs as attached herewith for persons with disability, expectant women, elderly people and person with infant to promote easy mobility using the public transportation services by such persons with special attention.

# **NOTICE PAPER I**

## **Tentative business for Tuesday, 3<sup>rd</sup> December, 2019**

*(Published pursuant to Standing Order 39(1))*

IT IS NOTIFIED that the Select Committee on Assembly Business, at its last meeting, approved the following ***tentative*** business to appear in the Order Paper for Tuesday, 3<sup>rd</sup> December, 2019: -

### **A. MOTION – HON. KENNEDY OYUGI, MCA**

***Subject: A policy that provides for establishment of a kitty to support needy students in polytechnics***

**THAT**, aware that Article 6(2) of the Constitution recognizes that both the National and County governments are distinct and inter-dependent and that devolution is an important principle in the new structure of governance; further aware that the function of village polytechnics is vested in the County Governments pursuant to provisions of Part Two of the Fourth Schedule to the Constitution 2010; acknowledging that there has been increased enrolment in both primary and secondary schools in recent years; concerned that the low number of primary school leavers transiting to secondary school and from secondary school to universities and colleges has become a cause for alarm for both National and County Governments; further concerned that some students especially from informal settlements in the County are unable to proceed with their education due to lack of fees; acknowledging that Technical and Vocational Education and Training (TVET) constitutes a form of education, training and learning activity that leads to acquisition of practical knowledge, understanding and skills relevant for gainful economic engagement, both formal and informal, this Assembly urges the County Executive to develop a policy that provides for establishment of a kitty to support needy students in Technical and Vocational Education and Training institutions across all Wards in the County.
