Subject Provision of scholarships and subsidies for learners on village polytechnics and home craft centres

THAT, aware that Article 43 of the Constitution of Kenya 2010 provides that every person has a right to education; **FURTHER AWARE THAT** Part 2 of the second schedule of the CoK, 2010 apports the education function of village polytechnics and home craft centres to County Governments; and that the Social Pillar of Kenya's Vision 2030 underscore the importance of education and training to the realization of the objective of realizing a newly industrializing, middle-income country providing a high quality of life to all its citizens by 2030 in a clean and secure environment; **COGNIZANT THAT** technical and training institutions offer a unique opportunity to students who graduate from secondary schools who fail to meet the requisite threshold to join tertiary institutions; **ACKNOWLEDGING THAT** in response to demand for technical and vocational training in Kenya, Parliament passed the Technical and Vocational Education Act, 2013 to that is comprehensive on the overall government objective towards educating its citizens; **OBSERVANT THAT** the national government in its quest to enhance enrolment into primary and secondary schools rolled out a raft of measures including provision of subsidies and whereas this the HELB loans to university students is a repayable advancement, it has helped many

students realize their potentials by eliminating the interruption factor of fee arrears; **CONCERNED THAT** the bursaries given advanced to trainees by the County Government notwithstanding, many students are currently missing out on the training programmes offered by village polytechnics for lack of funding; This Assembly urges the County Executive to domesticate the national government subsidy and scholarship programmes for students being enrolled or already enrolled into village polytechnics and home craft centres that are under the purview of County Government mandate.
