Subject: Second Reading

The Nairobi City County Civic Education Bill, 2021 (Assembly Bill No.8 of 2021)

(Hon. Silas Matara, MCA)

(Second Reading)

NOTICES

I. The Assembly resolved on Thursday, 10th February, 2022 as follows: -

- a) **THAT**, notwithstanding the provisions of Standing Order 103(4), this Assembly orders that, each speech in a debate on a **Report of a Committee**, a Sessional Paper or any other Report submitted to the Assembly, be limited as follows: - A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that Order.
- b) **THAT**, notwithstanding the provisions of Standing Order 103(4), this Assembly orders that, each speech in a debate on **Bills NOT** sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of three hours and thirty minutes, with not more than thirty (30) minutes for the Mover, in moving and ten (10) minutes in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

IT IS NOTIFIED that the Select Committee on Assembly Business, at its last meeting, approved the following ***tentative*** business to appear in the Order Paper for Tuesday, 31st May 2022 at 2.30 p.m.: -

A. MOTION – HON. KABIRO MBUGUA, MCA

Subject: Appointment of persons to the Nairobi City County Sister Cities Committee

AWARE that the Sister Cities International was founded by President Dwight D. Eisenhower in 1956, and is a nonpartisan and nonprofit organization which serves as the national membership organization for individual sister cities, counties, and states across the United States; **FURTHER AWARE** that the organization was established on a mission of promoting peace and prosperity by creating bonds between people from different cities around the world, by forming these relationships that people of different cultures would celebrate and appreciate their differences and build partnerships that would lessen the chance of new conflicts; **ACKNOWLEDGING** that the Nairobi City County Assembly on 20th November 2019 passed a Motion to establish a special Committee known as the **Nairobi City County Sister Cities Committee** that would work towards expanding and strengthening the existing relationships with the organization and to enable members boast exchanges in arts and culture, business and trade, youth and education, and community development and friendship; **NOTING** that the Nairobi City County Government including the County Assembly have so far signed a number of Memorandum of Understanding (MoU) with a number of Cities Internationally based in the United States of America, to create bonds between people from different cities within Kenya and around the world for local and global friendships, peace, unity and prosperity; **NOWTHEREFORE**, this Assembly resolves to appoint the underlisted Membership to the Nairobi City County Sister Cities Committee;

- i. Chairperson appointed by the Governor among the professionals Serving in Nairobi County;
- ii. Facilitated by Joint Secretaries being:-
 - a. County Secretary of the Nairobi City County Government or his/her representative;
 - b. Clerk of the County Assembly of Nairobi or his/her representative;
- iii. The Director of Public Communication and E-Government;
- iv. Representative of the Kenya National Chamber of Commerce appointed by the Chamber President;
- v. Representative from the National Ministry of Foreign Affairs appointed by the Principal Secretary;
- vi. Three representatives of the Public appointed by the Governor from amongst Professionals in Nairobi County;

B. *MOTION – HON. MARK MUGAMBI, MCA***Subject: Interventions to prohibit PSV operators from terminating at petrol stations***

THAT, aware that Article 46 of the Constitution of Kenya 2010 provides that consumers of goods and services have a right to protection of their health, safety and economic interests; **COGNIZANT THAT** passengers aboard public service vehicles enjoy the rights to safety under statutes as it is under the Constitution including Section 27 of Nairobi City County Transport Act, 2020 which prohibits PSVs from picking and dropping passengers at undesignated bus stops; and Section 33 (g) of the Act prohibits PSVs not reaching the final destination and other actions that endanger the lives of passengers; **NOTING THAT** Section 11(g) of Energy Act mandate the Energy and Petroleum Regulatory Authority (EPRA) to formulate, set, enforce and review environmental, health, safety and quality standards for the energy sector in coordination with other statutory authorities including requiring fuel dispensing to safeguard against fire accidents; **CONCERNED THAT** petrol stations are areas that store and sell highly flammable substances including petrol and Liquefied Petroleum Gas (LPG) that are susceptible to explosion unless necessary safety steps are taken by operators, consumers and passenger vehicles; **OBSERVING THAT** public transport vehicles have continued to violate public transport regulatory frameworks as well as safety standards for passengers by establishing and utilizing petrol stations as pick and drop terminals hence endangering lives of passengers despite safety signs and symbol placed by petrol station operators in accordance with the established regulatory frameworks. This Assembly urges the County Executive and the Nairobi Metropolitan Services to:

- 1) Issue a public notice prohibiting Public Transport Vehicles (PSVs) from terminating at petrol stations for picking and dropping of passengers; and
- 2) Formulate regulations to Nairobi City County Transport Act, 2020 forthwith to provide for punitive measures for operators who use petrol stations as termini.
