8. *PROCEDURAL MOTION – THE LEADER OF THE MAJORITY PARTY

Subject: Limitation of Debate on Bills Sponsored by Parties or Committees

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on **Bills** sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

9. *PROCEDURAL MOTION – THE LEADER OF THE MAJORITY PARTY**Subject: Limitation of Debate on Motions**

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on any **Motion**, including a Special motion be limited in the following manner:-A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

10. *PROCEDURAL MOTION – THE LEADER OF THE MAJORITY PARTY**Subject: Limitation of Debate on Individual Members' Bills**

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on **Bills NOT** sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of three hours and thirty minutes, with not more than thirty (30) minutes for the Mover, in moving and ten (10) minutes in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

11. *PROCEDURAL MOTION – THE LEADER OF THE MAJORITY PARTY**Subject: Limitation of Debate on Reports**

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on a **Report of a Committee**, a Sessional Paper or any other Report submitted to the Assembly, be limited as follows: - A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that Order.

12. *PROCEDURAL MOTION – THE LEADER OF THE MAJORITY PARTY**Subject: Limitation of Debate on the Motion on the Address by the Governor**

THAT, pursuant to the provisions of Standing Order 106(1), and in furtherance to the provisions of Standing Order 27(5), this Assembly orders that debate on the **Motion on the Address by the Governor** be limited to no more than five (5) minutes for each Member Speaking, thirty (30) minutes for the Mover in moving and replying and twenty (20) minutes for the Leader of Minority Party.

13. *PROCEDURAL MOTION – THE LEADER OF THE MAJORITY PARTY**Subject: Limitation of Debate on the Adjournment Motion**

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly orders that, the debate on **any Motion for the Adjournment** of the Assembly to a day other than the next normal Sitting Day in accordance with the Calendar of the Assembly, be limited to a maximum of three (3) hours with not more than five (5) minutes for each Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of ten (10) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order. Provided that, when the period of Recess proposed by any such motion does not exceed ten (10) days, the debate shall be limited to a maximum of thirty minutes (30), and shall be strictly confined to the question of the adjournment.

14. *MOTION – THE LEADER OF THE MAJORITY PARTY**Subject: Adoption of the Assembly Calendar – Second Session**

THAT, pursuant to the provision of Standing Order 31(1), this Assembly approves the Calendar of the County Assembly (*Regular Sessions*) for the Second Session (2023) as contained in the Schedule.

IT IS NOTIFIED that the Select Committee on Assembly Business, at its last meeting, approved the following ***tentative*** business to appear in the Order Paper for Tuesday, 21st February, 2023 at 2.30 p.m.: -

A. *MOTION – HON. PERPETUA MPONJIWA, MCA

Subject: *Deployment of traffic marshals near Schools for school going children's safety*

THAT, aware that Article 26 (1) of the Constitution of Kenya 2010 provides that every person has the right to life; Further Article 53 (2) of the Constitution states that a child's best interests are of paramount importance in every matter concerning the child; **concerned** that there is increased rate of road accidents involving school going children in Nairobi City County especially in public schools; **further concerned** that many schools children travel longer distances to access the few available education facilities that are affordable; **cognizant** of the vulnerability of unaccompanied school children crisscrossing Nairobi highways and busy roads to access the few affordable education institutions endangers their lives; **acknowledging** that the National Transport and Safety Authority (NTSA) has put in place measures to ensure road safety performance in line with international best practice, this Assembly urges the County Executive to:-

1. erect or put bumps and signals along County roads that are near schools and other social amenities to save vulnerable schools children from accidents on roads; and
2. deploy traffic marshals at all zebra crossing lanes on all major roads in Nairobi City to help school children in Nairobi safely cross the road to and from school, on or before the beginning of the new 2023 School calendar.
