Subject: Adoption of Committee Report

THAT, this Assembly adopts THE REPORT OF THE SECTORAL COMMITTEE ON CHILDREN, EARLY CHILDHOOD EDUCATION AND VOCATIONAL TRAINING ON THE PROPOSED PARTNERSHIP BETWEEN THE COUNTY GOVERNMENT AND THE KENYA INSTITUTE OF SPECIAL EDUCATION, laid on the Table of the Assembly on Tuesday, 21<sup>st</sup> March, 2023.

Subject: Provision of basic counselling skills for teachers working in ECDE Centers

THAT, aware that Article 43 of the Constitution of Kenya, 2010 provides that every person has the right to education; FURTHER AWARE that the Education Act, 2013 mandates respective Counties to implement the right of every child to Free and Compulsory Pre-School Education; RECOGNIZING that Early Childhood Development Education lays a lot of emphasis on the holistic development of a child's social, emotional, cognitive and physical needs in order to build a solid and broad foundation for lifelong learning and well-being; ACKNOWLEDGING that among the essential skills for teachers in Early Childhood Development Education (ECDE) are guidance and counselling, coaching, and mentoring. NOTING THAT Since teachers are dealing with children they must understand and at the same time assist them along in their growth and development; ACKNOWLEDGING that Nairobi City County has about 25,000 pre-primary school learners who enjoy free learning in the 232 ECDE centers. (The Star 1st September, 2021); APPRECIATING that the County Executive has budgeted for construction of Early Childhood Development Education Centers in the 17 Sub-Counties with the aim of increasing the number of children enrollment in Early Childhood Education; DEEPLY CONCERNED that it is important for ECDE teachers to be well trained in guidance and counselling in order to impart teacher-trainee-skills and knowledge on how to care for and guide the young children in their academic work, play, interactions with other children and counsel children with special needs and behavioral problems, now therefore this Assembly **URGES** the County Executive to continuously roll-out trainings for all County ECDE teachers on counseling and special child care skills.

10. \*MOTION - HON. ANTONY KIMEMIA GATHUMBI, MCA

**Subject:** Public Participation on the proposed Urban Renewal Plan to build and sale affordable housing in various County Government Estates.

THAT, aware that paragraph 8 of Part Two of the Fourth Schedule to the Constitution of Kenya 2010 provides for the functions of the County Governments which include Planning, Housing and land survey and mapping; further aware that paragraph 14 of Part Two of the Fourth Schedule to the Constitution provides for the function of ensuring and coordinating the participation of communities and locations in governance at the local level and assisting communities and locations to develop the administrative capacity for the effective exercise of the functions and powers and participation in governance at the local level under the County Government; Acknowledging that the County Government developed an Urban Renewal programme which is anchored in the Nairobi Integrated Urban Development Master Plan (NIUPLAN) that identified the need to redevelop old developments and their related social and physical infrastructure within the County; **Noting that** the County Government has prepared the Eastland's Urban Renewal Master Plan with the support of the World Bank and the State Department for Housing and Urban Development specifically focusing on the redevelopment of the Eastland's area; **concerned that** the County Government had advertised tenders for proposal for design, finance, build and sale of affordable housing through a joint venture in nine (9) identified areas such as Lumumba, Jericho, Woodley and Ziwani Estates amongst others without adequate public participation; **further acknowledging** the effort by the County Government to fulfil the provisions of Article 43 of the Constitution on the right to accessible and adequate housing, this Assembly urges the County Executive to undertake a comprehensive public participation on the proposed projects in the identified areas to address pending questions by the residents before commencing the works.

#### I. The Assembly resolved on Tuesday, 21st February, 2023 as follows: -

- a) THAT, each speech in a debate on a **Report of a Committee**, a **Sessional Paper or any other Report submitted to the Assembly**, be limited as follows: A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that Order.
- **b) THAT,** each speech in a debate on any **Motion,** including a Special motion be limited in the following manner:-A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

IT IS NOTIFIED that the Select Committee on Assembly Business, at its last meeting, approved the following <u>tentative</u> business to appear in the Order Paper for Tuesday, 4<sup>th</sup> April, 2023 at 2.30 p.m.: -

#### A. \*<u>MOTION</u> – <u>HON. ANTONY KIMEMIA GATHUMBI, MCA</u> Subject: *Rehabilitation of the County Social Halls.*

THAT, aware that Article 55 of the Constitution of Kenya 2010 provides for the State to take measures, including affirmative action programmes to ensure that the youth have opportunities to associate, be represented and participate in political, social, economic and other spheres of life, access employment and are protected from harmful cultural practices and exploitation; further aware that Part Two of the Fourth Schedule to the Constitution provides for the functions of the County Government which include ensuring and coordinating the participation of communities and locations in governance at the local level and assisting communities and locations to develop the administrative capacity for the effective exercise of the functions and powers and participation in governance at the local level; concerned that there is joblessness among youth with talents in the County which has negative impact on the economy as it forces to depend on small working class thus stretching family resources; further concerned that most County social halls are in deplorable conditions due to negligence and desertion by the County Government which has contributed to lack of talent nurturing venues for youth within the County; noting that creative Arts and Talents Sector is greatly overlooked, under-appreciated window of opportunity in the County where youth with talents can be mentored to discover, develop and build up their capacities; further noting that unemployment among young people fuels frustration and desperation and in response, some of the youths turn to socially and legally unacceptable vices such as violence, substance abuse and even suicide, which have negative repercussions on the young people and contribute to growing security, moral and psychological instability in the society; acknowledging that in many developed countries creative arts such as films, music, dance and painting amongst others have proved to be well-paying and good revenue earnings, this Assembly urges the County Executive to urgently rehabilitate and modernize all the existing County Social halls and streamline their management to ensure that youths across the County are encouraged and mentored to develop and manage their arts and talents in the County.
