8. *MOTION – CHAIRPERSON, SELECT COMMITTEE ON PROCEDURE & RULES

Subject: *Adoption of report*

THAT, this Assembly adopts the **REPORT OF THE SELECT COMMITTEE ON PROCEDURE AND RULES ON AMENDMENT OF THE STANDING ORDERS**, laid on the Table of the Assembly on Wednesday, 18th October, 2023.

9. *MOTION – HON. PETER JATESO IMWATOK, MCA – MAJORITY LEADER

Subject: *Operationalization of the Sports Fund*

THAT, aware that Paragraph 4 (h) of Part 2 of the Fourth Schedule to the Constitution of Kenya (2010) mandates County Governments with the responsibility of managing sports activities and facilities; **FURTHER AWARE** that, the Nairobi City County Assembly enacted the Nairobi City County Sports Management Act, 2017 to provide for the management, promotion and regulation of sports in the County; **NOTING** that, Section 11 of the said Act provides for the establishment of the Sports Fund whose purpose amongst others is to fund the training, research, development and

capacity building of sports activities in accordance with the Sports Plan contemplated under Section 8 of the said Act; **CONCERNED** that, despite these clear provisions of the law, the County Executive is yet to establish the Sports Fund to support sporting activities in the County as envisioned in the Act thus hampering the development of sports; **FURTHER CONCERNED** that, sporting teams that represent the County in various national competitions have been turned into beggars depending on well-wishers which is not only heartbreaking but humiliating as well; this Assembly **RESOLVES** that the County Executive:-

- i) Operationalize the Sports Fund as envisioned under Sections 10 and 11 of the Nairobi City County Sports Management Act, 2017 and further that the funds be utilized in supporting sporting teams in the County;
- ii) Factors monies in the Budget Estimates for the FY 2024/25 for purposes of the Fund; and
- iii) Develops and submit to the County Assembly Regulations contemplated under Section 16 of the said Act within three (3) months of adoption of this Motion. The regulations should amongst other things provide for the management of the Sports fund.

NOTICES

I. The Assembly resolved on Tuesday, 21st February, 2023 as follows: -

- a) **THAT**, each speech in a debate on a **Report of a Committee, a Sessional Paper or any other Report submitted to the Assembly**, be limited as follows: - A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that Order.

- b) **THAT**, each speech in a debate on any **Motion**, including a Special motion be limited in the following manner:-A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

IT IS NOTIFIED that the Select Committee on Assembly Business, at its last meeting, approved the following ***tentative*** business to appear in the Order Paper for Thursday, 19th October, 2023 at 2.30 p.m.: -

A. MOTION – HON. AMI AMBALA, MCA

Subject: To *conduct a mandatory mental health assessment of all its employees in the County with an aim of sensitizing, diagnosing and recommending treatment.*

AWARE THAT paragraph 2 of Part 2 of the Fourth Schedule to the Constitution of Kenya, 2010, provides for primary health as one of the devolved County Government's function; **CONCERNED THAT**; according to the Kenyan National Commission of Human Rights an estimate of 25% and 40% of outpatients and inpatients suffer from mental health conditions, with most frequent diagnoses of mental illnesses made in general hospital settings being depression, substance abuse, stress, and anxiety disorders; **FURTHER CONCERNED THAT**; public service has not been an exception as evident by the rising cases of mental health with alarming rate of alcohol and substance use, anxiety disorders, suicides, occupational injuries, workplace conflicts and absenteeism leading to a decline in quality of service delivered and productivity among public officers; **ACKNOWLEDGING THAT**; there is need of urgent prevention and mitigation measures by public and private sector employers that will enable timely sanitization, counselling and assessment of mental health cases without stigmatization; this **ASSEMBLY THEREFORE RESOLVES** that the County Executive conducts a mandatory mental health assessment of all its employees in the County with an aim of sensitizing, diagnosing and recommending treatment for any mental health cases for the same and the exercise to be emulated by the private sector.
