8. \*. **MOTION** – (Hon. Peter Imwatok, MCA)

**THAT**, aware that youth employment remains a major challenge for both the National and County Governments; deeply concerned that Nairobi City County has the highest number of unemployed urban youth, leading to a rise in insecurity and other vices from the lack of economic opportunities for the youth; noting that the city has the potential to provide employment opportunities for the youths in the environmental and garbage management sectors if well leveraged; recognizing that unplanned waste dumping and blockage of drainage systems can be cured by providing a formalized, well-structured casual labor employment opportunities for thousands of youths across the city within their areas of habitation for purposes of waste collection and disposal; observing that the foregoing arrangement has the potential to provide a clean living environment for all residents as well as create sustainable livelihoods for the youths; this Assembly urges the County Executive to explore modalities for creating a framework for the employment of a 1000 strong casual laborers positions spread across all wards for the purpose of collection and proper disposal of garbage across the City.
