## 1.2 Official Opening and Introductory remarks

The workshop was officially opened by a word of prayer by the Hon. Chairperson before welcoming Members to the meeting. Members were reminded of the key objective of the workshop which was to review the Committee work for the year, consideration of the pending inquiries and pending statements.

The Chairperson in his remarks reminded Members that the Committee was yet to consider any Bill other than its pending legislative proposal on the Nairobi City County Sports Management Bill. Further, Members were informed that, being the end of the 4<sup>th</sup> Session, as the Committee prepares to commence to the fifth session of an election year, efforts needed to be channeled to all the pending business.

The Chairperson concluded by urging Members to maximize on the remaining time and to actively participate on the oncoming deliberations.

### 1.2.1 Adoption of the Program and Deliberations

A member proposed that deliberations of the under-listed report be deferred to enable in-depth deliberations with the County Public Service Board Members as the originators. The report was:-

- a) Annual report to the County Assembly on the Promotion of National Values and principles of Governance in Public Service for the FY 2015.

The Committee agreed to amend the program as proposed by the Member. The program was adopted thereafter for deliberations as proposed by Hon. Peter Isuha and seconded by Hon. Rose Ogonda.

## 1.3 DELIBERATION ON THE EARLIER CONCLUDED SPORTS GROUNDS INSPECTION IN THE COUNTY BY THE COMMITTEE

Sessional Chairperson: Hon. Peter Isuha, MCA

The Committee Chairperson took Members through one the Committee's site visit reports to fifteen (15) County sports facilities. The said visits had been conducted on 25<sup>th</sup>, 26<sup>th</sup> February and 2<sup>nd</sup> March 2015.


The Objective of the site visits was to; assess the status of the sports grounds and facilities, their development against the previous allocated budget and to give recommendations and way forward from the findings.

During the deliberations, the following issues were pointed out, that:-

i. Kibera sports grounds "Kwa DC";

- The ground was in a generally poor state; no sports activities were being held in the ground;
- The site was being used by the NYS as a loading and offloading field for materials used in the upgrading of roads in Kibera;
- There was no washroom nor changing room in the facility.

The situation in the ground is as illustrated below;









ii. Joseph Kangethe grounds;

- the sports ground was in a poor condition;
- no security wall erected especially towards the Kibera residential;
- the facility lacks public toilet and changing room;
- the grounds' podium needs renovation;
- there was no lighting/ security lights in the facility; and,

The indoor games hall (for boxing and table tennis) behind the podium had been converted into a rehabilitation center and beddings equipped in one of the rooms.




### iii. Riruta grounds "BP";


- the ground was fence and a wash room and changing room developed through a partnership between Nairobi County Government and Kenya Power and Lighting Company;
- the Committee was informed that the project was not completed as per the contract;
- part of the ground has been used to develop a resource center with indoors activities my the area MP through Constituency Development Fund initiative;
- the management of the sports ground and revenue collection in done by the area youths;
- the part of the facility is claimed to have been grabbed by the Administration police department and metallic officers houses installed; and,
- the ground ownership needs to be determined.

The situation in the ground is as illustrated below;

#### iv. Kangemi grounds;



- access to the sports facility from the main entrance was and is always hindered by parked ~~matatus~~ and handcarts (*mkokoteni*);
- the security gate needs reinforcement since it was weak;
- there was presence of an ablution block shared by the traders in the market – Kangemi adjacent to the facility, nevertheless,
- it was also noted that people relieved themselves inside the facility wall leaving a disturbing odor at the entrance; and,
- there was a Committee in place which claimed to be the one managing the facility.



#### v. Hamza grounds;

- only one side of the wall was constructed and parts of it already collapsed/destroyed;
- the facility has no ablution block, running water and changing room in place;
- there is a need of a wire mesh to be erected in the wall to prevent the ball from going to the busy Jogoo road; and,
- the Committee was informed that a number of correspondence had been made requesting the City Engineering Department to repair the wall but in vain.


The situation in the ground was as illustrated below;



vi. Komarok Phase 1 grounds;

- the field lacks a perimeter wall as lorries and other motorists use it as a short cut to link Komarok Phase one estate road with Kang'undo road;
- the land has been encroached by informal settlements from one side and a church on the other hand;
- part of the ground had been recommended for establishment of a basketball and volleyball pitch but since then, no development could be seen;
- the facility is often used by school pupils in the environ though it is alleged that the sessional charges for using the facility is always collected by another group claiming to be managing the facility;
- it was also claimed that there was a youth group claiming ownership of the facility; and,
- there was no ablution block nor changing room in place.




vii. Komarok Phase 1 grounds offices;

- the Sports department has offices on the other side of the road, sharing a compound with a church, the piece of land is on an ownership dispute between the Church – Restoration of Hope Church;




vii. Tena grounds;

- parts of the sports facility had been encroached by two different churches on its extreme ends and a plastic waste management yard;
- the facility lack a security wall and more often the facility is used by driving schools and individuals for driving lessons;
- there was a proposal of establishing hockey, volleyball and basketball pitch but there was no evidence of any development in place; and,
- there was no ablution block and changing rooms in place.




*Field used for driving lessons, part of the grabbed land by the Church and a plastic waste management yard*


viii. Jericho grounds "Camp Toyoyo";

- part of the facility is being used to develop a football stadium with a modern tuff – carpet by the area MP through a CDF initiative before being handed over to the Community;
- the other part of the facility has various sections like;
  - i. Handball pitch;
  - ii. Basketball court;
  - iii. 3 (there) lawn tennis courts;
  - iv. 2<sup>nd</sup> football pitch;
  - v. Netball pitch and yet the county does not generate any revenue on the same.
- there was no office on the ground for the facility's management; and,
- beside the new stadium under construction, the parts lacked an ablution block and changing rooms.

ix. Kaloleni III grounds;

- the field initially had 2 football pitch but the Committee noted that one of the pitch had been grabbed and developed;
- the facility lacked an ablution block and changing rooms; and,
- there was no perimeter wall nor street lights in the facility.



- the facility was developed through a CDF initiative;
- the facility is not under the County Management; and,
- the facility had basketball and football pitch in place.



- the facility is not fully fenced;
- there were no toilets and changing rooms in the facility; and,
- the facility lacked security lighting.



xii. Kariobangi North grounds;

- the facility had an incomplete perimeter wall;
- the facility is shared between Kariobangi primary school and the community;
- the facility had no toilet nor changing facility;



xiii. Korogocho grounds "Koch";

- the NYS had fenced half of the facility to use it in its operations towards the slam – Korogocho rehabilitation program. The Committee was as well informed that there were plans of renovating the facility after completion of the project by the NYS;
- the facility is shared by the school and the community, though the Committee was informed that there was a group claiming ownership of the facility; and,
- the facility also had no ablution block nor changing rooms.

#### Other facilities;

##### xiv. Huruma grounds;

- The facility had a perimeter wall in place courtesy of the Ministry of Sports;
- the football pitch in place was well established;
- the entire facility had the following ground established;
  - a) 2 football pitches
  - b) Volley ball section; and,
  - c) a mini-street soccer pitch.

##### xv. Califonia grounds "*Calif desert*".

- the facility had an mini established stand and shade installed; and,
- there was no ablution block or changing rooms in pace.

##### xvi. Ziwani grounds;

- the facility was fully fenced without a gate in place;
- there was an ablution block under construction; and,
- the facility had no security lightings.

Upon deliberations on the same, the Committee made the following observation, that;

- (i) there was no development nor signs of project initiated in all of the facilities visited by the Committee EXCEPT for Camp Toyoyo – Jericho grounds whose project had been initialized and Ziwani sports ground which had an ablution block in progress;
- (ii) most of the sports ground facilities had either been grabbed or encroached by informal settlers, churches or private developers;
- (iii) some facilities like Kawangware, Korogocho, Komarok among others had ownership conflict as area youths are alleged to be managing the facility and collecting revenues;

- (iv) majority of the facilities lacked ablution blocks in place, changing rooms and running water and security lights installed;
- (v) most of the facilities had no security walls in place and for the few that had; was through CDF or the Ministry of Sports initiative;
- (vi) most of the facilities had no officers on the ground nor offices within the facilities for effective operations; and,
- (vii) Some of the County facilities had been developed by area MPs through the CDF initiative and later handing the project to the community. This has led to some facilities being operated as private entities.

#### 1.4 DELIBERATIONS AND WAY FORWARD

During the plenary discussion of all the aforementioned presentations, the following issues were raised by the Committee Members THAT;

- i) Measures that can be taken to bring order and effective management of the County Sports facilities.

*Way forward:*

- a) *Committee was advised to follow up with the Executive Sports Sector on its earlier proposal to a policy on the County Sports Management; and,*
- b) *That the Committee follows up on its earlier proposed Legislation on the Nairobi City County Sports Management Bill that was developed by the Committee with the help of its secretariat and whose approval for publishing had been made; and,*
- c) *The Committee to consider meeting with the relevant parties to deliberate on the same and to assess the current situation as the finding herewith were made in 2015.*

#### 1.5 COMMITTEE PENDING STATEMENTS

Chairperson: Dan Mutiso, MCA

The Sessional Chairperson took Members through the status of the Committee statements that were sought on the floor of the Assembly. This were as follows:-

- i. From June to December 2016, the Committee had received five (5) statement requests and responded to two (2). However, three (3) were still pending and the Committee awaits responses from the Executive;

ii. Some of the responded statements were as follows;

- a) Statement regarding the positions awarded to Directors in different departments on acting capacity and the recruitment of candidates in the Cooperative Department as advertised in the County Government Website; and,
- b) Statement regarding plans to hand Lap trust pension scheme another estate in debt swap

iii. The Statements that were pending responses were as follows;

- a) Statement request regarding the recent public dismissal of some County Inspectorate employees by the Governor for alleged failure to reign in the general lack of order in the CBD;
- b) Statement request regarding medical cover for the County Government staff and;
- c) Statement regarding the payment of youth who worked for the City County under the Decentralization Department for a month in various Wards.
- d) Statement regarding shortage of ambulance drivers within the County

#### DELIBERATIONS AND WAY FORWARD

The following concern and advice to the same were raised during the plenary session, that:-

- i) There was consistent delay by the Executive in responding to the Committee statement requests.

*Way forward:*

- d) The Committee to invite the C.E.C Member and the Chief Officer concerned to its meeting to deliberate on the same together with the statement pursuer and the outcome be reported in the Assembly;*

#### 1.6 DELIBERATION ON ISSUES AFFECTING HEALTH WORKERS IN THE COUNTY

Chairperson: Rose Ogonda, MCA

The following key issues were proposed by Members, that:-

- i. That the Committee considers entering into a joint-sitting with the Sectoral Committee on Health Services together with the County Public Service Board, The CEC Member and Chief Officer of Health to deliberate on the issues affecting the medics and how it could be addressed.

Members were in agreement with the proposal made by the Hon. Member.

## 1.7 STATUS OF THE IMPLEMENTATION OF THE COMMITTEE REPORTS

Chairperson: Christine Abuto, MCA

The Sessional Chairperson briefly took Members through the Committee recommendation of its previous two (2) reports that had been tabled in the Assembly. These reports were;-

- i. The Report of the Sectoral Committee on Labour and Social Welfare on the Consideration of the Nairobi County Public Service Board Annual report for the FY 2014/2015; and,
- ii. The Report of the Sectoral Committee on Labour and Social Welfare on the report of the Nairobi County Public Service Board on Promotion of National Values and Principles of Governance in Public Service for the FY 2014.

One of the Committee Members proposed that the implementation status of the recommendations of the aforementioned reports be deliberated in one of the Committee's meeting with the County Public Service Board.

## WAY FORWARD

The Committee Chairperson concluded by urging Members to channel their efforts on a number of areas once the Assembly resumes the 5<sup>th</sup> Session as they were critical. These were;

- i. Finalizing on all the pending statements;
- ii. Adoption and tabling of all the pending reports;
- iii. Expediting the development and implementation of the County Sports Management policy with the sports sector as a primary ground for legislation;
- iv. Follow up on the issue of the employment of Health workers who had been shortlisted as per advertised positions in August, 2016 and communication and way forward on the same;

- v. Consideration of the sector's Supplementary budget for the FY 2016/2017 and the sectors' Budget estimates for the FY 2017/2018 and,
- vi. Consideration of the Annual Report of the County Public Service Board on the Promotion of National Values and Principles of Governance in Public Service

#### **1.8 COMMITTEE'S RECOMMENDATIONS;**

Following the Committees findings and oral submissions by the Stadium Management officers who had accompanied the Committee, the following recommendations were raised, THAT:-

- a) The Committee be facilitated to develop a legislation that will address the challenges. That is ; The County Sports Management Bill which will establish a Sports Management Board that will oversee the operations of all the activities and leagues in the County together with a Sports Committee of at least 5 members who will be managing the facility's operation on the ground but answerable to the Board;
- b) That a taskforce be formed to carry out a thorough audit of all the facilities, determine their ownership and original demarcation, investigation on the developments against budget allocation together with the stakeholders views;
- c) The executive to ensure that each sports facility of certain standard or size to have an ablution block, changing room and staff office in place for effective management of the facility and revenue collection; and,
- d) All county facilities be fenced and security lighting and shades be installed.

- the facility is often used by school pupils in the environ though it is alleged that the sessional charges for using the facility is always collected by another group claiming to be managing the facility;
- it was also claimed that there was a youth group claiming ownership of the facility; and,
- there was no ablution block nor changing room in place.

vi. Komarok Phase 1 grounds offices;

- the Sports department has offices on the other side of the road, sharing a compound with a church, the piece of land is on an ownership dispute between the Church – Restoration of Hope Church;

vi. Tena grounds;

- parts of the sports facility had been encroached by two deferent churches on its extreme ends and a plastic waste management yard;
- the facility lack a security wall and more often the facility is used by driving schools and individuals for driving lessons;
- there was a proposal of establishing hockey, volleyball and basketball pitch but there was no evidence of any development in place; and,

The Committee Chairperson took Members through the remaining County sports facilities.

vii. Jericho grounds "*Camp Toyoyo*";

- part of the facility is being used to develop a football stadium with a modern turf – carpet by the area MP through a CDF initiative before being handed over to the Community;
- the other part of the facility has various sections like;
  - i. Handball pitch;
  - ii. Basketball court;
  - iii. 3 (there) lawn tennis courts;
  - iv. 2<sup>nd</sup> football pitch;
  - v. Netball pitch and yet the county does not generate any revenue on the same.
- there was no office on the ground for the facility's management; and,
- beside the new stadium under construction, the parts lacked an ablution block and changing rooms.

The situation in the ground regarding the CDF Project is as illustrated below;

viii. Kaloleni III grounds;

- the field initially had 2 football pitch but the Committee noted that one of the pitch had been grabbed and developed;
- the facility lacked an ablution block and changing rooms; and,
- there was no perimeter wall nor street lights in the facility.

The situation in the ground is as illustrated below;

ix. Uhuru sports grounds;

- the facility was developed through a CDF initiative;
- the facility is not under the County Management; and,
- the facility had basketball and football pitch in place.

The situation in the ground is as illustrated below;

x. Dandora Phase 4 sports grounds;

- the facility is not fully fenced;
- there were no toilets and changing rooms in the facility; and,
- the facility lacked security lighting.

The situation in the ground is as illustrated below;

xi. Kariobangi North grounds;

- the facility had an incomplete perimeter wall;
- the facility is shared between Kariobangi primary school and the community;

- the facility had no toilet nor changing facility;

The situation in the ground is as illustrated below;

xii. Korogocho grounds "*Koch*";

- the NYS had fenced half of the facility to use it in its operations towards the slam – Korogocho rehabilitation program. The Committee was as well informed that there were plans of renovating the facility after completion of the project by the NYS;
- the facility is shared by the school and the community, though the Committee was informed that there was a group claiming ownership of the facility; and,
- the facility also had no ablution block nor changing rooms.

The situation in the ground is as illustrated below;

xiii. Huruma grounds;

- The facility had a perimeter wall in place courtesy of the Ministry of Sports;
- the football pitch in place was well established;
- the entire facility had the following ground established;
  - a) 2 football pitches
  - b) Volley ball section; and,
  - c) a mini-street soccer pitch.

xiv. California grounds "*Calif desert*".

- the facility had an mini established stand and shade installed; and,
- there was no ablution block or changing rooms in place.

xv. Ziwani grounds;

- the facility was fully fenced without a gate in place;
- there was an ablution block under construction; and,
- the facility had no security lightings.

MIN 211/LSW/NOV/2016 – RECOMMENDATIONS;

Following the Committees findings, the following recommendations were raised, THAT:-

- a) The Committee be facilitated to develop a legislation that will address the challenges. That is ; The County Sports Management Bill which will establish a Sports Management Board that will oversee the operations of all the activities and leagues in the County together with a Sports Committee of at least 5 members who will be managing the facility's operation on the ground but answerable to the Board;

- b) That a taskforce be formed to carry out a thorough audit of all the facilities, determine their ownership and original demarcation, investigation on the developments against budget allocation together with the stakeholders views;
- c) The executive to ensure that each sports facility of certain standard or size to have an ablution block, changing room and staff office in place for effective management of the facility and revenue collection; and,
- d) All county facilities be fenced and security lighting and shades be installed.
