In order to achieve the above mandate the Liaison Committee undertook a workshop to consider the bi-annual reports of all the Committees for the period June to December, 2016



1.0 Official Opening and Introductory remarks

The workshop was officially opened by a word of prayer by the sessional Chairperson before welcoming Members to the meeting. Members were reminded of the key objective of the workshop which was to deliberate on all the Committee's bi-annual report, pending work and its focus for the year 2017.

Being an election year, members were made to understand how short the 5th Session of the 1st Assembly will be. The Chairperson thereafter invited the Assembly Clerk to give remarks on the way forward for the 5th session and how Committees and Assembly at large can utilize the remaining time.

1.1 OPENING REMARKS BY THE ASSEMBLY CLERK

Clerk: Mr. Jacob Ngwele.

The Assembly Clerk thanked the Chairperson and Members before giving the following remarks, THAT;-

- Being the 5th Session and an election year, the Assembly will be in operation until 8th August 2017, and campaign will commence 3 month to elections (May) as provided by the law;
- ii. The Assembly is required to manage the remaining time efficiently to ensure pending works are prioritized and finalized;
- iii. That some of the areas that needs prioritization/ consideration during the first three months of the year are;
 - a. Consideration of the County Fiscal Strategy Paper CFSP;
 - b. Tabling of Budget Estimates for fy 2017/2018 and conducting Public Hearings before March 2017; and,
 - c. Pending statement responses.
- iv. Swearing in of new members shall be done collectively and not in isolation a per the new amendments of the County Government Act;
- v. The current case in court over the 4th and 5th floor office space between the Assembly and the Executive has led to the stalemate of business between the Assembly and the Executive and that the Office of the Speaker and the Office the Clerk are working to address the same:
- vi. Due to the limited time, Committees are advised not to open new business or inquiries but to focus on the pending ones;
- vii. the Committee Chairperson to ensure that all the pending Bill or the ones awaiting introduction in the floor of the Assembly be fast tracked;
- viii. Committees to follow up on Bills from their Executive sectors. Correspondence in that effect to be dispatched to the County Executive Committee Member to forward the same for consideration;
- ix. In handling of the pending statements, Committee to invite the executive officers with pending statements for deliberations on the same together with the Member who sought the statement and report tabled in the Assembly;



- x. Failure by the Executive Officers to attend Committee meetings for statements deliberation, be subjected to sanctions;
- xi. All Committees will be required to compile a Sessional report, indicating the activities Committees have done since the beginning to the end of the 1st Assembly. The office of the Clerk will enhance its secretariat capacity in preparation of the same. The said reports will be for documentation and future reference; and,
- xii. The aforementioned Committees Sessional reports will be used by the new Assembly for purpose of continuity;

1.2 Adoption of the Program and Deliberations

The workshop program was adopted for the deliberations of the workshop through a proposal by Hon. Ken Oduru and a seconding by Hon. Shadrack Juma.

1.3 Committee deliberations

The Committee considered the biannual progress report of nine (9) Sectoral Committees and eight (8) Select Committees. The biannual progress reports of the Committees included the following items; Committee sittings, reports, statements, bills, petitions, investigations, retreats, site visits and foreign study visits.

2.0 PRESENTATION OF THE BI-ANNUAL PROGRESS REPORTS

The respective Sectoral Committee Chairpersons took the meeting through the Committee's biannual reports as contained below;

2.1 SECTORAL COMMITTEE ON HEALTH SERVICES

Chairperson: Hon. Manoah Mboku, MCA

The Committee Chairperson took Members through the Committee's activities during the period under review which was as follows;

(a) Sittings

In the period under review the Committee held most of their sittings in County Assembly Buildings.


(b) Local Visits

During the period under review the committee has undertaken one site visit to Eastleigh Health Centre to inspect the quality of health care services offered to the public.

(c) Seminars/Workshops/Conferences

During the period under review the Committee conducted three (3) workshops;

- i. Workshop held at Sawela Resort, Naivasha from Thursday 9th Sunday 12th June, 2016 to:
 - Deliberate on the proposed Nairobi City Health Services legislation;
 - Deliberate on the proposed Nairobi City Maternal Health legislation; and



- Understanding the procurement process and way forward on the enhancement of Health Sector projects implementations through procurement.
- ii. Workshop held at Sawela Lodge Hotel, Naivasha from Thursday 15TH Sunday 18th September with the following objectives:
 - To deliberate on the harmonized Health Strategic Plan;
 - To deliberate on the Sector performance for the 4th quarter of FY 2015/2016; and
 - To consider progress in addressing key challenges in the sector
- iii. Workshop held at Sawela Lodge Hotel, Naivasha from Thursday 10TH Sunday 13th November 2016 with the following objectives:
 - To deliberate on the progress report for (quarter 1) 2016/2017 FY;
 - To deliberation on key public health concerns in the county; and
 - To deliberation on the recommendations in committee reports.

2.2 SECTORAL COMMITTEE ON WATER AND SANITATION

Chairperson: Hon. Alex Ouda Otieno, MCA

The Committee Chairperson took Members through the Committee's activities during the period under review which was as follows:

a) Sittings

The Committee has held a total of 52 meetings where agendas involved amongst others; meeting the County Executive officers in line with the mandate of the Committee as provided for in Standing Orders 191 (5).

b) Local visits

During the period under review, the Committee undertook the following visits:-

- i. Visits to Nairobi Dam (8th July, 2016) and Kahawa Soweto informal settlement (15th July, 2016). The objective of these visits was to assess restoration progress of the dam and establish effectiveness of the automated water dispensers in informal settlement; and.
- A courtesy call to the Cabinet Secretary on 28th July, 2016, Ministry of Water and Irrigation as follow up on;
 - > The pending Water Bill, 2014 aimed at strengthening the legal framework in the Water Sector:
 - > The launch of new machine/ driller in Muranga to boost the infrastructural capacity to increase water supply to the City;
 - > Partnership with Nyandarua County Government to tap into the existing water potential to supplement the Northern Collector; and,
 - > Recycling of waste water as a measure to abate incessant rationing.

c) Workshops/retreats

The Committee conducted two workshops in Naivasha from Sunday 20th – Wednesday 23rd November, 2016 and from 28th September – 2nd October, 2016.

The issues under discussion included among others;

- a) The status of Njiru, Dandora and Kayole Sewer that were allocated kshs. 9 million, kshs. 7 million and kshs. 6.8 million respectively in 2016/2017 FY;
- b) Implementation plan of the kshs. 340 million Ward based water projects;
- c) Detailed presentation of the work plan and performance contract of the sector for the FY 2016/2017; and,
- d) Pending Nairobi City County Water and Sanitation Bill and Policy.

d) Statements

During the period under review, the Committee has received two statement requests as follows:

- i. Statement requested by the Hon. Hashim Kamau, MCA regarding the process of recruitment of Board of Directors of Nairobi City Water and Sewerage Company Limited; and,
- ii. Statement requested by Hon. Elkana Mauti, MCA regarding the implementation status of Water Tanks project in every Ward.

It is worth noting that these were the only statements in the period under review. Respective Members have since been satisfied by the responses which are due to be responded on the floor once the Assembly resumes its plenary sittings.

e) Reports

The Committee is currently considering two reports on the Sasumua Dam and Melbourne study tour.

f) Priority Areas 2017

In this New Year, 2017, the Committee intends to among others;

- Meet with the Cabinet Secretary in charge of Water and Irrigation to share recommendations and resolutions resultant from the Melbourne study tour CS (initiation of implementation process of Storm Water harvesting and Waste water treatment technologies in Nairobi by the readily willing Australian government);
- ii) Liaise with the County Executive to expedite submission of Water and Sanitation Bill and Policy to the Assembly;
- iii) Table the Sasumua Dam Report that has taken fairly long due to prolonged conflict of interest between Nyandarua and Nairobi County Governments;
- iv) Follow up with the Cabinet Secretary in charge of Environment and Natural resources on progress in restoration of Nairobi Dam (getting acquainted with the reports/briefs on the work of the Nairobi Dam task force constituted and spearheaded by the CS, Environment); and,
- v) Meet with the newly appointed Nairobi City Water and Sewerage Company Board of Management.



2.3 SECTORAL COMMITTEE PLANNING AND HOUSING Vice-Chairperson: Hon. Maxwell Ochar, MCA

The Acting Committee Chairperson (who is the Vice-Chairperson of the Committee) took Members through the Committee's activities during the period under review which was as follows;



2.17 ASSEMBLY BUSINESS COMMITTEE - ABC

In the period under review the Committee held a total of 35 sittings held at City Hall Buildings, Mombasa and Kisumu. The meetings were held for the following purposes;-

- i. To allocate business for the Assembly (business for 43 sittings allocated);
- Consultative forum with Members of Kisumu County Assembly Business Committee;
 and,
- iii. To plan for the Fifth Session.

b.Committee Reports

The Committee has, during the period under review produced one report,

i) Report of the Committee workshop on strategizing on the prioritization of business in light of the impending conclusion of the First Assembly and preparation of work plan held at Serena Beach Hotel as from 21st to 25th September, 2016.

c.workshop and retreats attended

During the period under review, the Committee held two retreats as follows:-

i) Retreat held from 21st to 25th September, 2016 at Serena beach hotel. The objective of the retreat were:-



- Review the performance of the Committee in terms of the management of Assembly Business for the period April 2016 to August, 2016;
- Strategizing on the prioritization of business in light of the impending conclusion of the First Assembly; and
- Review of the Committee's annual work plan
- ii) Retreat and benchmarking visit held from 5th to 9th December, 2016 at Kisumu County Assembly and Imperial Hotel, Kisumu. The objectives of the retreat and the visit were:-
 - To enable members interact, share experiences and exchange ideas with their counterparts of Kisumu County Assembly regarding the discharge of their mandate.
 - Take stock of the progress made by the Committee during the Fourth Session particularly on procedural issues that have confronted Members while discharging their mandate and identify areas of improvement;
 - Share experiences and challenges of the Fourth Session and develop a work plan for the next and final session.

DELIBERATIONS AND WAY FORWARD

During the plenary discussion of all the aforementioned presentations, the following issues raised by the Committee Members and advice of the same provided by the Clerk and Committee secretariat, THAT;

i) Lack of implementation of the Assembly resolutions by the Executive was raised by Members.

Way forward:

- a) Committees were advised to deliberate on the same during their meeting with the CECM; and,
- b) a summary of the resolutions which were passed in the floor of the Assembly be made by the implementation Committee for follow up;
- ii) A Member also raised a concern regarding decentralization of the County Treasury which has since yet to be implemented by the CEC Finance limiting the operations of the Chief Officers in procuring and implementing projects and programs.

Way forward:

- a) The Public Account Committee in its reports consider recommending the same for adoption by the Assembly; and,
- b) Public Accounts Committee to limit its deliberations with the Chief Officers on audit report and instead focus on the CEC Finance since financial function is yet to be decentralized.
- iii) The Committee was made aware by one of the Member of the salary payment of the defunct Nairobi City Council primary school teachers by the County Government despite the Primary Education being a function of the National Government;

Way forward:

Report of the Liaison Committee on consideration of Biannual progress Reports of all Committees for the period June to December, 2016.



- a) The Sectoral Committee on Education to follow up on the matter; and,
- b) The County Government should consider coming up with Memoranda of Understanding –MOU for lease of primary school lands in that regard.
- iv) A concern was also raised by a Member regarding Ward Development Fund whose funds are yet to be transferred to the account for development purpose despite that same having been budgeted for in the current fy budget.

Way forward:

- a) The Ward Development Fund Committee, Budget and Appropriations Committee an Implementation Committee to consider in a joint sitting with the CEC Finance to deliberate on the same and ensue the following questions are answered;
 - > How much was the Budget allocation for WDF?
 - What were the vote numbers given?
 - > Were the codes assigned in the IFMIS?
- v) There is a need for a Liaison sub- Committee to be formed to look into the issues of the collapsed buildings in the County; and,
- vi) That a joint sitting with WDF Committee be considered on Wednesday 25th January 2016.

CONCLUSION AND THE WAY FORWARD

- > The Committee resolved to form a sub- Committee that will conduct site visits in an inquiry in to the collapse of building in the County;
- ➤ The Committee resolved to meet with the County Executive Committee in Mid-February 2017;
- > The Assembly to create a Liaison Desk that will coordinate and act as a linkage to the two organs of the County;
- > The Committee proposed to undertake a benchmarking visit to either the Republic of Uganda or Rwanda.
