On **Tuesday, 20th June, 2017**, the Committee held a meeting where Members were briefed on the content and objectives of the Policy. It's worth noting that the County Executive ,UNEP & Kenya Alliance of Resident Associations (KARA) have worked in partnership towards the development of the Policy and that the Committee was engaged by the stakeholders during a workshop held in Naivasha during the period 7th-8th June 2017. The purpose of the workshop was to familiarize Members on the objectives of the policy.

Mr. Speaker,

Nairobi City County is not only the capital city of Kenya, but also an important commercial and industrial hub for East and Central African region. However, the city has faced perennial challenges such as traffic congestion, poor infrastructure, poor adherence to traffic rules by both motorists and pedestrians amongst others. There are many ways in which policies can address the challenge of assisting people to go about their business whilst making it easier for everyone to move around. One way is through the embracing the use of Non-Motorized transport (NMT) for our County which is expanding both in infrastructure and population. NMT can be defined as means of transport that includes walking, use of bicycles and tricycles for passenger and freight transport, the use of wheelbarrows and carts, animal transport (horses, camels, donkeys, mules and oxen) and animal-drawn carriages (such as sledges). NMT modes also include the use of wheelchairs, skateboards and strollers.

Mr. Speaker,

Upon scrutiny of the NMT Policy, the committee established that the policy aims at:-

1. Increasing mobility by reducing number of vehicles on the road by encouraging citizens to adopt NMT use as a mode of Transport;
2. Increasing safety to pedestrians and NMT users by including NMT facilities on our roads;
3. Improving amenities for NMT; and
4. Increasing presence of NMT in the City.

2.0 INTRODUCTION

Mr. Speaker,

- 2.01. The Sessional Paper No.1 of 2017 on Non-Motorized Transport was tabled in the County Assembly on 15th June, 2017 for approval in accordance with Section 8(1) (e) of the County Governments Act, 2012.
- 2.02. The Sessional paper was thereafter committed to the Sectoral Committee on Roads, Transport & Public Works for consideration and report to the Assembly. The Committee met on 20th June 2017 to consider and adopt the policy. It is important to note that since the NMT is among the Sectors' flagship projects, there had been previous engagements on the same between the **Committee**, the **County Executive Committee Member** and the **Chief Officer responsible for Roads, Transport & Public Works** on Tuesday, 7th March, 2017, to brief Members on the content and substance of the policy. Further on 7th June 2017, the Committee met with UNEP and Kenya Alliance of Resident Associations (KARA) who are the key persons behind development of the NMT policy.
- 2.03. The Policy acknowledges the significance of Nairobi city as the capital city of Kenya and the regional economic and industrial hub in East Africa. It also recognizes the current challenges bedeviling the County such as traffic congestion, poor infrastructure, and insecurity amongst others.
- 2.04. The policy aims at developing concepts for implementation of Non-Motorized Transport facilities for ease of traffic congestion and improvement of living conditions based on the The Nairobi Integrated Urban Development Master Plan (NIUPLAN) 2014-2030 which proposes the development of a creative and green centered, pedestrian friendly Nairobi; complete with an all-encompassing and supportive transport system.

3.0 ANALYSIS OF THE NON MOTORIZED POLICY.

Mr. Speaker sir,

The Committee having scrutinized the policy established the following:-

1. NMT is the dominant transport mode in Nairobi accounting for over 40 per cent of total trips every day. In lower income areas, NMT accounts for 64

per cent, demonstrating its significant role in supporting marginalized and impoverished communities.

2. In Nairobi County, NMT serves a critical role and is an integral part of the County both as a means of transport as well as a contributor to commerce and trade.
3. Article 39(1) of the Constitution of Kenya states that every person has the right to freedom of movement. It is on this basis that this NMT policy proposes an integrated and all-inclusive transport system for Nairobi in which the non-motorized users are provided with appropriate space and facilities to enjoy their freedom of safe movement, which is a fundamental human right.
4. The Kenya Vision 2030 aspires for a country firmly interconnected through a network of roads, railways, ports, airports, water ways, and telecommunications. It aspires to setting up a strong institutional framework for infrastructure development, implementation of infrastructure projects that will target increased connectivity and reduced transport and other infrastructure costs.
5. The Traffic Act provides the framework for the enforcement of traffic laws, including those relevant to NMT users.
6. The Nairobi Master plan proposes the development of a compact urban centre that is creative, liveable, green, and competitive. It proposes that the urban centre should be pedestrian friendly for an efficient, effective and inclusive transport system. This NMT policy however advocates for the development and full integration of NMT within the whole of the Nairobi County transport system, not just the urban centre.
7. Ideally, the City County would aim to develop a comprehensive integrated transport policy. However, in the expectation that it may take some time, there is an argument that for Nairobi City County Government to better serve its citizens it has to commit to instituting a stable and progressive Non-Motorized Transport Policy. An NMT Policy will lead the way in

addressing a great challenge for Nairobi County and for the country as a whole.

8. The implementation of the policy will have the following outputs and outcomes;

a) Expected outputs

- Increase in NMT space coverage, services along NMT facilities, safe NMT crossings, better designed streets and increased user satisfaction.

b) Expected outcomes

- Increased modal share between public transport and cyclists, reduced NMT accidents and increased intermodal linkage.

9. As the draft NMT Policy 2015 document explains, a commitment to NMT will:

- i. Provide economic benefits through the creation of employment opportunities, a reduction in household travel costs and increased time savings for productive use; and
- ii. Assist in the reduction of fatalities and injuries among pedestrians due to generally uniform and lower motor vehicle speeds.

10. The Policy's vision is to make Nairobi an iconic and globally attractive city aimed at regional integration and sustainability. The plan recognizes the challenges currently affecting the city and as such, it aims at providing the mechanism for accelerating sound and sustainable development by improving infrastructure such as transport network.

11. Specifically, the policy seeks to address challenges affecting Nairobi City County in a multifaceted approach as follows:

i. Integration of NMT with Public Transport, Private Cars and Street Trading

The plan acknowledges challenges faced in urban transport mainly traffic congestion. As such, it seeks for the improvement of public and private transport, regularization of street vending that takes up space on street walkways, and applying of efficient and suitable transport systems. As per the Policy, to achieve efficient urban transport, the County

Government shall ensure enforcement of traffic rules governing on violations that endanger NMT users by deploying County Traffic Marshalls to police NMT facilities especially at intersections and along Public Transport routes. The Marshals should be able to arrest and prosecute both non-motorized and motorized transport users that violate traffic regulations.

ii. Education, Awareness and Promotion

In view of the neglected large portion of the population that uses and requires more comprehensive NMT facilities, the policy proposes that the County Government shall develop and roll-out basic NMT education and awareness programmes for local neighborhoods and public schools, and provide targeted educational and awareness opportunities for existing and potential cyclists and motorists. The Policy proposes that the County Government will specifically develop awareness information targeting private car users on the individual and social benefits of using NMT modes. Modal shift from private car use to cycling and Public Transport will free road space and reduce on congestion and vehicle smoke emissions. Cycling education and training curriculum will be introduced in County schools to create a cycling culture among school going children.

iii. Motor Vehicle Parking and Restrictions

Congestion of the City with private cars and Public transport remains the greatest nightmare to Nairobi citizens leading to a lot of time wasted maneuvering through traffic. To mitigate on this challenge the Policy proposes that the County should amongst others, Combine incentives for NMT and public transport with disincentives for private car use to make NMT and public transport trips competitive. One of the strategies will be to progressively make parking expensive and scarce within commercial districts so as to make cycling, walking and Public Transport trips more feasible and cheaper. This strategy will also reduce unnecessary private car trips to the CBD and reduce congestion.

i. Traffic Calming Measures

Over the years motorized transport users in Nairobi have been labelled as having little regard for other road users i.e NMT users. In this regard, so as to ensure the safety of NMT users the Policy proposes for the County Government to Review speed limits with the view of lowering speeds on roads that provide important connections in the NMT network to below 50 km/h, and creating 30 km/h within heavily pedestrianized areas like the CBD and residential areas. Motor vehicle speed is one of the main factors influencing NMT users' negative safety perception of a road/street.

Appropriate limits will be set in accordance with road functions, in consultation with the National Transport and Safety Authority (NTSA) and the relevant Road Authorities.

4.0 COMMITTEE OBSERVATIONS

Mr. Speaker sir,

The Committee having analyzed the Policy observed as follows:-

1. That the Policy was developed as a response to various perennial challenges facing Nairobi City County such as traffic congestion, poor infrastructure, dilapidated environment, insecurity amongst others.
2. That the Policy was developed through a comprehensive stakeholder participation and therefore most concerns of the stakeholders are addressed.
3. That the Policy seeks to address the challenges affecting the city in a multifaceted approach. Key interventions include:-
 - Preparing new Nairobi streets and roads manual
 - Classifying all city roads
 - Routinely improving the City's transport network
 - Routinely maintaining roads in the City
 - Collecting data continuously and creating a data base to inform future planning of transport and roads.
 - Developing and maintaining new NMT facilities.

4. Should the Nairobi City County Assembly adopt such a policy, Nairobi will not only be the first County to engage on this issue on a purposeful policy level, but will also provide the first NMT policy framework in the Country at both national and county Levels. Nairobi will set the stage for benchmarking across the country and the region as a whole.
5. Despite the broad support for a strong Non-motorized Transport Policy, past experience shows that transport policies (as well as public investments) have largely supported motorized transport at the expense of non-motorized transport, and public transport as a whole. As a result, the poor and disadvantaged, in both urban and rural areas, have been marginalized and denied an effective and efficient means and mode of movement.
6. The effects of private cars which account for 15 per cent of transport use in Nairobi has meant that the policy regime and development agenda has failed to address critical issues affecting Nairobi including:
 - i. Traffic congestion – as a result of failure to cater to transport needs of the majority.
 - ii. Inefficient public transport – that is plagued by poor network coverage and poor management.
 - iii. Land use planning & development is weak and is not linked to developing a city of the future that caters for NMT.
 - iv. Inefficient transport management – resulting in encroachment of NMT spaces and lack of both compliance and enforcement.
 - v. Road traffic accidents involving pedestrians – whilst these cannot all be blamed on the absence of a NMT policy, it does seem that the County Government has shown little regard for non-motorized road users or for pedestrian safety and consequently that motorists do not respect NMT users and infrastructure.
7. That if the aforementioned initiatives are implemented as envisioned in the Policy, challenges affecting the city shall effectively be addressed. However, this shall require Commitment by all the stakeholders. The County

Assembly ought to allocate resources to the projects while the County Executive must stick to and implement the plan by committing resources budgeted for the projects and seek support from other development partners.

5.0 RECOMMENDATIONS

The Committee recommends that in accordance with Section 8(1) (e) of the County Governments Act, 2012 and provisions of Standing Order 191(5)(b):-

This Assembly approves the Sessional Paper No. 1 of 2017 on the Non-Motorized Transport.

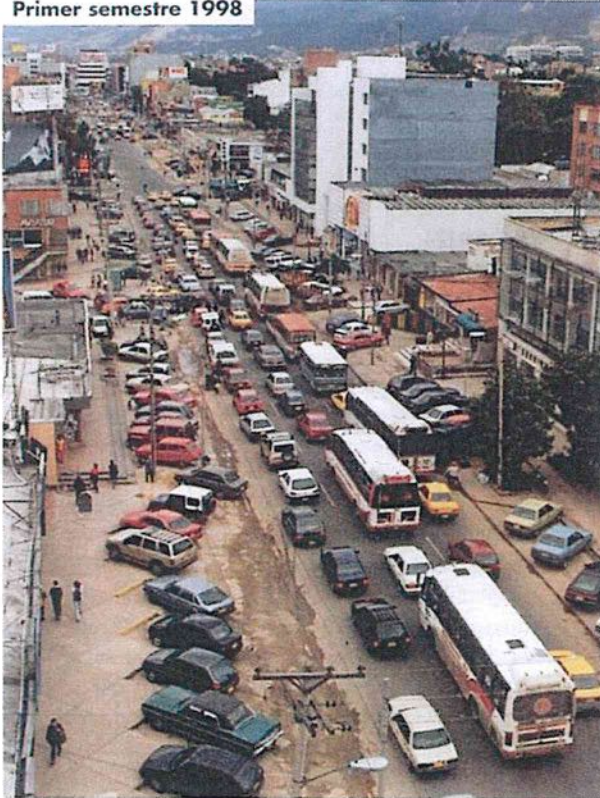

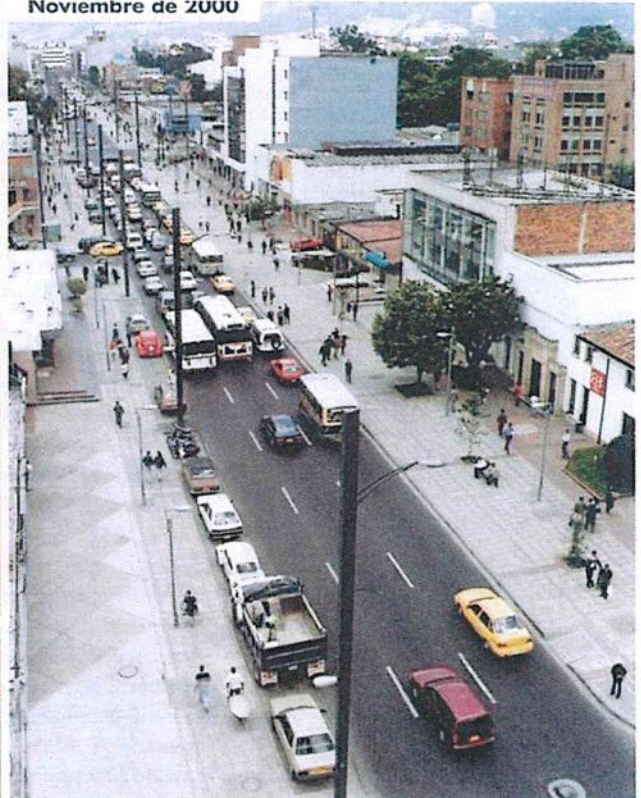


A pedestrian struggles to make his way on a road in the city. This picture shows the urgency needed for the city to embrace NMT facilities.
