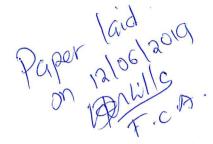

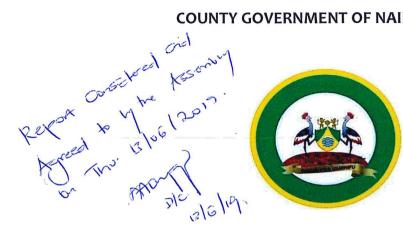

1.4 Committal to Committee on Labour and Social Welfare

Hon. Speaker,

Standing Order 43 (2) provides that 'If a message is received from the Governor or the Senator of the County, at a time when the County Assembly is not in session, the Speaker shall forthwith cause the message to be transmitted to every Member and shall report the message to the County Assembly on the day the County Assembly next sits'. The notification of nominations was therefore referred to the Sectoral Committee on Labour and Social Welfare on 13th May, 2019 for vetting and reporting to the Assembly within 21 days in accordance with Section 9(1) of the Public Appointments (County Assemblies Approval) Act, 2017 (hereinafter referred to as "the Act").

Subsequently, the Clerk of the County Assembly placed an advertisement in the in the local dailies, specifically the Daily Nation on Friday 17th May, 2019, inviting the public to submit memoranda by way of written statements on oath (sworn

affidavits) on the suitability or otherwise of the nominees in conformity with Section 7(10) of the Act.

1.5 Committee Meetings

The nominees for the County Public Service Board (C.P.S.B) appeared before the Committee on Tuesday 28th May, 2019 and were vetted in accordance with the provisions of the Constitution, the Public Appointments (County Assemblies Approval) Act, 2017, and the County Assembly Standing Orders on their suitability for appointment to the CPSB. In total, the Committee held three sittings in consideration of this matter.

2.0. BACKGROUND

2.1 Mandate of the Sectoral Committee on Labour and Social Welfare

The Sectoral Committee on Labour and Social Welfare is one of the Sectoral Committees established under Standing Order No. 203 with amongst others, the mandate to vet and report on all appointments where the Constitution or any law requires the County Assembly to approve, except those under Standing Order 196 (Committee on Appointments).

2.2 Appointment process of the County Public Service Board Nominees

Article 235 (1) of the Constitution of Kenya provides for the Governor's power to appoint persons to hold offices in the County Public Service with the approval of the Assembly, from among persons competitively sourced.

A letter from the Office of the Governor dated 8th May, 2019 addressed to the Speaker of the County Assembly indicated that the names of six (6) nominees has been forwarded for vetting by the Sectoral Committee on Labour and Social Welfare and consideration for approval by the County Assembly for appointment as Members of the County Public Service Board.

2.3 Notification to the Public

Section 7(5) and (10) of the Public Appointments (County Assemblies Approval) Act, provides that-, "the committee shall, by notice in at least one newspaper of national circulation, notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing" and "any person may, prior to the approval hearing and by a written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

Pursuant to the above provisions of the law, the Clerk of the County Assembly placed an advertisement in the local dailies, specifically the Daily Nation on Friday 17th May, 2019 inviting the public to submit memoranda by way of written statements on oath (sworn affidavits) on the suitability or otherwise of the nominees. At the close of business on Friday 24th May, 2019, no memoranda contesting the suitability of the six

nominees to the Board had been received.

In accordance with the provisions of Article 196 of the Constitution and section 7(5) of the Public Appointments (County Assemblies Approval) Act, the general public was also notified in the local dailies by the Clerk of the County Assembly of the intention of the Sectoral Committees to conduct the vetting and approval hearing of the nominees on Tuesday, 28th May, 2019.

The nominees were vetted by the Sectoral Committee on Labour and Social Welfare on Tuesday 28th May, 2019 at the County Assembly Committee room 5.

2.4 Clearance Requirements

To ensure compliance with the provisions of Chapter 6 of the Constitution, the nominees were required to submit their clearance status with the following institutions for the vetting exercise –

- a) Kenya Revenue Authority (KRA)
- b) Criminal Investigation Department (CID)
- c) Higher Education Loans Board (HELB)
- d) Credit Reference Bureau (CRB) and
- e) The Ethics and Anti-Corruption Commission (EACC)

The clearance by the foregoing institutions was primarily meant to provide information about the nominees on: -

- a) Matters touching on integrity;
- b) Tax compliance;
- c) Loan repayments; and
- d) Presence or absence of criminal records.

3.0 VETTING OF COUNTY PUBLIC SERVICE BOARD NOMINEES

In conducting the vetting process, the Sectoral Committee on Labour and Social Welfare examined the nominees against the following criteria, amongst others, as set out in the Public Appointments (County Assemblies Approval) Act No. 5 of 2017–

- i. Academic qualifications
- ii. Employment record
- iii. Professional associations
- iv. Potential conflict of interest
- v. Knowledge of the relevant subject
- vi. Overall suitability for the position
- vii. Tax compliance
- viii. Integrity

During its Sitting held on Tuesday, 28th May, 2019 at Committee Room 5, County Assembly Precincts, City Hall Buildings from 9:00 am, the Committee conducted face to face interviews of the nominees. The minutes of the vetting proceedings are attached to this report.

3.1 APPEARANCE BEFORE THE COMMITTEE BY MR. ABDIHAKIM MOHAMED KAHIYA – NOMINEE FOR CHAIRPERSON OF THE COUNTY PUBLIC SERVICE BOARD

The nominee for County Public Service Board Chairperson, Mr. Abdihakim Mohamed Kahiya, appeared before the Committee on Tuesday 28th May, 2019 at 9.00 am and was informed by the Chairperson that in line with the provisions of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the Committee had invited submissions from the Public on his suitability or otherwise for appointment to Public office, and none had been received by close of business on Friday 24th May, 2019.

While under oath, he proceeded to inform the Committee as follows:-

- A. With respect to self-introduction, knowledge, experience and qualification, the nominee informed the Committee that he was born in 1978 and:
 - a) He is a communication and public relations specialist with diverse managerial

background;

- b) He is currently pursuing masters of Art, diplomacy and foreign relations at Moi University, hoping to graduate in August this year;
- c) He holds a Bachelor of Science in communication and public relations and a diploma in community development and project planning management; and
- d) He has attended other professional courses, ranging from managerial, legislative drafting, communication and MME.

B. In response to his employment history and its relevance to the position, the nominee stated as follows:-

- a) Currently he is working for a consultancy firm as an executive director, where he
 is in charge of coordination of all sectors, including; governance, research,
 training etc;
- b) 2013-2017 he was the deputy speaker of Kakamega County Assembly and Member of the County Assembly, where he represented the minority and marginalized groups. He was also the chair of Liaison Committee;
- c) 2010-2011 he served as Red Cross national disaster response manager, where he was in charge of coordination of disaster response in the Country. He advocated and championed the disaster response policy;
- d) 2005-2009 he worked in the Office of the President Ministry of special programs, Ireland resource project which was a World Bank project. There he worked as a policy coordinator, coalition for pastoralist children education. It's during this time that he advised the Government of Kenya to come up with favorable policies and institution for the pastoralists. He came up with the vision and mission of the coalition and also formulated policies;
- e) 2004-2005 he worked in the Office of the President, Ministry of state special programs; world food program projects, where he was the emergency logistics coordinator. He was also the secretariat for the district steering group where he was coordinating secretarial committees and taking lead in the assessment based on those sectors; and

f) 2000-2002 He worked in an international organization Ox firm Quebec (Canadian foundation) where he was a distribution relief coordinator in Mandera.

C. Regarding his understanding for the position he applied for, he responded as follows:-

a) That the position he applied for is the Chairperson of County Public Service Board Nairobi City County; which is a corporate body that has the capability of suing and being sued. It has Members of not more than three and not less than five. That he will attend board meetings and guide the establishment and abolition of offices.

D. With regards to what motivated him to apply for the position and the relevant experience he will bring, the nominee stated that:-

- a) The nominee is passionate about the Public Service Board, having served in the public service. He understands the critical needs of the devolution structure and the practice to work in a noble County like Nairobi;
- b) In terms of professional experience, he has a successful managerial administrative policy working experience. He also has a wealth of experience in leadership that will help to attain the objective of the Board, having worked in similar positions where he developed policies into law. He has no doubt that the leadership qualities and experience that he has will help the Board to attain its objectives as stated in the County Governments Act;
- c) He was a Deputy Speaker and a Member of Kakamega County Assembly where he participated in drafting policies and legislation;
- d) He worked as a policy coordinator for coalition of pastoralist's education and helped to formulate a nomadic program (Nomadic Education National Council); and
- e) He has also served in the Office of the President special programs and the Red Cross where he initiated various policies.

E. On functions of the County Public Service Board, the nominee informed the Committee that the Board has powers to:-

- a) Establish and abolish offices in the County public service;
- b) Appoint persons to hold or act in offices of the County public service including in the Boards of cities and urban areas within the County and to confirm appointments;
- c) Prepare regular reports for submission to the County Assembly on the execution of the functions of the Board;
- d) Advise the County Government on human resource management and development; and
- e) Promote in the County public service the values and principles referred to in Articles 10 and 232 of the Constitution;

F. In response to some of the values referred to in Article 10 and 232 of the Constitution of Kenya, he stated as follows:-

The national values and principles of governance, article 10 include-

- a) Patriotism, national unity, sharing and devolution of power, the rule of law, democracy and participation of the people;
- b) Human dignity, equity, social justice, inclusiveness, equality, human rights, nondiscrimination and protection of the marginalized;
- c) Good governance, integrity, transparency and accountability; and
- d) Sustainable development.

The values and principles of public service, article 232 include-

- a) High standards of professional ethics;
- b) Efficient, effective and economic use of resources;
- c) Responsive, prompt, effective, impartial and equitable provision of services;
- d) Involvement of the people in the process of policy making;
- e) Accountability for administrative acts;
- f) Transparency and provision of timely and accurate information to the public;
- g) Fair competition and merit as the basis of appointments and promotions; and
- h) Representation of Kenya's diverse communities.

He also stated that he comes from the minority and the marginalized group, which is not only in the County Governments Act, but also the objects of devolution under Article 174 (b) of the Constitution.

He will perform his duties and responsibility as expected from a public officer, with transparency and accountability.

- G. Regarding what he considers as the main challenges and to address the challenges:
 - a) Streamlining the workforce in line with competence
 - b) Ensuring teamwork and cohesion among the staff.
 - c) Demoralized workforce is also a challenge
 - d) Inadequate funding of the public service
 - e) To review and streamline the skills to maintain the services.
 - f) Adherence to labor laws and regulations
 - g) Establishing relevant committees in the Board and offices that will FastTrack the needs of the staff.
 - h) Engaging the relevant structures in the County especially the committee that will hand work to the Board.
 - i) Executive to have enough funding so that the Public service Board can be able to implement its mandate as enshrined in the constitution.
- H. On the steps he will take to help the County to achieve its vision and plans:-

The nominee stated that he will make use of the performance contracting tool to commit each officer through monitoring and evaluation.

I. In terms of what he will do to ensure that officers in the County adhere to the values and principles as contained in article 10 and 232 of the Constitution. He responded as below:-

The nominee stated that he will ensure that fairness and equity is upheld in all Sectors and implementation of the Report prepared by the County Public Service Board on Staff Promotion.

J. Regarding what he can do to ensure the Board achieves its priorities, he stated as below:-

He will uphold transparency, integrity and accountability in executing his duties.

K. On whether he renders any community service and if yes where:-

He is a volunteer and a member of Red Cross, which is a national society whose mission and vision is to alleviate human suffering; and

He also volunteers through appeals for donation on media to support orphanage centers.

L. On what Nairobi residents can expect from him if approved:-

A public service full of cohesiveness and inclusion;

Best service delivery by the public service; and

Nairobi County Public Service Board will be run by professionals.

3.2 APPEARANCE BEFORE THE COMMITTEE BY MS. AISHA WANJIKU KARANJA – NOMINEE FOR MEMBER OF THE COUNTY PUBLIC SERVICE BOARD

The nominee for County Public Service Board Chairperson, Ms. Aisha Wanjiku Karanja, appeared before the Committee on Tuesday 28th May, 2019 at 10.30 am and was informed by the Chairperson that in line with the provisions of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the Committee had invited submissions from the Public on her suitability or otherwise for appointment to Public office, and none had been received by close of business on Friday 24th May, 2019.

While under oath, she proceeded to inform the Committee as follows:-

- A. With respect to self-introduction, knowledge, experience and qualification, the nominee informed the Committee that she was born in 1967 and:
 - a) She holds a Master's degree in community development and sociology from University of Agra in India;
 - b) She holds Bachelor's degree in political science, economics and sociology from the same University;
 - c) She also holds a postgraduate diploma in mass communication;
 - d) She has worked in several organizations both private and non-governmental, in

- the capacity of Human Resource Officer growing to senior Human Resource Officer through to HR manager in both the NGO and private sector;
- e) She served as the director of Green Belt Movement that was founded by Prof. Wangari Maathai from 2013 to 2017;
- f) She is currently the director of an NGO that is dealing with environmental stewardship and sustainable livelihoods; and
- g) She has held many positions mostly in administration and operational services.

B. In response to her employment history and its relevance to the position, the nominee stated as follows:-

- a) She has worked as an administrator in various capacities and in various organizations, both private and non-governmental;
- b) To the best of her knowledge, the position fits well with her qualifications, skills and experiences, since it is the Board of the county public service that deals with human resource management; and
- c) She will use her skills and experiences to ensure that the values and principles of the County public service are adhered to.

C. Regarding her understanding for the position she applied for, she responded as follows:-

- a) She understands that the public service board primarily handles HR management according to Article 235 of the Constitution of Kenya 2010;
- b) The Board is expected to promote the values and principles referred in Article
 10 and 232 of the Constitution;
- c) The Board establishes and abolishes offices in the public service;
- d) Exercises disciplinary controls; and
- e) Reports on how the executive executes its functions.

D. On what motivated her to apply for the position and the relevant experience she will bring, the nominee stated that:-

- a) She has experience in holistic human resource matters;
- b) She has experience in administrative work and reporting; and

c) She has worked and helped organizations that are non-governmental as an administrator and it is now time to bring that knowledge and experience to the public sector.

E. On functions of the County Public Service Board, the nominee informed the Committee that the Board has powers to:-

- a) Establish and abolish offices;
- b) Exercises disciplinary controls on staff;
- c) Reports on how the board executes its functions; and
- d) Promotes values and principles referred in Article 10 and 232.

F. In response to some of the values referred to in Article 10 and 232 of the Constitution of Kenya, she stated as follows:-

Public officers are supposed to efficiently deliver their work in terms of-

- (a) Integrity;
- (b) Performance;
- (c) Principles;
- (d) Involvement of the people in the process of policy making;
- (e) Accountability for administrative acts;
- (f) Transparency and provision to the public of timely an accurate information;
- (g) Fair competition and merit as the basis of appointments and promotions; and
- (h) Representation of Kenya's diverse communities.

G. Regarding what she considers as the main challenges and to address the challenges:-

- a) She will try and harmonize the national values and the specific principles of the public service;
- b) With her experience in HR and administration she will ensure that the Board is transparent;
- c) The nominee will ensure that actions of the Board espouse integrity;
- d) Ensuring that the Board plays the role of advisory and educating;
- e) Make sure that the Board is accountable;
- f) Ensure the reports to the Assembly are submitted on time; and

- g) Ensure the County adheres to the values and principles articulated in Articles 10 and 232 of the Constitution.
- H. In terms of what she will do to ensure that officers in the County adhere to the values and principles as contained in article 10 and 232 of the Constitution:- She will ensure that officers understand the two Articles in relation to what is expected from them as officers. Sometimes People break laws because they do not understand them.
- I. Regarding what she can do to ensure the Board achieves its priorities, she informed the Committee that she will ensure that:
 - a) Officers work as a team;
 - b) She is always available to address issues;
 - c) The Board has action plans and timelines; and
 - d) Priorities are well articulated.
- J. On any unique component, she is bringing on board to fight graft and whether she has ever been mentioned in any graft before:-

The nominee stated that-

- a) She has never been mentioned in any graft case;
- b) She is coming into the Board as a member who is above board with high standards of integrity and accountability;
- c) She will also bring on board working systems that hold people accountable and adhere to code of conduct; and
- d) Understanding where the loopholes are and advising the County Government or the relevant bodies within the County on the best approach to address them.
- K. Regarding how she will handle the pressure from family and friends who will be seeking services and favour:
 - a) She brings years of experience in human resource management and understands the human resource ethics, therefore this will just be a

- continuation of what she has been doing. To her, it is not about the pressure that one gets, what matters id ones reaction to the pressure.
- b) She further stated that the Board is accountable to the County Assembly and therefore there will be questions if proper standards are not followed.

L. In response to whether she renders any community service within Nairobi:-

She offers community service not only in Nairobi but also outside Nairobi, where she mentors youths in Kibera, Kawangware, Uthiru and other places outside Nairobi.

M. On what Nairobi residents can expect from her if approved:-

The nominee informed the Committee that she will uphold high standards of-

- a) Professionalism;
- b) Accountability;
- c) Integrity;
- d) Commitment; and
- e) Ensure that the public service upholds the all the values and principles as articulated in the Constitution.

3.3 APPEARANCE BEFORE THE COMMITTEE BY MS. SHARON MIRELLA WAKHU – NOMINEE FOR MEMBER OF THE COUNTY PUBLIC SERVICE BOARD

The nominee for County Public Service Board Chairperson, Ms. Sharon Mirella Wakhu, appeared before the Committee on Tuesday 28th May, 2019 at 11.30 am and was informed by the Chairperson that in line with the provisions of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the Committee had invited submissions from the Public on her suitability or otherwise for appointment to Public office, and none had been received by close of business on Friday 24th May, 2019.

While under oath, she proceeded to inform the Committee as follows:-

A. With respect to self-introduction, knowledge, experience and qualification, the nominee informed the Committee that she was born in 1978 and:-

- a) She is a chemical processing engineer by training;
- b) She is a certified sub-systems solutions consultant, where SAP is the number one

- leading ERP solution in the world;
- c) She holds a Master's degree in IT application development; and
- d) She is in the process of completing her PHD in management science and engineering.

B. In response to her employment history and its relevance to the position, the nominee stated as follows:-

- a) She started her career as a management trainee at Mumias Sugar Company, where she was employed as a production manager;
- b) She was transferred to IT department as a systems analyst after the company underwent implementation of the ERP solution;
- c) She left Kenya to pursue her PHD in Shanghai China, where she landed a job at the UNDP, as an international business development manager;
- d) Upon completing her PHD, she came back to Kenya around 2014 and continued with her career as an ICT analyst;
- e) She has also worked at an IT solutions company as a senior business systems manager; and
- f) Her most recent job is at Mumias Sugar Company as the head of ICT.

C. Regarding how she will work considering her IT background, she responded as follows:-

- a) The advert was open in terms of ones field of training, the only requirement was that one must have held a management position for five years or above;
- b) Human Resource functions do not operate in isolation but rely on the recommendations of line managers, especially when it comes to specialized fields for recruitment purposes;
- c) She has been a member of many recruitment committees or boards where the HR have to include line managers to be able to perform recruitment function. Recommendations such as skills and qualifications come from line managers; and
- d) Her experience in terms of holding senior management positions in various companies will come in handy not just as advisory but also implementing policies for the Board.

D. On what motivated her to apply for the position and the relevant experience she will bring, the nominee stated that:-

- a) She has held diverse senior management positions, which means she has been relatively involved throughout her career in strategy management, development and implementation;
- b) She has been intricately involved in the planning and budgeting for staff meaning that the Human Resource department never works in isolation. They will always rely on line managers to come up with an organizational structure for each department, decide the skills and training that is required for various staff, come up with job descriptions and qualifications for personnel;
- c) She has worked in fields that were not part of her original training. She is comfortable working outside of her comfort zone, versatile and a quick learner;
- d) She is well equipped in terms of preparing and presenting management reports to demonstrate achievement of the objectives that the Executive would want to align their functions with.

E. On functions of the County Public Service Board, the nominee informed the Committee that the Board has powers to:-

- a) Establish and abolish offices in the County public service;
- Appoint persons to hold or act in offices of the County public service including in the Boards of cities and urban areas within the County and to confirm appointments;
- c) Prepare regular reports for submission to the County Assembly on the execution of the functions of the Board;
- d) Perform disciplinary procedures against employees who violate Articles 10 and 232 of the Constitution of Kenya;
- e) Monitor adherence to Articles 10 and 232 of the Constitution of Kenya; and
- f) Work in liaison with SRC to set remuneration, pension and gratuity for County public officers.

F. In response to some of the values referred to in Article 10 and 232 of the Constitution of Kenya, she stated as follows:-

The national values and principles of governance under Article 10 include-

- a) Patriotism, national unity, sharing and devolution of power, the rule of law, democracy and participation of the people;
- b) Human dignity, equity, social justice, inclusiveness, equality, human rights, non-discrimination and protection of the marginalized;
- c) Good governance, integrity, transparency and accountability; and
- d) Sustainable development.

The values and principles of public service under Article 232 include-

- a) High standards of professional ethics;
- b) Efficient, effective and economic use of resources; responsive, prompt, effective, impartial and equitable;
- c) Provision of services;
- d) Involvement of the people in the process of policy making;
- e) Accountability for administrative acts; and
- f) Transparency and provision to the public of timely, accurate information.

G. Regarding what she considers as the main challenges and to address the challenges:-

- a) The nominee stated that one of the main challenge is pressure in terms of expectations from the Executive, Assembly and members of the public;
- b) The other challenge is on the resources allocated constraining the number of people one can employ and determining their remuneration;
- c) The Board is an independent arm of the County Government and decisions are made independently but she will encourage engagements with both the Assembly and the Executive; and
- d) She will recommend certain changes in the manner in which the functions of the Board are carried out such as financial and accounting. The Board should be made independent just like the Public Service Commission in the National

Government to minimize dependence on other arms of Government, so that one can perform their duties freely.

H. In terms of what she will do to ensure that officers in the County adhere to the values and principles as contained in article 10 and 232 of the Constitution:- She will entrench regular and structured engagements concerning the two Articles 10 and 232 between the Board and officers of the Executive.

- I. Regarding what she can do to ensure the Board achieves its priorities, she informed the Committee that she will ensure that:
 - a) The decisions that are made by the Board are owned by every member of the Board; and
 - b) She will exclude self-interests or her own strong opinion or desires from the work of the Board, so that they move in the same direction.
- J. On how she will use her diverse experience to make the Board effective:-

The nominee stated that-

- a) The three countries she has visited are closer to developed countries and the experience she got is that the contact between the public and the public service is very limited;
- b) Most of the public functions in developed countries are performed online because in terms of automation they are way ahead of us; and
- c) She has seen a lot of efficiency, proper resource utilization and in terms of training, developed countries have a higher quality of staff than we do here.
- d) She would aspire to see that some of these things can also be married here to try and improve efficiency, productivity of staff and technology.
- K. Regarding how she will handle the pressure from family and friends who will be seeking services and favour:-

The nominee informed the Committee that she will avoid self-interest and biasness and ensure she executes her duties on merit.

L. In response to whether she renders any community service within Nairobi:-

- a) She does community service at Dagorreti children's home where she resides.

 Part of the work involves taking time with the children, taking them out and assisting those with disability.
- b) She also works with AIBA foundation which is a group that was put together by the Nubians in Kibra. She supports Hon.Ken Okoth (Member for Kibra) in taking children to school and sponsors some of the children to get to good schools, because due to high level of competition they are mainly disadvantaged when it comes to the normal process of getting positions in national schools.
- c) She was among the first lot of Kenyan students who were sponsored in 2010 by the UN to go and study in China. Since then working together with the University and the UN and in conjunction with the County Government of Kakamega where she comes from, they have been able to sponsor 40 students so far, to go and study degrees in technical fields like engineering, medical and sciences; and
- d) She does this voluntarily outside her normal work duties just to transform people's lives without expecting any benefits out of it.

M. On what Nairobi residents can expect from her if approved:-

The nominee stated that her primary duty-

- a) To give back to society in terms of serving them.
- b) To transform people's lives

3.4 APPEARANCE BEFORE THE COMMITTEE BY MRS. CONSOLATA MUTHONI KIMUYA – NOMINEE FOR MEMBER OF THE COUNTY PUBLIC SERVICE BOARD

The nominee for County Public Service Board Chairperson, Mrs. Consolata Muthoni Kimuya, appeared before the Committee on Tuesday 28th May, 2019 at 12.30 pm and was informed by the Chairperson that in line with the provisions of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the Committee had

invited submissions from the Public on her suitability or otherwise for appointment to Public office, and none had been received by close of business on Friday 24th May, 2019.

While under oath, she proceeded to inform the Committee as follows:-

A. With respect to self-introduction, knowledge, experience and qualification, the nominee informed the Committee that she was born in 1958 and:-

- a) She holds a Bachelors degree in mathematics and business studies from the University of Nairobi;
- b) She has a Masters in educational administration from the same University;
- c) She is currently pursuing PHD in educational administration and planning at the Maasai Mara University; and
- d) She has also trained in the country and outside the country on leadership and management of business entities and education, and is graduating in 2019.

B. In response to her employment history and its relevance to the position, the nominee stated as follows:-

- a) She started as a teacher in various schools before she rose to deputy and finally chief principal of Buru Buru Girls-
 - 1990-2000 deputy principal Buru Buru Girls
 - 2000-2018 principal of the same school;
- b) She has wide experience in administration and management of the people, some of them being parents and the society, which she can contribute to the human resource which is part of the functions of the County Public Service Board; and
- c) She has a wealth of experience and training to enable her handle the job.

C. On what motivated her to apply for the position and the relevant experience she will bring, the nominee stated that:-

- a) Her wealth of experience motivated her to apply;
- b) Her training both in the country and outside the country on high level management motivated her further; and

c) She felt the need to give back to the society, to continue interacting with the people and assisting them in day today running of the County and to be able to serve them within the management of the County.

D. On functions of the County Public Service Board, the nominee informed the Committee that the Board has powers to:-

- a) Create and abolish offices in the County public service;
- b) Appoint persons to hold or act in offices of the County public service;
- c) Discipline persons employed by the County Public Service Board;
- d) Advise the County Government on human resource management and development; and
- e) Promote in the County public service the values and principles referred to in Articles 10 and 232;

E. In response to some of the values referred to in Article 10 and 232 of the Constitution of Kenya, she stated as follows:-

The national values and principles of governance under Article 10 include-

- a) Human dignity, equity, social justice, inclusiveness, equality, human rights, non-discrimination and protection of the marginalized;
- b) Good governance, integrity, transparency and accountability; and
- c) Sustainable development.

The values and principles of public service under Article 232 include-

- a) High standards of professional ethics;
- b) Efficient, effective and economic use of resources; responsive, prompt, effective, impartial and equitable;
- c) Involvement of the people in the process of policy making;
- d) Fair competition and merit as the basis of appointments and promotions; Representation of Kenya's diverse communities.

F. Regarding how she will handle women seeking jobs in the County if approved:-

- a) She will put Chapter six of the Constitution into practice;
- b) She will practice good governance;

- c) She will uphold transparency;
- d) She will make sure those who are qualified are the ones who will be employed;
- e) She knows that she is not supposed to practice nepotism and favouritsm.

G. In terms of what she will do to ensure that officers in the County adhere to the values and principles as contained in Article 10 and 232 of the Constitution:-

- a) She will ensure that the board follows the rule of law;
- b) There will be no favouritsm;
- c) She will help to identify qualified people for the right job to help meet the vision and mission of the Governor;
- d) She will encourage officers to do their work with patriotism and put the County at heart; and
- e) To encourage staff complete their duties within a given time so that the county can move forward.

H. Regarding what she can do to ensure the Board achieves its priorities, she informed the Committee that she will:-

- a) Be prompt in sorting the issues at hand in good time;
- b) Ensure reports are prepared in good time so that they are submitted to the County Assembly; and
- c) Ensure that the Board is available at short notice for any issues that needs to be discussed and forwarded to the County Assembly.

I. On how she will use her diverse experience to make the Board effective: The nominee stated that-

- a) She brings her wealth of experience especially ideas to do with human resource management; and
- b) She has much experience in interviewing personalities in the education sector and also within the public sector.

J. Regarding how she will navigate the relationship between her and the staff of the County Government:-

The nominee stated that she will-

- a) Practice integrity;
- b) Avoid nepotism and favoritism during employment;
- c) Uphold human dignity; and
- d) Exercise transparency to gain public confidence.

K. In response to steps she will take to help the Governor to achieve his vision and plans for Nairobi:-

- a) She will join her colleagues to make sure that the policies are promptly implemented and the reports required by the County Assembly are done in good time; and
- b) Institute policies that are in line with the vision and mission of the County

3.5 APPEARANCE BEFORE THE COMMITTEE BY MR. THOMAS MWEU KASOA – NOMINEE FOR MEMBER OF THE COUNTY PUBLIC SERVICE BOARD

The nominee for County Public Service Board Chairperson, Mr. Thomas Mweu Kasoa, appeared before the Committee on Tuesday 28th May, 2019 at 1.30 pm and was informed by the Chairperson that in line with the provisions of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the Committee had invited submissions from the Public on his suitability or otherwise for appointment to Public office, and none had been received by close of business on Friday 24th May, 2019.

While under oath, he proceeded to inform the Committee as follows:-

A.With respect to self-introduction, knowledge, experience and qualification, the nominee informed the Committee that he was born in 1972 and:-

- a) He holds a Bachelors Degree in global business management from Belmont University in the UK;
- b) He holds a Diploma in leadership and management from scot Christian University; and
- c) He also has a Certificate in County management from KCA University.

B. In response to his employment history and its relevance to the position, the nominee stated as follows:-

- a) He started his career around 20 years ago here in Nairobi's industrial area for about 4 years;
- b) He then worked as a taxi driver at Jatco Tour Services for five years;
- c) In 2007, he contested as a Councilor at Komarock Ward, but due to political challenges in Nairobi he thought it wise to move to Machakos where he was elected as a Councilor:
- d) He was elected as the Vice Chairman of the County Council of Machakos;
- e) In the course of the 5 years he was also elected as the Director Tana/Athi Service Board;
- f) In 2013, he was elected as a Member of the Machakos County Assembly and Leader of Minority in the Assembly; and
- g) He served at the Machakos County Assembly Service Board for the last five years.

C. Regarding his understanding for the position he applied for, he responded as follows:-

The Board is mandated to-

- a) Establish and abolish offices in the County public service;
- b) Appoint persons to hold or act in offices of the County public service; and
- c) Perform disciplinary procedures against employees who are in violation of Articles 10 and 232 of the constitution of Kenya.

D. With regards to what motivated him to apply for the position and the relevant experience he will bring, the nominee stated that:-

He is a servant leader who has served in the public service for long and due to his dedication, he thought it wise to apply and serve the people of Nairobi County.

E. On functions of the County Public Service Board, the nominee informed the Committee that the Board has powers to:-

a) Exercise discipline among County staff;

- b) Appoint persons to hold or act in offices of the County public service;
- c) Prepare regular reports for submission to the County Assembly on the execution of the functions of the Board;
- d) Establishes and abolishes offices in the County public service; and
- e) Prepare strategic plans for the term of the Board.

F. In response to some of the values referred to in Article 10 and 232 of the Constitution of Kenya, he stated as follows:-

The national values and principles of governance, article 10 include-

- a) National unity, sharing and devolution of power, , democracy and participation of the people;
- b) Equity, social justice, inclusiveness, equality, human rights, non-discrimination and protection of the marginalized;
- c) Integrity, transparency and accountability; and
- d) Good governance.

The values and principles of public service, article 232 include-

- a) Efficient, effective and economic use of resources;
- b) Impartial and equitable provision of services;
- c) High standards of professional ethics;
- d) Involvement of the people in the process of policy making;
- e) Accountability for administrative acts;
- f) Representation of Kenya's diverse communities; and
- g) Provision of timely and accurate information to the public.

G. Regarding what he considers as the main challenges and how he proposes to address them:-

The nominee informed the Committee that one of the biggest challenge in most Counties is equity and fair treatment of staff. He will therefore use the law in place to make sure that equity is followed to the letter e.g. Employment Act and other labour laws.

H. On the steps he will take to help the County to achieve its vision and plans:-

The nominee stated that he will make use of the performance contracting tool to commit each officer through monitoring and evaluation.

I.In terms of what he will do to ensure that officers in the County adhere to the values and principles as contained in article 10 and 232 of the Constitution. He responded as below:-

- a) He will push for refresher courses for the staff to help the County achieve its target;
- b) He will ensure the Board works in consultation with stakeholders e.g. County Assembly more specifically Labour Committee and the CECM for Public Service Management.

3.6 MR. JACK BABJI OWINO – NOMINEE FOR MEMBER OF THE COUNTY PUBLIC SERVICE BOARD

The sixth nominee to the County Public Service Board, Mr. Jack Babji Owino, did not appear before the Committee on Tuesday 28th May, 2019. The Committee noted that the nominee neither picked up a vetting form and neither did he submit clearance documents from the listed institutions as required

4.0. COMMITTEE'S GENERAL OBSERVATIONS AND FINDINGS

The Committee having considered the nominees Curriculum Vitaes and heard their oral submissions during the vetting exercise, made the following observations and findings.

4.1 General Observations:

The Committee having considered the nominees' filled Questionnaires pursuant to the Public Appointments (County Assemblies Approval) Act, 2017, their Curriculum Vitae and having heard their oral submissions during the vetting exercise made the following general observations:

THAT: -

- 1. Five out of the six nominees satisfied the requirements of Chapter Six of the Constitution of Kenya on leadership and integrity which is a requirement under section 35(3)(c) of the County Governments Act, 2012 in that:
 - a) The nominees have been cleared by the Ethics and Anti-Corruption Commission (EACC), Directorate of Criminal Investigations (DCI), Kenya Revenue Authority (KRA), Higher Education Loans Board (HELB) and the Credit Reference Bureau (CRB).
 - b) The nominees have not been charged in a Court of Law.
 - c) The nominees do not exhibit a potential conflict of interest.
- 2. The nominees meet the requirements of the provisions of Section 35(2) of the County Governments Act, 2012 in that:
 - a) There is representation of the minorities, marginalized groups and communities within Nairobi City County; and
 - b) Upholds the community and cultural diversity within Nairobi City County.
- 3. One nominee, Mr. Jack Babji Owino did not attend the approval hearing and hence the Committee did not make any observations with regard to his nomination.
- 4. The nominees meet the requirements of Section 35(3) (d) since they exhibited impressive knowledge of topical and legal issues touching on the respective dockets and have the requisite abilities, qualifications and experience.
- 5. The Committee further observed that Section 58 (1) (c) of the County Governments Act provides that the CPSB shall comprise 'a certified public secretary of good professional standing nominated and appointed by the Governor, with the approval of the County Assembly, who shall be the secretary to the Board'. The composition of members as nominated by H.E the Governor does not have a person competent to perform the role of Secretary to the Board. The Committee therefore urges H.E the Governor to nominate a suitable candidate for the said position and forward the name to the County Assembly for approval.

5.0. COMMITTEE'S RECOMMENDATIONS

Pursuant to Section 45 (1) (a) and (b) of the County Governments Act, 2012, Section 9 of the Public Appointments (County Assemblies Approval) Act, 2017, and Standing Order No. 203 (6) (f) of the Nairobi City County Assembly Standing Orders, the Committee recommends:-

THAT, this Assembly approves the following Five Nominees for appointment by **H.E. the Governor Hon. Mike Gideon Mbuvi Sonko** as Members of the Nairobi City County Public Service Board as follows:-
