The Committee invited the Petitioners to a sitting of the Committee held on Wednesday 12th June, 2019 to deliberate on the Petition. The Committee also invited the Ag. County Secretary and the County Executive Committee Member for Education, Sports, Culture, Youth Affairs and Social Services to a meeting held on Wednesday 10th July 2019 to deliberate on the Petition. In total, the Committee held five sittings in consideration of this matter.

2.0. BACKGROUND

2.1 Mandate of the Sectoral Committee on Labour and Social Welfare

The Sectoral Committee on Labour and Social Welfare is one of the Sectoral Committees established under Standing Order No. 203 with amongst others, the mandate to investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly.

2.2 Background of the Public Petition

Article 21, Sub –Article 3 of the Constitution of Kenya,2010 state that all State organs and all public officers have the duty to address the needs of vulnerable groups within society, including women, older members of society, persons with disabilities, children, youth, members of minority or marginalised communities, and members of particular ethnic, religious or cultural communities.

Article 185 of the Constitution rests the legislative Authority and Oversight function at the County level on the County Assembly.

Article 54 of the Constitution gives persons with disabilities rights to be treated with dignity and respect and to be addressed and referred to in a manner that is not demeaning; to access educational institutions and facilities for persons with disabilities that are integrated into society to the extent compatible with the interests of the person; to reasonable access to all places, public transport and information; to use Sign language, Braille or other appropriate means of communication; and to access materials and devices to overcome constraints arising from the person's disability.

Article 56 further gives persons with disabilities rights to participate as is represented in governance and other spheres of life; are provided special opportunities in educational and economic fields; are provided special opportunities for access to employment; develop their cultural values, languages and practices; and have

reasonable access to water, health services and infrastructure.

The Nairobi County Disabled People Organizations petitioned the Nairobi City County Assembly and expressed their concern regarding their lack of representation in decision making in the County, poor service delivery to Persons living With Disabilities; and laxity of meeting Constitutional obligations concerning PWDS set out in the Employment and Procurement Acts.

The residents Nairobi County Disabled People Organizations confirmed that efforts have been made to have the matter addressed by the relevant body but it has failed to give a satisfactory response and that the issues in respect of which the Petition is made, is not pending before any Court of law, or Constitutional or legal body.

The Petitioners therefore PRAYED that the County Assembly of Nairobi City intervenes and ensure that:-

- a. The Nairobi City County Executive establishes Persons with Disabilities Board as provided in the Nairobi City County Persons with Disabilities Act, 2015 and enacts the Regulations thereon;
- b. The Nairobi City County Executive ensures compliance with accessibility requirements of the buildings within Nairobi City County and have a front office desk that serves persons with disabilities in the County and Sub-county managed by a person with disability and a sign language interpreter; and
- c. The Nairobi City County Executive sets aside special needs bursary fund for schools from lower primary to higher levels of education for learners with disabilities.

3.0 CONSIDERATION OF THE PUBLIC PETITION

In considering the Petition, the Sectoral Committee on Labour and Social Welfare considered the provisions of the Nairobi City County Persons with Disabilities Act, 2015 the Persons with Disabilities Act, 2003 and the Constitution of Kenya, 2010.

The Committee held a meeting with the representatives of the Nairobi County Disabled People Organizations on Wednesday 12th June 2019 where the Committee gathered views from the petitioners with regard to the petition.

The Committee also held a meeting on Wednesday, 10th July, 2019 where the Committee engaged Officers from the Education, Youth Affairs, Sports Culture and Social Services Sector of the County Executive on the Petition prayers and the implementation status of the Nairobi City County Persons with Disabilities Act, 2015. The minutes of the proceedings are attached to this report.

3.1 <u>MEETING WITH THE PETITIONERS: NAIROBI COUNTY DISABLED PEOPLE</u> ORGANIZATIONS

- 3.1.1 The Committee held a meeting with the Petitioners on Wednesday 12th June, 2019 at Charter Hall, Assembly Precincts, City Hall Buildings to deliberate on the Petition.
- 3.1.2 The petitioners informed the Committee that one of the main purpose of the Petition was lack of implementation of the Nairobi City County Persons with Disabilities Act, 2015. The petitioners also informed the Committee that they would like the County Government to consult widely with persons living with disabilities in the County prior to the establishment of the Nairobi City County Persons with Disabilities Board.
- 3.1.3 The petitioners sought the Committee's assistance in ensuring that buildings and public roads within the County cater for movement of persons living with disabilities in adherence to Article 54 of the Constitution of Kenya and Sections 16,17 and 18 of the Nairobi City County Persons with Disabilities Act 2015; and that they are accorded equal job/business opportunities and not treated as second-class citizens.
- 3.1.4 The representatives of the Nairobi County Disabled People Organizations brought to the attention of the Committee that there was need for the County Government to set up customer service desks that serve persons with disabilities in the County and Sub-County managed by officers who are trained in sign

- language and braille. These desks will facilitate persons living with disabilities especially the visually impaired and the deaf, to easily access services from the County.
- 3.1.5 The petitioners further sought the Committee's intervention in ensuring that their rights are addressed by the County Government as is stipulated in the Nairobi City County Persons with Disabilities Act, 2015. They also advocated for disability mainstreaming in the County in order to promote, protect and ensure full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities; and to promote respect for their inherent dignity.
- 3.1.6 Finally, the petitioners sought the Committee's intervention in ensuring that the Nairobi City County Government sets aside special needs bursary fund for schools from lower primary to higher levels of education for learners with disabilities. The Committee assured the petitioners that they would take up the matter with the relevant Sector.

3.2 <u>MEETING WITH THE COUNTY EXECUTIVE COMMITTEE MEMBER FOR</u> <u>EDUCATION, SPORTS, CULTURE, YOUTH AFFAIRS AND SOCIAL SERVICES</u>

- 3.2.1 The Committee held a meeting with the County Executive Committee Member for Education, Sports, Culture, Youth Affairs and Social Services on Wednesday 10th July, 2019 at Committee Room 5, Assembly Precincts, City Hall Buildings to deliberate on the Petition.
- 3.2.2 The Chairperson informed the County Executive Committee Member the various grounds of the Petition key ones being:
 - Lack of implementation of the Nairobi City County Persons with Disabilities Act, 2015;
 - Lack of compliance to accessibility requirements in buildings and public roads within the County in adherence to Article 54 of the Constitution of Kenya and Sections 16,17 and 18 of the Nairobi City County Persons with Disabilities Act 2015;
 - Lack of customer service desks to serve persons with disabilities in the County; and

- The need for special needs bursary fund for schools from lower primary to higher levels of education for learners with disabilities.
- 3.2.3 On implementation of the Nairobi City County Persons with Disabilities Act, 2015;
 The County Executive Committee Member informed the Committee that the Nairobi City County Persons with Disabilities Regulations were drafted in 2017 and the Nairobi County Persons with Disabilities Board gazetted on 28th July 2017. The County Executive Committee Member has however never convened a sitting of the Board since gazettement of the Board Members. This is because the County Executive Committee Member noticed the need to amend the Nairobi City County Persons with Disabilities Act, 2015. As per her observations, the functions of the Nairobi City County Persons with Disabilities Board seem to override the functions of the County Executive.
- 3.2.4 On compliance to accessibility requirements in buildings and public roads within the County in adherence to Article 54 of the Constitution of Kenya and Sections 16,17 and 18 of the Nairobi City County Persons with Disabilities Act, 2015;

The County Executive Committee Member informed the Committee that Part II of the draft Nairobi City County Persons with Disabilities Regulations provide for an authorized officer to inspect public buildings, roads or other social amenities to ensure that the proprietor satisfies the requirements of Sections 16, 17 and 18 of the Nairobi City County Persons with Disabilities Act, and shall make a recommendation to the relevant board for the issuance of adjustment orders.' She has however not yet liaised with the technical officers in the County Executive to ensure that all buildings, public roads and walkways adhere to the accessibility requirements set out in the Act.

3.2.5 On the lack of customer service desks to serve persons with disabilities in the County;

The Committee was informed that there are programmes in place for persons living with disabilities under the Social Services and Community Development department. Five staff are currently undergoing training on sign language since March 2019 in collaboration with Nairobit Trust, which will end in September

2019. The County will then set up five customer service desks within City Hall Buildings to serve persons with disabilities.

3.2.6 On special needs bursary fund for schools from lower primary to higher levels of education for learners with disabilities;

The County Executive Committee Member informed the Committee that the Nairobi City County Bursary and Scholarship Fund Regulations, 2019 have taken into consideration children with disability under Regulation 20. The Regulations have a provision for children with special needs.

3.2.6 The Committee further sought to know whether the Sector has set aside a budget for operations of the Board since it was gazetted;

The County Chief Officer for Social Services informed the Committee that the Board has never been able to operate since it does not have a provision for a fund under the Act. This has also necessitated the need to review the Act.

4.0. COMMITTEE'S OBSERVATIONS AND FINDINGS

Following the meetings held with the representatives of the Nairobi County Disabled People Organizations, the County Executive Committee Member for Education, Sports, Culture, Youth Affairs and Social Services and the oral submissions received, the Committee made the following observations:-

4.0.1 The Sector for Education, Sports, Culture, Youth Affairs and Social Services has inordinately delayed implementing the Persons with Disabilities Act 2015. Members observed that nothing prohibited the Sector from implementing the Act even as they proposed amendments on areas the Sector felt needed to be amended. Members further noted that while considering the legislation while still a Bill, the Sector was fully engaged and submitted their proposals which were incorporated. Members further noted that the implementation of legislation is not discretionary and shall come into force as provided by Section 25 (2) of the County Governments Act, 2010.

- 4.0.2 The Committee noted that the Nairobi City County Persons with Disabilities Regulations drafted in 2017 have never been forwarded to the Assembly for consideration and approval as envisaged by the Statutory Instruments Act, 2013.
- 4.0.3 The Committee also noted that many buildings including public buildings, roads and walkways in the City are not disability friendly, as they do not adhere to the accessibility requirements set out in Section 16, 17 and 18 of the Nairobi City County Persons with Disabilities Act, 2015. The County Executive Committee Member is yet to initiate consultations with the relevant Sectors in order to comply with the provisions in the Act.
- 4.0.4 Members further noted that there was nothing hindering the Sector from setting up the customer service desks and training the officers while on the job. It was also noted that the deaf were not the only persons with disabilities to be served at the service desks.
- 4.0.5 The Committee also observed that there had been an allocation of Kshs. 50 Million for persons living with disabilities in the Financial Year 2015/2016 but no budget allocation was given for the same in the subsequent Financial Years. Members proposed that moving forward, it would be important for the Sector to allocate a budget towards programmes for persons living with disabilities and operations of the Nairobi City County Persons with Disabilities Board.

5.0. COMMITTEE'S RECOMMENDATIONS

Following the above deliberations on the Petition, the Committee makes the following recommendations:- That;

1. The CECM to convene the first sitting of the Nairobi County Persons with Disabilities Board as soon as possible and not later than thirty days from the date of tabling this report, to deliberate on the implementation of the Nairobi City County Persons with Disabilities Act, 2015 and to immediately inform the Committee on the resolutions of the said meeting;

- 2. The Sector to collaborate with the relevant Sectors of the County Executive to ensure compliance with accessibility requirements of all the buildings and public roads in the County as set out in Section 16, 17 and 18 of the Nairobi City County Persons with Disabilities Act, 2015 and urgently update the Committee on the progress. A report on the same be forwarded to the Committee on or before 10th August 2019;
- 3. The Sector to immediately set up customer service desks at the main receptions of City Hall Buildings and City Hall Annex equipped to serve persons living with disabilities in the County. Members noted that there was nothing hindering the Sector from setting up the service desks as provided in the Act and training the officers while on the job;
- 4. The CECM to ensure compliance with part V of the Nairobi City County Bursary and Scholarship Fund Regulations, 2019 on issuance of bursaries to children with special needs and a report be forwarded to the Committee on or before 30th August 2019 on the number of indigent special needs children awarded bursaries in the last two Financial Years;
- 5. The Sector forward to the Assembly the proposed amendments Bill to the Nairobi City County Persons with Disabilities Act, 2015 within 30 days from the date of tabling this report for consideration;
- 6. The County Executive Committee Member to urgently complete the drafting of the Nairobi City County Persons With Disabilities Act, 2015 Regulations and forward them to the Assembly in compliance with Section 11 of the Statutory Instruments Act, 2013; and
- 7. The Sector to re-allocate its budget to provide for programmes for persons living with disabilities and operations of the Nairobi City County Persons with Disabilities Board, in concurrence with the County Executive Committee Member for Finance, and the same submitted to the County Assembly for approval through Supplementary Estimates.

The Ag. Chairperson read out the letter of invitation and the petition, which formed the agenda of the meeting after a round of introduction. He then welcomed the CECM and her team to respond to the petition prayers.

The CECM informed the Committee that the Nairobi County Persons with Disabilities Board was gazetted on 28th July 2017 but has never convened a sitting since gazettement. This is because the CECM noticed the need to amend the Nairobi City County Persons with Disabilities Act, 2015 because the functions of the Board seem to override the functions of the County Executive.

The Committee sought to know whether the Sector has set aside a budget for operations of the Board since it was gazetted. The County Chief Officer for Social Services informed the Committee that the Board has never been able to operate since it does not have a provision for a fund under the Act. This has also necessitated the need to review the Act.

Members also sought to know measures the County Government has put in place to ensure that all buildings in the County cater for the needs of PWDs in terms of accessibility in adherence to Article 54 of the Constitution of Kenya, 2010 and Section 16 of the Nairobi City County Persons with Disabilities Act, 2015.

The Committee was informed that the Nairobi City County Persons with Disabilities Regulations were drafted in 2017 and provide for the same. Part II of the Regulations state that 'An authorized officer shall inspect public buildings, roads or other social amenities to ensure that the proprietor satisfies the requirements of Sections 16, 17 and 18 of the Nairobi City County Persons with Disabilities Act and shall make a recommendation to the relevant board for the issuance of adjustment orders.'

The CECM also informed the Committee that the Nairobi City County Bursary and Scholarship Fund Regulations, 2019 have taken care of persons with disability under Regulation 20. The regulations have a provision for children with special needs.

The Committee was further informed that there are programmes in place for persons living with disabilities under the Social Services and Community development departments. Five staff are currently undergoing training on sign language since March 2019 in collaboration

with Nairobit Trust, which will end in September 2019. The County will then set up five customer service desks within City Hall Buildings to serve persons with disabilities.

Following the above deliberations on the petition, the Committee made the following resolutions:-
