#### 1.0 Establishment, Mandate and Membership

#### 1.1 Establishment and Mandate

Hon. Members, the Committee on Powers and Privileges is established pursuant to the Standing Order 183 as read together with Section 15 of the County Assemblies Powers and Privileges Act, 2017 ("*the Act*"). The Committee's mandate amongst others, as outlined under Section 15 of the Act is to:

- a. Inquire into the conduct of a member whose conduct is alleged to constitute a breach of privilege; and
- b. Either of its own motion or a result of a complaint made by any person, inquire into the conduct of a member whose conduct is alleged to constitute a breach of privilege
- c. Investigate, table reports and make recommendations to the floor of the house
- d. Issue summons to witnesses to appear before the committee,
- e. Receive evidence and to request for and receive papers and documents from the Government and the public.

Further, as envisaged under Section 18 of the Act as read together with Article 195 of the Constitution of Kenya, the Committee as constituted has the same powers as the High Court.

#### **Committee Inquiry into Breaches of Privileges**

#### a) Legal Framework

The Select Committee on Powers and Privileges draws its mandates and powers from various Constitutional and statutory provisions, as well as parliamentary dictates derived from long standing practice and procedure.

Primarily the enabling law to the mandate of the Committee is the Nairobi County Assembly Standing Orders, which draws its legality and powers from County Governments Act, 2012 and the Constitution. Standing Order 183 provides for the Powers and privileges of committees, thus-

Committees shall enjoy and exercise all the powers and privileges bestowed on County Assembly by the Constitution and statute, including the power to summon witnesses, receive evidence and to request for and receive papers and documents from the Government and the public.

The committee is established under the County Assemblies Powers and Privileges Committee Act, 2017, Section 15 (1). The Act is established under Article 196(3) of the Constitution of Kenya, 2010.

The Committee's powers to summon witnesses for purposes of giving evidence is provided for under Article 196 of the Constitution, thus –

A county assembly or any of its committees has power to summon any person to appear before it for the purpose of giving evidence or providing information. For the purposes of clause (1), an assembly has the same powers as the High Court to—

- a) enforce the attendance of witnesses and examining them on oath, affirmation or otherwise;
- b) compel the production of documents; and
- c) issue a commission or request to examine witnesses abroad.

Further, Article 196(3) provides that Parliament shall enact legislation providing for the powers, privileges and immunities of county assemblies, their committees and members. It is on the basis of the foregoing that the Senate and the National Assembly of the Republic of Kenya enacted the County Assemblies Powers and privileges Act, 2017.

Section 16 of the County Assemblies Powers and Privileges Act, 2017 states what constitutes to be a breach of the privileges and Section 15 of the Act gives the Committee the mandate to inquire into conduct of a Member whose conduct is alleged to constitute a breach of privileges in terms of Section 16.

The Act provides comprehensively for offenses, under Section 27 for failure to attend to summons and for general breaches of the law's provisions elsewhere.

### b) Events Occasioning Breaches and the Inquiry

The matters for which the Select Committee on Powers and Privileges now undertakes this inquiry arise from the alleged unethical conduct of the honorable Mary Ariviza, MCA, during the County Assemblies Forum 2019, held in Kisumu County, which conduct according to Section 16 (e) the County Assemblies Powers and Privileges Act, 2017 may have been meant to demean the office of the speaker and most likely reflect adversely on the dignity or integrity of the County Assembly and its Members contrary to the best interests of the County Assembly.

On 23<sup>rd</sup> April, 2019, the Leader of the Majority party Hon. Abdi .l. Hassan, MCA rose on the floor of the House under Standing Order No. 45 (2) (b) and made a Statement reporting alleged misconduct by Hon. Mary Ariviza during the County Assemblies Forum, 2019 held in Kisumu County. In his Statement, the Leader of the Majority party alleged that during the address to the delegates by the Hon. Acting Speaker, the Hon. Chege Mwaura, MCA, the Hon. Mary Arivisa, MCA conducted herself in a manner to denounce the leadership of the Hon. Acting Speaker in the midst of the conference hence bringing the Assembly to dispute in violation of section 16 of the Powers and Privileges Act.

It was alleged that the Hon. Mary Arivisa had threatened to disrupt the Hon. Chege Mwaura's speech, proceeding to openly declare before all delegates and anyone who cared to listen to her that the Hon. Chege Mwaura, MCA was an imposter and not the rightful Speaker of the Nairobi City County Assembly. This remarks, the Majority Leader alleged, and the Member's conduct, were willfully timed to cause the Hon. Acting Speaker embarrassment, which matter was raised by other delegates from other Assemblies who implored the Hon. Mary Ariviza, MCA to tone down her uncalled for agitation.

In view of the above, the presiding Chair for the day's sitting directed that the matter be committed to the Select Committee on Powers and Privileges to investigate and report to the House before the Assembly proceeds on Recess on 13<sup>th</sup> May, 2019.

#### 1.4 Witnesses

As earlier indicated, the Committee called various witnesses for purposes of preparing a comprehensive report on the alleged unethical conduct of the Hon. Mary Arivisa, MCA and the breaches of the County Assemblies Powers and Privileges Act, 2017 as relates to the honorable member acting in a manner to demean the institution of the County Assembly.

On behalf of the Committee, and pursuant to Section 18 of the County Assemblies Powers and Privileges Act, 2017, the Committee, under the direction of the Chairperson, wrote and issued Summonses for the following to appear before the Select Committee on Powers and Privileges to shed light on the alleged misconduct of Hon. Mary Arivitsa, MCA during the County Assemblies Forum, 2019.

#### 1.5 Acknowledgement

Hon. Members, I wish to acknowledge with gratitude the Members of the Select Committee on Powers and Privileges for the dedication that they have portrayed in ensuring that the Committee implements its mandate and that the County Assembly upholds its dignity and integrity, while looking into the alleged unethical conduct of members within the precincts and investigations into the allegation of bribery of Committees of the Assembly.

Hon. Members, my sincere appreciation also goes to the office of the Clerk of the County Assembly and the Secretariat of the Select Committee on Powers and Privileges for offering sound legal advice on the mentioned cases.

#### 2.0 Background to The Inquiry

Hon. Members, the County Assembly Committees are extensions of the Assembly established under the County Assembly Standing Orders and in accordance with Section 14 of the County Governments Act, 2012. The Committees are supposed to perform functions that the Assembly is not well fitted to consider in plenary.

The select Committee on Powers and Privileges exercises its mandate by investigating any matter pertaining conduct of members and staff within the precincts of the Assembly. Pursuant to the provisions of Standing Order 183 as read together with Section 15 of the Act, the Select Committee on Powers and privileges had a meeting to consider, deliberate and lay modalities on how to proceed with matters that had been placed before the Committee for investigation. This was necessary for the effective discharge of the Committee's mandate.

Subsequently, the Select Committee on Powers and Privileges held the first sitting on the 24<sup>th</sup> day of April 2019 at the Assembly Chamber Boardroom between 10:00 Am and 12.00 Noon. Upon deliberations, the Committee resolved to summon both the honorable members and the staffs whom it wished to appear before it to shed light on an alleged incident that occurred in Kisumu during the County Assemblies Forum, 2019.

The Committee held a total of eight (10) Sittings during which evidence was received from witnesses and statements received from the sergeant at arms. During the sittings, witnesses were summoned to appear and adduce evidence in chief. The Committee held sittings on 24<sup>th</sup>, 25<sup>th</sup>, 26<sup>th</sup>, 27<sup>th</sup>, 29<sup>th</sup> and 30<sup>th</sup> April 2019 and 8<sup>th</sup>, 28<sup>th</sup>, 29<sup>th</sup> May 2019 and 4<sup>th</sup> June, 2019.

The Select Committee on Powers and Privileges invited members and Assembly staffers who were present at the event and were willing to provide an account of what transpired to enable them to do investigations at the Committee meeting level as directed by the Hon. Speaker and further directing the office of the Clerk to promptly contact and facilitate Members and the Assembly staffs in regards to the same.

The Select Committee on Powers and Privileges invited Hon. Abdi .l. Hassan, MCA; Hon. Mary Arivitsa, MCA; Hon. Melab Afwayi, MCA; Hon. Emilly Wanjiru Waithaka, MCA; Mrs. Rose Ogonda, MCA; Mr. Francis Kivila, Mr. Daniel Osewe, Mr. Patrick Moindi (Sergeant – At – Arms present during the event) and Mr. John Moiyare to appear before the committee on respective dates in April and May 2019.

On 23<sup>rd</sup> April, 2019, Hon. Abdi .I. Hassan, MCA rose on the floor of the House under Standing Order No. 45 2 (b) and made a Statement reporting alleged misconduct by Hon. Mary Ariviza during the County Assembly Forum held in Kisumu County. The said Member was accordingly named pursuant to Standing Order No. 115. In his Statement, the Leader of the Majority party alleged that during the address to the delegates by the Hon. Speaker, the Hon. Member conducted herself in a manner to denounce the leadership of the Hon. Speaker in the midst of the delegate hence bringing the Assembly to dispute in violate of Section 16 of the Powers and Privileges Act, against whom the Select Committee on Powers and Privileges sent invitations to appear before it to shed light on the foregoing.

Standing Order 183 of the Nairobi City County Assembly Standing Orders provides that; "Committees shall enjoy and exercise all the powers and privileges bestowed on County Assembly by the Constitution and statute, including the power to summon witnesses, receive evidence and to request for and receive papers and documents from the Government and the public."

As such, the Committee at its meeting held on **24<sup>th</sup> April 2019** resolved to invite honorable members and named members of staff of Nairobi City County Assembly to appear before it for purposes of shedding light in regards to the alleged misconduct of honorable Mary Arivitsa, MCA during the County Assemblies Forum 2019 in Kisumu County.

# 3.0 Proceedings of the Inquiry Into The Alleged Misconduct By Hon. Mary

#### Proceedings

## 3.1 Witnesses from the County Assembly membership and staff

Statements and oral testimony from witnesses from the County Assembly were reviewed and noted as follows.

### 3.1.1 Mr. Francis Kivila (Sergeant At Arms - staff)

On Thursday, 24<sup>th</sup> April, 2019 Mr. Francis Kivila (Sergeant At Arms - staff) appeared before the Committee for purposes of giving evidence on the events that transpired on or about 15<sup>th</sup> – 17<sup>th</sup> April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

## When requested to share with the Committee what transpired on 17<sup>th</sup> April, 2019 in Kisumu during the Speaker's speech.

He confirmed to have travelled to Kisumu and shared with the Committee the major roles he played during that time in Kisumu which majorly was coordination, logistics and to ascertain that the badges for the honorable members and staffs from Nairobi City County Assembly were ready in good time. As sergeants, they were to coordinate youth and women summit event which had commenced before the main event (Legislative Summit).

He stated that, there were some officers who were assigned duties of manning the plenary point (where the main event was taking place) adding that he was in charge of protocol and access control at the entry point (gate).

He only interacted with the Hon. Speaker at the point of entry to the venue. Further, he did not participate in the plenary sessions. Subsequently, he could not be able to confirm what Hon. Mary Ariviza is alleged to have stated.

#### 4 If he Could have heard the Speaker's speech by any chance at the point he was.

He reaffirmed that the distance from the plenary point to the entrance, where he was assigned the duties, was far (about 200 or 300metres away). He stated that unless one used a loud speaker, one would not be able to hear what was said.

## ✤ When asked to name the sergeant –Art –Arm who was assigned the plenary point where the speeches were being delivered.

He stated, there were two officers, Mr. Patrick Moindi, and Mr. Daniel Osewe (both being commissionaire at Nairobi City County Assembly).

Further, among other duties, Mr. Patrick Moindi was to receive the Hon. Speaker and guide him to a holding room for the Speakers and thereafter escort the Speaker to where the plenary was taking place. He was to reserve a seat for the Speaker too.

Mr. Kivila Francis confirmed that Mr. Patrick Moindi was to be assisted by Mr. Daniel Osewe in the event that he could be out of the plenary and that if the said utterances were loud enough to be heard then, the two officers were in a position to shed more light.

# + When asked to confirm that Hon. Mary Ariviza, MCA was in attendance at the summit

He confirmed that he met Hon. Mary Ariviza, MCA during the summit and he could even recall issuing her with a meal card.

# ✤ On whether he heard anybody complain within Kisumu of Hon. Mary Ariviza, MCA utterances

He stated that he didn't interact with any Member of the County Assembly or members of staff who expressed dissatisfaction on the conduct of one Hon. Mary Arivitsa, MCA.

+ On the advice he could give to the Hon. Members in case of any misconduct

He stated that he would be the least person to give advice, however, public and state officers ought to adhere to the Chapter six of the Constitution.

### 3.1.2 Mr. Daniel Osewe (Sergent-At-Arms staff)

On Thursday,  $24^{th}$  April, 2019 Mr. Daniel Osewe (Sergent-At-Arms - staff) appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

# + When requested to state where he was at the time honorable Speaker was moderating the plenary session

He confirmed that he was at the venue.

+ If there was any interruption during the session moderated by the Honorable Speaker by Hon. Mary Ariviza, MCA

He did not witness.

## + Whether Hon. Mary Ariviza, MCA had an opportunity to address the crowd

He stated that Hon. Mary Arivitsa, MCA didn't have opportunity to address the crowd.

# ✤ On whether he heard anybody complain about Hon. Mary Ariviza during the sessions in Kisumu

He told the Committee that he didn't hear anyone complain.

#### 3.1.3 Mr. Patrick Moindi (Sergent At Arms staff)

On Thursday,  $24^{th}$  April, 2019 Mr. Patrick Moindi (Sergent At Arms - staff) appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

## On whether they had been assigned designated areas to perform their duties at the summit

He stated, they were not assigned specific areas of work for the entire period i.e each day they were allocated different place.

#### + On whether Hon. Mary Arivitsa, MCA got an opportunity to address the plenary

He stated that much of his work was at the entrance thus he may not have known if the honorable member addressed the plenary.

## On whether members of the sergeant at arms department have mechanisms of communication amongst them

He didn't hear any of his colleagues discuss anything in regards to Honorable Mary Arivitsa's alleged misconduct but only heard the same during plenary in the Assembly on 23<sup>rd</sup> April 2019.

# ↓ As to whether he saw Hon. Mary Ariviza, MCA on that particular day when the Speaker was moderating the session

He stated that he met the honorable member at the exhibition which was situated close to main entrance.

### 🖶 As to whether he heard anybody complain about Hon. Mary Ariviza, MCA

He did not hear anyone complain of her actions at any given point.

#### 3.1.4 Mr. John Moyare (Speaker's body guard)

On Thursday, 24<sup>th</sup> April, 2019 Mr. John Moyare (*Speaker's body guard*) appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa, MCA while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

## If he was in Kisumu and specifically when the honorable speaker was moderating the session

He stated that he was not with the speaker on Wednesday 17<sup>th</sup> April 2019 but he witnessed the Speaker moderate the session in the afternoon.

## Whether he was aware that there is allegation that Hon. Mary Ariviza, MCA shouted down the Speaker during the County Assemblies Forum 2019 held in Kisumu

He was not aware but was present in the afternoon during the moderation session by the honorable speaker. Further stating on the restrictions and a number of instances that he should neither be close nor get beyond specific distances from the honorable speaker being armed.

3.1.5 Hon. Emilly Wanjiru Waithaka, MCA

On Thursday, 24<sup>th</sup> April, 2019, Hon. Emilly Wanjiru Waithaka, MCA appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

Whether he had knowledge on an incident that happened in Kisumu during the County Assemblies Forum event where Hon. Mary Arivitza, MCA was adversely mentioned to have demeaned the office of the Speaker.

She stated that on that particular day, she left Kisumu and moved towards Kakamega and that, during the moderation session by the honorable speaker, she was not present later when the speaker was concluding. Further added that, she only heard about it during plenary on 23<sup>rd</sup> April 2019 in the Chamber.

#### 4 If he saw Hon. Mary Ariviza, MCA in Kisumu during the conference days.

She admitted seeing Hon. Mary Arivitsa, MCA.

## Whether she was hearing about the alleged argument between Hon. Mary Ariviza and the Speaker on the floor for the first time.

She heard it the previous day in the plenary it prompted them to converse being of the same age but refuted the alleged incident.

# ↓ If she got an opportunity to engage one on one with Hon. Mary Ariviza concerning the alleged incident.

She did not have an opportunity since she left before the adjournment of the House while attending to a matter leaving her with no time to converse with the honorable member.

## On her take concerning Hon. Mary Ariviza's alleged abuse of privileges as a leader.

She termed the allegations as a bad show as the honorable member must not act in a manner to demean the house or expose in – house matters in public adding that, if there was anything concerning the Speaker then, it was advisable to dialogue with the Leadership for solutions.

#### 3.1.6 Hon. Mary Ariviza

On Thursday,  $25^{th}$  April, 2019, Hon. Mary Arivitsa, MCA appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry. She informed the Committee as follows:-

## On whether she received a written invitation from the Committee to appear before it.

She confirmed receipt of an invite via Nairobi County Assembly SMS and an official letter in regards to the same, but noted that the letter had been given to her formally on the morning of her appearance before the Committee.

## On Whether She needs more time to Prepare for her appearance having received her written invite late.

She noted that despite being served the written invite late, she decided it was appropriate she appear before the Committee if her appearance would not consume a lot of time, seeing as she was within precincts but had a flight later in the day to attend a workshop in Mombasa.

#### + On what transpired in Kisumu regarding the accusations against her.

She noted that she was indeed present the Conference from the first day and even attended conference for people with disability, youths and women and also women conference but did not attend the conference on the specific dates during which the honorable speaker moderated sessions.

# On whether she attended the session that was being moderated by the honorable Speaker.

She stated that she did not attend the session where the honorable Speaker gave a speech.

 ✤ Why she arose on the floor of the house to give an apology when she had no issue with the honorable speaker and the house at large.

She confirmed apologizing on the floor of the Assembly being the subject of discussion at the time.

## If she spoke ill of the Hon. Speaker during the moderating sessions by the honorable speaker.

She did not speak ill of anyone and did not see the leader of the majority Party sitting anywhere close to her.

#### + What she meant when she said that Nairobi City County has only one worker.

She stated that they ought to have three employees while Nairobi City County do not have a single worker or office adding that her prior quotes did not mean to demean anyone or any office

#### 3.1.7 Hon. Melab Atemah, MCA

On Thursday, 25<sup>th</sup> April, 2019, Hon. Melab Atemah, MCA appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by

Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry

# When asked to confirm whether she had received and invitation to attend the meeting

She confirmed to have received the invite.

# When asked to confirm the presence of Hon. Mary Ariviza, MCA during the summit

She stated that she saw the Honorable member attend the said meeting for a couple of days.

## ✤ When asked if she witnessed the Honorable Ariviza conducting herself in a way to demean the office of the Speaker

She didn't remember seeing or witnessing Hon. Arivitsa misconduct herself. Further, she met with the Hon. Arivitsa during the breaks but did not sit with her at the conference.

#### ✤ When asked if she had heard such allegation anywhere else

The honorable member said that, she heard it for the first time from the Majority leader in the Assembly which also shocked her because she believed that was not right thing to do.

## When asked to confirm to the committee whether there could be a conspiracy to heckle the Hon. Speaker, Chege Mwaura during the summit

She may not have known since she kept in touch with the honorable Speaker throughout County Assemblies Forum adding that Hon. Mary Arivitsa, MCA was not with them throughout and that the last time she sat with her was during the last day of the meeting (during resolution of the County Assemblies Forum)

# When asked if she attended any session together with Hon. Mary Arivitsa that was facilitated or moderated by the Hon. Speaker himself

Hon. Mary Arivitsa, MCA was present and sat about two rows away from where they sat next to Members of Parliament adding that, they only sat close to one another after the summit had ended and they were told to go for people to discuss the constitution of the summit for CAF. that is when Hon. Mary sat in front of her and the Hon. Speaker wasn't there at that time. In conclusion, the honorable member suggested that if the County have somebody who does psycho - social programs and counselling, it will assist Hon. Mary Arivitsa, MCA going forward.

#### 3.1-8-Hon. Abdi I Hassan, MCA

On Wednesday,  $29^{th}$  April, 2019, Hon. Abdi Hassan, MCA appeared before the Committee for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

The honourable member appeared before the Committee and shared an audio clip of the incident to the Committee. He stated that the source of the audio clip was by a member from another County Assembly who heard Hon. Mary Arivitsa, MCA talk in a manner to demean the office of the speaker.

Subsequent to the Hon. Abdi Hassan's appearance, the Committee resolved that the Hon. Mary Arivisa, MCA be re-invited to appear before the Committee for purposes of responding to the allegations raised by the Hon. Abdi Hassan, MCA, and the recording he tabled as evidence when he appeared before the committee. The member was subsequently invited to appear before the Committee on 8<sup>th</sup> May, 2019.

#### 3.1.9 Hon. Mary Ariviza, MCA

On Wednesday, 8<sup>th</sup> May, 2019, Hon. Mary Arivitsa, MCA re-appeared before the Committee for the second time for purposes of giving evidence on events of  $15^{th} - 17^{th}$  April 2019 over the alleged abuse of privileges while attending the County Assemblies Forum Legislative Summit 2019.

+ When asked if at all she understood why she was re - invited to the committee.

She said that she was aware of the invite and confirmed to have received a message from Nairobi City County Assembly that required her to attend the Select Committee on Powers and Privileges meeting that was rescheduled from 30<sup>th</sup> April 2019 to 8<sup>th</sup> May 2019 following a letter that she wrote to the Committee requesting the Committee to give her more days (seven days) to prepare for the meeting. Adding that, in the SMS, the Committee required her to shed light on an alleged misconduct incident that occurred in Kisumu.

On whether she had had the opportunity to listen to the recording alleging her misconduct and her comments on the same.

THE PARTY AND AND

She stated she had not heard the recording.

## When asked to state her reason for apologizing on the floor of the Assembly if she had not done anything

She noted that she is a Christian, quoting the bible verses while giving examples that when a person is offended with another or aggrieved, then the most important thing by that time is the need to make peace. So the apology was for the anger and the uproar that was in the House and not as perceived.

She even didn't know of her accuser or who might have brought the clip.

#### (At this point, the Audio was played for her)

# On what she understood from the clip and to confirm if she is the one in the recording

She was not sure if that was her voice and if it was hers then, it might be moved out of context of what was being said and the communication she received.

# (The Chairperson read a letter sent to her on 30th April 2019 and an SMS from Nairobi County Assembly explaining resolutions of the same)

She agreed to have received the communication but to her understanding, the Committee seemed to have shifted goal posts from the initial letter she received.

On whether it was her voice in the recording, she stated she did not attend the meeting where the Hon. Speaker was speaking and that, while she was in the summit, she did not speak anywhere near people from Nairobi County Assembly and that most of the time she stayed in her village.

She insisted that it may not be her voice since they are leaving in a digital era where anyone could change people's voices on digital machines to suit their needs.

# On her opinion on whether it was proper that the Committee pursue her for the alleged remarks

She noted that it was her prayer that Nairobi City County be a place where members can legislate and over sight so that it doesn't focus on Honorable members since it has become a routine appearing before the Select Committee on Powers and Privileges.

She wished the committee to take a reconciliatory step and not major in punishing members and that, there is a pre-arrangement that the powers and privileges plan to send her away for three months and not 21 days as was the first report, adding that, she knew Hon. Beatrice Elachi, MCA has been declared as the speaker Nairobi County Assembly by the court and that she would be coming, so she urged the Committee to have a reconciliatory attitude

# + When asked to name those she heard making allegations against the powers and privileges committee in regards to her punishment of three months.

She said that she may not be able to mention anyone.

# If she still believes that Hon. Beatrice Elachi is still the Nairobi City County Assembly Speaker and if she believes the Ag. Speaker has substantive powers

She stressed on the reconciliation as with that it doesn't mean she has to come to Nairobi City County Assembly but it ought to be beyond that, stating that, people should reconcile and focus ahead. That being a constitution maker, she believed in the rule of law and would urge Nairobi City County Assembly to be reconciliatory and work together to serve Nairobians.

### 4.0 Committee's Observations, Findings and Recommendations

#### 4.1 Observations

Having reviewed the audio - clip containing allegations of alleged misconduct of Hon. Mary Arivitsa, MCA from various members of the County Assembly and members of staff who appeared before the committee as witnesses and the oral evidence adduced by the witnesses, the Committee observes that-

- That indeed Hon. Mary Arivitsa, MCA attended the CAF Legislative Summit, 2019 in Kisumu County, and was indeed present at the material day, time and place that it is alleged she misconducted herself with a view to demeaning the reputation of not just the office of the Speaker, but of the County Assembly as recalled by various witnesses;
- 2. That the Hon. Mary Arivitsa, MCA had acted in a manner to demean the office she holds, that of the speaker and the Assembly and that it was evident in an audio clip that was presented before the Committee by one of the witnesses, the Hon. Abdi. I. Hassan, MCA, and other witnesses who were present at the material time;
- 3. That the Hon. Mary Arivitsa, MCA misled, and therefore lied in her witnesses testimony that she did not attend the conference on the material day as alleged and was therefore not present at the time the Hon. Acting Speaker moderated a session, contrary to irrefutable evidence on record that she did sign for her attendance with the Sergeants at Arms on the material day and was indeed present as recalled by other witnesses at the material time and place that the alleged misconduct occurred.

#### 4.2 Findings

 Upon Scrutiny of information from all witnesses by the Committee, and prima facie evidence in an audio clip that was presented before the Committee by one of the witnesses, Hon. Abdi.
 Hassan, MCA – Leader of the majority party, the Committee finds that a strong inference can be made that the Hon. Mary Arivitsa, MCA acted in a manner to demean the office of the speaker.

2. The Committee finds that the Hon. Mary Arivitsa, MCA, misled, and therefore lied in her witnesses testimony that she did attend the conference on the material day as alleged and was therefore not present at the time the Hon. Acting Speaker moderated a session, contrary to irrefutable evidence on record that she did sign for her attendance with the Sergeants at Arms on the material day and was indeed present as recalled by other witnesses at the material time and place that the alleged misconduct occurred.

#### **4.3 RECOMMENDATIONS**

Having reviewed the evidence on record, including oral testimony from all witnesses invited to appear before the Committee, the Committee makes the following recommendations: -

#### THAT: -

- a. Pursuant to Section 17 (3)(g) of the County Assemblies Powers and Privileges Act, 2017, the Hon. Mary Arivitsa, MCA be suspended from the Assembly for **THIRTY (30)** plenary sittings upon adoption of the report for conducting herself in a manner intended to demean the office she holds, that of the honorable speaker and conduct likely to reflect adversely on the dignity or integrity of the County Assembly, or of its members contrary to the best interest of the Assembly and contrary to Section 16 (e) of the County Assemblies Powers and Privileges Act and for violation of Standing Orders 113 (g) and (j).
- b. Pursuant to Section 17 (3) (c) of the County Assemblies Powers and Privileges Act, 2017, the Hon. Mary Arivitsa, MCA shall formally apologize to the Assembly after serving the suspension.
- c. The Assembly forthwith conduct rigorous training for all Honorable members on conduct, powers, immunities and privileges.

On Thursday, 24<sup>th</sup> April, 2019 *Mr. Francis Kivila (Sergent At Arms - staff)* appeared before the Committee for purposes of giving evidence on events of 15<sup>th</sup> – 17<sup>th</sup> April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa, MCA while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

When requested to share with the Committee what transpired on 17<sup>th</sup> April, 2019 in Kisumu during the Speaker's speech.

He confirmed to have travelled to Kisumu and shared with the Committee the major roles he played during that time in Kisumu which majorly was coordination, logistics and to ascertain that the badges for the honorable members and staffs from Nairobi City County Assembly were ready in good time. They were too to coordinate youth and women summit event which had commenced before the main event (CAF event).

He stated that, there were other officers who were assigned duties of manning the plenary point (where the main event was taking place) adding that he was in charge of protocol and access control at the entry point (gate).

He further said that he only interacted with the Hon. Speaker at the point he entered the venue. And hence, he didn't participate in the plenary events, so he may not be able to confirm hearing anything in relation to the said matter that was under investigation at that event.

If he Could have heard the Speaker's speech by any chance at the point he was.

He reaffirmed that from the plenary point to the entrance where he was assigned the duties was far (about 200 or 300metres away) unless one used a loud speaker, one may not be able to hear what they said.

When asked to name the sergeant –Art –Arm who was assigned the plenary point where the speeches were being delivered?

They had two officers, that is Mr. Patrick Moindi, and Mr. Daniel Osewe (Commissionaire of Nairobi City County Assembly).

In regards to designation of duties during that time, Mr. Patrick Moindi was to receive the Hon. Speaker and guide him to a holding room for the Speakers and thereafter escort the Speaker to the plenary.

He was to be assisted by Mr. Daniel Osewe. in an event that he could be out of the plenary and that if the said utterances were loud enough to be heard then, they could be the officers to share some information in relation to that.

To confirm whether Hon. Mary Ariviza, MCA was in attendance that day.

He confirmed that he met Hon. Mary Ariviza, MCA on that particular day and he even recalled issuing her with a meal card.

If he heard anybody complain anywhere within Kisumu of Hon. Mary Ariviza, MCA behavior.

He stated that he didn't interact with any Member of the County Assembly or staff who in any way expressed dissatisfaction on the conduct of one Hon. Mary Arivitza, MCA unless it happened somewhere else from where he was.

The advice he could give to the Hon. Members in case of any misconduct.

He stated that he would be the least person to give advice, however, public and state officers ought to adhere to the chapter six of the constitution.

### 2) Mr. Daniel Osewe (Sergent At Arms staff)

On Thursday, 24<sup>th</sup> April, 2019 *Mr. Daniel Osewe (Sergent At Arms - staff)* appeared before the Committee for purposes of giving evidence on events of 15<sup>th</sup> – 17<sup>th</sup> April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

Where he was at the time honorable Speaker was delivering his speech.

He confirmed that he was at the venue during the speaker's speech.

If there was any interruption to the Speaker's speech by Hon. Mary Ariviza.

He didn't see any interruption during the hon. Speaker's speech

Whether Hon. Mary Ariviza had an opportunity to address the crowed.

He stated that Hon. Mary Arivitsa, MCA didn't have opportunity to address the crowd.

If he ever heard anybody complain about Hon. Mary Ariviza during the sessions in Kisumu.

He told the Committee that he didn't hear anyone complain.

### 3) Mr. Patrick Moindi (Sergent At Arms staff)

He didn't hear any of his colleagues discuss anything in regards to honorable Mary Arivitsa's alleged misconduct but only heard the same during plenary on 23<sup>rd</sup> April 2019.

Whether he saw Hon. Mary Ariviza, MCA on that particular day when the Speaker gave the speech.

He stated that he met the honorable member at the exhibition which was situated close to main entrance.

If he heard anybody complain about her.

He did not hear anyone complain of her actions at any given point.

#### 4) Mr. John Moyare (Speaker's body guard)

On Thursday, 24<sup>th</sup> April, 2019 *Mr. John Moyare (Speaker's body guard)* appeared before the Committee for purposes of giving evidence on events of 15<sup>th</sup> – 17<sup>th</sup> April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa, MCA while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

If he was in Kisumu and specifically when the honorable speaker was moderating

He stated that he wasn't with the speaker full time on Tuesday and didn't attend on Wednesday too but went there in the afternoon and found him moderate the event.

Whether he was aware that there is allegation that Hon. Mary Ariviza, MCA shouted down at the Speaker during the County Assemblies Forum 2019 held in Kisumu.

He was not aware but was there in the afternoon when the honorable speaker was moderating but not giving the speech and that was in the afternoon stating that there are instances like in the Chamber where his duties are restricted (he is not supposed to be inside the Chamber adding that the one who is supposed to be protecting the Speaker is the Sargent Art Arms who is not armed and so being armed, he is expected not to be close) hence he could be in the tent but could not move beyond where honorable Members were seated to the point where the Speaker concluding that, at any given point during the workshop.

She said that that she stood on the floor to apologize because she was the subject of discussion urging the Committee members to have time to listen to the you will Hansard on that day so that they may certify whatever she uttered on that day.

### If she spoke ill of the Hon. Speaker during that time.

She didn't and at no given time did she see the leader of the majority Party sitting anywhere near her and she would have liked to know the Standing Order that allows one to give an allegation, however she wanted to know other details in regards to the allegations against her.

## What she meant when she said Nairobi County has only one worker.

#### MIN.087/P&P/MAY/2019 APPEARANCE BEFORE THE COMMITTEE BY HON. MARY ARIVITZA, MCA

On Wednesday, 8<sup>th</sup> May, 2019, Hon. Mary Arivitsa, MCA appeared before the Committee for the second time for purposes of giving evidence on events of 15<sup>th</sup> – 17<sup>th</sup> April 2019 over the alleged abuse of privileges by Hon. Mary Arivitsa while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County now under inquiry.

Hon. Mary Arivitsa, MCA appeared before the Committee. the vice chairperson welcomed her and thanked her for having honoured the Committee

The vice chairperson made reference to Hon. Mary Arivitsa's letter dated 30<sup>th</sup> April 2019 requesting the Committee to give her more time to adequately prepare for the meeting of the Committee to shed light on the alleged abuse of privileges while attending the County Assemblies Forum, Legislative Summit 2019 held in Kisumu County from 15<sup>th</sup> – 17<sup>th</sup> April 2019 refer,

Adding that, the Committee at its sitting held on 30<sup>th</sup> April 2019, considered her request and resolved to grant her request and that the said meeting therefore had been rescheduled to 8<sup>th</sup> May 2019.

The vice chair added that the Committee thereby resolved to request her to attend the Committee meeting on 8<sup>th</sup> May 2019 at 10:30 a.m.

The committee took the member through an audio clip that was presented by one of the witnesses (leader of the Majority Party) and requested the Hon. Member to confirm if the voice was hers. she said that the voice was not hers and that they are in a world of technology where people's voices can be interfered with to suit their needs.

## If at all she understood why she was re - invited to the committee.

She said that she was aware of the invite and confirmed to have received a message from Nairobi City County Assembly that required her to attend the Select Committee on Powers and Privileges meeting that was rescheduled from 30<sup>th</sup> April 2019 to 8<sup>th</sup> May 2019 following a letter that she wrote to the Committee requesting the Committee to give her more days (seven days) to prepare for the meeting. Adding that, in the SMS, the Committee required her to shed light on an alleged misconduct incident that occurred in Kisumu.

She felt that she had been over followed by the Select Committee on Powers and Privileges. And that her cases were always hurried unlike for other honorable members whom she referred their cases to be taking longer time before being followed. Giving instances of what she referred to as harsh punishment for having picketed by the Committee than other Members. Hence she felt like she has been over focused on by the Committee.

## Her take on the issue since the Committee had recordings before it and do not rely on hearsay.

She may not have a take since she has not heard the recordings.

She was not sure if that was her voice and if it was hers then, it might be moved out of context of what was being said and the communication she received.

(she was read for a letter that was forwarded to her on 30th April 2019 and an SMS from Nairobi County Assembly explaining resolutions of the same)

She agreed to have received the communication but to her understanding, the Committee seemed to have shifted goal posts from the initial letter she received and an SMS from Clerk.

#### (Vice chair rectified her that the message was from NCCA and not Clerk as she said and agreed that it was from NCCA).

To confirm whether the voice is hers.

She may not know because she did not attend the meeting where the Hon. Speaker was speaking and that, while she was in the summit, she was led by the spirit of God and did not speak anywhere near people from Nairobi County Assembly and that most of the time she stayed in her village.

She insisted that it may not be her voice since they are leaving in a digital era where anyone could change people's voices on digital machines to suite their needs.

#### To advice the Committee going forward.

It was her prayer that Nairobi City County be a place where people can do legislate, do over sight role so that it doesn't focus on Honorable members since it has become a routine appearing before the Select Committee on Powers and Privileges.

She wished the committee to take a reconciliatory step and not major in punishing members and that, there is a pre-arrangement that the powers and privileges plan to send her away for three months and not 21 days as was the first report, adding that, she knew Hon. Beatrice Elachi, MCA has been declared as the speaker Nairobi County Assembly by the court and that she would be coming, so she urged the Committee to have a reconciliatory attitude

To name those she heard putting allegation against the powers and privileges committee in regards to her punishment of three months.

She said that she may not be able to mention anyone.

If she still believes that Hon. Beatrice Elachi is still the Nairobi City County Assembly Speaker and if she believes the Ag. Speaker have substantive powers. Nairobi City County Assembly but it ought to be beyond that, stating that, people should reconcile and focus ahead.

Being a constitution maker, she believes in the rule of law and would urge Nairobi City County Assembly to be reconciliatory and work together to serve Nairobians.

#### OBSERVATIONS

Having reviewed the audio- clip containing allegations of alleged misconduct of Hon. Mary Arivitsa, MCA from various members of the County Assembly and members of staff who appeared before the committee as witnesses and the oral evidence adduced by the witnesses, the Committee observes that-

- 1. That indeed Hon. Mary Arivitsa, MCA had acted in a manner to demean the office of the speaker and that it was evident in an audio clip that was presented before the Committee by one of the witnesses Hon. Abdi. 1. Hassan, MCA
- 2. Honorable member had lied before the Committee that she did not act in anyway at any given point in a manner to demean the office of the speaker and was not present at the time the Hon. Speaker moderated a session

#### FINDINGS

- 1. Upon Scrutiny of information from all witnesses by the Committee, it was evident in an audio clip that was presented before the Committee by one of the witnesses Hon. Abdi. I. Hassan, MCA that it was true that Hon. Mary Arivitsa, MCA acted in a manner to demean the office of the speaker.
- 2. The Committee also noted that the honorable member had lied before the Committee that she did not act in anyway at any given point in a manner to demean the office of the speaker and even after an audio clip from one of the witnesses was played she, she told the committee that she was not sure if the voice was hers and that she was not present during that time (*The committee therefore concluded that it was their role as a Committee to judge and give recommendations accordingly*).
