

#### I. PREAMBLE

Madam Speaker, the First Supplementary Revenue and Expenditure Estimates for the FY 2019-20 were tabled in the County Assembly on 22<sup>nd</sup> January 2020 during a special sitting. The estimates were tabled pursuant to the provisions of Section 135 of the Public Finance Management (PFM) Act, 2012, the Public Finance Management (County Government) Regulations 2015 and Standing Order 228.

The consideration of these Estimates were done by the Nairobi City County Assembly Finance, Budget & Appropriations Committee established pursuant to the provisions of Standing Order 199 with a specific mandate among which is to:

- a) Investigate, inquire into and report on all matters related to coordination, control and monitoring of the of the county budget;
- b) Discuss and review the estimates and make recommendations to the County Assembly;
- c) Examine the County Fiscal Strategy Paper presented to the County Assembly;
- d) Examine Bills related to the county budget, including Appropriations Bills; and
- e) Evaluate tax estimates, economic and budgetary policies and programs with direct budget outlay

- II. SCRUTINY OF THE NAIROBI CITY COUNTY FIRST SUPPLEMENTARY ESTIMATES FOR THE FY 2019-20
- 1. Madam Speaker, on 25th September 2019 this County Assembly approved the Annual Estimates of Revenue and Expenditure for the FY 2019-20 totaling Kshs. 36.98billion consisting of Kshs. 25.71billion for recurrent and Kshs. 11.27billion for development expenditures. In the approved budget the County Government had purposed to prioritize garbage collection with an allocation, continue rolling out the Ward Development projects, implement the various critical programmes under the Public Works Sector, settle part of the pending bill for statutory creditors among other issues across various Sectors. The supplementary estimates submitted has retained the total County Budget at Kshs. 36.98billion with the revised recurrent budget standing at Kshs. 27.95billion while the revised development budget stands at Kshs. 9.03billion. With that allocation there is a proposed increase in recurrent budget by Kshs. 2.2billion with the development budget projected to reduce by a similar amount.
- 2. Madam Speaker, the Finance, Budget and Appropriations Committee has been consistent in reminding this Chamber on the circumstances under which supplementary budgets can be prepared, how they should be submitted and the mode of dispensing with the same in this house. The cornerstone of the legal provisions on supplementary budgets is that they should only be prepared to take care of matters that were unforeseen during the time of preparing the annual budget estimates. Further, such matters to be considered must remain unavoidable during the time of preparing the supplementary budget. To provide more clarity on the legal provisions, the provisions of Regulation 39 of the PFM (County Government) Regulations 2015 allow Accounting Officers to spend not more than 10% for various programmes and votes of the approved budgets but the same has to be subject to the concurrence of the County Executive Committee Member responsible for Finance. The concurrence of the County Executive Committee Member for Finance must then be followed by tabling of revised estimates on the reallocations and overexpenditures to the County Assembly for approval.

3. The Regulation decree, Madam Speaker, that that those expenditures which were known during the time of consideration of annual estimates but could not be accommodated in the estimates shall not be considered unavoidable. It is therefore the expectation of the law that supplementary estimates should not be used as an avenue to correct mistakes arising from poor planning and improper prioritization at the time of making the annual budget. From the foregoing it is clear that supplementary budgets can be used to request for new funds or to ratify funds that have already been spent within the legal parameters. The Committee in the scrutiny of the tabled estimates confirmed that the first supplementary estimates for the FY 2019-20 have been prepared in tandem with the statutory requirements.

4. Madam Speaker, the third supplementary estimates have been submitted to provide basis for payment of pending bills that were audited by the Office of the Auditor General (OAG). The OAG picked up the work had by the Pending Bills Committee which in its report had found that there were 839 legitimate claims representing a total of Kshs. 11.4billion. In its report, the Pending Bills Committee also noted that there were 174 claims representing a total of Kshs. 6.1billion which were not recommended for payment due to various reasons ranging from lack of authenticity, lack of supporting documents among other reasons. On their part the OAG found that there was a total of Kshs. 23billion worth of pending bills as at 30th June 2018. Further the office noted that the outstanding eligible bills as at 15th February 2019 stood at Kshs. 10.8billion while ineligible bills amounted to Kshs. 11.3billion. The commitment and desire to settle pending bills is in line with His Excellency the President directive that Counties should set aside resources for settling of pending bills that are devoid of audit queries. This supplementary budget therefore aims to provide resources to the tune of Kshs. 2.825billion for settling of part of the recurrent pending bills and Kshs. 859million for settlement of part of the pending bills owed to development contractors. To make resources available for these payments, reallocations have been done across various votes in line with the provisions of Section 135 and 154 of the PFM Act 2012.

5. Madam Speaker, the Finance, Budget and Appropriations Committee has reviewed the Supplementary Estimates together with the submissions of the County Executive Committee Member for Finance and wishes to confirm that the intention is to improve the face of the County by ensuring that those who undertake works for the County are compensated for jobs done. The Committee therefore requests that this House approves the First Supplementary Estimates for the FY 2019-20 to enable the utilization of the funds before 30th June 2020.

#### III. RECOMMENDATIONS

Madam Speaker, in conclusion and pursuant to the provisions of Section 135 (2) and (4) of the Public Finance Management Act 2012 and Standing Order 228 the Select Committee on County Finance, Budget and Appropriations recommends that:

"This County Assembly adopts the Report of the Select Committee on County Finance, Budget and Appropriations on the First Supplementary Budget Estimates for the Nairobi City County Government and County Assembly for the FY 2019-20"
