
#### 2.0 PROPOSED AMENDMENTS TO STANDING ORDERS

Hon. Speaker, the below tabulated amendments to the Nairobi City County Assembly Standing Orders, is in line with the Provisions of **Standing Order No. 246** which provides that; "The County Assembly Procedure and Rules Committee may at any time propose amendments to these Standing Orders."

Hon. Speaker, the Committee at its sitting held on Tuesday, 3<sup>rd</sup> December 2019 deliberated on the proposed amendments and adopted the same.



#### Standing Order No. 204 (1): On the establishment of the Liaison Committee:

There shall be a Committee to be known as the Liaison Committee which shall consist of:

- (a) the Chairperson of Committees as Chairperson;
- (b) the Majority and the Minority Party Whips
- (b) the First Chairperson of the Chairpersons Panel, who shall be the vice chairperson; Chairpersons of all Committees of the County Assembly excluding Ad Hoc

Committees.



#### 3.0 Justification for the Amendments

The Committee justified that there was need to increase the membership of the watch dog committees to enhance the efficiency of the roles of the committee. Also the need to increase the membership of the Select Committee on County Finance, Budget and Appropriations for deeper engagement of financial matters relating to the County Government.

Having agreed to these changes on the Budget committee and the watch dog committees it was agreed that it is inevitable for Standing Orders 169 and 203 on composition of select Committees and sectoral Committees be amended to fit the said numbers in the membership.

Lastly, the committee agreed that there is a need to have the party whips to the Liaison Committee as established under Standing Order 204 in order to ensure that the whips facilitate the Chairpersons in their role of transaction of the business in the County Assembly including Whipping the Chairpersons on matters concerning the parties in the Liaison Committee.

Having dispensed with the deliberation and having resolved as stated above the Committee adopted the amendments as proposed by Hon. Clarence Munga, MCA and seconded by Hon. Muchene Kabiru, MCA.

#### 5.0 Recommendations

On the foregoing, the Committee recommends as follows, THAT;-

- a) That Pursuant to Provisions of Standing Order No. 246, the Assembly Approves the report of the Committee on the proposed amendments to the Nairobi City County Assembly Standing Orders as contained in Table 1; and,
- b) That the amended Standing Orders take effect from the time of adoption of this report.

### MIN 004/P&R/DEC./2019 - PROPOSED AMENDMENTS TO THE STANDING ORDERS.

The Secretariat submitted the draft proposals for amendment of the Standing Order as had been directed by the Chairperson.

Upon deliberations, the Committee resolved to amend the Standing Orders as follows;

#### Resolutions, THAT: -

- i) Standing Order No. 169 (1) on the Composition of the Select Committees be amended by deleting the last word "'seventeen' in the paragraph and replacing thereof the words **twenty one**.
- ii) Standing Order No. 199 (2) on the establishment of the County Finance, Budget and Appropriations be amended by deleting the word "eighteen" appearing immediately after the words "more than" and replacing thereof the words **twenty two**.
- iii) Standing Order No. 197 (3) on the establishment of the Public Accounts Committee be amended by deleting the word "eighteen" appearing immediately after the words "more than" and replacing thereof the words **twenty two**.
- iv) Standing Order No. 198 (2) on the establishment of the Public Investment Committee be amended by deleting the word "eighteen" appearing immediately after the words "more than" and replacing thereof the words **twenty two**.
- v) Standing Order No. 203 (1) on the appointment of the Sectoral Committees be amended by deleting the word "nineteen" appearing immediately after the words "more than" appearing in the middle of the paragraph and replacing thereof the words **twenty one**.
- vi) Standing Order No. 196 (1) on the establishment of the Committee on Appointments be amended by deleting the word "seven" appearing immediately after the words "more than" appearing in the middle of the paragraph and replacing thereof the word **ten**.

vii) Standing Order No. 204 (1) on the establishment of the Liaison Committee by introduction of the following paragraph between paragraph (a) and paragraph (b): **new (b)** the Majority and minority party whips.

#### Justification for the Amendments

The Committee justified that there was need to increase the membership of the watch dog committees to enhance the efficiency of the roles of the committee. Also the need to increase the membership of the Select Committee on County Finance, Budget and Appropriations for deeper engagement of financial matters relating to the County Government.
