

2.0 BACKGROUND

The Select Committee on Liaison is mandated to deliberate on and apportion annual operating budget among other Committees and to consider the programmes of all Committees including their need to travel and sit away from the precincts of the County Assembly. Consequently, during the period under review (October 2022 and June 2023), the Committee has held workshops for Quarter 3, Quarter 4 and Quarter 4 of FY 2022/2023 and Quarter 1 of FY 2023 to allocate budget and schedule workshops for other Committees. The Committee has held meetings to consider and approve various other business related to its mandate, more so, on operations of Committees.

Standing Order 197 require that all Assembly Committees submit half year progress reports on their activities related to their respective mandates to the Select Committee on Liaison for consolidation and submission to the Assembly within 21 days of receipt.

At its workshop held from 9th to 13th June 2023 at Sarova Whitesands, Mombasa, Assembly Committees presented and submitted their half-year progress reports to the Committee, thus, this report consolidates all the reports from other Committees.

2.1 EXCERTS OF HALF-YEAR COMMITTEE REPORTS

2.1.1 SECTORAL COMMITTEE ON TRANSPORT AND PUBLIC WORKS

2.1.1.1 Investigation and site inspection visits

a) Site visit to Thigiri Lane in Karura Ward

A statement was requested from the Committee by Hon. Fiunifiu Thuo, MCA regarding blockage of Thigiri Lane in Karura Ward. The Committee resolved to convert the Statement into an investigation. Accordingly, the Committee conducted a site visit to gather information on the same. The Committee compiled a report and Tabled the same in the Assembly on 15th June 2023.

b) Site inspection visit to County facilities

The Committee conducted a site inspection visit on 6th June 2023 to Nairobi City County Mobility and Works facilities including Kangundo Road and Nanyuki Road Asphalt plants to assess their capacity, conditions and management. The Committee is concluding on the report in view of Tabling in the Assembly.

2.1.1.3 Workshops

2.1.1.4 Public Petitions

The Committee received a public Petition from the Association of Online Taxi Drivers presented by Hon. Mark Mugambi, MCA. The Committee met the stakeholders and compiled a report which has since been adopted by the Committee. Once reviewed, the report will be Tabled in the Assembly.

2.1.1.5 Bills

The Committee has neither originated nor received any legislative proposal for consideration

2.1.1.6 Other business

The Committee considered, processed and reported on the Nairobi City County Integrated Development 2023-2027, Nairobi City Annual Development Plan FY 2023/2024, the Nairobi City County Fiscal Strategy Paper FY 2023/2024 and the Budget Estimates FY 2023/2024. The said reports were forwarded to the Select Committee on County Finance, Budget and Appropriations as required by the Standing Orders.

2.1.1.7 Challenges

The Committee reported to be experiencing challenges in raising quorum in time during Committee;

- a) The Committee reported that peculiar interests interfere with effective discharge of its mandate;
- b) The Committee reported that lack of commitment to the work of the Committee by some Executive Officers; and
- c) The Committee requested for continued capacity building form Members on effective discharge of their mandate in the Committee.

2.1.2 SECTORAL COMMITTEE ON LANDS, PLANNING AND HOUSING

2.1.2.1 Sittings

During this period, the Committee has held 34 meetings with the County Executive and various stakeholders to consider a number of businesses. It has also conducted five workshops in Mombasa County and Kiambu County.

2.1.2.2 Bills

While the Committee do a lot of work in sifting out facts and coming up with sound recommendations/resolutions, the Executive only implements what is favorable to it and disregards most of what the Assembly recommends. To address this, before tabling its report, the Committee usually shares the recommendations with the CEC Member to determine the practicality of the recommendations;
- 5) Failure by the County Health sector to submit quarterly Audit reports for every subsector to allow scrutiny by the Committee has been challenge for the Committee to perform its oversight functions; and
- 6) Failure to pay Members and staff of County Assembly by the County Executive for attending Executive Sponsored.

During the period under review, the Committee experienced the following challenges:

- a) There are many pending regulations that Sectors are yet to submit to the Assembly for consideration;
- b) There is lack of commitment in publishing Acts of the Assembly by the Office of the County Attorney; and
- c) The County Executive to provide financial and human resource support to the Office of the County Attorney for processing of Assembly resolutions especially publication of Acts.

3.0 OBSERVATIONS

Having considered the half-year progress reports submitted by the Assembly Committees, the Select Committee on Liaison made the following observations:

- 1) That even though there are a number of legislative proposals awaiting drafting and publication in the Office of the Clerk, County Assembly was far from its target in terms of generation and processing of legislative proposals;
- 2) That Assembly Committees were failing in following their approved quarterly work plans;
- 3) That Assembly Committees were fairly on track in the conduct of oversight and representation roles. However, Committees' performance with respect to timely response to Statements was very unsatisfactory;
- 4) That a number of business whose timelines had lapsed were still pending before Committees despite the directions from the Speaker for re-introduction, i.e Bills and Petitions;
- 5) That virtually all Assembly Committees were fairly resourced to properly carry out their mandate;
- 6) That there were delays in the payment of imprest advanced to Members of Committees who take part in workshops outside the Assembly;
- 7) That the County Executive delay to submit statutory documents and information requested by Committees was negatively affecting informed scrutiny and processing of relevant reports to the County Assembly;
- 8) That the shortage, size and inadequately equipped Committee rooms was affecting effective conduct of meetings given the membership of Committees and stakeholders Committees meet;
- 9) That Members fail to optimally participate and contribute to Committee meetings whenever such meetings are scheduled to take place same time;
- 10) That Committees often experience lack of quorum to commence scheduled meetings;

- 11) That there was need for continued capacity building for Members of County Assembly on Committee mandates, administration and stakeholder engagements;
- 12) That Members' peculiar and undisclosed interests in Statements often delay the work of Committees as a result of disinterest in the response whenever the peculiar interest is satisfied or unavailability to attend meetings of Committees whenever County Executive Committee Members are invited to discuss statements;
- 13) That there was inadequate/outdated equipment such as printers for Committees Secretariat to effectively facilitate Committees; and
- 14) Lack of commitment to the work of the Assembly Committees by the some Executive Officers. Some officers and sectors deliberately delay appearance before Committees, refuse to submit documents or request for postponement of meetings more than twice to delay Committee action. Some Sectors fail to submit quarterly reports to the Assembly Committees for review and action.

4.0 RECOMMENDATIONS

Having received considered the half-year progress reports pursuant to Standing Order 197, the Select Committee on Liaison makes the following recommendations to streamline the affairs of Committees:

- 1) Members of County Assembly and Committees advised to re-examine their respective mandates, review Constitutional functions of County Governments and examine submissions from stakeholders in view of identifying areas of legislation in order to originate legislative proposals;
- 2) Committees to prepare realistic work plans that take into account comprehensive issues within the their respective mandates;
- 3) Committees to step up discharge of their respective mandates by observing timelines attached to various business. The Select Committee on Liaison would hold a meeting with the H.E the Governor to address the issue of delayed response to questions raised by the Assembly and timely submission of reports, policy documents and responses;
- 4) Chairpersons and Committee secretariat to examine pending business before respective Committees in view of expediting their consideration and re-introducing those that lapsed;
- Select Committee on Liaison to rally for more resource allocation to Committees in order to adequately resource all Committees for effective discharge of their mandate and capacity building;
- 6) The Speaker and the Clerk to put in place long term measures to address the challenge of delays in payment of imprest for Members and staff who attend workshops of Committees;
- 7) The Clerk to prepare a realistic schedule of Committee meetings to both prevent clashing of Committee meetings. Further, the Clerk to ensure that the said rooms are adequately equipped for effective conduct of meetings;

- 8) The Speaker to issue a Communication to Members in the Assembly on the consequences of violating Standing Order 183 on missing four (4) consecutive Sittings, the need for commitment to Committee business and upholding the integrity code;
- 9) The Clerk to adequately equip, facilitate and continuously build capacity for officers to enable them effectively provide administrative support to Assembly Committees; and
- 10) Select Committee on Liaison to continuously hold meetings to deliberate on and address teething issues that affect Assembly Committees and provide guidance and advisory on the conduct of Committee business.
