The nomination of the thirty three (33) persons was conveyed to the Assembly vide a letter **Ref. NCC/GOV/Legal/438/2022** dated **8**th **December, 2022.** On **Tuesday 13**th **November, 2022** and pursuant to Standing Order 45(1), the Honorable Speaker read the message from His Excellency the Governor to the Assembly communicating the names of the nominees. Pursuant to Standing Order 48 read together with Section 7 of the Public Appointments (County Assemblies Approval) Act, 2017 the names of the nominees were referred to the

relevant Sectoral Committees for vetting and reporting to the Assembly within twenty-one (21) days.

Consequently, pursuant to Section 7(4) and 7 (5) of the Public Appointments (County Assemblies Approval) Act, 2017, the Clerk of the County Assembly placed an advertisement in the local dailies, specifically the Daily Nation and Standard Newspaper on **Wednesday 14th December, 2022**, inviting the public to submit memoranda by way of written statements on oath (*sworn affidavits*) on the suitability or otherwise of the nominees in conformity with Article 196 (b) of the Public Participation Act. The advertisement indicated that the submissions were to be received by **Tuesday, 20th December, 2022**.

Further, in the fulfilment of the provisions of Section 7 of the Public Appointments (County Assembles Approvals) Act, 2017, the Clerk notified the general public that the approval hearings of the nominees would be held on **Thursday 22nd December, 2022.**

Having conducted the approval hearing of the nominees pursuant to Article 179(2)(b) of the Constitution, Section 7(4) and 7 (5) of the Public Appointments (County Assemblies Approval) Act, 2017 and Standing Order 209(6)(f) the Committee recommends that the House-

- 1. approves the nomination of Oscar Mafunga Igaida for appointment as County Chief Officer for Youth, Talent and Sports by His Excellency the Governor.
- 2. approves the nomination of Michael George Mutiso Musembi for appointment as County Chief Officer for Social Services by His Excellency the Governor.
- 3. approves the nomination of Clement Rapudo Sijenyi for appointment as County Chief Officer for City Culture, Arts and Tourism by His Excellency the Governor.
- 4. approves the nomination of Bramwell Wesangula Simiyu for appointment as County Chief Officer for Disaster Management and Coordination by His Excellency the Governor.

5. approves the nomination of Lydia Wambui Maitha for appointment as County Chief Officer for Public Participation, Citizen Engagement and Customer Service by His Excellency the Governor.

May I take this opportunity to thank Members of the Committee for their input and valuable contributions during the deliberations and vetting exercise. The Committee also takes this opportunity to thank the Offices of the Speaker and of the Clerk of the County Assembly for the logistical support accorded to it during the vetting exercise. The Committee is grateful to the staff of the County Assembly attached to the Committee for their services rendered to the Committee. Their efforts and input made the work of the Committee and the production of this Report possible. The Committee is also grateful to the media for their coverage of the proceedings of the Committee, thus enhancing accountability and transparency of the vetting exercise.

2.O. PREFACE

2.1 Establishment and Mandate of the Committee

- 1. Section 14 (3) of the County Governments Act, 2012 provides that when a County Assembly considers any appointment for which its approval is required under the Constitution, an Act of Parliament or county legislation, the appointment shall be considered first by a committee of the County Assembly.
- The Sectoral Committee on Culture and Community Services is established under Standing Order No. 209 (1). Its mandate pursuant to Standing Order 209 (6) is to:
 - a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned departments;
 - b) study the programme and policy objectives of departments and the effectiveness of the implementation;
 - c) study and review all county legislation referred to it;
 - d) study, assess and analyse the relative success of the departments as measured by the results obtained as compared with its stated objectives;
 - e) investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly;
 - f) vet and report on all appointments where the Constitution or any law requires the County Assembly to approve, except those under Standing Order 202(Committee on Appointments): and make reports and recommendations to the County Assembly as often as possible, including recommendation of proposed legislation
- Section 10(1) of the Public Appointments (County Assemblies Approval)
 Act, 2017 (No. 5 of 2017) provides thus:-

"Where the nomination of a candidate is rejected by a County Assembly, the appointing authority may submit to the relevant County Assembly the name

of another candidate, and the procedure for approval specified in this Act shall apply accordingly."

3.0. BACKGROUND

3.1. Notification of Nominations

- 4. Section 45 (1) (a) and (b) of the County Governments Act, 2012, provides for the Governor's power to nominate Chief Officers, with the approval of the Assembly, from among persons who are not members of the County Assembly.
- 5. A letter from the Office of the Governor dated 8th December, 2022, addressed to the Speaker of the County Assembly indicated that pursuant to section 45 (1) (a) and (b) of the County Governments Act, 2012, H.E. the Governor, Hon. Sakaja Arthur Johnson had nominated thirty three (33) nominees to be considered for approval by the County Assembly for appointment as Chief Officers of the ten Sectors.
- 6. On Tuesday, 13th December, 2022, the Honourable Speaker in a Message to the Assembly informed the Assembly that his office had received the names of the thirty three (33) nominees, and directed that the names and curriculum vitae of the said nominees be referred to the various Select and Sectoral Committees for vetting and reporting to the Assembly pursuant to Standing Order 203 (6) (f) and Section 7 of the Public Appointments (County Assemblies Approval) Act, 2017(No. 5 of 2017).

3.2. Notification to the House and referral to the Sectoral Committee on Culture and Community Services.

3. Pursuant to Standing Order 45(1), the Honorable Speaker informed the Assembly on 13th December, 2022 that he had received the notification of the nominations. The notification of nomination of the nominees for Chief Officers responsible for Youth, Talent and Sports; Social Services; City Culture, Arts & Tourism and Disaster Management and Coordination sectors were therefore referred to the Sectoral Committee on Culture and Community Services on 13th December, 2022 for vetting and reporting to the Assembly within 21 days in accordance with Section 9(1) of the Public Appointments (County Assemblies Approval) Act, 2017 (hereinafter referred to as "the Act").

3.3 Notification to the Public

- 4. Section 7 (5) and (10) of the Public Appointments (County Assemblies Approval) Act, 2017 provides that-, "the committee shall, by notice in at least one newspaper of national circulation, notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing" and "any person may, prior to the approval hearing and by a written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".
- 5. Pursuant to the above provisions of the law, the Clerk of the County Assembly placed an advertisement in the in the local dailies, specifically the Standard Newspaper and the Daily Nation Newspaper on Wednesday 14th December, 2022 inviting the public to submit memoranda by way of written statements on oath (sworn affidavits) on the suitability or otherwise of the nominees. At the close of business on Tuesday 20th December, 2022, no memoranda contesting the suitability of the nominees for Chief Officers for Youth, Talent and Sports; Social Services; City Culture, Arts & Tourism and Disaster Management and Coordination had been received from the public.
- 6. In accordance with the provisions of Article 196 of the Constitution and section 7(5) of the Public Appointments (County Assemblies Approval) Act, the general public was also notified in the local dailies by the Clerk of the County Assembly of the intention of the Sectoral Committee on Culture and Community Services to conduct the vetting and approval hearing of the nominees on Thursday 22nd December, 2022.
 - 3.4 Notification to the Nominees.

7. On **Wednesday 14th December, 2022**, the Clerk invited the nominees in writing and through the print media, for the approval hearings in accordance with Section 7 (4) of the Public Appointments (County Assembles Approvals) Act, 2017.

3.5 Clearance and Compliance Requirements

- 8. To ensure compliance with the provisions of Chapter 6 of the Constitution, the nominees were asked to submit their clearance status with the following institutions for the vetting exercise –
 - a) Kenya Revenue Authority (KRA)
 - b) Criminal Investigation Department (CID)
 - c) Higher Education Loans Board (HELB)
 - d) Credit Reference Bureau (CRB) and
 - e) The Ethics and Anti-Corruption Commission (EACC)
- 9. On 15th December, 2022, the Clerk wrote to the Ethics and Anti-Corruption Commission (EACC), the Directorate of Criminal Investigations (DCI), Kenya Revenue Authority (KRA) requesting for reports with respect to the nominees on the following matters: -

(a) Ethics and integrity;

(b)Tax compliance; and

(c) Criminal records.

- 10. The DCI through a letter DCI/CRO/SEC/6/7/2/A/VOL.XII/17 dated 20th December, 2022 stated that the Police Clearance Certificates issued to the thirty three (33) nominees were genuinely issued and had negative results from both its nominal index and criminal database.
- 11. The clearance by the foregoing institutions was primarily meant to provide information about the nominees on:
 - a) Matters touching on integrity;
 - b) Tax compliance;
 - c) Loan repayments; and
 - d) Presence or absence of criminal records

4.0. APPROVAL HEARINGS OF THE NOMINEES.

- 12. During its Sitting held on Thursday, 22nd December, 2022, at Assembly Committee Room 6, City Hall Buildings from 9:00am, the Committee conducted face to face interviews of the nominees. The minutes of the vetting proceedings are attached to this report.
- 13. In conducting the approval hearing/vetting process, the Sectoral Committee on Culture and Community Services examined the nominees against the following criteria, amongst others, as set out in the Public Appointments (County Assemblies Approval) Act No. 5 of 2017–
 - i. Academic qualifications.
 - ii. Employment record
 - iii. Professional associations.
 - iv. Potential conflict of interest.
 - v. Knowledge of the relevant subject.
 - vi. Overall suitability for the position.
 - vii. Tax compliance.
 - viii. Integrity.

4.1 MR. OSCAR MAFUNGA IGAIDA- NOMINEE FOR YOUTH, TALENT AND SPORTS

4.1.1 Submissions by the Nominee

14. Mr. Oscar Mafunga Igaida, the nominee for Youth, Talent and Sports appeared before the Committee on Thursday 22nd December, 2022 and was vetted under oath. The Committee noted the following: -

Date and Place of Birth

 The nominee is a male Kenyan Born on 10th December, 1972 in Kakamega County and does not hold dual citizenship.

Academic and Professional Qualifications

 $\left(\frac{1}{2} \right)$

- 16. The nominee holds a Bachelor of Arts in Economics, Public Administration, Sociology, French and English from the Punjab University
 India.
- 17. The nominee also holds a Post graduate Diploma in Personnel Management and Industrial Relations - India

Employment Record

- 18. The nominee is currently the Managing Director at Sicar Investments.
- 19. He is also serving as an Administrative/ Office Manager at Khaminwa & Khaminwa Advocates.
- 20. He previously served as a member for Makadara constituency Roads Board under Kenya Rural Roads Board, Switchboard Operator at Kenya College of Communications Technology.

Income and net worth

21. The nominee estimated his net worth to be Kshs. 10.35 million with the sources of income being rental houses, salary from Khaminwa & Khaminwa Advocates.

Professional Associations and Memberships

22. He is a member of the KADDU, TNA, JUBILEE PARTY, UDA Political parties.

Potential Conflict of Interest

23. The nominee declared that he did not have any persons or matter that would present any potential conflict of interest should he assume the position of Chief Officer for Youth, Talent and Sports.

Probono/Charity Work

24. The nominee is involved in charitable work with the Christianity Community.

Integrity

25. The nominee has neither been charged in a court of law nor mentioned in any investigatory report of Parliament, County Assembly or any Commission of inquiry in the last three (3) years. He has also never been dismissed or otherwise removed from office for contravention of the provisions of Article 75 of the Constitution.

Responses to general and sector specific questions to the nominee

26. The Committee posed several questions to the nominee on his knowledge of the Sector he had been nominated to and his conduct in public and private life. The nominee responded as follows: -

On relevance to the position nominated to

27. The nominee highlighted that having worked as an administrator for over twenty (20) years he has dealt with different situation that encompasses the day to day activities of any office.

On why he applied for the position nominated

28. He indicated that having been a Secretary General at AFC Leopards club he had garnered the experience to serve as a Chief Officer.

On Knowledge of what the Sub - Sector he had been nominated to serve entails-

29. He indicated that the Sub-Sector is very wide especially since there are so many youths and most of them are unemployed. Therefore it's the mandate of the sub-sector to identify the talented youth and develop them.

ON Main challenges in the Sub- Sector and how he would address those challenges if confirmed to the position

- 30. The nominee noted that lack of resources has been an impediment in the completion of old projects and commencement of new projects.
- 31. He mentioned that he would lobby to the County Treasury and County Assembly to ensure that the sub-sector is allocated adequate funds.

Regarding what experience he was bringing to the position

32. Having served as Secretary General at AFC Leopards club and also being a former football player he has been in the sports sector for many years and he brings to the table years of experience and passion for sports and the youth.

On what can Wananchi expect to benefit from the above mentioned experience?

- 33. He undertook to Work closely with Members of County Assembly to ensure that all the projects and programs in the sector are well planned to help the Mwananchi.
- 34. He emphasized that a cordial working relationship with subordinate staff will be key to ensuring that Mwananchi gets fast and timely response.

Regarding navigating the relationship between the roles of the position nominated to and those of the County Executive Committee Members and other County Staff if appointed

- 35. He recognized that as a Chief Officer he will be working very closely with the County Executive Committee Member to ensure that work is done effectively.
- 36. He mentioned that he will be a team player so that he can work seamlessly with his staff.

With respect on how the roles of the County Assembly will be of help in enhancing efficiency and effectiveness in service delivery of the Sector nominated to –

37. He responded that with the key main roles of the County Assembly being Oversight, Legislation and Representation he would work hand in hand with the Members of the County Assembly to ensure that their issues are handled efficiently and effectively.

On how he will navigate the relationship between himself and Members of the Assembly

38. He promised that his Office would operate under the open door policy so as to ensure that he works together with the Members of the County Assembly.

On how will you ensure full implementation of the Nairobi City County Sports Management Act, 2017?

39. The Nominee mentioned that the Act, provides for the creation of a Sports Committee for the promotion of sports and management of sports facilities. However, he noted that since as a chief officer isn't part of the Committee, he will work with his sector CECM to ensure that the act is fully implemented.

On the number the stadia the County manages

40. He stated that there are four (4), namely City, Woodley, Kihumbuini and Dandora stadia.

On how he will ensure that the stadia are managed effectively?

41. He noted that the sub-sector has been grappling with the allocation of funds, therefore the stadia haven't been renovated for a several years.42. He therefore proposed that the construction of underground parking in the stadia would generate revenue for the County.

On which strategies can the County use to identify and develop talents of the youths in the County?

43. The nominee mentioned that it would be important to build sports infrastructure so that sporting activities can be conducted there.

44.He mentioned that he would promote sports activities by engaging former Kenyan professional players to mentor the youths and help in talent identification.

The approach will you use to ensure that youths are empowered in the County

45. The nominee stated that he will involve Members of the County Assembly so that the youths of the Nairobi City are empowered.

Regarding handling pressure from family and friends seeking services and favors

46. The nominee observed that he would act professionally and within the confines of the law in dealing with pressures. Accordingly, he undertook to rely on due procedures in dealing with friends should such arise.

Regarding Past experiences to Nominees commitment to the requirements of Chapter Six of the Constitution on Leadership and Integrity

47. He informed the Committee that he has always been guided by integrity values and good faith in his work and has never been investigated on any matters of corruption.

On rendering Community Service within the County

48. He told the Committee that he has been giving back to the community by visiting children homes and also supporting young talented players over the years.

4.5 MS. LYDIA WAMBUI MAITHA- CHIEF OFFICER NOMINEE FOR PUBLIC PARTICIPATION, CITIZEN ENGAGEMENT AND CUSTOMER SERVICE

4.1.5 The Submissions by the Nominee

166. Mr. Lydia Wambui Maitha, the nominee for public participation, citizen engagement and customer service appeared before the Committee on Thursday 22nd December, 2022 and was vetted under oath. The Committee noted the following: -

Date and Place of Birth

167. The nominee is a female Kenyan Born on **24th October, 1986** in Kiambu County and does not hold dual citizenship.

Academic and Professional Qualifications

- 168. The nominee holds a Master of Arts in Diplomacy from the b University of Nairobi
- 169. The nominee also holds a Bachelor of Arts in Political Science, Public Administration and Communication

Employment Record

170. The nominee is currently the Policy Advisor, Office of the Cabinet Secretary, Ministry of Public Service, Gender, Senior Citizens Affairs and Special Programmes. She previously served in the Ministry of Public Service, Youth and Gender; as an advisor – Youth Affairs Office of the Cabinet Secretary. She has served as technical advisor – Youth Affairs, NEPAD Kenya.

Income and net worth

171. The nominee estimated his net worth to be Kshs. 6 million with the sources of income being salary.

Professional Associations and Memberships

172. She is a member of the Research on Ethical African Leadership (REAL) Network, Daughters of Kenya and Bi- partisan Youth Initiative.

Potential Conflict of Interest

173. The nominee declared that she did not have any persons or matter that would present any potential conflict of interest should he assume the position of Chief Officer for Youth, Talent and Sports.

Probono/Charity Work

174. The nominee is involved in charitable work young women and youth groups & Individual Cases

Integrity

175. The nominee has neither been charged in a court of law nor mentioned in any investigatory report of Parliament, County Assembly or any Commission of inquiry in the last three (3) years. He has also never been dismissed or otherwise removed from office for contravention of the provisions of Article 75 of the Constitution.

Responses to general and sector specific questions to the nominee

176. The Committee posed several questions to the nominee on his knowledge of the Sector he had been nominated to and his conduct in public and private life. The nominee responded as follows: -

On relevance to the position nominated to

177. Having served as Policy Advisor, Office of the Cabinet Secretary, Ministry of Public Service, Gender, Senior Citizens Affairs and Special Programs as well as an advisor – Youth Affairs Office of the Cabinet Secretary and as a technical advisor – Youth Affairs, NEPAD Kenya. She brings a wealth of experience from the public sector.

On why he applied for the position nominated

178. She stated that having served as a policy advisor to the National Government she was interested in contributing to the implementation of the Governors' manifesto.

On Knowledge of what the Sub - Sector he had been nominated to serve entails-

179. She undertook to fulfill statutory instruments of Public Participation and Implement the Public Participation Act, 2016. Further, she would fast track civic education to Nairobians especially on the different roles of the County levels of government while ensuring that customer service remain at the core of the County business.

On main challenges in the Sub- Sector and how he would address those challenges if confirmed to the position

180. She reminded the Committee that public participation is a costly affair that require engagement with large groups of people. She indicated that the impact of public participation is to collect, quantify and interpret data to help in decision making.

Regarding what experience he was bringing to the position

181.She stated that having served in various capacities in National Government as a Policy Advisor. She was acquainted with vast knowledge of the public sector.

On what can Mwananchi expect to benefit from the above mentioned experience

182. She undertook to serve with diligence and commitment to deliver on mandate of sub sector.

Regarding navigating the relationship between the roles of the position nominated to and those of the County Executive Committee Members and other County Staff if appointed

183. She said that as a Chief Officer she will be part of the team, responsible for policy and day to day administration of the Public participation, citizen engagement and Customer service Sub-Sector.

With respect on how the roles of the County Assembly will be of help in enhancing efficiency and effectiveness in service delivery of the Sector nominated to –

184. She responded that with the key main roles of the County Assembly being Oversight, Legislation and Representation she would work hand

in hand with the Members of the County Assembly to ensure that their issues are handled efficiently and effectively.

185. That on the policies the Sub-Sector will propose in regards to Nairobi City County Public Participation Act, 2015 she would work with the County Assembly to ensure that the policies outlines what the Sub - Sector hopes to achieve and the methods and principles it will use to achieve them.

On how she would navigate the relationship between himself and Members of the Assembly

186. She averred that partnership and collaboration with the Assembly through the relevant Sector committee of the Assembly will be key, being the Sectoral Committee on Culture and Community Services.

On how she would ensure full implementation of the Nairobi City County Public Participation Act, 2016.

187. To achieve this, she would develop an implementation framework and a work plan to ensure full implementation of the Act while deploying technology in conducting virtual public participation.

On what other measures she would come up with to improve the process of public participation?

188. She purposed to institute an office of County rapporteur to get feedback from the public.

On how she would handle pressure from family and friends seeking services and favors from your docket, once appointed?

189. She promised to employ good judgement and adhere to the laid down legal requirements.

On whether she render community service within the County

190. She had reported issues with the Youth the relevant CS.

On what can residents of Nairobi expect from you should this Assembly approve your nomination

191. She promised to be committed leader who will serve diligently.

Regarding handling pressure from family and friends seeking services and favors

192. The nominee observed that she would act professionally and within the confines of the law in dealing with pressures. Accordingly, she would rely on due procedure in dealing with friends should such arise.

Regarding Past experiences to Nominees commitment to the requirements of Chapter Six of the Constitution on Leadership and Integrity

193. The nominee informed the Committee that there was misappropriation of funds in the Youth Fund where issues of integrity were raised and she was not part of the team involved

On rendering Community Service within the County

194. She stated that through Daughters of the mountain, a charitable organization, the nominee gives back to society through sponsoring graduates from Tertiary and Vocational Educational Training Schools (TVETS).

4.1.1 Committee Observations on the suitability of the nominee

195. The Committee having considered the nominee filled Questionnaire pursuant to Section 7 of the Public Appointments (County Assemblies Approval) Act, 2017, his Curriculum Vitae and having heard his oral submission during the vetting exercise made the following observations: on his suitability for appointment as Chief Officer responsible for Youth, Talent and Sports:-

THAT: -

- 9. The nominee satisfies the requirements of Chapter Six of the Constitution of Kenya on leadership and integrity which is a requirement under section 35(3)(c) of the County Governments Act, 2012 in that:
 - m)The nominee has been cleared by the Ethics and Anti-Corruption Commission (EACC), Directorate of Criminal Investigations (DCI),

Kenya Revenue Authority (KRA), Higher Education Loans Board (HELB) and the Credit Reference Bureau (CRB).

- n) The nominee has not been charged in a Court of Law.
- o) The nominee does not exhibit a potential conflict of interest.
- 10.The nominee meets the requirements of Section 45(1) (a) of the Public Appointments (County Assemblies Approval) Act, 2017 since he:-
 - Exhibited impressive knowledge of topical issues touching on the subsector nominated to and has the requisite abilities, qualifications and experience.
 - j) He was competently sourced and recommended by the County Public Service Board.
 - a) The Committee found the nominee suitable and qualified for appointment as the Chief Officer responsible for Public Participation, Citizen Engagement and Customer Service.
