1.0 EXECUTIVE SUMMARY

- 1.1.1 Pursuant to Article 179(2) (b) of the Constitution and Section 45 (a) and (b)of the County Governments Act, 2012, H.E. the Governor, Sakaja Johnson Arthur vide a letter Ref: NCC/GOV/Legal/438/2022 dated 2nd December 2022 forwarded to the Speaker of the Nairobi City County Assembly the names of nominees for appointment to the position of County Chief Officers for approval by the Assembly.
- 1.1.2 Pursuant to Standing Order No. 45, the Message on nomination of the nominees was conveyed in the County Assembly by the Hon. Speaker on 13th December 2022 and the names were subsequently committed to the relevant Sectoral Committees for vetting and reporting within Twenty-One (21) days in accordance with Section 9(1) of the Public Appointments (County Assemblies Approval) Act, 2017 (hereinafter referred to as "the Act") and pursuant to Standing Order No. 48(1).

3.0 BACKGROUND;

3.1 Referral of the nominees to the Committee.

- 3.1.1 Pursuant to Article 179(2) (b) of the Constitution, Section 45 (a) and (b) of the County Governments Act, 2012, and Standing Order No. 48 as read with Standing Order No. 209, the Hon. Speaker on the 13th day of December 2022 committed the names of the nominees for the position of Chief Officers being; Mr. John Murungi Lintari, Mr. Victor Otieno AGOLLA, Mr. Tiras Wanaina Njoroge and Ms. Lucky Ogutu Okundo to the Sectoral Committee on Energy and ICT for vetting.
- 3.1.2 Section 9(1) of the Public Appointments (County Assemblies Approval) Act, 2017, the Sectoral Committee on Energy was required to vet and report to the Assembly within 21 days the suitability or otherwise of the nominees in conformity with Section 7(10) of the) of the Public Appointments (County Assemblies Approval) Act, 2017.





3.2 Notification to the Public.

- 3.2.1 Article 196(b) of the Constitution of Kenya provides that the County Assembly shall facilitate public participation and involvement in the legislative and other business of the Assembly and its Committees.
- 3.2.2 Section 7 of the Public Appointments (County Assembles Approvals) Act, 2017 requires the Committee by notice in at least one newspaper of national circulation, notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing including hearing dates being Thursday, 22nd December 2022.
- 3.2.3 Further Section 7(10) of the Act provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

3.3 Notification to nominees.

- 3.3.1 On **Friday, 16th December, 2022**, the Clerk invited the nominees in writing and through the print media, for the approval hearings in accordance with Section 7 (4) of the Public Appointments (County Assembles Approvals) Act, 2017.
- 3.3.1 Further, the nominees through communication via bulk SMS messaging system were requested to complete and return questionnaire forms together with their curriculum vitae and relevant supporting documents to the Office of the Clerk of the County Assembly between 9.00 forenoon and 5.00 afternoon on or before Tuesday, 20th December 2022.
- 3.3.2 From the notice, nominees were further reminded to appear before the Committee with original copies of the underlisted documents;
 - i. Curriculum vitae;
 - ii. Academic Certificates and testimonials:
 - iii. Certificate of Good Conduct from the Police;
 - iv. Clearance from the Higher Education Loans Board;
 - v. Clearance from the Kenya Revenue Authority;
 - vi. Clearance from Credit Reference Bureau;
 - vii. Clearance from the Ethics and Anti-Corruption Commission;

3.4 Clearance and compliance required.

- 3.4.1 On Thursday, 15th December 2022, the Clerk wrote to the Ethics and Anti-Corruption Commission (EACC), the Directorate of Criminal Investigations (DCI), Kenya Revenue Authority (KRA)vide letter ref: NCCA/CCA/VET/12(02) requesting for reports with respect to the nominees on the following matters: -
 - (a) Ethics and integrity;
 - (b) Tax compliance; and
 - (c) Criminal records.





3.4.1 The Directorate of Criminal Investigation through a letter ref: DCI/CRO/SEC/6/7/2/A/VOL.XII/17 dated 20th December 2022 addressed to the Clerk of the Nairobi City County Assembly confirmed that ALL the nominees applied for police clearance certificates on diverse dates and were genuinely issues accordingly. See Annex – DCI Clearance.

3.5 Constitutional and Statutory Requirements.

- 3.5.1 The Constitution gives guidelines on how to appoint persons to public office which include observing the following: -
 - (a) Two-Thirds Gender Rule
 - (b) Representation of Regional and Ethnic Balance
 - (c) Leadership and Integrity.

3.6 Memorandum from Members of Public.

- 3.6.1 Pursuant to Section 7(10) of the Public Appointments (County Assemblies Approval) Act, 2017 which provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated"
- 3.6.2 The Clerk placed an advertisement in the print media on Friday, 16th December 2022 inviting the public to submit memoranda by way of written statements on oath (sworn affidavits) on the suitability or otherwise of the nominees in conformity with Section 7(10) of the Act.
- 3.6.3 In this regard by close of business **Tuesday**, **20**th **December**, **2022**, the Committee had **NOT** received any memoranda for or against the nominees under consideration.

3.7 Vetting Criteria.

- 3.7.1 In conducting the vetting process, the Sectoral Committee on Energy and ICT examined the nominees against the following criteria, amongst others, as set out in the Public Appointments (County Assemblies Approval) Act No. 5 of 2017;
 - i. Academic qualifications.
 - ii. Employment record
 - iii. Professional associations.
 - iv. Potential conflict of interest.
 - v. Knowledge of the relevant subject.
 - vi. Overall suitability for the position.
 - vii. Tax compliance.
 - viii. Integrity.
