





Hon. Speaker,

On Thursday, 3rd November, 2022, Hon. Fiunifiu Kamau Thuo, MCA rose on the floor of the Assembly pursuant to Standing Order 47 (2) (c) and requested the Chairperson of the Trade, Tourism and Cooperatives Committee for a statement regarding a private wholesale and retail food market that is alleged to be operating illegally at Popin Centre. In his statement the Member requested the Chairperson to inquire into and report on:-

- i. Whether the sector is aware of the existing private market operating at Parklands
 Popin Centre and efforts being put in place to ensure fair market competition;
- ii. The measures that the sector has put in place to provide adequate water and sanitation at City park market;
- iii. Reasons the sector has failed to close down the private market even after numerous petitions to the County Government by the City park informal traders that the said market was also operating along a public road and road reserve which cause human and vehicle traffic; and
- iv. Measures the sector is putting in place to ensure city park market acquires the intended rental status that in turn will increase revenue for the County.

In the exercise of its mandate, the Committee wrote to the Sector to report on the aforementioned concerns raised by the Member. The Sector vide a letter Ref: NCC/MKT/29/634/2022 dated 8TH December, 2022 responded. The Committee considered sector submission and further resolved to undertake an inspection site visit to ascertain the alleged private wholesale and retail food market operating illegally at City Park. The site inspection was conducted with the sole intention of allowing Members of the Committee access into the markets and establish whether the alleged unscrupulous traders employ deceptive business practices to gain competitive advantage.

1.4. Acknowledgement

Hon. Speaker, I wish to acknowledge with gratitude the offices of the Speaker and the Clerk of the County Assembly for the logistical and technical support accorded to the Committee while conducting the site visits. Appreciation is also extended to the County Executive officers who played a great role in Committee observations.

Finally, much thanks to the Members of the Committee and the Secretariat for their dedication, untiring commitment and valuable contributions during the site visit.

Hon. Speaker, it is therefore my pleasant duty and privilege, on behalf of the Members of the Sectoral Committee on Trade, Tourism and Cooperatives to table the report of the Sectoral Committee on Trade, Tourism and Cooperatives on the site visit to City Park Market in Westland Sub-County held on 29th February, 2023.



4.0. COMMITTEE OBSERVATIONS

During the site visit, the Committee made the following observations among others;

- i. That Poppin market had adequate parking space and off the road reserve;
- ii. That the said market had clean running water;
- iii. That the market was spacious to accommodate more traders;
- iv. That traders in the market contribute cess to the County Government;
- v. That the market has a well-established waste management plan and that garbage is collected twice in a week:
- vi. That the market is well fenced enhancing enough security for trading activities;
- vii. That the market has clean toilets for both the vendors and their clients;
- viii. That the two markets are in two different wards and approximately 300metres apart; and
 - ix. There was no alleged unfair competition between City Park Market and Poppin Market since Poppin market operate twice in a week and each market has its own loyal clients.

5.0. CONCLUSION

County Markets contribute immensely not only in revenue generation to the County Government but also ease access to various goods to residents and creates employment in the County.

6.0. COMMITTEE RECOMMENDATIONS

Following the findings and observations together with the submissions obtained from the site visit to Poppin Market and City Park Market, the Committee urges the Assembly to resolve as follows;

- i. The County Executive department of markets should develop a policy on the management of County markets to ensure efficient service delivery to traders and customers;
- ii. The County Department of Markets should develop a database for traders in all the County Markets;
- iii. The Chairman Poppin Market to submit the application for legalizing the Poppin Market;
- iv. The owner of the building where poppin market is located to immediately report to Chief Officer Security and Compliance on the establishment of the market to avert demolition;
- v. That the leaders in the Markets to preach peace in both Markets and urge traders not to politicize issues;
- vi. That the Chairman City park Market to provide a list of all stalls that are not allocated:
- vii. That the Nairobi City County Government to immediately undertake branding, erection of signage and promotion of City Park Market; and
- viii. The County Department of Markets to keep Poppin and City Park Market operational and to enhance delivery of County services to traders in the areas since the two markets are vast and are located approximately 300 meters apart and are also in two different Wards.
