



1.0 PREFACE

1.1 Establishment and Mandate

Hon. Members,

The Committee on Powers and Privileges is established pursuant to Section 15 of the County Assemblies Powers and Privileges Act, 2017 (hereafter referred to as "the Act") as read together with Standing Order 187. The Committee arises out of the provisions of Article 196 (3). The Committee's mandate amongst others, as outlined under Section 15 of the Act is to:

- a. Inquire into the conduct of a member whose conduct is alleged to constitute a breach of privilege; and
- b. Either of its own motion or a result of a complaint made by any person, inquire into the conduct of a member whose conduct is alleged to constitute a breach of privilege
- c. Investigate, table reports and make recommendations to the floor of the house
- d. Issue summons to witnesses to appear before the committee,
- e. Receive evidence and to request for and receive papers and documents from the Government and the public.

Further, as envisaged under Section 18 of the Act as read with Article 195 of the Constitution of Kenya 2010, the Committee as constituted has the same powers as the High Court in terms of summoning of any person to appear before it for the purposes of giving evidence or providing information.

Hon. Members,

The County Assembly Committees are extensions of the Assembly established under the County Assembly Standing Orders and in accordance with Section 14 of the County Governments Act, 2012. The Committees are supposed to perform functions that the Assembly is not well fitted to consider in plenary.

The Select Committee on Powers and Privileges exercises its mandate by investigating any matter pertaining conduct of Members of the County Assembly and staff of the Assembly within the precincts of the Assembly.

Following allegations of physical confrontation between Hon. Joseph Karanja Ndung'u, MCA and Hon. Christopher Wanjohi Mtumishi, MCA on 12th June, 2023, the Committee at its sitting held on 13th June, 2023 on its Motion deliberated on the said allegations and resolved to initiate investigations into the matter.

The Committee noted that the Director for Security Services had filed an incident report with the Clerk reporting that the two Members engaged in a physical altercation at the corridor between Committee Rooms 5 and 6 on 12th June 2023 at around 11.40 a.m. The report also indicated that there were a number of persons who had participated in separating the two and that a CCTV footage of the incident had been preserved in case it was needed.

2.0 BACKGROUND OF THE INVESTIGATION

2.1 Inquiry into the alleged physical confrontation between two Members of County Assembly

On 13th June, 2023, the Committee on its own Motion noted that there was alleged breach of privilege by two Members of County Assembly, namely, Hon. Joseph Karanja Ndung'u, MCA (Member for Kiamaiko Ward) and Hon. Christopher Wanjohi Mtumishi, MCA (Member for Komarock Ward). The Committee noted that on 12th June 2023, the two Members had allegedly engaged in a physical confrontation within the precincts of the Assembly, specifically in the corridor of Committee rooms.

The Committee pursuant to the provisions of Standing Order 187 as read together with Section 15 (5) of the County Assemblies Powers and Privileges Act, 2017, deliberated on the matter and resolved to conduct an investigation and compile a report for tabling in the County Assembly.

During the several meetings of the Committee, the following witnesses were invited to appear before the Committee on diverse dates and time for the purpose of giving oral evidence and producing material evidence on the said case:

2.2 COMMITTEE'S INVESTIGATION INTO THE ALLEGED MISCONDUCT BY MEMBERS OF COUNTY ASSEMBLY

2.2.1 Legal Framework

i) The Select Committee on Powers and Privileges draws its mandates and powers from various Constitutional and statutory provisions, as well as parliamentary dictates derived from long standing practice and procedure.

- ii) Primarily the enabling law to the mandate of the Committee is Section 15 of the County Assemblies Powers and Privileges Act, 2017, the Nairobi County Assembly Standing Orders, which draws its legality and powers from County Governments Act, 2012 and the Constitution of Kenya, 2010, provides for the Powers and privileges of Committees, under Standing Order 187, thus, Committees shall enjoy and exercise all the powers and privileges bestowed on Parliament by the Constitution and statute, including the power to: Summon any person to appear before it for the purposes of giving evidence or providing information; and request for and receive papers and documents from the Government and the public.
- iii) Section 15 (1) of the County Assemblies Powers and Privileges Act, 2017 (the Act) establishes the Committee. The Act is enacted pursuant to provisions of Article 196(3) of the Constitution of Kenya, 2010. The Committee's powers to summon witnesses for purposes of giving evidence is provided for under Article 196 of the Constitution of Kenya 2010, thus, a county assembly or any of its committees has power to summon any person to appear before it for the purpose of giving evidence or providing information. For the purposes of clause (1), an assembly has the same powers as the High Court to:
 - a) enforce the attendance of witnesses and examining them on oath, affirmation or otherwise;
 - b) compel the production of documents; and
 - c) Issue a commission or request to examine witnesses abroad.
- iv) Section 15 of the Act mandates the Committee, on its own Motion, to inquire into conduct of a Member whose conduct is alleged to constitute a breach of privilege in terms of Section 16.
- v) Section 16 of the Act outlines what constitutes to be a breach of privilege and in particular, "Section 16 (c) provides that a Member can be considered to be in breach of privilege if he/he willfully fails or refuses to obey any rule, order or resolution of a county assembly and in (d), conducts himself or herself in a manner which, in the opinion of the Committee on Powers and Privileges, is intended, or is likely to reflect adversely on the dignity or integrity of a county assembly, or of the Members or to be contrary to the best interests of a county assembly or its Members."
- vi) In addition, Section 10 of the Act, prohibits questioning of the proceedings or decisions of this Committee in any court.
- vii)Section 26 of the Act provides for the Prohibited Acts in respect of a County Assembly and its Members.
- viii) In Section 17 (3) of the Act provides for the attendant penalties should the Committee establish culpability for breach of privilege by a Member.
- ix) In investigating the matter in question, the Committee relied on Chapter Six of the Constitution of Kenya, 2010 and Leadership and Integrity Act, 2012.

2.2.2 Events Occasioning Breaches and the Inquiry

The matter for which the Select Committee on Powers and Privileges had undertaken investigation arose from allegations of physical confrontation between two Members, namely, Hon. Joseph Karanja Ndung'u, MCA and Hon. Christopher Wanjohi Mtumishi, MCA on 12th June 2023 in the corridor between Committee rooms. Should the Members found culpable, the Member (s) would be penalized for violation of the following laws: -

- 1) Articles 73 and 75 of the Constitution of Kenya, 2010;
- 2) Sections 7, 11, 32 and 34 of Leadership and Integrity Act, 2012; and
- 3) Sections 26 of County Assemblies Powers and Privileges Act, 2017.

The subject under investigation was allegations of engagement in a physical confrontation within the precincts of the Assembly by Hon. Joseph Karanja Ndung'u, MCA and Hon. Christopher wanjohi Mtumishi, MCA on 12th June 2023.

2.3 WITNESSES

With regard to the investigations of the issues placed before the Committee, it invited various witnesses for purposes of preparing a comprehensive report on the matter. The following witnesses appeared before the Select Committee to shed more light on the alleged physical confrontation within the precincts of the Assembly by Hon. Joseph Karanja Ndung'u, MCA and Hon. Christopher wanjohi Mtumishi, MCA on 12th June 2023: -

In addition, the accused, Hon. Joseph Karanja Ndung'u, MCA and Hon. Christopher Wanjohi Mtumishi, MCA also appeared before the Committee.

3.0 INVESTIGATION INTO ALLEGED PHYSICAL CONFORNTATION BETWEEN TWO MEMBERS OF COUNTY ASSEMBLY

3.1 Witnesses from the County Assembly

Statements and oral testimony from witnesses from the County Assembly were reviewed and noted as follows: -

a) Director for Security Services

On Thursday, 27th July, 2023, the Director for Security Services, Mr. Francis Kivila appeared before the Committee for purposes of informing the Committee about the incident where it was alleged that two Members of the Assembly engaged in a physical confrontation and submit a CCTV recording for the incident. Accordingly, while on oath, the Director informed the Committee as follows:

- i) That he did not witness the incident first-hand hence the information he was to give was purely based on his review of the CCTV footage;
- ii) That he had indeed prepared an incident report on the physical confrontation between Hon. Joseph Karanja and Hon. Christopher Wanjohi Mtumishi to the Clerk of the Assembly;
- iii) That indeed the aforementioned two Members engaged in a physical confrontation on 12th June 2023 at around 10.40 a.m at the corridor between Committee Rooms 5 and 6:
- iv) That an Officer from the Directorate of Security Services (Mr. Ramadhan Juma) witnessed the incident first-hand and was one of the persons who participated in separating the Members;
- v) That key other persons who may have information regarding the incident included Members of County Assembly as mentioned in his incident report;
- vi) That he had not established the root cause of the confrontation; and
- vii) That thereafter, he secured the CCTV footage that captured the incident, even though it lacks the voice and he tabled it before the Committee.

b) Ms. Josephine Kamau

On Thursday, 27th July, 2023, Ms. Josephine Kamau appeared before the Committee for the purpose of informing the Committee about the alleged physical confrontation between two Members of County Assembly. Accordingly, while on oath, Ms. Kamau informed the Committee as follows:

- i) That on 12th June 2023, the during the meeting of the Sectoral Committee on Justice and Legal Affairs, there was a commotion along the corridor at the Committee rooms;
- ii) That some Members of the Committee went outside to establish what was happening but the Secretariat and the Officers from the Executive remained in Committee Room 5:
- iii) That later in the day, she heard from other staff and Members that two Members had engaged in a physical confrontation;
- iv) That Hon. Joseph Ndung'u, MCA is a Member of the Sectoral Committee on Justice and Legal Affairs and that after the commotion, he came back to the Committee room escorted by the Leader of Minority Party, Hon. Antony Kiragu, MCA, settled down as the meeting proceeded; and

v). That she was not in possession of any document or material to hand to the Committee to aid the investigation.

c) Hon. Hamisi Maleya, MCA

On Thursday 27th July 2023, Hon. Hamisi Maleya, MCA appeared before the Committee for purposes of shedding light on the allegations physical confrontation between two Members of County Assembly.

Hon. Hamisi Maleya while on oath, informed the Committee as follows:

- i) That indeed he had been the one who brought the matter to the attention of the Committee as a Member of the Committee;
- ii) That two Members indeed engaged in a physical confrontation at the corridor during the meeting of the Sectoral Committee on Justice and Legal Affairs in one of the Committee rooms;
- iii) That Hon. Antony Kiragu, MCA rushed out of the meeting who went to reconcile them; and
- iv) That Mr. Ramadhan Juma, a sergeant-at-arms separated the Members.

d) Hon. Virginia Waitherero, MCA

Hon. Virginia Waitherero, MCA appeared before the Committee on 31st July 2023 to shed more light on the alleged physical confrontation between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA on 12th June, 2023. While on oath, the Hon. Virginia Waitherero, MCA informed the Committee as follows:

- i) That she was in a meeting of the Sectoral Committee on Culture and community Services when she heard a commotion at the corridor;
- ii) That on coming out of the Committee room, she was made to understand that there was a confrontation between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA and that Hon. Ndung'u was insulting Hon. Mtumishi; and
- iii) That she did not witness the physical confrontation between the Members as the Sergeant-at-Arms on duty had separated them. That on hearing the commotion, she came out of the meeting and tried to calm the situation by escorting Hon. Mtumishi away from the scene.

e) Hon. Joyce Lugonzo, MCA

The Hon. Joyce Lugonzo, MCA appeared before the Committee on 31st July 2023 to shed more light on the alleged physical confrontation between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA on 12th June, 2023. While on oath, the Hon. Joyce Lugonzo, MCA informed the Committee as follows:

- i) That she was in a meeting of the Sectoral Committee on Culture and Community Services when she heard a commotion at the corridor. That she heard a perturbing voice of Hon. Joseph Ndung'u, MCA whom she knew well since she was from the same locality in Mathare Sub-County, that prompted her to rush out;
- ii) That upon inquiry, she established that the confrontation was between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA;
- iii) That she escorted Hon. Ndung'u who was angry to room 4 to minimize the noise since several Committees were having meetings with stakeholders; and
- iv) That she did not witness the physical confrontation between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA. However, she heard the crowd around calming down Hon. Ndung'u. That the fracas took less than five minutes to be contained.

f) Hon. Emmy Isalambo, MCA

The Hon. Emmy Isalambo, MCA appeared before the Committee on 31st July 2023 to shed more light on the alleged physical confrontation between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA on 12th June, 2023. While on oath, the Hon. Emmy Isalambwa, MCA informed the Committee as follows:

- i) That when she was heading to a meeting of the Sectoral Committee on Agriculture, Fisheries and Livestock in the Committee room four (4), she heard two people talking in a Kikuyu language which she does not understand;
- ii) That she saw Minority Leader, Hon. Antony Karanja, MCA conversing with other Members and that from the facial expressions, she noted that something was not well. She later established that there had been a confrontation between Hon. Joseph Karanja Ndung'u, MCA and Hon. Christopher Wanjohi Mtumishi, MCA;
- iii) That she took Hon. Ndung'u to Committee room four where a meeting of the Sectoral Committee on Agriculture, Fisheries and Livestock was ongoing to calm him since he was agitated; and
- iv) The Member urged the Committee to review the CCTV footage covering the incident to ascertain her account of what transpired.

g) Mr. Ramadhan Juma - Sergeant-at-Arms

Mr. Ramadhan Juma, Sergeant-at-Arms appeared before the Committee on 1st August, 2023 to shed light on the alleged physical confrontation between Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA on 12th June, 2023. While on oath, the officer informed the Committee as follows:

i) That he was from escorting guests to a Committee meeting when he heard commotion. He rushed to the scene and found Hon. Joseph Ndung'u, MCA and Hon. Christopher Mtumishi, MCA confronting each other;

- ii). That he managed to separate the two Members and calmed the situation before other Members of County Assembly including the Minority Leader joined him. That the two Members were summoned in the office of the Minority Leader to discuss the incident;
- iii) That he (the officer) reported the matter to his Supervisor (Director, Security Services) and recorded the same in the Occurrence Book (O.B.) available at the Directorate of Security Services;
- iv) That he heard Hon. Ndung'u, MCA confronting Hon. Mtumishi, MCA informing him (Hon. Mtumishi) not to use abusive language on him (Hon. Ndung'u);
- v) On the opinion of the officer, Hon. Mtumishi may have used abusive language on Hon. Ndung'u which led to the confrontation; and
- vi) Upon viewing the CCTV footage covering the incident, the Committee requested the Officer to give advice on what steps should be taken to deal with such incidents going forward. In response, the officer stated that Members may have had their own differences elsewhere, in such case, Members should have informed the security department. The officer proposed for deployment of additional security officers within Committee rooms during meetings.

h) Hon. Antony Karanja Kiragu

Hon. Antony Karanja Kiragu appeared before the Committee on 2nd August 2023 and while on oath, informed the Committee as follows:

- i) That he was in Committee room 5 attending a meeting of the Sectoral Committee on Justice and Legal affairs when he heard noise outside and went to investigate;
- ii) That on reaching the corridor, he established that Hon. Joseph Ndung'u and Hon. Christopher Mtumishi were acting for a TikTok video and that the allegations that Hon. Joseph Ndung'u and Hon. Christopher Mtumishi engaged in a physical confrontation was not true; and
- iii) That he (Hon. Kiragu) requested the Committee to schedule another meeting in which he could view the CCTV footage to jog his memory on the incident. Thereafter, he would give the Committee a further account of the incident.

The Committee scheduled for the meeting to have Hon. Antony Kiragu view the CCTV footage on 3rd August 2023, but the Member refused to appear and further attempts by the Secretariat to have the Member appear were not successful. The Committee resolved to rely on the Member's first account of the incident and to make a recommendation for the Member be severely warned.

j) Hon. Peter Wahinya

Hon. Peter Wahinya appeared before the Committee on 9th August 2023 to explain to the Committee about the incident where two Members allegedly engaged in a physical

confirmation on 12th June 2023. While on oath, the Member informed the Committee as follows:

- i) That on the material day, 12th June 2023, he was partaking refreshments along the corridor leading to the Committee rooms 5 and 6 with Hon. Joseph Ndng'u before heading for a meeting of the Sectoral Committee on Water and Sanitation;
- ii) That out of nowhere, he heard Hon. Ndung'u say "tutaheshimiana" upon which he saw Hon. Christopher Mtumishi approaching from the Records Department way;
- iii) That indeed there was a physical confrontation between the two Members and that Hon. Joseph Ndung'u was the one who attacked Hon. Mtumishi;
- iv) That thereafter, the Members were separated by the Leader of Minority Party and later reconciled in his office (Minority Leader's office); and
- v) That the confrontation was not spontaneous, however, it had been building over time for reasons the Member was not aware of.

i) Hon. Christopher Wanjohi Mtumishi

Hon. Christopher Wanjohi Mtumishi, MCA appeared before the Committee on 3rd August 2023 to shed more light on the alleged physical confrontation between Hon. Joseph Ndung'u, MCA and him on 12th June, 2023. While on oath, the Member informed the Committee that he was heading to a meeting of the Sectoral Committee on Agriculture and Livestock when he was physically attacked by Hon. Joseph Ndung'u, MCA who elbowed and injured him on his left arm. That he took the matter as a friendly joke and did not retaliate. That it was not a serious fight as he first alleged.

Upon viewing the CCTV footage, the Member admitted that there was confrontation between him and Hon. Joseph Ndung'u, MCA. Hon. Mtumishi, MCA stated that indeed he was attacked by Hon. Ndung'u, MCA. The Member stated that Hon. Ndung'u, MCA started the fight.

In addition, Hon. Mtumishi informed the Committee that the matter started on the WhatsApp page of Kenya Kwanza where he felt Hon. Ndung'u was undermining him by questioning his leadership skills. The Members informed the Committee that he was the victim in the case. However he forgave Hon. Ndung'u for attacking him on the material day. That they had since reconciled.

The Member informed the Committee that they used abusive language on each other on the *WhatsApp page* two weeks prior to the physical confrontation witnessed on 12th June, 2023. In addition, Hon. Mtumishi stated that he was humiliated by Hon. Ndung'u during a Church service in the presence of H.E the Governor.

j) Hon. Joseph Karanja Ndung'u

Hon. Joseph Ndun'gu appeared before the Select Committee on Powers and Privileges on 9th August 2023 and while on oath, the Members informed the Committee as follows regarding the alleged physical confrontation between him and Hon. Christopher Mtumishi:

- i) That it was true that he attacked Hon. Christopher Mtumishi on the material day at the corridor between Committee rooms 5 and 6;
- ii) That the confrontation stemmed from an altercation between the two Members on the Whatsapp *page* for Members of County Assembly;
- iii) That he (Hon. Ndung'u) was especially agitated when Hon. Mtumishi referred to him as "uncircumcised" which was a grave insult according to their culture;
- iv) That indeed he acted irrationally and with disregard to the legal requirements on the conduct of Members and that he was sorry for engaging in the confrontation within the precincts of the Assembly;
- v) That the Committee needs to intervene and reign in on Hon. Christopher Mtumishi since he had found himself in various forms of misconduct with a number of Members of County Assembly including Hon. Joy Muthoni, MCA and Hon. Joyce Lugonzo, MCA.

4.0 FINDINGS OF THE COMMITTEE

Having analyzed the oral accounts from the witnesses regarding the incident and viewing the CCTV footage covering the incident, the Committee makes the following findings:

- i) That on 12th June 2023, there was a meeting of the Sectoral Committee on Justice and Legal Affairs with stakeholders in Committee Room 5;
- ii) That while the meeting was in progress, Hon. Joseph Karanja Ndung'u, MCA and Hon. Peter Wahinya, MCA were having refreshments at the corridor between Committee rooms 5 and 6;
- iii) That Hon. Christopher Wanjohi Mtumishi, MCA was on his way to a Committee meeting when he was suddenly elbowed by Hon. Joseph Karanja Ndung'u, MCA who continued to throw punches at him (Hon. Mtumishi);
- iv) That the incident led to an exchange of words relating to an earlier brawl between the two Members on a *Whatsapp page* of Members of County Assembly;
- v) That the Committee later learnt that Hon. Mtumishi in the WhatsApp exchange referred to Hon. Ndung'u as "uncircumcised" which Hon. Ndung'u considered to be a grave insult;
- vi) That Hon. Antony Kiragu, MCA, Hon. Joyce Lugonzo, MCA, Hon. Virginia Waitherero, MCA, Hon. Peter Wahinya, MCA, Hon. Emmy Isalambo and Mr. Ramadhan Juma were among the persons who participated in containing the situation and calming down the two Members who were confronting each other;
- vii) That Article 73 of the Constitution of Kenya, 2010 requires State Officers to demonstrate respect for people; to bring honour to the Nation and dignity to the office; and to promote public confidence in the office;

- viii) That Section 7 of the Leadership and Integrity Act, 2012 requires State Officers to respect and abide by the Constitution and the law;
- ix) That Section 11 of the Leadership and Integrity Act, 2012 requires State Officers to carry out duties of the office in a manner that maintains public confidence in the integrity of the office and to treat members of the public and other public officers with courtesy and respect;
- x) That Section 32 of the Leadership and Integrity Act, 2012 requires State Officers to conduct private affairs in a manner that maintains public confidence in the integrity of the office;
- xi) That Section 34 of the Leadership and Integrity Act, 2012 prohibits State officers from bullying any person; and
- xii) Section 26 of County Assemblies Powers and Privileges Act, 2017 provides for prohibited acts with respect to County Assembly and its Members which include assaulting, threatening, molesting, use of abusive language, insult and interruption of Assembly or Committee proceedings.

5.0 RECOMMENDATIONS

Having received evidence in chief from summoned witnesses; having examined documentary and video evidences tabled before the Committee and; having deliberated and made observations and findings, the Select Committee on Powers and Privileges makes the following recommendations for approval by the County Assembly:

- 1) THAT, pursuant to Section 17 (3)(c) of the County Assemblies Powers and Privileges Act, 2017, Hon. Joseph Karanja Ndung'u to orally apologize to the County Assembly while standing at the Assembly Chamber Bar, for assaulting, bullying and disrespecting Hon. Christopher Wanjohi Mtumishi; and conducting himself in a manner that brought dishonor to the Office of Member of County Assembly and impacted negatively to the dignity of the County Assembly;
- 2) THAT, pursuant to Section 17 (3)(a) of the County Assemblies Powers and Privileges Act, 2017, Hon. Joseph Karanja Ndung'u be formally warned for engaging in a conduct that interrupted the proceedings of Assembly Committees; and
- 3) THAT, pursuant to Section 17 (3)(a) of the County Assemblies Powers and Privileges Act, 2017, Hon. Christopher Wanjohi Mtumishi be severely warned for disrespecting and using abusive language against Hon. Joseph Karanja Ndung'u on Assembly Members' Whatsapp page.



The office of the undersigned reports an incident report in a matter of altercation resulting to physical confrontation between Hon. Joseph Karanja Mca, Kiamaiko ward and Hon. Christopher Wanjohi Mtumishi, Mca Komarock Ward.

It was reported by one Serjeant Ramadhan Juma that on Monday 12th June, 2023 at about 1140 hours, there arouse brief altercation between the above referenced Hon. Members resulting to physical fight within Assembly precincts, precisely at the aisle outside committee room 5 and 6. This was short lived as it took swift action of the officer (Serjeant Ramadhan) who moved in, in time to separate the Hon. Members with assistance of other Hon. Members who were within and who witnessed the whole episode as it unfolded. Notable among them was Hon. Virginia Waitherero, Hon. Joyce Lugonzo and Emma Isalambo among others.

However, the officer could not immediately establish the facts leading to the altercation and the after-fight as the Hon. Minority Leader intervened and immediately whisked away the Hon. Members.

The Matter was there after booked in the Assembly Occurrence Book under OB No. 01/12/06/2023 and a footage of the same has since been secured for future reference should any investigative agency come calling.

This is therefore to report the same for your noting and any other action as may be appropriately justified.
