2.0. INTRODUCTION

The County Assembly Committees are extensions of the Assembly established under the County Assembly Standing Orders and in accordance with Section 14 of the County Governments Act, 2012. The Committees are supposed to perform functions that the Assembly is not well fitted to consider in plenary. Following the constitution of County Assembly Committees on 27th November, 2022 and the consequent election of Chairperson and the Vice-Chairperson of the Committee on 11th December, 2022, the Women Caucus undertook its induction workshop held from 8th to 12th December, 2022, at Continental Hotel, Mombasa County.

The objective of the workshop induction was to;

- i. Introduce Members to the new caucus leadership;
- ii. Inform members on the role and functions of the Caucus:
- iii. Caucus Activities and Programmes for 2022/3 including the re-launch of the caucus;
- iv. Develop a strategic plan/action plan for the Caucus; and
- v. Election of Caucus Leadership (Treasurer, Vice Treasurer, Secretary, Vice Secretary, Organizing Secretary and Deputy Organizing Secretary/Whip)

1. Official Opening

The workshop was officially opened by a word of prayer by the Committee Clerk before welcoming Members to the meeting. The Committee Clerk then invited Members, the facilitator and the Secretariat to introduce themselves and subsequently urged Members to actively participate in the proceedings to enable them grasp the basics on the establishment, management and operations of the Committee. In her introductory remarks, the Clerk Assistant stated the following as the objectives of the retreat;

- i) Introduce Members to the new caucus leadership;
- ii) Inform members on the role and functions of the Caucus;
- iii) Caucus Activities and Programmes for 2022/3 including the re-launch of the caucus:
- iv) Develop a strategic plan/action plan for the Caucus; and
- v) Election of Caucus Leadership.

2.2 Expectations from Members

The Members present presented their expectations from the induction workshop which included the following: -

- Improvement on women's impact on political decisions in the County;
- Under the role of the Members for active participation in the Caucus proceedings;

- Enhance and facilitate the attainment of gender equity and equality in decision making structures and elective leadership;
- Mobilization, lobbying, advocating and sensitizing of women to enable women to influence political, economic and social processes; and
- Link the Caucus to stakeholders including the National Government and internationally.

In her opening remarks, the facilitator – Ms. Rachel Kamweru informed the Caucus that the induction workshop would equip Members with requisite skills necessary in understanding the roles of the Caucus. She then took Members through the induction programme after being adopted by the Caucus as proposed by Hon. Lily Kidenda, MCA and seconded by Hon. Catherine Okoth, MCA.

3.0 PRESENTATION BY THE FACILITATOR

The facilitator took Members through the induction on various topics as follows;

3.1 Reasons for the formation of Women Caucus as follows;

- Protection from the Political Party Act;
- Protect each other- Special elect were looked down upon;
- Discrimination- No office, No Budget, not sitting in Liaison Committee; and
- Assist those who were going for elective politics.

3.2 Achievements of the Nairobi City County Assembly Women Caucus during the first Assembly Caucus.

- Registered the caucus and had a constitution;
- Pushed for the Title Special elect;
- Had Strategic Partners;
- Started Pro Caucus sports e.g Tug of war, Netball, Volleyball, Fashion show;
- Got a budget for the caucus;
- Monthly activities moving on with the theme eg 16 days of GBV;
- A force to Reckon with (a scheme that we should not vote); and
- Encouraged each other to move motions, Bills, Statements.
- She urged the hon. Members to show up for meetings both stakeholders or state related and be proactive. Additionally, the women ought to be active in the Shows i.e Radio, TV shows e.t.c, participate in sports and a column for the women caucus to assist escalates their agenda.
- Further, she reiterated that, even though they had achieved much, there were challenges that they encountered during their dispensation of their mandates. The challenges entailed;
 - No bank account;
 - Divide and Rule from the leadership;

- Lack of Unity towards the end;
- Didn't Have Social Media Presence;
- Conflict among members; and
- In the constitution members are supposed to save however, they did not save.
- She therefore urged the Caucus to be involving the social media present in their activities, need to have Women Caucus newsletters, have visibility for the caucus, form a mission and a vision for the women caucus and that Members ought to be alert on the current issues

3.3 The role of the Member of County Assembly and specifically in relation to the Nairobi City County Assembly Women Caucus (NAWOCAC)

- Representation the Caucus MCAs are representing voters and therefore their main agenda ought to represent the interest of your voters for instance, Members to bring up motions in relation to issues affecting society i.e motions on sexual harassment, issues to do with HIV, Elderly e.t.c
- 2. Oversight the caucus to participate actively in the budget making process and pass budgets pro women.
- 3. Legislation; As legislature, they ought to bring motions on board

The hon. Members were separated into groups purposefully to discuss on the following:

- What the Caucus would want to Champion (Social Programs);
- What Opportunities do the Caucus envisage; and
- Possible Partners as far as women caucus is concerned.

Upon the groups' deliberations, the groups came up with the following in response to the above stated questions. THAT;

- There is need for Social protection programmes for women in developing countries and specifically the widows and the vulnerable;
- Planting of trees in Nairobi i.e During City Festivals;
- Focus on climate change since it is becoming a menace in the County and Country at large; Caucus to set precedence by planting trees in honor of the three-year Caucus Anniversary;
- Enforcement of both Girl child and boy child education;
- Safe places for breast feeding; as was entailed in the governor's maiden speech;
- Gender balance in budget making process;
- Mental Health in educational institution;
- Championing women /children with disabilities;
- Create awareness on drug abuse, rehabilitating street families, FGM advocacy
- Focus on the surge of high teenage pregnancy this can be done by sensitizing girls on the significance of abstaining and going to institutions and enlighten the girls on menstruation;
- Advocating for gender especially those abused; Focus in both gender abuse;

- Issues mental health is important since there was rise in depression cases following statistics given by the World Health Organizations (WHO); and
- Embracing Cultural day by engaging in activities such as modelling

- There was need to give back to the society by attending even meetings that are not being paid.
- Master the Nairobi City County Assembly standing orders
- Learn to ask questions
- Show up even without invites
- Keep networks
- Respect for party
- Engage in TV shows and radio shows. Create your own brand

Leaders to build their advocacy and lobbying skills and ensure they network on behalf of the Caucus with leadership of the Assembly, the Clerk, Governor and his CEC's, media, NGO's as partners such as NDI, Ahadi, UN Women, Fida, Kewopa, Crew, University of Nairobi amongst others in order to get support for the Caucus activities; Corporate world; and
- vi. Every leader to ensure that the duties and responsibilities bestowed upon them are well done and support each other for effective delivery of services to the Members
