



I. PREAMBLE

Mr. Speaker Sir, the provisions of Section 126 (1) of the Public Finance Management Act 2012 decree that each county government shall prepare a development plan in accordance with Article 220(2) of the Constitution. Section 126(3) of the same Act states that the County Executive Committee Member responsible for planning shall, not later than 1st September of each year submit the development plan to the County Assembly for its approval and send a copy to the Commission on Revenue Allocation and the National Treasury.

Mr. Speaker Sir, it is in the realization of the provisions of the above legislation and Standing Order 225 (read with necessary modifications), that on Tuesday 12th September 2023, the Annual Development Plan for Financial Year 2024-25 was tabled in this Assembly. Having been tabled in the County Assembly, the Plan was committed to the Sectoral Committees for review in line with their respective mandates and reporting to the Finance, Budget and Appropriations Committee. The Plan was also concurrently submitted to the Finance, Budget and Appropriations Committee for consideration of the Sectors it oversights namely the Finance Sector and the County Assembly.

Mr. Speaker Sir, the Finance, Budget and Appropriations Committee of this third Assembly exists as a creation of the provisions of Standing Order 205 in which it is mandated to evaluate tax estimates, economic and budgetary policies and programmes with direct budget outlays. The ADP is an annual budget document that operationalizes the County Integrated Development Plan by providing projections and clarity on the development` path that the County wishes to undertake to achieve the set objectives and priorities.

Specifically, the Committee wishes to acknowledge: -

- b) Members of the public who honored their civic duty and took part in the public participations on the Plan in the various venues in each of 17 Sub-counties;
- c) The Members of the Finance, Budget and Appropriations Committee who reviewed the strategies, scrutinized and deliberated on the Annual Development Plan;

A. BACKGROUND INFORMATION

Hon. Speaker,

- 1. The stages of the County budget process are outlined in the provisions of Section 125 of the Public Finance Management Act 2012 which provides safeguards for utilization of public resources in the hands of the County Government. The guiding law is unambiguous that the annual budget roadmap starts with integrated planning which is anticipated to include establishment of financial and economic priorities over the medium term. The law requires that during integrated planning the County Government should be able to make an overall estimation of the county governments revenues and expenditures. The Planning stage therefore involves setting up of County priorities by striking off areas with less impact for those that can attract the most optimal returns. The balancing of priorities is customarily undertaken in an environment of limited budget legroom, growing budget deficits and shrinking revenue figures hence the need for timely awareness of the prevailing factors that may alter the intended projections.
- 2. The County Integrated Development Plan (CIDP) 2023-27 which houses the contents of the ADP 2024-25 was adopted by the County Assembly towards the conclusion of the FY 2022-23. The approved CIDP for 2023-2027 provides clear goals and objectives accompanied with targets, key performance indicators and implementation matrix for the realization of the set outcomes. This Annual Development Plan is meant to actualize the aspirations of the County Government as set out in the second year of implementation of the CIDP. The Committee reviewed the ADP with this background and critical information in mind.

B. COMPLIANCE OF THE ANNUAL DEVELOPMENT PLAN FOR THE FY 2024-25 TO THE PREVAILING LEGISLATION

Mr. Speaker Sir,

- 3. The provisions of the law mandate the Finance, Budget and Appropriations Committee to conduct the litmus test on the extent to which budget documents submitted to the County Assembly have lived up to the required legal expectations. This is a duty that the Committee has undertaken on an annual basis with a lot of fidelity and indeed informed this Chamber on areas where the budget master plans have fallen short of the intended glory. In this regard, the Committee would once again wish to compare the extent to which the submitted ADP in content and form has been aligned to what the drafters of the law anticipated in the County Governments Act and the Public Finance Management Act, 2012. From the foregoing, the provisions of the law which have underscored the place and value of planning in public finance management with the pivotal role of the ADP in the annual budget calendar also secured by available legal literature.
- 4. The provisions of Section 126 (3) of the PFM Act 2012 require that not later than 1st September of each year the County Executive Committee Member for planning shall submit the development plan to the County Assembly for its approval. Early submission of the ADP to the County Assembly is meant to clear the terrain for timely realization of the subsequent budget processes. It is for this reason that the provisions of Section 107 of the County Governments (CGA) Act, 2012 provides that the plan would be able to guide, harmonize and facilitate development within the County. The Committee once again wishes to commend the County Treasury for having adhered to the above provisions of the law and submitted the ADP for the FY 2024-25 within the legal timelines.
- 5. Hon. Speaker, Section 126 (1) of the PFM Act, 2012 dictates that the ADP shall include:
 - strategic priorities for the medium term that reflect the county government's priorities and plans;
 - a description of how the county government is responding to changes in the financial and economic environment;
 - programmes to be delivered with details for each programme of—
 - (i) the strategic priorities to which the programme will contribute;
 - (ii) the services or goods to be provided;
 - (iii) measurable indicators of performance where feasible; and
 - (iv)-the-budget-allocated to the programme;

- payments to be made on behalf of the county government, including details of any grants, benefits and subsidies that are to be paid;
- a description of significant capital developments;
- a detailed description of proposals with respect to the development of physical, intellectual, human and other resources of the county, including measurable indicators where those are feasible;
- a summary budget in the format required by regulations; and
- such other matters as may be required by the Constitution or this Act.
- Mr. Speaker Sir, review of the submitted ADP led the Committee to the considered conclusion that to a great extent the Plan had lived up to the statutory threshold spelt out in both the County Governments Act and the Public Finance Management Act 2012. In summary the Plan has taken steps in evaluating the strategies and priorities that the County would aim to pursue in the medium-term period. These strategies are aligned to the regime's clarion desire of making the County A city hope, dignity and opportunities for all. However, as was said during a previous exercise, despite clear outline on the measures the County has put in place to respond to crosscutting financial and economic issues, the Committee notes that some of the challenges and their respective mitigating measures have found hoarding ground in planning books and now their implementable solutions must be found. The Committee noted that some priority areas like acquisition of county assembly administration block, construction of rehabilitation centre in Ruai, roll over of projects, pending bills, aging county human resource, environmental degradation and effective solid waste management mechanisms have remained in the budgets for Nairobi City County since rolling out of the County Government and answers to the same must now be found. The Committee has urged the County Executive to use this Plan as the ultimate solution to these challenges and ensure that any progress in realization of sectoral priorities is periodically shared with the County Assembly.
- 7. **Mr. Speaker Sir,** the ADP has provided the programmes that the County wants to implement with details of their budget requirement fully captured in the book. The Committee is convinced that most of the indicators are realistic and measurable. However, the Committee continues to decry the budgetary link between the CIDP and the ADP and the fact that sectors' targets are

largely not alive to the reality regarding their previous allocations and absorption rates of the same. The submitted ADP lacks quantum of the proposed projects and therefore the committee is concerned the document may not be realistic as far as the approved CIDP is concerned. Whereas the summary budget provided in the ADP conforms to the provisions of law, the Committee once again notes the request for resources to fund the various programmes may amount to nothing more than wishful thinking if the County does not bolster its revenue collection strategies to fund the activities. In this regard, the Committee has directed the County Treasury to always ensure that the all future Plans submitted to this County Assembly for approval are within the resource requirements achievable by the County in one financial year.

C. SUBMISSIONS FROM THE PUBLIC ON THE PLAN

8. Mr. Speaker Sir, the Constitution of Kenya 2010 has placed the public at the center of decision making in the determination of how resources are mobilized and how the same are utilized. In cementing this legal canon, the High Court of Kenya has made pronouncements defining the modalities and procedures of ensuring effective public involvement in legislative matters. In this regard, the County Assembly through the Finance, Budget and Appropriation Committee undertook public hearings across the 17 Sub-counties between Tuesday 21st to Thursday 23rd November 2023 in addition to request for submission of memoranda following the placing of adverts on the local dailies. During these hearings, the County Assembly through the Committee had the honor to interact with the residents of Nairobi City who submitted their views which the committee subsequently considered and a separate report on public participation has been tabled for information of the Honorable Members. This report has taken into the submissions by the members of the public when drafting the recommendations for adoption by the house.

D. SUBMISSIONS FROM THE SECTORAL COMMITTEES

9. Mr. Speaker Sir, the Nairobi City County Standing Order 205 (6) requires that the Budget Committee shall invite Chairpersons of all Sectoral Committees to make presentation during consideration of the budget. The Sectoral Committees of the County Assembly have an essential duty of not only ensuring that the resources allocated to departments within their

watch are adequate for the intended sector priorities but also to confirm to this Assembly that there is value for money in all such undertakings. Further the Sectoral Committees are expected to certify the sector achievements and the viability of any mitigating measures. After considering the contents of Annual Development Plan, the Committees are then required to submit their recommendations to the Finance, Budget and Appropriations Committee. In this regard, therefore the Budget Committee commends all those Sectoral Committees who diligently reviewed their Annual Development Plan for the FY 2024-25 and submitted viable proposals to the Committee. The following were some of the recommendations which were submitted by the Sectoral Committees:

(a) Health Service Committee

- The Committee adopts the sector's programmes, strategies and priorities as contained in the County Annual Development Plan (CADP) for Financial Year 2024/25.
- The Committee adopts all the development projects laid down in the strategic matrix submitted by the sector which entailed projects informed by the public forums that were conducted in all the 17 No. Sub-Counties totaling Kshs. 3.17billion.
- In order to improve absorption rate in the sector, the CEC Member to decentralize Finance and Treasury functions to sectors to enable them exercise the power of payment prioritization.
- All existing incomplete and stalled projects to be prioritized for completion and make them functional.

(b) Lands, Planning and Housing Committee

- The County Annual Development Plan 2024/2025 for the Lands, Housing & Urban Renewal, Urban Planning & Development be adopted as presented.
- The additional expense of Kshs. 114.9million arising from the unforeseen transfer of the management of the newly constructed Customer Care Facility at City Hall Annex from Administration vote to Valuation vote be considered as a new allocation to the Sector budget as it was not initially captured in the ADP document.

(c) Water and Sanitation Committee

- The Committee adopts the Programmes, strategies and priorities as contained in the County Annual Development Plan (CADP) for Financial Year 2024/2025 for Water & Sewerage Sector.
- The Committee approves the upward review of the Water & Sewerage Sector by Kshs. 855million comprising of Kshs. 100million for connection of clean water to household, Kshs. 33million for increased water supply in the City, Kshs. 77million for improved water access, Kshs. 72.8million for improved sanitation, and Kshs. 100million for increased sanitation services Kshs. 340million for increased waste water recycling.

(d) Labour and Social Welfare Committee

— The Public Service Management County Annual Development Plan for Financial Year 2024-2025 be approved in line with the proposed programmes and projects as contained in the table below;

- The County Public Service Board Annual Development Plan for Financial Year 2024-2025 be approved at Kshs. 302million to undertake the following activities; Kshs. 41million for personal emoluments, Kshs. 10million for Boards Charter & Strategic Plans Review, Kshs. 15million for Succession Planning Policy Development, Kshs. 60million for recruitment, Kshs. 15million for Promotions / Appeals, Kshs. 15million for Disciplinary Control, Kshs. 40million for Synchronization and Synergy, Kshs. 45million for Promotion of Values and Principles of Governance, Kshs. 20million for stakeholder engagement and Kshs. 41million for procuring Utility Vehicles.
- Family & Social Welfare ADP plans of Kshs. 96million be approved being Kshs. 6million for assisting 400 disadvantaged households, Kshs. 3million for psycho-social support, Kshs. 10million for exchange programs, Kshs. 10million for aged persons support care and protection, Kshs. 15million for policies development on older persons' welfare, Kshs. 12million for construction of duty houses for care givers, Kshs. 25million for putting social welfare fund in place, Kshs. 20million for recruitment of social workers & care givers and Kshs. 5million for conducting family welfare clinics.
- Youth Affairs ADP plans be approved as follows; Kshs. 80million for improving living standard for Nairobi Youth, Kshs. 7million for youth groups mapping and Kshs. 10million for development of youth policies.
- The Gender and Inclusivity Sub-Sector's Annual Development Plan for Financial Year 2024-2025 be approved at Kshs. 824million being Kshs. 432million for gender mainstreaming, Kshs. 252million for disability mainstreaming and Kshs. 140million for women empowerment.
- The County to provide adequate funding for the Sectors in order to ensure implementation of planned activities.

(e) Agriculture, Livestock and Fisheries Committee

- The Committee adopts the programmes, strategies and priorities as contained in the Annual
 Development Plan for the FY 2024-25 for the Agriculture Sub sector.
- The sub sector be allocated additional funds to recruit at least 100 No. staff to curb succession crisis that is currently being witnessed.

(f) Trade, Tourism and Cooperatives Committee

- The Committee allocates Kshs. 250million for aggregated Industrial Park and the Sector should inform extent of implementation of the project and the support from the National Government.
- The Committee be furnished with reports on how liquor licensing department has impacted lives of Nairobians in the context of alcoholic control.
- The proposal to procure GIS data collection & inspection Gargets for business site locations (Wards) at Kshs. 1 million is not a priority in the CIDP and hence ought to be undertaken by Planning and customized in such a way as to serve all other sectors.
- The Committee to evaluate the performance of Biashara Fund and whether it is achieving the desired results before allocating more funds.
- There is a mismatch in the construction of modern kiosks costing between the CIDP and the ADP and measures should be taken to ensure that the two documents are aligned to each other.
- There is need for collaboration with Environment sector and County Public Service Board to have two garbage collection skips in each of the 45 markets and for deployment of cleaners in each market.
- There is need for collaboration with the enforcement sector for deployment of security officers in all the markets.

(g) Justice and Legal Affairs Committee

— The Committee adopts the programmes, strategies and priorities as contained in the County Annual Development Plan (CADP) for the Office of the Governor, Office of the County Secretary, Boroughs and Sub County Administration, Security and Compliance, Office of the County Attorney and Internal Audit as presented.

(h) Children, Early Childhood Education and Vocational Training Committee

- The sector to set realistic, implementable programmes and projects to be implemented within the financial year.
- All existing incomplete projects to be prioritized for completion before embarking on new projects with a view to complete them.
- The Sectoral Committee approves the County Annual Development Plan 2024-25 for the sub-sector of Early Childhood Education and Vocational Training and the department of Children and Rehabilitation Services programmes, priorities, strategies and projects subject to alignment with the approved CIDP, with additional resource requirements including Kshs. 195million for Ward Bursary Fund being addition of Kshs. 170million for Ward Bursary and Kshs. 25million for administrative purposes.
- The County Executive Finance be decentralized to the sectoral level to enable the sector to increase its absorption rate especially development budget.
- The County Procurement Department be decentralized to the sectoral level to avoid the long procurement process that hamper implementation of the projects.

(i) Energy and Information Communication Technology Committee

- The sector should align its ADP programmes to those contained in the CIDP and as such should look into how to accommodate the E-Learning programmes under the recognized 4 programmes contained in the CIDP.
- The County Executive to operationalize the ICT policy so that management of fund will be ring-fenced and limit encroachment from other sectors on matters ICT since it cuts across all the other sectors.
- Recruiting and training of technical staff offering essential services in the sector should be carried out to address the issue lack of skilled staff for the effective running of the sector.
- The Committee approves the programmes, strategies and priorities contained in the County Development Plan (CADP) for the FY 2024-25 amounting to Kshs. 1.55billion being Kshs. Page **13** of **37**

100million for General Administration Planning and Support Services, Kshs. 294million for Smart Nairobi, Kshs. 866million for ICT Infrastructure and Kshs. 273million for Digital Economy and Start Ups.

(j) Transport and Public Works Committee

- The County Executive to decentralize Finance and Treasury functions to sectors to enable them exercise the powers of payment prioritization and improve absorption of funds.
- In order to mobilize sufficient funds to execute sector development commitments, County Executive to operationalize Section 10 of Nairobi City County Transport Management Fund that will help to ring fence financial receipts for the Sector.
- The County Executive to correct the Sector ADP summation from Kshs.4,400,490,000 to Kshs.4,537,000,000.
- The County Executive corrects the heading of the Sector Strategic Matrix to read FY 2024/2025 rather than 2023/2024.
- The County Executive to harmonize ADP programmes to those of CIDP.
- The Committee adopts the programmes, strategies and priorities as contained in the County Annual Development Plan (CADP) for Financial Year 2024/2025
- The Committee approves the list of proposed projects for implementation during the FY 2024/2025.
- The Committee advises the County Executive to consider terminating contracts related to uncompleted defunct NMS projects and allocate more resources for in-house capacity to complete the works once the contracts are transferred to the County.
- The Committee advises the County Executive to align the resource requirement for General Administration Programme to Year 2 of the County Integrated Development Plan 2023-2027.
- The Committee to ensure upon the County Executive incorporates RMLF projections in the Annual Development Plan (ADP) for the purposes of informed budgeting and budget monitoring.

- The Committee to recommend that the County Executive should utilizes RMLF amounts for its purpose and in accordance with approved work plans by the Kenya Roads Board (KRB) should the Court case on RMLF be determined in favour of the petitioners (Council of Governors).
- The Committee advises the County Executive to consider terminating contracts related to NCCG projects that stalled at the advent of NMS and have the projects undertaken by inhouse capacity upon allocation of adequate resources.

(k) Environment and Natural Resources Committee

- The Committee adjusts and approves the Environment and Natural Resources sub sector's proposed programmes, projects and sub sector's priorities for recurrent expenditure to align to CADP programmes, projects and priorities to the projections of the 2nd year of the approved CIDP at Kshs. 5.2billion being Kshs. 1.6billion for environment administration, Kshs. 2.3billion for solid waste management and Kshs. 1.2billion for final disposal.
- That the Committee adjusts and approves the Environment and Natural Resources sub sector's proposed programmes, projects priorities for development expenditure to align to CADP and the 2nd year of CIDP of Kshs. 841million being Kshs. 30million for purchase of 5 No supervision vehicle and fueling of garbage trucks, Kshs. 27million for renovation of Kaloleni depot, Kshs. 70million for installation of 2000 litter bins, Kshs. 60million for construction of 3 No MRFs, Kshs. 9million for containerized offices, Kshs. 299million for Dandora dumpsite access road, office block and its perimeter wall, Kshs. 214million for parks and natural resources, Kshs. 80million for environmental monitoring compliance & enforcement and Kshs. 50million for climate change and air quality.

(1) Ward Development Fund Committee

- The Sector to liaise with the Finance and Economic Planning Sector to complete all the ongoing/ pending projects.
- The budgetary provision for each Ward be increased from Kshs. 25million to Kshs. 27million.

- The list of projects to be undertaken in the FY 2024-25 be reconciled with the projects forwarded/ prioritized by the 85 elected members.
- The resources for the WDP in the FY 2024-25 amounting to Kshs. 2.3billion be approved as follows; administration of Ward Development Programme at Kshs. 100million and Ward Development Projects at Kshs. 2.2billion.

(m) Culture and Community Services Committee

- The programmes for Social Services, Youth, Talent and Sports totaling to Kshs. 285.72million be included in the CIDP Year 2 for ease of budget implementation.
- The County Executive aligns the ADP with Year 2 of CIDP i.e. Sports and Development Sector programmes approved in the CIDP was Kshs. 2.71billion, however the CADP has programmes amounting to Kshs. 3.25billion.
- The variance of Kshs. 2million under Control of Drugs and Pornography be approved in the CADP according to the year 2 of CIDP.
- The Committee approves the adjustments of the Liquor Board ADP activities amounting to Kshs. 271million for the FY 2024/2025 and be aligned with the year 2 of CIDP as follows:-Kshs. 80million for education/ sensitization programmes on alcoholism, Kshs. 22million for school based programmes, Kshs. 10million for workplace programmes, Kshs. 20million for establishment of rehabilitation centre, Kshs. 10million for research on alcoholism, Kshs. 25million for staff trainings, Kshs. 7million for formulation of liquor policies and regulations, Kshs. 60million for issuance of liquor licenses, Kshs. 34million for inter-agency enforcement operations and Kshs. 3million for inter-agency meetings.
- The instead of purchasing a vehicle as projected in the CIDP, the allocations should be redirected to formulation of Liquor policy and Regulations. However, since the Kshs. 7million is not enough, the Sector requested the approval for the substitute of the Key output and additional Kshs. 23million to complete the Liquor policy and regulations.
- The Committee approves the strategies and priorities for the Youth, Talent and Sports; Social Services, Disaster Management and Coordination and Liqour Board sectors as outlined in the report and the same be included in the County Annual Development Plan FY 2024/2025.

— The Committee consider and approved the programs and costing for the Public Participation, Citizen Engagement and Customer Service sector as contained in the Sectoral report.

E. OBSERVATIONS OF THE FINANCE, BUDGET AND APPROPRIATIONS COMMITTEE ON THE SECTORS' PROGRAMMES AND PROJECTS

- 10. Mr. Speaker, in the process of consideration of this ADP the Finance, Budget and Appropriations Committee held discussions with the County Treasury, Chairs of Sectoral Committees and the various Sectors to disseminate the specifics of the projects and programmes enlisted in the ADP and from the discussions the Committee managed to come up with a number of observations. This section of the report would endeavor to record some of the observations of the Committee on selected Sectors programmes as well as propose ways of dealing with any identified gaps.
- 11. Mr. Speaker Sir, the consideration of this ADP has been undertaken at a time when the County Assembly through the Ad hoc Committee on Revenue Systems and Administration is on the homestretch on determining the bottlenecks to the County revenue collections and proposing befitting solutions. During these deliberations the Committee heard from the Chief Officer for Finance that we are largely off track in realizing the revenue targets assigned to the various streams in the budget estimates for the FY 2023-24. The Committee associates itself with the concerns by the County Treasury officials that we must all continue converging at the revenue collection table with a clear view of ensuring that our revenue targets are achieved hence the positive externality of funding the progressive aspirations contained in our planning documents like the Annual Development Plan. The Committee believes that the impending report of the Ad hoc Committee will be the first tool to unclog the dirt on the County's revenue collection system.
- 12. Hon. Speaker, the national focus to ensure that every Kenyan is housed under the universal health coverage is properly aligned with the aspirations of the County Government of Nairobi which are geared towards provision of affordable and accessible health care for all. The administration's flag ship projects under the approved County Integrated Development Plan

2022-27 is the school feeding programme which is meant to improve the menu of nutritious food that all children within the city schools enjoy. The Committee appreciates that the Health Sector intends to improve the quality of health services, strengthen collaboration with health-related sectors and coordinate operational research. The Committee was however taken aback that the submitted ADP had no programme allocations and targets associated with the School Feeding Programme thereby putting the continuity of the programme in great jeopardy. The Committee hopes that the consideration and approval of the attendant regulations now before the Committees in the Assembly will improve administration accountability of funds allocated for the School Feeding Programme. Further, the Committee heard from the County Treasury during the deliberations on this ADP that the Health Sector is a beneficiary of a number of conditional grants that are neither declared nor included in the budget estimates approved by the County Assembly. The Committee shall be making recommendations aimed at ensuring that management of such grants and donations is aligned to the provisions of the PFM Act, 2012 and the attendant regulations.

13. Mr. Speaker Sir, the achievement of any approved programmes and projects in the budget estimates has a great correlation with the level of morale and motivation in the existing workforce. This therefore calls to question the role of the Public Service Management and the County Public Service Board that are mandated with the management of the County human resource. The submitted ADP once again opened the lid on the concern that the Sector is not an efficient implementer of programmes that have been allocated resources. Specifically, the Committee wishes to encourage the Sector to find workable mechanisms of rolling out the Car Loan and Mortgage Scheme. This scheme has a direct contribution to the national objective of affordable housing by ensuring that Nairobi County Government employees access affordable housing. The Committee also reminds the two entities to hit accelerator pedal with regard to roll out of the Voluntary Retirement Programme. Review of the draft ADP led to glaring instances where the Committee noted that some of Sector projects were inaccurately costed, some costs were above those approved in the CIDP among other connected deficiencies.

- 14. Mr. Speaker Sir, the Committee has further noted that the submitted ADP has not fully lived up to the expectations of the County Assembly as espoused in the report of the Committee on the ADP with respect to the Boroughs and Personnel Sector. The Committee shall hence be restating these resolutions related to enhancing the capacity of the Office of the County Attorney, purchase of vehicles, rolling out of the boroughs, allocation for the Office of the Governor for stakeholder engagement and operations of the Inspectorate Sector. Mr. Speaker Sir, there have been a number of disasters across various wards that have necessitated expenditures out of the emergency fund. However, the Committee was not convinced on the need to increase the allocation to Kshs. 1.87billion compared to the allocation of Kshs. 200million in the current financial year. The Committee agrees on the need to enhance allocations for tackling disasters but the same should be done in full cognizance of our fiscal position and revenue basket. Further the relevant Sector should work round the clock to tighten the provisions of the Disaster Management Act, 2015.
- 15. Mr. Speaker Sir, the Agriculture Sector intends to promote urban agriculture and regulation. During the consideration of this ADP, the Committee learnt that the Sector still has challenges in delivering on its mandate thereby putting the city granary at risk of running dry any time soon. The Committee hence emphasized to the Sector on the need to focus on value addition while also being on the lookout on the quality of meat inspectors in the County. The Committee agrees with the Sectoral Committee that employment of additional meat inspectors is health issue that cannot wait anymore and the County Treasury should ensure that this priority is funded in the budget estimates for the FY 2024-25. On the flipside the Sector must also ensure that it improves its absorption capacity of allocated funds.
- 16. Mr. Speaker Sir, the purpose of the Ward Development Programme is to ensure that no part of the County is left behind in terms of development. The relevant Select Committee reminded the Budget Committee on the need to enhance the allocations for WDP with an aim of ensuring that each ward can undertake additional and high impactful projects every financial year. The Committee shall be making necessary recommendations on the proposed development allocation for ward development programmes. Whereas the Committee agrees

with the Select Committee, it has also emphasized that there is need to finalize the pending projects started under the umbrella of the Ward Development Programme. On the proposed recurrent allocation of Kshs. 100million the Committee has urged the Sector to ensure that the amounts requests are aligned with the Sector objective and can be fully absorbed and accounted for.

- 17. Mr. Speaker Sir, the Innovation and Digital Economy Sector is mandated to improve service delivery through the deployment of modern ICT technology solutions. The Committee heard from the Sectoral Committee and the Sector that whereas the ICT Sector is fully prepared to address the contemporary technological challenges, such efforts were watered down by scattered ICT budgetary allocations. The Sector also decried the limited allocations granted to the Sector in the budget for the FY 2023-24 and hence implored upon the Budget Committee to enhance the allocations in the coming financial year. The Committee shall be proposing necessary recommendations to address these emerging ICT issues that threaten to roll back the gains made in development of a modern ICT infrastructure in Nairobi City County.
- 18. Mr. Speaker Sir, environmental conservation and solid waste management are at the epicenter of the action points for the current administration. The Committee appreciates the efforts that have thus far been made in acquisition of additional cleaning trucks, purchase of litter bins and supervision vehicles. The Committee was informed during these deliberations that the Green Nairobi Sector under the Environment Sub Sector intends to acquire additional working tools for a cleaner environment. The Committee however learnt that the Sector is notorious for not living within the ceilings of approved resources thereby stretching the County limited resources. The increases cost of servicing the acquired trucks and purchase of fuel should be undertaken to improve service delivery within framework that does not crowd out other critical County functions.
- 19. **Mr. Speaker Sir**, overally the Committee noted a number of issues in the submitted ADP against which it will be proposing amendments to make the plan a perfect launching pad for

the budget making process of the FY 2024-25. The Committee shall aim to address issues related to arithmetic errors in the ADP, implementation of resolutions of the County Assembly on the ADP for the FY 2023-24, alignment of the ADP to the approved CIDP, consideration of stakeholder engagements, budget targets for the various activities in the submitted among other Sectoral issues identified during this review.

F. COMMITTEE'S RECOMMENDATIONS

20. Mr. Speaker, in summary and pursuant to the provisions of Section 126 (3) of the PFM Act, 2012 and Standing Order 225, the Finance, Budget and Appropriations Committee recommends that the Annual Development Plan for the FY 2024-25 be amended as follows under the respective Sectors:

a) Policy and Cross Cutting Recommendations

- 1. That not later than 7 days after the adoption of this report the Finance and Economic Affairs Sector in consultation with all Sectors shall make all the amendments contained in this Section and the observation in Part E of this report and submit revised copy to the County Assembly for verification.
- 2. That all Sectors indicate the list and location of projects to be undertaken in the next financial year.
- 3. That all the mathematical errors contained in the document be corrected.
- 4. That all the budget summaries for all sectors be provided in line with Section 126(1)(g) of the PFM Act,2012.
- b) Amendments and Specific Interventions to the to the County Integrated Development Plan and the Annual Development Plan for the various Sectors
- Talents, Skills Development and Care
- 1. That all pending construction and rehabilitation of exiting ECDE Centers and VTCs be finalized before initiating new projects.

- 2. That the Sector programmes, priorities, strategies and projects in the proposed ADP be aligned to the approved CIDP.
- 3. That subject to (2) above the resource requirements for Ward bursaries be increased by Kshs. 170million.
- 4. That the Sector prioritizes the following additional projects in the FY 2024-25
 - Construction of safe houses
 - Establishment of units for children with disabilities
 - Employment of care givers
 - Training of survivors of gender based violence

— Built Environment

1. That, subject to available resources, an additional expense of Kshs. 115million be provided for Valuation department.t

Boroughs, Sub County Administration and Personnel

- 1. That to improve accountability for all donor and stakeholder engagements, the coordination of all such engagements be undertaken by the Office of the Governor through the Donor and Stakeholder Engagement Directorate. Specifically, that all donor engagements under the Health, Wellness and Nutrition Sector be declared and included in the draft budget estimates for the FY 2024-25.
- 2. That a report on the County fleet audit be prepared and submitted to the County Assembly together with the budget estimates for the FY 2024-25 and that all requests for purchase of vehicles shall be informed by this audit.
- 3. That subject to (2) above all allocations for purchase of administration vehicles across Sectors be harmonized and centralized under the Fleet Management Department
- 4. That all conveyancing functions and attendant budgetary allocations be domiciled in the Office of the County Attorney.
- 5. That the Sector prioritizes and budgets for the following programmes in the FY 2024-25
 - Car loan and mortgage
 - Retiree benefits

- Roll of Voluntary Early Retirement
 - Improvement of Dagorreti Training School

Green Nairobi

- That the Environment Sub Sector shall contain its expenditures within approved budgets with any variations subjected to the provisions of Section 135 of the Public Finance Management Act, 2012.
- 2. That the Agriculture Sub Sector prioritizes recruitment of additional meat inspectors in the FY 2024-25.
- 3. That the Sector prioritizes and budgets for the following projects/programmes in the ADP for the FY 2024-25
 - Servicing of trucks
 - Fueling of trucks
 - Maintenance of roads within the dumpsites
 - Purchase of litter bins

Mobility and Works

- 1. That the arithmetic errors in the ADP be corrected
- 2. That the Sector heading be corrected to read FY 2024/25 instead of FY 2023/24.
- 3. That the Sector programmes be aligned to names and matrix the approved in the CIDP.
- 4. That the allocations for General Administration contained in the ADP be aligned to the CIDP.
- 5. That the implementation of the Roads Maintenance Levy Fund be undertaken within the framework of approved workplans by the Kenya Roads Board.
- 6. That the County Executive through the Office of the County Secretary and the Office of the County Attorney explores mechanisms of terminating contracts related to incomplete defunct NMS projects.
- 7. That the projects in (6) above be finalized using internal capacity once the contracts have been transferred to the County.
- 8. That the County Executive through the Office of the County Secretary and the Office of the County Attorney explores mechanisms of terminating contracts related to NCCG projects

- that stalled at the advent of NMS and have the projects undertaken by internal capacity upon allocation of adequate resources.
- 9. That the projects attached in Annex of this report be properly costed and prioritized in the FY 2024-25.

Innovations and Digital Economy Sector

- 1. That the Sector, in collaboration with KIPPRA, develops a policy to ensure that all ICT related functions including procurement of ICT related items are undertaken by the Sector.
- 2. That, while taking into account the needs of other Sectors, the budget ceilings for the Sector be considered for enhancement in the County Fiscal Strategy Paper 2024.

Business and Hustler Opportunities

- 1. That the implementation of the Kshs. 250million allocated for industrial parks be guided by the provisions of Sections 191A- E of the Public Finance Management Act, 2012.
- 2. That any projected expenditure of amounts for Biashara Fund be guided by regulations approved by the County Assembly.
- 3. That the expenditure of the amounts be preceded with the acquisition of Information Management Software.
- 4. That the proposed procurement of GIS data collection and inspection gadgets for business site locations be undertaken by the Planning Sector.
- 5. That the cost for construction modern kiosks be aligned to the figures contained in the approved CIDP noting that the cost for development of a prototype modern kiosk was to Kshs. 50million.
- 6. That the allocation for construction of modern kiosks be distributed equitably across all the wards in the County.
- 7. That the ADP for the Liquor Licensing Board be aligned to the matrix approved in the CIDP with a total resource requirement of Kshs. 271million.
- 8. That as part of (7) above the Sector allocates resources for development of liquor policy and regulations.
- 9. That all purchase of vehicles under the Liquor Licensing Board be knocked off the plan.

Built Environment and Planning

- 1. That all budgetary provisions for renovation of City Hall and City Hall Annexe be centralized in the Built Environment and Planning Sector.
- 2. That all projects listed in 1st year of the CIDP be reconciled with the ADP 2023-24.
- 3. That the cost of redevelopment of housing units be adjusted to be commensurate to the actual number of units to be redeveloped.

Ward Development Programmes

1. That allocation for ward development projects be increased to Kshs. 27million per ward.

Health, Wellness and Nutrition

- 1. That programme matrix and attendant budgetary allocations for the School Feeding Programme be included in the ADP for the FY 2024-25.
- 2. That in line with the provisions of Section 138 of the PFM Act, 2012 and Regulations 71, 72 and 73 of the PFM (County Government) Regulations 2015, the County Executive Committee Member for the Finance shall ensure that all grants due to the Health Sector are declared, deposited in the County Revenue Fund, appropriated by the County Assembly before commencement of disbursement and factored in the budgets with counterpart funding appropriated accordingly.

County Assembly Service Board

1. That the pursuant to the provisions of Section 149 (g) of the PFM Act, 2012, the Clerk of the County Assembly shall ensure that the Strategic Plan is finalized and adopted.

Submissions from the Public on the ADP

1. That the public views contained in the 13th report tabled in the County Assembly be included in the ADP.

Mr. Speaker, in conclusion and pursuant to the provisions of Section 126 (3) of the Public Finance Management Act 2012 the County Finance, Budget and Appropriations Committee recommends that:
