

2.0 SECTION 1: PROCEEDINGS OF THE WORKSHOP

2.1 Session 1: Official Opening

The inaugural session of the workshop set the tone for the comprehensive training that followed. The chairperson's opening address, underscored the importance of parliamentary assembly etiquette, global protocol regulations, legislative rules and practices, communication best practices, skill development, and related professional etiquette, protocol, and diplomacy.

This session also delved into legislative protocol best practices, where Members were provided with practical guidance on how to conduct themselves during legislative sessions. Case studies demonstrated the effectiveness of adhering to established rules and parliamentary decorum in maintaining a conducive environment for constructive debate and decision-making.
