WE, THE UNDERSIGNED citizens of Kenya who are Members of California Estate Residents Committee of New Pumwani Estate and tenants of Nairobi City County Government within Kamukunji Sub-County, California Ward;

DRAW the attention of Nairobi City County Assembly to the following;

THAT, aware that the Constitution of Kenya under Article 37 and Section 15 and 88 of the County Governments Act, 2012, provide the right for citizens to petition authorities or County Governments on any matter;

THAT WHEREAS, Article 62 of the Constitution of Kenya provides that public land shall vest in and be held by a County Government in trust for the people resident in the county and may be administered by the National Land Commission on behalf of the County Government;

THAT WHEREAS, Article 43 (b) of the Constitution further guarantees every person the right to accessible and adequate housing, and to reasonable standards of sanitation;

THAT WHEREAS, the County Government of Nairobi City in its pursuit to actualize the right to housing for the residents of the City initiated the urban renewal program aimed at developing decent and affordable housing units particularly in the County owned Estates;

THAT WHEREAS, a feasibility report on the implementation of urban renewal of Eastlands in Nairobi by Real Plan Consultants exempted Pumwani Estate from the urban renewal program since in the said report the Houses in Pumwani Estate were found to be in good condition and could only be renovated as and when need arise.

THAT WHEREAS, in the above circumstances, the current Resident Rental Tenants of New Pumwani Estate are likely not to benefit from the urban renewal program since they are unable to purchase the units they are currently renting unlike is the case in other Estates undertaking the affordable housing projects where the tenants would have the opportunity to own the houses;

THAT WHEREAS, the Resident Rental Tenants of New Pumwani Estate also aspire to own the houses under a similar arrangement as is the case with other tenants in Estates undertaking the urban renewal program;

AND WHEREAS, all the matters in respect of which the petition is raised are not pending before any court of law or constitutional body and the petitioners' efforts to directly engage the County Executive on this matter have not been fruitful;

NOW THEREFORE your humble petitioners **PRAY** the Nairobi City County Assembly intervenes to ensure that: -

- 1. The current Resident Rental Tenants of New Pumwani Estate enjoy the benefit of the affordable housing program by the County Government of Nairobi City by converting the existing New Pumwani Social Rental Tenants under the tenancy of Nairobi City County Government from Rental to a Tenant Purchase Scheme.
- 2. Take any other measures to protect the right to accessible and adequate housing for the Resident Rental Tenants of New Pumwani Estate.

And your Petitioners will forever pray.



PUBLIC PETITION TO THE OFFICE OF THE GOVERNOR - NAIROBI COUNTY, BY RESIDENTS OF RENTAL SOCIAL HOUSING UNITS NEW PUMWANI ESTATE UNDER TENANCY OF NAIROBI CITY COUNTY GOVERNMENT.

WE THE UNDERSIGNED Citizens of Kenya who are Rent Paying Residents under Tenancy of Nairobi City County Government within Kamukunji Sub-County, California Ward, Nairobi County DRAW the attention of HON GOVERNOR Nairobi City County Government and by way of legislative representation vide the incumbent area MCA CALIFORNIA WARD, to the following: -

AWARE THAT, Article 62 (2) of the Constitution of Kenya 2010 vests public land be held by a County Government in trust for the people resident in the County, and shall be administered on their behalf by the National Land Commission;

- 1.1. THAT WHEREAS, The Constitution of Kenya 2010 Chapter FOUR BILL OF RIGHTS ARTICLE 19 states as Thus,
- (a). RIGHTS & FUNDAMENTAL FREEDOMS Part 1 (2), the purpose of recognizing and protecting human rights and fundamental freedoms is to preserve the dignity of individuals and communities and to promote social justice and the realization of the potential of all human beings;
- (b). ARTICLE 21, IMPLEMENTATION OF RIGHTS AND FUNDAMENTAL FREEDOMS states as Thus,
- (1) It is a fundamental duty of the state and every state organ to observe, respect, protect, promote and fulfil the rights and fundamental freedoms in the bill of Rights,
- (2) The state shall take legislative, policy and other measures, including the setting of standards to achieve the progressive realization of the rights guaranteed under Article 43,
- (3) All state organs and all public officers have the duty to address the needs of vulnerable groups within the society, including women, older members of the society, persons with disabilities, children, youth, members of minority or marginalized communities and members of particular ethnic, religious or cultural communities;
- (c). ARTICLE 28 HUMAN DIGNITY states as Thus,

Every person has inherent dignity and the right to have that dignity respected and protected;

- (d). ARTICLE 43 ECONOMIC & SOCIAL RIGHTS (1) States as Thus, Every person has the right:-
- (B) To accessible and adequate housing, and to reasonable standards of living,
- (3) The state shall provide appropriate social security to persons who are unable to support themselves and their dependents;

- THAT WHEREAS, Article 42 of the Constitution further provides that every person has the right to a clean and healthy environment, which includes the right;
 - a) to have the environment protected for the benefit of present and future generations through legislative and other measures, particularly those contemplated in Article 69; and
 - b) to have obligations relating to the environment fulfilled under Article 70;
- 2.1. THAT, The National Government of Kenya has ascribed to such human rights vide the Economic. Social and political pillars of vision 2030 that are anchored on the foundations of macroeconomic stability. infrastructural development, science technology and innovation (STI), LAND REFORMS, HUMAN RESOURCES DEVELOPMENT, SECURITY AND PUBLIC REFORMS. The First and Second Medium Term Plans have been actualized over the last 10 years and in the last dispensation, the third MTP and BIG FOUR AGENDA, Affordable Housing are in motion:
- 2.2. THAT, The Nairobi City County Government has complimented the Affordable Housing Big Four Agenda vide the URBAN RENEWAL, HOUSING & PROJECT MANAGEMENT whose sector objectives include but not limited to:-
- Facilitate development of decent and affordable housing units within Nairobi city county in support of agenda 4 plan on provision of affordable housing,
- Improve security of tenure and living conditions in informal settlements,
- Improve habitability of county rental houses / estates,
- Provide technical assistance in construction of modern county buildings;
- THAT, as per the final plan report UP/UPR&S/URP-E/ZONE8/178/09/19 Vol. 2 URBAN RENEWAL PLAN; FINAL PLAN REPORT as documented by Real Plan Consultants on the implementation of the URBAN RENEWAL OF EASTLANDS, NAIROBI, a report that discounted New Pumwani Estate from the Urban Renewal Program,
- THAT, as per the final plan report UP/UPR&S/URP-E/ZONE8/178/09/19 Vol. 2 URBAN RENEWAL PLAN; FINAL PLAN REPORT, and quote, "The housing developments in New Pumwani are being retained. This is because they are in good condition and can only be renovated as need arises. The proposed redevelopment approach is thus renovation";
- THAT, the realization of the basic social human rights of affordable housing shall not be enjoyed by the Resident Rental Tenants on the social units under the tenancy of Nairobi City County Government:
- THAT New Pumwani Estate is a mixed residential restricted and controlled development Estate Plan consisting of Tenant Purchase Scheme house units ownership and Social Rental Units Tenancy Under Nairobi City County Government;
- AND THAT, all the matters in respect of which the petition is raised is not pending before any court of law or constitutional body.

WHEREFORE, your humble Petitioners PRAY that Your Esteemed offices and Custodian of and As the HON Governor of the Nairobi City County Government legislates with concerted efforts of the incumbent Area MCA California Ward and the enabling County Assembly Committees and County Assembly House, legislation that shall ensure; -

- a) The tenants shall enjoy the benefits and human social rights of affordable housing by way of converting the existing New Pumwani Social Rental Tenants under the tenancy of Nairobi City County Government from Rental to Tenant Purchase Scheme;
- b) Such a legislation and any other action that your esteemed offices and Nairobi County assembly may consider necessary to protect the Rental Tenants Rights under social housing and the Constitutional Human rights of the Estates' residents be taken;


