RE: REQUEST TO STOP RENT PAYMENT GOROFANI ESTATE

Fire broke out sometime in 2014 and consumed four blocks in phase one. Soon thereafter in the month of July 2014 another inferno occurred in phase two whereby almost a similar number of houses were gutted down leaving your tenants without shelter, is a basic necessity.

After the two fires instances we sought the intervention of your good office for the repairs and renovation of the houses, and the help sought somehow took a snail speed thus occasioning the tenants to further seek permission to repair and renovate the houses since they risked losing the essential facility (house) Or facing eviction from the houses. With your permission some tenants

Who were able to repair and renovate their rooms and others remain unrepaired to date thus posing a danger to the tenants by disinheriting their houses.

Last year 23rd June 2015 another fire burnt down the following blocks 22,23,24,25,26,27,28,29,30,31,32,33,34 and 35. After this fire incident we have made several follow ups with your office for repairs and renovation and your good office finally allowed us to repair and renovate our houses even though some houses remain unattended to due to lack of funds given that the amounts involved in repairing is quite substantial and not many of your tenants can afford to raise such figure. With such in mind sir we request your office to consider offsetting the costs incurred by those who repaired their houses by allowing them period within which you suspend collecting rent from them so that they recover their costs and further kindly make arrangements to repair the houses not repaired to date so that the tenants can reoccupy their houses. The rent is still accumulating day and night making it dangerous for us tenants to lose our houses.

We would also be grateful if your officers can identify to the tenants the water points which have been taken up by the mtumba merchants so that we can as well be of help when such fire incidents occur in the future. We also kindly request your officers to organize to educate the tenants on firefighting lessons for them to be equipped with the modern firefighting techniques.
